[PROPOSED] JUDGMENT

1 After full consideration of the Application for Default Judgment and supporting documents
2 submitted, the Court hereby GRANTS Plaintiff’s Application for Default Judgment pursuant to and in
3 accordance with Health & Safety Code §25249.7(f)(4). The Court reviewed the Application and
4 makes the following findings pursuant to Health & Safety Code § 25249.7(f)(4):

5 a. Alfa Travelgear, Inc., is hereby enjoined to place warnings upon its pet waste bag
6 products containing Di [2-Ethylhexyl] Phthalate, which it sells into California. The warnings shall
7 use the following language:

8 the text, **“WARNING This product can expose you to chemicals, including**
9 **DEHP, which is known to the State of California to cause cancer, birth defects or other**
10 **reproductive harm. For more information go to www.P65Warnings.ca.gov.”**

11 accompanied by and placed to the right of a symbol consisting of a black exclamation point
12 in a yellow equilateral triangle with a bold black outline sized to be no smaller than the
13 word, “WARNING” as provided by regulations adopted on or about August 30, 2016; or

14 the text, **“WARNING Cancer and Reproductive Harm -**
15 **www.P65Warnings.ca.gov.”** accompanied by and placed to the right of a symbol consisting
16 of a black exclamation point in a yellow equilateral triangle with a bold black outline sized
17 to be no smaller than the word, “WARNING” as provided by regulations adopted on or
18 about August 30, 2016.

19 The triangular warning symbol specified in Section 3.3(a) and 3.3(b) shall be in yellow with
20 a black exclamation mark; *provided however*, the symbol may be printed in black and white if the
21 Covered Product label is not printed against a yellow background.

22 b. Pursuant to health and Safety Code § 25249.7(b), Alfa Travelgear, Inc., is hereby
23 ordered to pay \$2,500.00 in civil penalties, with 75% of the penalties payable to the Office of
24 Environmental Health Hazard Assessment, and 25% payable to Plaintiff Shefa LMV, Inc.

25 c. Pursuant to Code of Civil Procedure section 1021.5, Alfa Travelgear, Inc. is hereby

1 ordered to pay \$20,720.70 in attorney's fees to Plaintiff, made payable to Plaintiff's counsel, the Law
2 Office of Daniel N. Greenbaum.
