20	1. <u>INTRODUCTION</u>	
21	1.1 On May 19, 2022, the Ecological Ri	ghts Foundation ("ERF"), acting on behalf of itself
22	and the general public, filed a Complaint for civ	ril penalties and injunctive relief ("Complaint") in
23	Alameda County Superior Court, Case No. 22CV	011540, against defendant AMAZON.COM, INC.,
24	hereinafter "Amazon" or "Defendant." On Octobe	er 19, 2022, ERF, acting on behalf of itself and the
25	general public, filed a Complaint for civil penaltie	s and injunctive relief in Alameda County Superior
26	Court, Case No. 22CV020002, against Defendant	On November 29, 2022, ERF, acting on behalf of
27	itself and the general public, filed a Complaint f	or civil penalties and injunctive relief in Alameda
28	County Superior Court, Case No. 22CV022798, a	gainst Defendant. All three Complaints are referred

to collectively herein as the "Complaints." On August 31, 2023, Case Nos. 22CV011540, 22CV020002, and 22CV022798 were consolidated for all purposes, with Case No. 22CV011540 designated the lead case.

- 1.2 The Complaints allege that Defendant violated provisions of the Safe Drinking Water and Toxic Enforcement Act of 1986, Health and Safety Code Sections 25249.5, et seq. ("Proposition 65") by failing to give clear and reasonable warnings pursuant to Health and Safety Code Section 25249.6 to those residents of California who use filaments incorporating a stryrene monomer, and 3D Pens and 3D Printers intended to be used with filaments incorporating a styrene monomer, that Defendant distributes, markets, or offers for sale in the State of California. The Complaints further allege that use of these filaments, 3D Pens, and 3D Printers results in release of Styrene, a chemical known to the State of California to cause cancer, into the air, exposing users and others standing in the same room through inhalation to Styrene in the normal course of use. ERF further alleges that the Complaints were based upon three 60-Day Notice letters sent by ERF on April 24, 2019 to Defendant, the California Attorney General, all District Attorneys, and all City Attorneys with populations exceeding 750,000: (i) AG Notice # 2019-00884 for Alameda Case No. 22CV011540, (ii) AG Notice # 2019-00885 for Alameda Case No. 22CV020002, and (iii) AG Notice # 2019-00886 for Alameda Case No. 22CV022798. All three Notices are referred to collectively herein as the "Notices."
- 1.3 For purposes of this Consent Judgment, "Covered Products" are the specific products listed by Amazon Standard Identification Number (ASIN) on the attached Exhibit A for filaments incorporating a styrene monomer, Exhibit B for 3D Printers, and Exhibit C for 3D Pens.
- 1.4 Defendant is a business that employs more than ten persons, and operates an online marketplace on which Covered Products were sold.
- 1.5 For purposes of this Consent Judgment only, ERF and Amazon ("the Parties") stipulate that this Court has jurisdiction over the allegations of violations contained in the Complaints and personal jurisdiction over Defendant, that venue is proper in the County of Alameda, and that this Court has jurisdiction to enter this Consent Judgment as a full settlement and resolution of the allegations contained in the Complaints.
 - 1.6 This Consent Judgment resolves claims that are denied and disputed. The Parties enter

The word "WARNING" shall be in upper case letters and bold. The warning symbol to the left of the

word "WARNING" must be a black exclamation point in a yellow equilateral triangle with a black outline.

- (c) Amazon shall notify in writing all vendors and third-party sellers of the Covered Products of the legal requirement to provide the Section 2.1(b) warning statement for each Covered Product online, and that the California Attorney General requires that vendors and third-party sellers of the Covered Products that are subject to Proposition 65 also apply the Section 2.1(b) warning statement, or a Proposition 65 compliant warning, directly on the packaging of the Covered Products. Amazon shall not be responsible or liable for failures of any vendors or third-party sellers of the Covered Products to fulfill their independent Proposition 65 obligations.
- (d) To the extent that the product information for any of the Covered Products appears in a foreign language (e.g., if a potential purchaser chooses to review amazon.com's website in Spanish, using amazon.com's translation feature), the Proposition 65 warning shall appear in the same foreign language.
- (f) The Parties agree that the Section 2.1 warnings set forth above shall constitute compliance by Amazon with Proposition 65 with respect to any Covered Products.

2.2 Covered Products in the Stream of Commerce

Any Covered Products that have been distributed, shipped, or sold prior to the Effective Date, shall not be subject to the requirements of Section 2.1.

2.3 Notice to Cure

To the extent ERF identifies any Covered Product on amazon.com in the future which it believes is not in compliance with this Consent Judgment, ERF agrees to advise Amazon of such alleged breach in the manner set forth in Section 14.2, and provide Amazon with 20 business days (calculated from the date notice is provided) to cure any alleged violation of this Consent Judgment (the "Notice to Cure"). Such Notice to Cure shall contain, to the extent known by ERF, information sufficient for Amazon to identify the Covered Product, including but not limited to the ASIN for such product and a screenshot of the Covered Product's online listing on amazon.com.

ERF shall not be entitled to seek or recover any civil penalties, and ERF and its counsel shall not be entitled to recovery or reimbursement of attorney's fees and/or costs, or any other available

remedies arising from or related to any Notices to Cure, provided Amazon timely remedies the alleged non-compliance within 20 business days of receiving the Notice to Cure by Amazon (1) adding a Section 2.1(b) warning on the amazon.com online product page for the Covered Product, or (2) delisting the Covered Product from amazon.com, or (3) ceasing to offer the Covered Product for sale in California.

If Amazon provides notice and proof to ERF that it has so remedied the alleged non-compliance within 20 business days of receiving the Notice to Cure, Amazon shall not be deemed in breach or violation of this Consent Judgment in any respect.

In the absence of Amazon curing within 20 business days of receiving the Notice to Cure, ERF may bring an action to enforce this Consent Judgment to seek additional civil penalties, reimbursement of reasonable attorney's fees and costs, injunctive relief, and any other available remedies, or bring a new Proposition 65 action.

2.4 The injunctive relief awarded herein applies only to Covered Products for sale in California on amazon.com.

3. <u>SETTLEMENT PAYMENTS</u>

3.1 Civil Penalties

Pursuant to Health and Safety Code section 25249.7(b)(2), Defendant shall pay \$2,000.00 in civil penalties. The penalty payment will be allocated in accordance with California Health and Safety Code section 25249.12(c)(1) & (d), with 75% of the penalty amount remitted to the California Office of Environmental Health Hazard Assessment ("OEHHA") and the remaining 25% of the penalty amount paid to Ecological Rights Foundation.

Amazon shall make the above payment within 30 days of the Effective Date of this Agreement via electronic transfer to the Law Offices of Brian Gaffney APC ("Law Offices") pursuant to the wiring instructions that shall be confirmed in written correspondence between counsel. Such payment shall only be made after Amazon's receipt of a current W-9 for the Law Offices.

Law Offices will thereafter timely provide payments in two checks for the following amounts made payable to: 1) "OEHHA" in the amount of \$1,500.00 and 2) "Ecological Rights Foundation" in the amount of \$500.00. These payments shall be sent to the following addresses:

3.2 Attorneys' Fees and Litigation Costs

Defendant shall reimburse ERF's counsel for \$68,000.00 in ERF's fees and costs incurred as a result of investigating and bringing this matter to Defendant's attention and negotiating a settlement in the public interest. The payment shall be made within 30 days via electronic transfer in the same manner as set forth above in Section 3.1.

4. <u>RELEASE OF ALL CLAIMS</u>

4.1 Release of Defendant

ERF, acting on its own behalf and on behalf of each of its past, current, and future agents, representatives, attorneys, successors and/or assignees (all of whom, collectively, are defined as the "ERF Releasors") and in a representative capacity in the public interest under Health & Safety Code § 25249.7, releases Defendant, and its past, current, and future direct and indirect subsidiaries, affiliated entities under common ownership, predecessors, successors, directors, officers, managers, shareholders, members, agents, employees, assignees, and attorneys (collectively, Releasees), of, from, and with regard to any and all alleged or actual violations of Proposition 65 through the Effective Date for failure to warn about exposures to Styrene from the Covered Products that were offered for sale or sold on amazon.com prior to the Effective Date, including as set forth in the Notices and/or Complaints ("Released Allegations"). This settlement is a full, final and binding resolution of all claims that were asserted against the Releasees in the Notices or the Complaints for alleged failure to provide warnings under Proposition 65 for alleged exposures to Styrene from use of the Covered

Products that were offered for sale or sold on amazon.com prior to the Effective Date. This release does not apply to any product brought to Defendant's attention and not timely cured as provided in Section 2.3 *supra*. This release does not apply to any vendors or third-party sellers of the Covered Products.

In further consideration of the promises and agreements herein contained, and for the payment to be made pursuant to Section 3 above, the ERF Releasors provide a release herein, which shall be effective as a full and final accord and satisfaction, as a bar to all actions, causes of action, obligations, costs, expenses, attorneys' fees, damages, losses, claims, liabilities and demands against the Releasees of any nature, character, or kind, arising out of the claims and allegations set forth in the Notices or the Complaints for the alleged failure to provide warnings for alleged exposure to Styrene from use of the Covered Products.

4.2 **Defendant's Release of ERF**

Defendant, on behalf of itself and the Releasees, hereby waives any and all claims against ERF and the ERF Releasors for any and all actions taken or statements made (or those that could have been taken or made) by ERF and/or its attorneys and other representatives, whether in the course of investigating claims or otherwise seeking to enforce Proposition 65 against it in this matter or with respect to the Covered Products.

4.3 California Civil Code Section 1542

It is possible that other claims not known to the Parties arising out of the facts alleged in the Notices or the Complaints, and relating to the Covered Products, will develop or be discovered. ERF on behalf of itself only, on one hand, and Defendant, on the other hand, acknowledge that this Agreement is expressly intended to cover and include all such claims up through the Effective Date, including all rights of action therefor. The Parties acknowledge that the claims released in Sections 4.1 and 4.2 above may include unknown claims, and nevertheless waive California Civil Code section 1542 as to any such unknown claims. California Civil Code section 1542 reads as follows:

A general release does not extend to claims that the creditor or releasing party does not know or suspect to exist in his or her favor at the time of executing the release, and that if known by him or her, would have materially affected his or her settlement with the debtor or released party.

5. <u>ENFORCEMENT OF JUDGMENT</u>

The terms of this Consent Judgment shall be enforced exclusively by the Parties hereto. Notwithstanding Section 4.1 *supra*, the Parties may, by noticed motion or order to show cause before the Superior Court of Alameda County, giving the notice required by law, enforce the terms and conditions contained herein. In the event that a dispute arises with respect to any of the provisions of this Consent Judgment, the Parties shall meet and confer within 10 days after either Party receives written notice of an alleged violation of this Agreement. In any proceeding brought by either Party to enforce this Consent Judgment, ERF may seek whatever fines, costs, penalties or remedies as may be provided by law for any violation of Proposition 65 or this Consent Judgment. This Section is subject to Amazon's right to timely cure as set forth in Sections 2.2 *supra*.

6. MODIFICATION OF JUDGMENT

This Consent Judgment may be modified only upon written agreement of the Parties and upon entry of a modified Consent Judgment by the Court thereon, or upon a successful motion of any Party as provided by law and upon entry of a modified Consent Judgment by the Court thereon. Any Party seeking to modify this Consent Judgment shall attempt in good faith to meet and confer with all affected Parties prior to filing a motion to modify the Consent Judgment.

7. <u>TERMINATION AND RETENTION OF JURISDICTION</u>

This Court shall retain jurisdiction of this matter to implement and enforce the terms this Consent Judgment.

8. <u>AUTHORITY TO STIPULATE</u>

Each signatory to this Consent Judgment certifies that he or she is fully authorized by the Party he or she represents to enter into this Consent Judgment and to execute it on behalf of the Party represented and legally to bind that Party.

9. <u>SERVICE ON THE ATTORNEY GENERAL</u>

ERF shall serve a copy of this Consent Judgment, signed by both Parties, on the California Attorney General concurrently with filing and serving the motion for approval in court. Service on

the Attorney General shall occur no later than forty five (45) days prior to the date the motion for approval will be heard in court.

10. ENTIRE AGREEMENT

This Consent Judgment contains the sole and entire agreement and understanding of the Parties with respect to the entire subject matter hereof and any and all prior discussions, negotiations, commitments and understandings related hereto. No representations, oral or otherwise, express or implied, other than those contained herein have been made by any Party hereto. No other agreements not specifically referred to herein, oral or otherwise, shall be deemed to exist or to bind any of the Parties. For the avoidance of doubt, the Parties agree that the prior version of this proposed Consent Judgment executed by the Parties in February 2024 is void, unenforceable, and of no effect, and no Party shall attempt to enforce it or use it against the other Party for any purpose.

11. GOVERNING LAW

The validity, construction and performance of this Consent Judgment shall be governed by the laws of the State of California, without reference to any conflicts of law provisions of California law.

In the event that Proposition 65 is repealed, preempted, or is rendered inapplicable by amendment or reason of law generally, as to any of the Covered Products and any of the alleged violations set forth in the Notices or Complaints, then Defendant may seek modification of this Consent Judgment pursuant to section 6 above. Nothing in this Consent Judgment shall be interpreted to relieve Defendant from its obligation to comply with any other applicable state or federal law or regulation.

The Parties agree that if the Office of Environmental Health Hazard Assessment changes any of its applicable regulations, including its warning regulations, then Defendant will continue to conform with the terms provided in this Consent Judgment if the new implementing regulations so allow.

12. EXECUTION AND COUNTERPARTS

This Consent Judgment may be executed in counterparts which taken together shall be deemed to constitute one document.
