ORDER re: Hearing on Motion to Confirm Settlement

The Motion re: Approval of Proposed Consent Judgment filed by Environmental Democracy Project on 07/26/2022 is Granted.

The Motion of Plaintiff Environmental Democracy Project for Court Approval and Entry of Consent Judgment as to Snackerz, Inc. is GRANTED.

Pursuant to and in accordance with Health & Safety Code § 25249.7(f)(4), the Court makes the following findings:

- 1. The Consent Judgment ensures compliance with the Proposition 65 warning requirement, in that it provides injunctive relief requiring both cessation of sales of the product and recall of all of the product from the marketplace, so no warnings are needed;
- 2. The attorneys’ fee award in the Consent Judgment is reasonable under California law; and
- 3. The civil penalty and additional settlement payment in lieu of civil penalty are reasonable, based upon the criteria set forth in Health & Safety Code 25249.7(b)(2).

Accordingly, the court approves the settlement and will sign the proposed consent judgment submitted to the court.


