1 Plaintiff Michael DiPirro, and Defendant BEE SALES COMPANY, have agreed  
2 through their respective counsel that judgment be entered in this Proposition 65 action  
3 pursuant to the terms of the Consent Judgment executed by the parties and attached to the  
4 Declaration of David Bush in Support of the Motion to Confirm the Proposition 65  
5 Settlement as Exhibit 1, and as Amended by the parties.


6 After consideration of the papers submitted and the arguments presented, the Court  
7 finds that the settlement agreement set forth in the Consent Judgment meets the criteria  
8 established by Health and Safety Code section 25249.7, in that:


- 9 1. any injunctive relief required by the Consent Judgment complies with  
10 Proposition 65;
- 11 2. the reimbursement of attorneys' fees pursuant to the Consent Judgment is  
12 reasonable under California law; and
- 13 3. based on the criteria set forth in Health and Safety Code section  
14 25249.7(b)(2), the civil penalty required by the Consent Judgment is  
15 reasonable.

17 Accordingly, the Motion to Confirm the Proposition 65 Settlement between the parties is  
18 GRANTED and the related Consent Judgment (as Amended) is hereby entered.


