DEFAULT JUDGMENT AGAINST DEFENDANT MANN LAKE, LTD.

Pursuant to Code of Civil Procedure § 585, the Court hereby enters final judgment in favor of plaintiff Keep America Safe and Beautiful ("KASB") against defendant Mann Lake, Ltd. as follows:

- 1. Pursuant to Health and Safety Code § 25249.7(a), Mann Lake is permanently enjoined from offering any tools with vinyl/PVC grips containing diisononyl phthalate ("DINP") in California without providing clear and reasonable warnings regarding the risks of cancer caused by DINP exposures, as set forth in paragraph 2 below. This includes but is not limited to *Economy Ring Clincher*, SKU: PP984, UPC: 7 14854 74984 7.
 - 2. The warning provided pursuant to this Judgment shall state:

▲WARNING: This product can expose you to diisononyl phthalate (DINP), which is known to the State of California to cause cancer. For more information go to www.P65warnings.gov.

The above language should be placed conspicuously on all tools with vinyl grips which contains detectable amounts of DINP or the product packaging.

- 3. Mann Lake, Ltd. is ordered to pay \$5,000 in statutory penalties, pursuant to Health and Safety Code § 25249.7(b);
- 4. Mann Lake, Ltd. is ordered to pay \$30,795 in attorneys' fees to KASB as reimbursement of reasonable attorneys' fees pursuant to Code of Civil Procedure section 1021.5. In addition, Mann Lake, Ltd. is ordered to pay \$5,142.05 in costs.
- 5. All amounts required by paragraphs 3 and 4 of this Default Judgment are due within thirty days of the date of entry of this Default Judgment and shall be sent to Seven Hills LLP, 4 Embarcadero Center, Suite 1400, San Francisco, CA 94111.

Mann Lake's civil penalty payment will be allocated according to Health and Safety Code §§ 25249.12(c)(1) and (d), with seventy-five percent (75%) of the penalty paid to the California Office of Environmental Health Hazard Assessment ("OEHHA"), and the remaining twenty-five percent (25%) retained by KASB. Mann Lake shall issue its payment in two checks made payable to: (a) "OEHHA" in the amount of \$3,750; and (b) "Seven Hills LLP in Trust for KASB" in the

amount of \$1,250. KASB's counsel shall deliver to OEHHA and KASB their respective portion of the penalty payment. The attorneys' fees and costs payments shall be combined in a single check in the amount of \$35,937.05 made payable to "Seven Hills LLP." IT IS SO ORDERED. July 31, 2024 Dated:
