3 IT IS HEREBY ORDERED that Plaintiff's Motion for Court Approval and Entry of Consent  
4 Judgment is GRANTED. Pursuant to and in accordance with *Health & Safety Code* § 25249.7(t)(4),  
5 the Court makes the following findings with respect to the Consent Judgment between KEEP  
6 AMERICA SAFE AND BEAUTIFUL, INC., and Defendant MEMEBOX CORPORATION in the  
7 action *Keep America Safe and Beautiful, Inc. v. Memebox Corporation, et al.*, Case No. 23TRCV01165  
8 (the "Consent Judgment"):

- 10 1. The Consent Judgment ensures compliance with the Proposition 65 warning requirement;
- 11 2. The attorneys' fee award in the Consent Judgment is reasonable under California law;
- 12 3. The civil penalty is reasonable based on the criteria listed in *Health & Safety Code* §  
13 25249.7(b)(2); and
- 14 4. The amount sought for reimbursement of Plaintiff's costs for testing and bringing this action  
15 are reasonable.

17 In light of the findings set forth herein, the Consent Judgment is hereby APPROVED.
