ON THE DEFAULT OF AND AGAINST
DEFENDANT ANIMA MUNDI
HERBALS LLC**

Pursuant to Code of Civil Procedure § 585, the Court hereby enters final judgment in favor of plaintiff Blue Sky Forever (“BSF”) against defendant Anima Mundi Herbals LLC as follows:

1. Pursuant to Health and Safety Code § 25249.7(a), defendant Anima Mundi Herbals LLC is permanently enjoined from offering health supplements containing Lead in California without providing clear and reasonable warnings regarding the risks of harm caused by Lead exposures, as set forth in paragraph 2 below. This includes but is not limited to *LIVER VITALITY Greens Daily Cleanser NET WT. 8 OZ. (227 G) UPC: 8 62613 00002 6*.

2. The warning provided pursuant to this Judgment shall state:

WARNING: Consuming this product can expose you to lead, which is known to the State of California to cause cancer and birth defects or other reproductive harm. For more information go to: www.P65Warnings.ca.gov/food.

The above language shall be prominently provided to a consumer prior to completing an internet purchase of health supplements containing lead (Pb) for shipment in or into California and placed conspicuously on the immediate packaging or food product label over the bag of health

1 supplements containing lead (Pb). **“WARNING:”** must be in all capital letters and bold print.
2 Where the warning is provided on the food product label, it must be set off from other surrounding
3 information and enclosed in a box.

4 3. Anima Mundi Herbals LLC is ordered to pay \$5,000 in statutory penalties, pursuant
5 to Health and Safety Code § 25249.7(b);

6 4. Anima Mundi Herbals LLC is ordered to pay \$18,397.50 in reimbursement of
7 attorneys’ fees and \$6,172.06 in reimbursement of costs pursuant to Code of Civil Procedure
8 section 1021.5.

9 5. All amounts required by paragraphs 3 and 4 of this Default Judgment are due within
10 thirty days of the date of entry of this Judgment and shall be sent to Seven Hills LLP,
11 1 Embarcadero Center, Suite 1200, San Francisco, CA 94111.

12 6. Anima Mundi Herbals LLC civil penalty payment will be allocated according to
13 Health and Safety Code §§ 25249.12(c)(1) and (d), with seventy-five percent (75%) of the penalty
14 paid to the California Office of Environmental Health Hazard Assessment (“OEHHA”), and the
15 remaining twenty-five percent (25%) retained by BSF. Anima Mundi Herbals LLC shall issue its
16 payment in two checks made payable to: (a) “OEHHA” in the amount of \$3,750; and (b) “Seven
17 Hills LLP in Trust for BSF” in the amount of \$1,250. BSF’s counsel shall deliver to OEHHA and
18 BSF their respective portion of the penalty payment.

19 7. The attorneys’ fees and costs payments shall be combined in a single check in the
20 amount of \$24,569.56 made payable to “Seven Hills LLP.”
