

NOTICE OF VIOLATION

California Safe Drinking Water
and Toxic Enforcement Act of 1986

This Notice of Violation is provided to Equilon Enterprises LLC pursuant to, and in compliance with, California Health and Safety Code Section 25249.7(d).

For general information regarding the California Safe Drinking Water and Toxic Enforcement Act, see the attached summary provided by the California Environmental Protection Agency (the attachment is not provided to public enforcement agencies but to all others who are served with this notice).

This Notice of Violation is provided by Dean Hilburn, individually and as trustee of the Edina Hilburn Trust, (collectively, "Mr. Hilburn) who may be contacted at the address, telephone and/or facsimile number set forth in the last paragraph of this Notice of Violation.

Description of Violation:

- The name and address of the violator is: Equilon Enterprises LLC, 1100 Louisiana Street, Ste. 2200, Houston, Texas 77002.
- The violations have been occurring since at least 2000 through to the present, though there are indications that separate and additional violations may have occurred before then as well.
- This Notice of Violation covers the "discharge or release prohibition" of Proposition 65, which is found at California *Health and Safety Code* Section 25249.5.
- The name of the listed chemical involved in these violations is benzene and toluene. Benzene and toluene are known carcinogens. Benzene and toluene are contained in the gasoline that was released.
- Discharges of the gasoline which contained benzene and toluene occurred and continue to occur at, and in the area around, the gasoline station located at 3009 N. Long Beach Boulevard (at West Spring Street) in Long Beach, California (the "gasoline station").

- The gasoline station and the equipment and fixtures associated with the gasoline station were and are the sources of the releases of the gasoline that contain the benzene and toluene.
- The releases of the gasoline that contain the benzene and toluene have been and continue to be into the soils and into the groundwater under the gasoline station and into the groundwater underlying the area around the gasoline station.
