“the Companies”) pursuant to and in compliance with California Health and Safety Code (“H&S Code”) Section 25249.7(d) and 22 California Code of Regulations (“CCR”) Section 12903. This Notice satisfies a prerequisite for Noticing Party to commence an action against the Companies to enforce the Safe Drinking Water and Toxic Enforcement Act of 1986. The violations addressed by this Notice occur in every county and city in California. This Notice is being served upon each violator, the California Attorney General, the district attorney of every California county and the city attorney of every California city with a population (according to the most recent decennial census) of over 750,000. If any of the Companies has a current registration with the California Secretary of State that identifies a Chief Executive Officer, President, or General Counsel, this Notice is being addressed to, and served upon, one of those persons.

Attached as Exhibit A to this Notice is a copy of “The Safe Drinking Water and Toxic Enforcement Act of 1986 (Proposition 65): A Summary.” The attached Summary was prepared by the California EPA and provides general information about the Safe Drinking Water and Toxic Enforcement Act of 1986. Copies of the Summary are not required to be, and are not being, provided to the public enforcement agencies.

Description of the Noticing Party, the Alleged Violator, and the Alleged Violations Addressed by this Notice:

- ◆ This Notice is provided by the American Environment Safety Institute. The American Environmental Safety Institute (hereinafter “Institute”) is based in Palo Alto and is registered as a California non-profit corporation with the office of the California Secretary of State. The Institute is acting in the public interest pursuant to California Health and Safety Code Section 25249.7(d), and is dedicated to protecting the environment; improving human health and supporting environmentally sound practices.

- ◆ The violations addressed by this Notice began on February 27, 1988, have occurred on numerous occasions each and every day since February 27, 1988, and are ongoing and continuing.
- ◆ This Notice of Violation covers the “warning provision” of Proposition 65, which is found at H&S Code §25249.6.
- ◆ The name of each chemical that is listed pursuant to the Safe Drinking Water and Toxic Enforcement Act of 1986 involved in the violations addressed by this Notice is set forth on Exhibit B attached to this Notice and incorporated into this Notice by this reference; (the “Listed Chemicals”). The Listed Chemicals are listed (and have been so listed for more than twelve months) by the Governor of the State of California as being chemicals known to the State of California to cause cancer or reproductive toxicity, or both cancer and reproductive toxicity. See Exhibit B attached hereto.
- ◆ The routes of exposure for the violations addressed by this Notice include inhalation and dermal contact.
- ◆ The type of consumer product causing the exposures addressed by this Notice are the class of products known as tattoo inks and/or pigments, including all tattoo inks and/or pigments manufactured or distributed by or for the Companies and sold for use in California to create a tattoo on and/or under a human being’s skin regardless of the brand. Thus, all tattoo inks and/or pigments manufactured or distributed by or for the Companies and sold for use in California are addressed by this Notice. Each and every Listed Chemical is contained in the tattoo inks and/or pigments manufactured or distributed by or for the Companies and sold for use in California.
- ◆ There are numerous sources of the exposures addressed in this Notice. These exposures occur in homes, the workplace, retail establishments and everywhere else in California where these products are sold and/or used. These exposures occur principally off the property of the Noticed Company.
- ◆ In the course of doing business, the Companies knowingly and intentionally have exposed, and continues to expose, individuals to the Listed Chemicals in its class of products known as tattoo inks and/or pigments. Although the Companies are required to do so by the Safe Drinking Water and Toxic Enforcement Act of 1986, no clear and reasonable warning is or has been provided by the Companies to individuals regarding those individuals’ exposures to the Listed Chemicals and the fact that the Listed Chemicals are known to the State of California to be carcinogens, reproductive toxicants, or both carcinogens and reproductive toxicants.
- ◆ These exposures have gone on since February 27, 1988, and are ongoing and continuing as the Institute believes and so alleges that the Companies has tolled the statute of limitations by fraudulent concealment of the constituents of the ingredients in their products from those persons that required warning in the stores where the Companies products are sold for consumer use in California. The labels on these products are further absent any warning that would meet the definition delineated at

Title 22 CCR §12601(b)(1)(A), nor do they comply with section (b)(3) and (b)(4)(B) of that regulation.

- ◆ The chemicals contained in the class of products known as tattoo inks and/or pigments, and subject to the warning requirements of H&S Code §25249.6 and more specifically 22 CCR §12601(b) *et seq.*, for either carcinogens and/or reproductive toxins are listed below (see exhibit B for details):
 1. Antimony (carcinogen)
 2. Arsenic (carcinogen and reproductive toxin)
 3. Beryllium (carcinogen)
 4. Chromium (carcinogen)
 5. Cobalt (carcinogen)
 6. Lead (carcinogen and reproductive toxin)
 7. Nickel (carcinogen and reproductive toxin)
 8. Selenium (carcinogen)
- ◆ The aforementioned carcinogens are on the Governor's list (Prop 65 List) as expressed at 22 CCR §12000. These chemicals are known to the State of California to cause cancer in humans, thus requiring specific warnings and care in handling and use.
- ◆ The principal route of exposure is through a "consumer products exposure" via inhalation occurring during the application of this class of products known as tattoo inks and/or pigments to human skin in the creation of a tattoo. There is a further danger of contacting these carcinogens via a dermal exposure while using this class of products known as tattoo inks and/or pigments in the creation of a tattoo.
- ◆ This notice alleges the violation of Proposition 65 with respect to occupational exposures governed by the California State Plan for Occupational Safety and Health. The State Plan incorporates the provisions of Proposition 65, as approved by Federal OSHA on June 6, 1997. This approval specifically placed certain conditions with regard to occupational exposures on Proposition 65, including that it does not apply to the conduct of manufacturers occurring outside the State of California. The approval also provides that an employer may use the means of compliance in the general hazard communication requirements to comply with Proposition 65. It also requires that supplemental enforcement be subject to the supervision of the California Occupational Safety and Health Administration. Accordingly, any settlement, civil complaint, or substantive court orders in this matter must be submitted to the Attorney General.
- ◆ The location of these alleged exposures are many and varied while occurring within the 58 counties of the state of California as evidenced by the District Attorneys addressed in the enclosed distribution list. The Institute believes and so alleges that at least one of the jurisdictions identified had the Companies products sold within

that county by the Companies wholesale or retail distributor, and that sale caused the utilization of the consumer product and subsequent exposure. That usage caused exposures of both an occupational and consumer nature in that jurisdiction to the constituents of the consumer product as identified herein, and those exposures by the Companies were allowed to take place without the prerequisite warnings as delineated by the applicable statutes specified in this notice.
