

NOTICE OF VIOLATION

California Safe Drinking Water
and Toxic Enforcement Act

Re: Lead in Wheel Balancing Weights

August 23, 2007

This Notice of Violation is provided to you pursuant to and in compliance with California Health and Safety Code Section 25249.7(d).

- For general information regarding the California Safe Drinking Water and Toxic Enforcement Act, see the attached summary provided by the California EPA (copies not provided to public enforcement agencies).
- This Notice of Violation is provided by the Center for Environmental Health ("CEH"), 528 61st Street, Suite A, Oakland, CA 94609, (510) 594-9864. The Center for Environmental Health is a nonprofit corporation dedicated to protecting the environment, improving human health and supporting environmentally sound practices. Michael Green is the Executive Director of and a responsible individual within CEH.

Description of Violation:

- The names and addresses of the violators are attached hereto as Exhibit 1.
- The violations have been occurring since at least August 23, 2004 and are continuing to this day.
- This Notice of Violation covers the "discharge prohibition" of Proposition 65 which is found at California Health and Safety Code Section 25249.5.
- The names of the listed chemicals involved in these violations are lead and lead compounds ("Lead"). Discharges of lead occur from use of the products identified in this notice.
- The specific type of products causing these violations is wheel balancing weights (the "Products").
- Identification of Discharge and Sources of Drinking Water: Ordinary use of the Products results in discharges or releases of Lead into water or onto land where Lead passes or probably will pass into a source of drinking water. Specifically, the wheel balancing weights that are the subject of this Notice of Violation are made with and contain Lead. The Products are installed on automobiles and other vehicles to balance the wheels. The Products are ejected from the wheels during ordinary use into water or onto or into land where such Lead passes or probably will pass into sources of drinking water in California. The Lead is discharged or released into sources of drinking water adjacent to and downstream of roadways throughout California, including surrounding surface waters and underlying ground water.
- Resolution of Noticed Claims: Based on the allegations set forth in this Notice, CEH intends to file a citizen enforcement lawsuit unless the alleged violators agree in a binding written instrument to remedy the violations alleged herein by recalling Products already sold, reformulating the Products to eliminate future Lead discharges, eliminating ongoing and threatened discharges caused by the Products, and paying an appropriate civil penalty based on the factors

enumerated in California Health and Safety Code Section 25249.7(b). If any of the alleged violators is interested in resolving this dispute without resorting to expensive and time-consuming litigation, please contact CEH through its counsel identified below. It should be noted that CEH cannot: (1) finalize any settlement until after the 60-day notice period has expired; nor (2) speak for the Attorney General or any District or City Attorney who received CEH's 60-day Notice. Therefore, while reaching an agreement with CEH will resolve its claims, such agreement may not satisfy the public prosecutors.


