

SIXTY-DAY NOTICE OF INTENT TO SUE FOR VIOLATION OF THE SAFE DRINKING WATER
AND TOXIC ENFORCEMENT ACT OF 1986
(*Cal. Health & Safety Code* § 25249.5, *et seq.*) (“Proposition 65”)

Re: Violations of Proposition 65 concerning **(1) Regent Garden Tool Cultivator; (2) Power +Plus 16ft Measuring Tape (#MU-34345); (3) Power +Plus Screwdriver and Sockets Tools Set (#RGD-14); and (4) 24” Christmas Tree (#151090) with “Flame Resistance” and “Tarnish Proof”**

Dear Mr. Shiffer, and to whom else this may concern:

Consumer Advocacy Group, Inc. (“CAG”), the noticing entity, serves this Notice of Violation (“Notice”) 99 Cents Only Stores and Deluxe Imports (collectively “Violators”) pursuant to and in compliance with Proposition 65. Violators may contact CAG concerning this Notice through its designated person within the entity, its attorney, Reuben Yeroushalmi, Esq., 3700 Wilshire Boulevard, Suite 480, Los Angeles, CA 90010, telephone no. (213) 382-3183, facsimile no. (213) 382-3430. This Notice satisfies a prerequisite for CAG to commence an action against Violators in any Superior Court of California to enforce Proposition 65. The violations addressed by this Notice occurred at numerous locations in each county in California as reflected in the district attorney addresses listed in the attached distribution list. CAG is serving this Notice upon each person or entity responsible for the alleged violations, the California Attorney General, the district attorney for each county where alleged violations occurred, and the City Attorney for each city with a population (according to the most recent decennial census) of over 750,000 located within counties where the alleged violations occurred.

- CAG is a registered corporation based in California. CAG is a nonprofit entity dedicated to protecting the environment, improving human health, and supporting environmentally sound practices. By sending this Notice, CAG is acting “in the public interest” pursuant to Proposition 65.
- This Notice concerns violations of the warning prong of Proposition 65, which states that “[n]o person in the course of doing business shall knowingly and intentionally expose any individual to a chemical known to the state to cause cancer or reproductive toxicity without first giving clear and reasonable warning to such individual . . .” *Cal. Health & Safety Code* § 25249.6.
- **(1) Regent Garden Tool Cultivator; (2) Power +Plus 16ft Measuring Tape (#MU-34345); (3) Power +Plus Screwdriver and Sockets Tools Set (#RGD-14); and (4) 24” Christmas Tree (#151090) with “Flame Resistance” and “Tarnish Proof”** contain lead, which is known to the State of California to cause both cancer and reproductive toxicity, female, male. On February 27, 1987, the Governor of California added lead to the list of chemicals known to the State to cause reproductive toxicity.

developmental, female, male, and on October 1, 1992, the Governor added lead and lead components to the list of chemicals known to the State to cause cancer. Both additions took place more than twenty (20) months before CAG served this Notice.

- This Notice addresses consumer products exposures. A “[c]onsumer products exposure” is an exposure which results from a person’s acquisition, purchase, storage, consumption, or other reasonably foreseeable use of a consumer good, or any exposure that results from receiving a consumer service.” *Cal. Code Regs.* tit. 27, § 25602(b).

Violators caused consumer product exposures in violation of Proposition 65 by producing or making available for distribution or sale in California to consumers (1) **Regent Garden Tool Cultivator (“Cultivator”)**; (2) **Power +Plus 16ft Measuring Tape (#MU-34345) (“Measuring Tape”)**; (3) **Power +Plus Screwdriver and Sockets Tools Set (#RGD-14) (“Screwdriver and Sockets Set”)**; and (4) **24” Christmas Tree (#151090) with “Flame Resistance” and “Tarnish Proof” (“Christmas Tree”)**. The packaging for the Cultivator, Measuring Tape, Screwdriver and Sockets Set, and Christmas Tree (meaning any label or other written, printed or graphic matter affixed to or accompanying the product or its container or wrapper) contain no Proposition 65-complaint warning. Nor did Violators, with regard to the Cultivator, Measuring Tape, Screwdriver and Sockets Set, and Christmas Tree, provide a system of signs, public advertising identifying the system and toll-free information services, or any other system, which provided clear and reasonable warnings. Nor did Violators, with regard to the Cultivator, Measuring Tape, Screwdriver and Sockets Set, and Christmas Tree, provide identification of the product at retail outlets in a manner that provided a warning through shelf labeling, signs, menus, or a combination thereof. The Cultivator is designed for use in gardening, including within the home environment and the Measuring Tape and Screwdriver and Sockets Set are designed for home repair and handy work. The Christmas Tree is designed meant for in home and office decoration.

- This Notice also concerns occupational exposures. An “[o]ccupational exposure” means an exposure to any employee in his or her employer’s workplace.” *Cal. Code Regs.* tit. 27, § 25602(f).

Violators caused occupational exposures in violation of Proposition 65 by allowing employees to handle the Cultivator, Measuring Tape, Screwdriver and Sockets Set, and Christmas Tree without having first given clear and reasonable warnings to such employees that by handling the Cultivator, Measuring Tape, Screwdriver and Sockets Set, and Christmas Tree such employees would suffer exposures to lead and lead compounds. Violators’ employees were exposed to lead by touching Cultivator, Measuring Tape, Screwdriver and Sockets Set, and Christmas Tree with their bare skin at Violators’ premises located at 4000 Union Pacific Avenue, Commerce, California 90023 and 6121 Wilshire Boulevard, Los Angeles, California 90048, among other locations where these activities take place including but not limited to other retail outlets. Violators did not provide any Proposition 65-compliant warnings on either the products or any substance present or any sign or system of signs within the workplace.

This notice alleges the violation of Proposition 65 with respect to occupational exposures governed by the California State Plan for Occupational Safety and Health. The State Plan incorporates the provisions of Proposition 65, as approved by Federal OSHA on June 6, 1997.

This approval specifically placed certain conditions with regard to occupational exposures on Proposition 65, including that it does not apply to (a) the conduct of manufacturers occurring outside the State of California; and (b) employers with less than ten (10) employees. The approval also provides that an employer may use any means of compliance in the general hazard communication requirements to comply with Proposition 65. It also requires that supplemental enforcement be subject to the supervision of the

California Occupational Safety and Health Administration. Accordingly, any settlement, civil complaint, or substantive court orders in this matter must be submitted to the California Attorney General.

- This Notice also addresses environmental exposures. An “[e]nvironmental exposure” is an exposure which may foreseeably occur as the result of contact with an environmental medium, including, but not limited to, ambient air, indoor air, drinking water, standing water, running water, soil vegetation, or manmade or natural substances, either through inhalation, ingestion, skin contact or otherwise. Environmental exposures include all exposures which are not consumer products exposures, or occupational exposures.” *Cal. Code Regs. tit. 27, § 25602(c)*.

Violators caused environmental exposures by not providing any Proposition 65-compliant warnings at their facilities located at 4000 Union Pacific Avenue, Commerce, California 90023 and 6121 Wilshire Boulevard, Los Angeles, California 90048, among other locations where such exposures could foreseeably occur, to persons who could foreseeably come into contact with Cultivator, Measuring Tape, Screwdriver and Sockets Set, and Christmas Tree. Such exposures also occurred beyond the property owned or controlled by Violators.

These violations occurred each day between November 20, 2006, and November 20, 2009, and are ever continuing thereafter.

The principal routes of exposure were through dermal contact, ingestion, and inhalation. Persons sustain exposures by handling the Cultivator, Measuring Tape, Screwdriver and Sockets Set, and Christmas Tree without wearing gloves or by touching bare skin or mucous membranes with gloves after handling Cultivator, Measuring Tape, Screwdriver and Sockets Set, and Christmas Tree, as well as hand to mouth contact, hand to mucous membrane, or breathing in particulate matter emanating from Cultivator during application in gardening and landscaping activities, from the Measuring Tape and Screwdriver and Sockets Set during use in home repair, and from placing and manipulating the Christmas Tree.

Proposition 65 requires that notice of intent to sue be given to the violator(s) sixty (60) days before the suit is filed. *Cal. Health & Safety Code § 252549.7(d)(1)*. With this letter, CAG gives notice of the alleged violations to Violator and the appropriate governmental authorities. In absence of any action by the appropriate governmental authorities within sixty (60) calendar days of the sending of this notice (plus five (5) calendar days because the place of address is within the State of California), CAG may file suit. *See Cal. Code Civ. Proc. § 1013; Cal. Health & Safety Code § 25249.7(d)(1); and Cal. Code Regs. tit. 27, § 25903(d)(1)*. CAG remains open to discussing the possibility of resolving its grievances short of formal litigation.


CERTIFICATE OF MERIT

1. This Certificate of Merit accompanies the attached sixty-day notice(s) in which it is alleged the party(s) identified in the notice(s) has violated Health and Safety Code section 25249.6 by failing to provide clear and reasonable warnings.
2. I am the attorney for the noticing party.
3. I have consulted with at least one person with relevant and appropriate experience or expertise who has reviewed facts, studies, or other data regarding the exposure to the listed chemical that is the subject of the action.
4. Based on the information obtained through those consultations, and on all other information in my possession, I believe there is a reasonable and meritorious case for the private action. I understand that "reasonable and meritorious case for the private action" means that the information provides a credible basis that all elements of the plaintiffs' case can be established and the information did not prove that the alleged violator will be able to establish any of the affirmative defenses set forth in the statute.
5. The copy of this Certificate of Merit served on the Attorney General attaches to it factual information sufficient to establish the basis for this certificate, including the information identified in Health and Safety Code section 25249.7(h)(2), i.e., (1) the identity of the persons consulted with and relied on by the certifier, and (2) the facts, studies, or other data reviewed by those persons.
