Re: Violations of Proposition 65 concerning **Hand Tools Containing Lead**

Dear Messrs. O'Sullivan, Balmuth, and Berger, and to whom else this may concern:

**Consumer Advocacy Group, Inc. ("CAG")**, the noticing entity located at **9903 Santa Monica Boulevard #225, Beverly Hills, California 90212**, serves this Notice of Violation ("Notice") on Ross Dress For Less, Inc., Ross Stores, Inc., and Howard Berger Company, Inc. ("Violators") pursuant to and in compliance with Proposition 65. Violators may contact CAG concerning this Notice through its designated person within the entity, its attorney, Reuben Yeroushalmi, Esq., 9100 Wilshire Boulevard, Suite 610E, Beverly Hills, CA 90212, telephone no. (310) 623-1926, facsimile no. (310) 623-1930. This Notice satisfies a prerequisite for CAG to commence an action against Violators in any Superior Court of California to enforce Proposition 65. The violations addressed by this Notice occurred at numerous locations in each county in California as reflected in the district attorney addresses listed in the attached distribution list. CAG is serving this Notice upon each person or entity responsible for the alleged violations, the California Attorney General, the district attorney for each county where alleged violations occurred, and the City Attorney for each city with a population (according to the most recent decennial census) of over 750,000 located within counties where the alleged violations occurred.

- CAG is a registered corporation based in California. CAG is an entity dedicated to protecting the environment, improving human health, and supporting environmentally sound practices. By sending this Notice, CAG is acting "in the public interest" pursuant to Proposition 65.
- This Notice concerns violations of the warning prong of Proposition 65, which states that "[n]o person in the course of doing business shall knowingly and intentionally expose any individual to a chemical

known to the state to cause cancer or reproductive toxicity without first giving clear and reasonable warning to such individual . . ." *Cal. Health & Safety Code* § 25249.6.

- **Hand Tools** ("Hand Tools") contains **lead**, which is known to the State of California to cause both cancer and reproductive toxicity, female, male. On February 27, 1987, the Governor of California added **lead** to the list of chemicals known to the State to cause reproductive toxicity, developmental, female, male, and on October 1, 1992, the Governor added **lead and lead compounds** to the list of chemicals known to the State to cause cancer. Both additions took place more than twenty (20) months before CAG served this Notice.
  - An exemplar of the violations caused by **Hand Tools** include but is not limited to:
    1. **H.B. Smith® Tools, 57PC. Bit Driver Set, Item No. 79957**
- This Notice addresses consumer products exposures. A "[c]onsumer products exposure" is an exposure which results from a person's acquisition, purchase, storage, consumption, or other reasonably foreseeable use of a consumer good, or any exposure that results from receiving a consumer service." *Cal. Code Regs.* tit. 27, § 25602(b).

Violators caused consumer product exposures in violation of Proposition 65 by producing or making available for distribution or sale in California to consumers **Hand Tools**. The packaging for the **Hand Tools** (meaning any label or other written, printed or graphic matter affixed to or accompanying the product or its container or wrapper) contains no Proposition 65-compliant warning. Nor did Violators, with regard to the **Hand Tools**, provide a system of signs, public advertising identifying the system and toll-free information services, or any other system, which provided clear and reasonable warnings. Nor did Violators, with regard to the **Hand Tools**, provide identification of the product at retail outlets in a manner that provided a warning through shelf labeling, signs, menus, or a combination thereof. The **Hand Tools** are designed for use for various automotive, home, business or industrial applications.

- This Notice also concerns occupational exposures. An "[o]ccupational exposure" means an exposure to any employee in his or her employer's workplace." *Cal. Code Regs.* tit. 27, § 25602(f).

Violators, Ross Dress For Less, Inc. and Ross Stores, Inc., caused occupational exposures in violation of Proposition 65 by allowing employees to handle the **Hand Tools**, within the course of packaging, distributing, promoting, and selling the **Hand Tools**, without having first given clear and reasonable warnings to such employees that by handling the **Hand Tools** such employees would suffer exposures to **lead and lead compounds**. Violators' employees were exposed to **lead** by touching the **Hand Tools** with their bare skin at Violators' premises located at 144 E. Compton Blvd., Compton, CA 90220, among other locations where these activities take place including but not limited to Violators' other retail outlets and distribution locations in California. Violators did not provide any Proposition 65-compliant warnings on either the product or any substance present or any sign or system of signs within the workplace.

*This notice alleges the violation of Proposition 65* with respect to occupational exposures governed by the California State Plan for Occupational Safety and Health. The State Plan incorporates the provisions of Proposition 65, as approved by Federal OSHA on June 6, 1997.

This approval specifically placed certain conditions with regard to occupational exposures on Proposition 65, including that it does not apply to (a) the conduct of manufacturers occurring outside the State of California; and (b) employers with less than ten (10) employees. The approval also provides that an employer may use any means of compliance in the general hazard communication requirements to comply with Proposition 65. It also requires that supplemental enforcement be subject to the supervision of the

California Occupational Safety and Health Administration. Accordingly, any settlement, civil complaint, or substantive court orders in this matter must be submitted to the California Attorney General.

- This Notice also addresses environmental exposures. An "[e]nvironmental exposure" is an exposure which may foreseeably occur as the result of contact with an environmental medium, including, but not limited to, ambient air, indoor air, drinking water, standing water, running water, soil vegetation, or manmade or natural substances, either through inhalation, ingestion, skin contact or otherwise. Environmental exposures include all exposures which are not consumer products exposures, or occupational exposures." *Cal. Code Regs. tit. 27, § 25602(c)*.


Violators, Ross Dress For Less, Inc. and Ross Stores, Inc., caused environmental exposures by not providing any Proposition 65-compliant warnings at their distributing, shipping, warehousing, and retail facilities located at 144 E. Compton Blvd., Compton, CA 90220, among other locations where such exposures could foreseeably occur, to persons who could foreseeably come into contact with **Hand Tools**. Such exposures also occurred beyond the property owned or controlled by Violators.

These violations occurred each day between May 24, 2008, and May 24, 2011, and are ever continuing thereafter.

The principal routes of exposure were through dermal contact, ingestion, and inhalation. Persons sustain exposures by handling the **Hand Tools** without wearing gloves or by touching bare skin or mucous membranes with gloves after handling **Hand Tools**, as well as hand to mouth contact, hand to mucous membrane, or breathing in particulate matter emanating from the **Hand Tools** during installation and use, as well as through environmental mediums that carry the **lead and lead compounds** once contained within the **Hand Tools**.

Proposition 65 requires that notice of intent to sue be given to the violator(s) sixty (60) days before the suit is filed. *Cal. Health & Safety Code § 252549.7(d)(1)*. With this letter, CAG gives notice of the alleged violations to Violators and the appropriate governmental authorities. In absence of any action by the appropriate governmental authorities within sixty (60) calendar days of the sending of this notice (plus ten (10) calendar days because the place of address is within the United States but beyond the State of California), CAG may file suit. *See Cal. Code Civ. Proc. § 1013; Cal. Health & Safety Code § 25249.7(d)(1); and Cal. Code Regs. tit. 27, § 25903(d)(1)*. CAG is ready and willing to discuss the possibility of resolving its grievances in the public interest short of formal litigation.


### CERTIFICATE OF MERIT

Health and Safety Code Section 25249.7(d)

I, Reuben Yeroushalmi, hereby declare:

1. This Certificate of Merit accompanies the attached sixty-day notice(s) in which it is alleged the party(s) identified in the notice(s) has violated Health and Safety Code section 25249.6 by failing to provide clear and reasonable warnings.
2. I am the attorney for the noticing party.
3. I have consulted with at least one person with relevant and appropriate experience or expertise who has reviewed facts, studies, or other data regarding the exposure to the listed chemical that is the subject of the action.
4. Based on the information obtained through those consultations, and on all other information in my possession, I believe there is a reasonable and meritorious case for the private action. I understand that "reasonable and meritorious case for the private action" means that the information provides a credible basis that all elements of the plaintiffs' case can be established and the information did not prove that the alleged violator will be able to establish any of the affirmative defenses set forth in the statute.
5. The copy of this Certificate of Merit served on the Attorney General attaches to it factual information sufficient to establish the basis for this certificate, including the information identified in Health and Safety Code section 25249.7(h)(2), i.e., (1) the identity of the persons consulted with and relied on by the certifier, and (2) the facts, studies, or other data reviewed by those persons.
