Re: Violations of Proposition 65 concerning **Children’s Flip Flops and Children’s Belts**

Dear Mr. Harary, Mr. Duke, and to whom else this may concern:

Consumer Advocacy Group, Inc. (“CAG”), the noticing entity, located at **9903 Santa Monica Boulevard #225, Beverly Hills, California 90212**, serves this Notice of Violation (“Notice”) on Gina Hosiery LTD, Gina Group LLC, Kids Club, W&W Wholesale, Incorporated, and Wal-Mart Stores, Inc. (collectively “Violators”) pursuant to and in compliance with Proposition 65. Violators may contact CAG concerning this Notice through its designated person within the entity, its attorney, Reuben Yeroushalmi 9100 Wilshire Boulevard, Suite 610E, Beverly Hills, CA 90212, telephone no. (310) 623-1926, facsimile no. (310) 623-1930. This Notice satisfies a prerequisite for CAG to commence an action against Violators in any Superior Court of California to enforce Proposition 65. The violations addressed by this Notice occurred at numerous locations in each county in California as reflected in the district attorney addresses listed in the attached distribution list. CAG is serving this Notice upon each person or entity responsible for the alleged violations, the California Attorney General, the district attorney for each county where alleged violations

occurred, and the City Attorney for each city with a population (according to the most recent decennial census) of over 750,000 located within counties where the alleged violations occurred.

- CAG is a registered corporation based in California. CAG is a nonprofit entity dedicated to protecting the environment, improving human health, and supporting environmentally sound practices. By sending this Notice, CAG is acting “in the public interest” pursuant to Proposition 65.
- This Notice concerns violations of the warning prong of Proposition 65, which states that “[n]o person in the course of doing business shall knowingly and intentionally expose any individual to a chemical known to the state to cause cancer or reproductive toxicity without first giving clear and reasonable warning to such individual . . .” *Cal. Health & Safety Code* § 25249.6.
- As to Gina Hosiery LTD, Gina Group LLC, Kids Club, and W&W Wholesale, Incorporated: **Children’s Flip Flops (“Flip Flops”)** contain **Di (2-ethylhexyl) phthalate (DEHP)**, also known as Diethyl Hexyl Phthalate and Bis (2-ethylhexyl) phthalate, which is known to the State of California to cause both cancer and reproductive toxicity, developmental, male. On January 1, 1988, the Governor of California added DEHP to the list of chemicals known to the State to cause cancer, and on October 24, 2003, the Governor added DEHP to the list of chemicals known to the State to cause developmental male reproductive toxicity. Both additions took place more than twenty (20) months before CAG served this Notice. **Flip Flops** also contain **Di-n-butyl Phthalate (DBP)**, also known as Dibutyl Phthalate, which is known to the State of California to cause reproductive toxicity, developmental, male, female. On December 2, 2005, the Governor of California added DBP to the list of chemicals known to the State to cause developmental, female, and male reproductive toxicity. The addition took place more than twenty (20) months before CAG served this Notice.
 - Exemplars of the violations caused by **Flip Flops** include but are not limited to:
 1. **Pink Girls Jelly Flip Flops, Style # ZTG-4501/A**
 2. **Yellow Girls Jelly Flip Flops, Style # ZTG-4501/A**
 3. **Blue Chatties® Sole Searching™ Flip Flops, Style # ZTG-4702/A**
- As to Kids Club, W&W Wholesale, Incorporated, and Wal-Mart Stores, Inc.: **Children’s Belts (“Belts”)** contains **lead**, which is known to the State of California to cause both cancer and reproductive toxicity, developmental, female, male. On February 27, 1987, the Governor of California added **lead** to the list of chemicals known to the State to cause reproductive toxicity, developmental, female, male, and on October 1, 1992, the Governor added **lead and lead compounds** to the list of chemicals known to the State to cause cancer. Both additions took place more than twenty (20) months before CAG served this Notice.
 - An exemplar of the violations caused by **Belts** as to Kids Club and W&W Wholesale, Incorporated includes but is not limited to:
 1. **Brown belt with yellow buckle**
 - An exemplar of the violations caused by **Belts** as to Kids Club, W&W Wholesale, Incorporated, and Wal-Mart Stores, Inc. includes but is not limited to:
 1. **Faded Glory®, Black and Brown belt, 15-81630**
- This Notice addresses consumer products exposures. A “[c]onsumer products exposure’ is an exposure which results from a person’s acquisition, purchase, storage, consumption, or other reasonably foreseeable use of a consumer good, or any exposure that results from receiving a consumer service.” *Cal. Code Regs.* 27 tit. § 25602(b).

Violators caused consumer product exposures in violation of Proposition 65 by producing or making available for distribution or sale in California to consumers **Flip Flops and Belts**. The packaging for **Flip Flops and Belts** (meaning any label or other written, printed or graphic matter affixed to or accompanying the product or its container or wrapper) contains no Proposition 65-compliant warning. Nor did Violators, with regard to **Flip Flops and Belts**, provide a system of signs, public advertising identifying the system and toll-free information services, or any other system, which provided clear and reasonable warnings. Nor did Violators, with regard to **Flip Flops and Belts**, provide identification of the product at retail outlets in a manner that provided a warning through shelf labeling, signs, menus, or a combination thereof. **Flip Flops** are designed as children's footwear. **Belts** are designed as clothing accessories.

- This Notice also concerns occupational exposures. An "[o]ccupational exposure' means an exposure to any employee in his or her employer's workplace." *Cal. Code Regs. tit. 27, § 25602(f)*.

Violators, Kids Club and W&W Wholesale, Incorporated, caused occupational exposures in violation of Proposition 65 by allowing employees to handle the **Flip Flops and Belts** in the course of packaging, shipping, distributing, promoting, and selling **Flip Flops and Belts** without having first given clear and reasonable warnings to such employees that by handling the **Flip Flops** such employees would suffer exposures to **DEHP and DBP**, and by handling **Belts** such employees would suffer exposures to **lead**. Violators' employees were exposed to **DEHP and DBP** by touching **Flip Flops** and exposed to **lead** by touching **Belts** with their bare skin at Violators' premises located at 5522 E. Whittier Blvd., Commerce, CA 90022, among other locations where these activities take place including but not limited to other distributing, shipping, warehousing, packaging and retail centers. Violators did not provide any Proposition 65-compliant warnings on either the products or any substance present or any sign or system of signs within the workplace.

This notice alleges the violation of Proposition 65 with respect to occupational exposures governed by the California State Plan for Occupational Safety and Health. The State Plan incorporates the provisions of Proposition 65, as approved by Federal OSHA on June 6, 1997.

This approval specifically placed certain conditions with regard to occupational exposures on Proposition 65, including that it does not apply to (a) the conduct of manufacturers occurring outside the State of California; and (b) employers with less than ten (10) employees. The approval also provides that an employer may use any means of compliance in the general hazard communication requirements to comply with Proposition 65. It also requires that supplemental enforcement be subject to the supervision of the California Occupational Safety and Health Administration. Accordingly, any settlement, civil complaint, or substantive court orders in this matter must be submitted to the California Attorney General.

- This Notice also addresses environmental exposures. An "[e]nvironmental exposure' is an exposure which may foreseeably occur as the result of contact with an environmental medium, including, but not limited to, ambient air, indoor air, drinking water, standing water, running water, soil vegetation, or manmade or natural substances, either through inhalation, ingestion, skin contact or otherwise. Environmental exposures include all exposures which are not consumer products exposures, or occupational exposures." *Cal. Code Regs. tit. 27, § 25602(c)*.

Violators, Kids Club and W&W Wholesale, Incorporated, caused environmental exposures by not providing any Proposition 65-compliant warnings at their distributing, shipping, warehousing, and retail facilities located at 5522 E. Whittier Blvd., Commerce, CA 90022, among other locations where such exposures could foreseeably occur, to persons who could foreseeably come into contact with **Flip Flops and Belts**. Such exposures also occurred beyond the property owned or controlled by Violators.


These violations occurred each day between May 25, 2008, and May 25, 2011, and are ever continuing thereafter.

The principal routes of exposure with regard to **Flip Flops and Belts** are and were through dermal contact, ingestion, and inhalation. Persons sustain exposures by handling **Flip Flops and Belts** without wearing gloves or any other personal protective equipment, or by touching bare skin or mucous membranes with gloves after handling **Flip Flops and Belts**, as well as through hand to mouth contact, hand to mucous membrane, or breathing in particulate matter dispersed from **Flip Flops and Belts**.

Proposition 65 requires that notice of intent to sue be given to the violator(s) sixty (60) days before the suit is filed. *Cal. Health & Safety Code* § 252549.7(d)(1). With this letter, CAG gives notice of the alleged violations to Violator and the appropriate governmental authorities. In absence of any action by the appropriate governmental authorities within sixty (60) calendar days of the sending of this notice (plus ten (10) calendar days because the place of address is beyond the State of California but within the United States), CAG may file suit. *See Cal. Code Civ. Proc.* § 1013; *Cal. Health & Safety Code* § 25249.7(d)(1); and *Cal. Code Regs.* tit. 27 § 25903(d)(1). CAG remains open to discussing the possibility of resolving its grievances short of formal litigation.


I, Reuben Yeroushalmi, hereby declare:

I understand that "reasonable and meritorious case for the private action" means that the information provides a credible basis that all elements of the plaintiffs' case can be established and the information did not prove that the alleged violator will be able to establish any of the affirmative defenses set forth in the statute.

The copy of this Certificate of Merit served on the Attorney General attaches to it factual information sufficient to establish the basis for this certificate, including the information identified in Health and Safety Code section 25249.7(h)(2), i.e., (1) the identity of the persons consulted with and relied on by the certifier, and (2) the facts, studies, or other data reviewed by those persons.
