Re: Violations of Proposition 65 concerning **Electrical Tape and Booster Cable**

Dear Mr. Fishman and Mr. Haubiel, and to whom else this may concern:

**Consumer Advocacy Group, Inc.** (“CAG”), the noticing entity, serves this Notice of Violation (“Notice”) on Big Lots Stores, Inc., Big Lots, Inc., and Consolidated Property Holdings, Inc. (“Violators”) pursuant to and in compliance with Proposition 65. Violators may contact CAG concerning this Notice through its designated person within the entity, its attorney, Reuben Yeroushalmi, Esq., 9100 Wilshire Boulevard, Suite 610E, Beverly Hills, CA 90212, telephone no. (310) 623-1926, facsimile no. (310) 623-1930. This Notice satisfies a prerequisite for CAG to commence an action against Violators in any Superior Court of California to enforce Proposition 65. The violations addressed by this Notice occurred at numerous locations in each county in California as reflected in the district attorney addresses listed in the attached distribution list. CAG is serving this Notice upon each person or entity responsible for the alleged violations, the California Attorney General, the district attorney for each county where alleged violations occurred, and the City Attorney for each city with a population (according to the most recent decennial census) of over 750,000 located within counties where the alleged violations occurred.

- CAG is a registered corporation based in California. CAG is a nonprofit entity dedicated to protecting the environment, improving human health, and supporting environmentally sound practices. By sending this Notice, CAG is acting “in the public interest” pursuant to Proposition 65.
- This Notice concerns violations of the warning prong of Proposition 65, which states that “[n]o person in the course of doing business shall knowingly and intentionally expose any individual to a chemical known to the state to cause cancer or reproductive toxicity without first giving clear and reasonable warning to such individual . . .” *Cal. Health & Safety Code § 25249.6.*

- **Electrical Tape (“Electrical Tape”) and Booster Cable (“Booster Cable”)** contain lead, which is known to the State of California to cause both cancer and reproductive toxicity, female, male. On February 27, 1987, the Governor of California added lead to the list of chemicals known to the State to cause reproductive toxicity, developmental, female, male, and on October 1, 1992, the Governor added **lead and lead compounds** to the list of chemicals known to the State to cause cancer. Both additions took place more than twenty (20) months before CAG served this Notice.
  - An exemplar of the violations caused by **Electrical Tape and Booster Cable** include but is not limited to:
    - **AUTOMATICS™ emergency repair kit 31 pc (Item #79283)**


Violators caused consumer product exposures in violation of Proposition 65 by producing or making available for distribution or sale in California to consumers **Electrical Tape and Booster Cable**. The packaging for the **Electrical Tape and Booster Cable** (meaning any label or other written, printed or graphic matter affixed to or accompanying the product or its container or wrapper) contain no Proposition 65-compliant warning. Nor did Violators, with regard to the **Electrical Tape and Booster Cable**, provide a system of signs, public advertising identifying the system and toll-free information services, or any other system, which provided clear and reasonable warnings. Nor did Violators, with regard to the **Electrical Tape and Booster Cable**, provide identification of the product at retail outlets in a manner that provided a warning through shelf labeling, signs, menus, or a combination thereof. The **Electrical Tape and Booster Cable** are designed for automobile repair, as well as household repairs.

These violations occurred each day between May 24, 2008, and May 24, 2011, and are ever continuing thereafter.

The principal routes of exposure were through dermal contact, ingestion, and inhalation. Persons sustain exposures by handling the **Electrical Tape and Booster Cable** without wearing gloves or by touching bare skin or mucous membranes with gloves after handling **Electrical Tape and Booster Cable**, as well as hand to mouth contact, hand to mucous membrane, or breathing in particulate matter emanating from the **Electrical Tape and Booster Cable** during application and installation, as well as through environmental mediums that carry **Lead** once contained within the **Electrical Tape and Booster Cable**.

Proposition 65 requires that notice of intent to sue be given to the Violators(s) sixty (60) days before the suit is filed. *Cal. Health & Safety Code* § 252549.7(d)(1). With this letter, CAG gives notice of the alleged violations to Violators and the appropriate governmental authorities. In absence of any action by the appropriate governmental authorities within sixty (60) calendar days of the sending of this notice (plus ten (10) calendar days because the place of address is within the United States but beyond the State of California), CAG may file suit. *See Cal. Code Civ. Proc.* § 1013; *Cal. Health & Safety Code* § 25249.7(d)(1); and *Cal. Code Regs.* tit. 27, § 25903(d)(1). CAG is ready and willing to discuss the possibility of resolving its grievances in the public interest short of formal litigation.


Health and Safety Code Section 25249.7(d)

I understand that "reasonable and meritorious case for the private action" means that the information provides a credible basis that all elements of the plaintiffs' case can be established and the information did not prove that the alleged Violatorss will be able to establish any of the affirmative defenses set forth in the statute.
5. The copy of this Certificate of Merit served on the Attorney General attaches to it factual information sufficient to establish the basis for this certificate, including the information identified in Health and Safety Code section 25249.7(h)(2), i.e., (1) the identity of the persons consulted with and relied on by the certifier, and (2) the facts, studies, or other data reviewed by those persons.
