Re: Violations of Proposition 65 concerning **Gloves containing DEHP and Bath Mats
containing DEHP and DIDP**

Dear Ms. Meyrowitz, Ms. Clancy, Mr. Guindi, and Ms. Josephs, or to whom else this may concern:

Consumer Advocacy Group, Inc. (“CAG”), the noticing entity located at **9903 Santa Monica Boulevard #225, Beverly Hills, California 902**, serves this Notice of Violation (“Notice”) on T.J. Maxx, TJX Companies, Inc., Concord Buying Group, Inc., A.J. Wright, Kennedy International, Inc., and The Macbeth Collection (collectively “Violators”) pursuant to and in compliance with Proposition 65. Violators may contact CAG concerning this Notice through its designated person within the entity, its attorney, Reuben Yeroushalmi 9100 Wilshire Boulevard, Suite 610E, Beverly Hills, CA 90212, telephone no. (310) 623-1926, facsimile no. (310) 623-1930. This Notice satisfies a prerequisite for CAG to commence an action against Violators in any Superior Court of California to enforce Proposition 65. The violations addressed by this Notice occurred at numerous locations in each county in California as reflected in the district attorney addresses listed in the attached distribution list. CAG is serving this Notice upon each person or entity responsible for the alleged violations, the California Attorney General, the district attorney for each county where alleged violations occurred, and the City Attorney for each city with a population (according to the most recent decennial census) of over 750,000 located within counties where the alleged violations occurred.

- CAG is a registered corporation based in California. CAG is an entity dedicated to protecting the environment, improving human health, and supporting environmentally sound practices. By sending this Notice, CAG is acting “in the public interest” pursuant to Proposition 65.
- This Notice concerns violations of the warning prong of Proposition 65, which states that “[n]o person in the course of doing business shall knowingly and intentionally expose any individual to a chemical known to the state to cause cancer or reproductive toxicity without first giving clear and reasonable warning to such individual . . .” *Cal. Health & Safety Code* § 25249.6.
- As to Violators, T.J. Maxx, TJX Companies, Inc., Kennedy International, Inc., and The Macbeth Collection: **Gloves (“Gloves”)** contain **Di (2-ethylhexyl) phthalate (DEHP)**, also known as Diethyl Hexyl Phthalate and Bis (2-ethylhexyl) phthalate, which is known to the State of California to cause both cancer and reproductive toxicity, developmental, male. On January 1, 1988, the Governor of California added **DEHP** to the list of chemicals known to the State to cause cancer, and on October 24, 2003, the Governor added **DEHP** to the list of chemicals known to the State to cause developmental male reproductive toxicity. Both additions took place more than twenty (20) months before CAG served this Notice.
 - An exemplar of the violations caused by **Gloves** include but is not limited to:
 - **The Macbeth Collection Multi-Purpose Glamour Gloves, Style # M-72660**
- As to Violators, Concord Buying Group, Inc., A.J. Wright, and Kennedy International, Inc.: **Bath Mats (“Bath Mats”)** contain **Di (2-ethylhexyl) phthalate (DEHP)**, also known as Diethyl Hexyl Phthalate and Bis (2-ethylhexyl) phthalate, which is known to the State of California to cause both cancer and reproductive toxicity, developmental, male. On January 1, 1988, the Governor of California added **DEHP** to the list of chemicals known to the State to cause cancer, and on October 24, 2003, the Governor added **DEHP** to the list of chemicals known to the State to cause developmental male reproductive toxicity. Both additions took place more than twenty (20) months before CAG served this Notice. **Bath Mats** also contain **Di-Isodecyl Phthalate (DIDP)**, which is known to the State of California to cause reproductive toxicity, developmental, male. On April 20, 2007, the Governor of California added **DIDP** to the list of chemicals known to the State to cause developmental reproductive toxicity. The addition took place more than twenty (20) months before CAG served this Notice.
 - An exemplar of the violations caused by **Bath Mats** include but is not limited to:
 - **Aqua Gel Comfort Pebble Bath Mat**
- This Notice addresses consumer products exposures. A “[c]onsumer products exposure’ is an exposure which results from a person’s acquisition, purchase, storage, consumption, or other reasonably foreseeable use of a consumer good, or any exposure that results from receiving a consumer service.” *Cal. Code Regs. 27 tit. § 25602(b)*.

Violators caused consumer product exposures in violation of Proposition 65 by producing or making available for distribution or sale in California to consumers **Gloves and Bath Mats**. The packaging for **Gloves and Bath Mats** (meaning any label or other written, printed or graphic matter affixed to or accompanying the product or its container or wrapper) contains no Proposition 65-compliant warning. Nor did Violators, with regard to **Gloves and Bath Mats**, provide a system of signs, public advertising identifying the system and toll-free information services, or any other system, which provided clear and reasonable warnings. Nor did Violators, with regard to **Gloves and Bath Mats**, provide identification of the product at retail outlets in a manner that provided a warning through shelf labeling, signs, menus, or a combination thereof. **Gloves** are designed to be worn on a person’s hands for use in homes, offices,

medical or industrial environments. **Bath Mats** are consumer products designed to be placed at the bottom of bath tubs.

- This Notice also concerns occupational exposures. An “[o]ccupational exposure’ means an exposure to any employee in his or her employer’s workplace.” *Cal. Code Regs. tit. 27, § 25602(f)*.

Violators, T.J. Maxx and TJX Companies, Inc., caused occupational exposures in violation of Proposition 65 by allowing employees to handle the **Gloves** in the course of packaging, shipping, distributing, promoting, and selling **Gloves** without having first given clear and reasonable warnings to such employees that by handling the **Gloves** such employees would suffer exposures to **Di (2-ethylhexyl) phthalate (DEHP)**. Violators’ employees were exposed to **Di (2-ethylhexyl) phthalate (DEHP)** by touching **Gloves** with their bare skin at Violators’ premises located at 271 W. Esplanade Drive Oxnard, CA 93030, among other locations in California where these activities take place including but not limited to other distributing, shipping, warehousing, packaging and retail centers. Violators did not provide any Proposition 65-compliant warnings on either the products or any substance present or any sign or system of signs within the workplace.

Violators, Concord Buying Group, Inc. and A.J. Wright, caused occupational exposures in violation of Proposition 65 by allowing employees to handle the **Bath Mats** in the course of packaging, shipping, distributing, promoting, and selling **Bath Mats** without having first given clear and reasonable warnings to such employees that by handling the **Bath Mats** such employees would suffer exposures to **Di (2-ethylhexyl) phthalate (DEHP)** and **Di-Isodecyl Phthalate (DIDP)**. Violators’ employees were exposed to **Di (2-ethylhexyl) phthalate (DEHP)** and **Di-Isodecyl Phthalate (DIDP)** by touching **Bath Mats** with their bare skin at Violators’ premises located at 1807 N. Hacienda Boulevard, La Puente, California 91744, among other locations where these activities take place including but not limited to other distributing, shipping, warehousing, packaging and retail centers. Violators did not provide any Proposition 65-compliant warnings on either the products or any substance present or any sign or system of signs within the workplace.

This notice alleges the violation of Proposition 65 with respect to occupational exposures governed by the California State Plan for Occupational Safety and Health. The State Plan incorporates the provisions of Proposition 65, as approved by Federal OSHA on June 6, 1997.

This approval specifically placed certain conditions with regard to occupational exposures on Proposition 65, including that it does not apply to (a) the conduct of manufacturers occurring outside the State of California; and (b) employers with less than ten (10) employees. The approval also provides that an employer may use any means of compliance in the general hazard communication requirements to comply with Proposition 65. It also requires that supplemental enforcement be subject to the supervision of the California Occupational Safety and Health Administration. Accordingly, any settlement, civil complaint, or substantive court orders in this matter must be submitted to the California Attorney General.

- This Notice also addresses environmental exposures. An “[e]nvironmental exposure’ is an exposure which may foreseeably occur as the result of contact with an environmental medium, including, but not limited to, ambient air, indoor air, drinking water, standing water, running water, soil vegetation, or manmade or natural substances, either through inhalation, ingestion, skin contact or otherwise. Environmental exposures include all exposures which are not consumer products exposures, or occupational exposures.” *Cal. Code Regs. tit. 27, § 25602(c)*.

Violators T.J. Maxx and TJX Companies, Inc. caused environmental exposures by not providing any Proposition 65-compliant warnings at their distributing, shipping, warehousing, and retail facilities located at 271 W. Esplanade Drive Oxnard, CA 93030, among other locations in California where such exposures could foreseeably occur, to persons who could foreseeably come into contact with **Gloves**. Such exposures also occurred beyond the property owned or controlled by Violators.

Violators Concord Buying Group, Inc. and A.J. Wright, caused environmental exposures by not providing any Proposition 65-compliant warnings at their distributing, shipping, warehousing, and retail facilities located at 1807 N. Hacienda Boulevard, La Puente, California 91744, among other locations where such exposures could foreseeably occur, to persons who could foreseeably come into contact with **Bath Mats**. Such exposures also occurred beyond the property owned or controlled by Violators.


These violations occurred each day between June 10, 2008 and June 10, 2011, and are ever continuing thereafter.

The principal routes of exposure with regard to **Gloves and Bath Mats** are and were through dermal contact, ingestion, and inhalation. Persons sustain exposures by handling **Gloves and Bath Mats** without wearing gloves or any other personal protective equipment, or by touching bare skin or mucous membranes with gloves after handling **Gloves and Bath Mats**, as well as through hand to mouth contact, hand to mucous membrane, or breathing in particulate matter dispersed from **Gloves and Bath Mats**.

Proposition 65 requires that notice of intent to sue be given to the violator(s) sixty (60) days before the suit is filed. *Cal. Health & Safety Code* § 252549.7(d)(1). With this letter, CAG gives notice of the alleged violations to Violator and the appropriate governmental authorities. In absence of any action by the appropriate governmental authorities within sixty (60) calendar days of the sending of this notice (plus ten (10) calendar days because the place of address is beyond the State of California but within the United States), CAG may file suit. *See Cal. Code Civ. Proc.* § 1013; *Cal. Health & Safety Code* § 25249.7(d)(1); and *Cal. Code Regs.* tit. 27 § 25903(d)(1). CAG remains open to discussing the possibility of resolving its grievances short of formal litigation.

I, Reuben Yeroushalmi, hereby declare:

1. This Certificate of Merit accompanies the attached sixty-day notice(s) in which it is alleged the party(s) identified in the notice(s) has violated Health and Safety Code section 25249.6 by failing to provide clear and reasonable warnings.
2. I am the attorney for the noticing party.
3. I have consulted with at least one person with relevant and appropriate experience or expertise who has reviewed facts, studies, or other data regarding the exposure to the listed chemical that is the subject of the action.
4. Based on the information obtained through those consultations, and on all other information in my possession, I believe there is a reasonable and meritorious case for the private action. I understand that "reasonable and meritorious case for the private action" means that the information provides a credible basis that all elements of the plaintiffs' case can be established and the information did not prove that the alleged violator will be able to establish any of the affirmative defenses set forth in the statute.
5. The copy of this Certificate of Merit served on the Attorney General attaches to it factual information sufficient to establish the basis for this certificate, including the information identified in Health and Safety Code section 25249.7(h)(2), i.e., (1) the identity of the persons consulted with and relied on by the certifier, and (2) the facts, studies, or other data reviewed by those persons.
