Re: Violations of Proposition 65 concerning **Hair Color** containing **Diaminotoluene**

To Whom It May Concern:

**Consumer Advocacy Group, Inc.** ("CAG"), the noticing entity, located at 9903 Santa Monica Boulevard #225, Beverly Hills, California 90212, serves this Notice of Violation ("Notice") on **Henkel Corporation, Schwarzkopf, Inc., and La Peer Beauty** ("Violators") pursuant to and in compliance with Proposition 65. Violators may contact CAG concerning this Notice through its attorney, Reuben Yeroushalmi, Esq., 9100 Wilshire Blvd., Ste. 610 E, telephone no. (310) 623-1926, facsimile no. (310) 623-1930. This Notice satisfies a prerequisite for CAG to commence an action against Violators in any Superior Court of California to enforce Proposition 65. The violations addressed by this Notice occurred at numerous locations in each county in California as reflected in the district attorney addresses listed in the attached distribution list. CAG is serving this Notice upon each person or entity responsible for the alleged violations, the California Attorney General, the district attorney for each county where alleged violations occurred, and the City Attorney for each city with a population (according to the most recent decennial census) of over 750,000 located within counties where the alleged violations occurred.

- CAG is an organization based in California. CAG is an entity dedicated to protecting the environment, improving human health, and supporting environmentally sound practices. By sending this Notice, CAG is acting "in the public interest" pursuant to Proposition 65.
- This Notice concerns violations of the warning prong of Proposition 65, which states that "[n]o person in the course of doing business shall knowingly and intentionally expose any individual to a chemical known to the state to cause cancer or reproductive toxicity without first giving clear and reasonable warning to such individual . . ." *Cal. Health & Safety Code § 25249.6*.
- **Hair Color** contains Diaminotoluene (mixed), which is known to the State of California to cause cancer. On January 1, 1990, the Governor of California added Diaminotoluene (mixed) to the list of chemicals known to the State to cause cancer, which took place more than twenty (20) months before CAG served this Notice.
  - An exemplar of the violations caused by **Hair Color** includes but is not limited to:
    - **Igora Color 10, 10 Minute Coloration, Speedlift +, 60 ml, 11-16 Super Blonde Cendre Auburn, #0903806483**
    - **Essensity Superb Colour Performance, 1-0 Black, 60 ml, #0914511271**

- This Notice addresses **consumer products exposures**. A “[c]onsumer products exposure’ is an exposure which results from a person’s acquisition, purchase, storage, consumption, or other reasonably foreseeable use of a consumer good, or any exposure that results from receiving a consumer service.” *Cal. Code Regs. 27 § 25602(b)*.

Violators caused consumer product exposures in violation of Proposition 65 by producing or making available its California consumers **Hair Color**. The surface of the **Hair Color** contains no Proposition 65-complaint warning; neither did Violators provide a Proposition 65 compliant warning with any packaging that accompanied the **Hair Color** (meaning any label or other written, printed or graphic matter affixed to or accompanying the product or its container or wrapper). Nor did Violators, with regard to the **Hair Color**, provide a system of signs, public advertising identifying the system and toll-free information services, or any other system, which provided clear and reasonable warnings. Nor did Violators, with regard to **Hair Color**, provide identification of the product at retail outlets in a manner that provided a warning through shelf labeling, signs, menus, or a combination thereof. **Hair Color** is designed for use on persons to color natural hair in scalp area.


These violations occurred each day between May 11, 2009, and May 11, 2012, and are ever continuing thereafter.

The principal routes of exposure were and are through dermal contact, ingestion, and inhalation caused when users of **Hair Color**, while wearing colorist gloves per the product's instructions or not wearing colorist gloves, apply color to their hair, or that of another, before rinsing thoroughly. In doing so, users permit bare skin, including scalp, and in some instances eyes and hands, to touch the product containing Diaminotoluene (mixed). Additionally when users rinse the product from their hair, users permit the product containing Diaminotoluene (mixed) to come into contact with the bare skin on the user’s face and body and in some instances the user’s mouth. In doing so, users also breathe in fumes emanating from **Hair Color**. The foregoing assumes use of **Hair Color** according to instructions.

Proposition 65 requires that notice of intent to sue be given to the violator(s) sixty (60) days before the suit is filed. *Cal. Health & Safety Code § 25249.7(d)(1)*. With this letter, CAG gives notice of the alleged violations to Violator and the appropriate governmental authorities. In absence of any action by the appropriate governmental authorities within sixty (60) calendar days of the sending of this notice (plus five (5) calendar days because the place of address is within the State of California, or plus ten (10) calendar days because the place of address is beyond the State of California but within the United States), CAG may file suit. *See Cal. Health & Safety Code § 25249.7(d)(1); Cal. Code Regs. 27 § 25903(d)(1); and Cal. Code Civ. Proc. § 1013*. CAG remains open and willing to discussing the possibility of resolving its grievances short of formal litigation.


**CERTIFICATE OF MERIT**

Health and Safety Code Section 25249.7(d)

I, Reuben Yeroushalmi, hereby declare:

1. This Certificate of Merit accompanies the attached sixty-day notice(s) in which it is alleged the party(s) identified in the notice(s) has violated Health and Safety Code section 25249.6 by failing to provide clear and reasonable warnings.
2. I am the attorney for the noticing party.
3. I have consulted with at least one person with relevant and appropriate experience or expertise who has reviewed facts, studies, or other data regarding the exposure to the listed chemical that is the subject of the action.
4. Based on the information obtained through those consultations, and on all other information in my possession, I believe there is a reasonable and meritorious case for the private action. I understand that "reasonable and meritorious case for the private action" means that the information provides a credible basis that all elements of the plaintiffs' case can be established and the information did not prove that the alleged violator will be able to establish any of the affirmative defenses set forth in the statute.
5. The copy of this Certificate of Merit served on the Attorney General attaches to it factual information sufficient to establish the basis for this certificate, including the information identified in Health and Safety Code section 25249.7(h)(2), i.e., (1) the identity of the persons consulted with and relied on by the certifier, and (2) the facts, studies, or other data reviewed by those persons.
