Dear Mr. Iger:

Environmental World Watch, LLC, as well as the individuals listed in Exhibit A to this Amended Notice Letter (collectively the "Noticing Parties") serve this Amended Notice of Violation ("Amended Notice") upon THE WALT DISNEY COMPANY ("Disney" or the "Noticed Company"), pursuant to and in compliance with California Health and Safety Code ("H&S Code") § 25249.7(d) and Title 27 California Code of Regulations ("CCR") § 25903.

This Amended Notice amends the prior Notice Letter (s) dated January 10, 2007, March 9, 2009, November 23, 2010 and May 2, 2012, ("Prior Notice Letters"), as served by Environmental World Watch, Inc./RBC Four Co. et al, and other individual parties. This Amended Notice incorporates the previous Notice Letters into this Amended Notice Letter as though set forth herein in full.

This Amended Notice satisfies a prerequisite for the Noticing Parties to commence an action against Disney to enforce the Safe Drinking Water and Toxic Enforcement Act of 1986 (California H&S Code § 25249.5 *et seq.*) On information and belief, the violations addressed by this Amended Notice occur in the City of Los Angeles, the City of Burbank, Los Angeles County, and in the state of California. This Amended Notice is being served upon Disney, the California Attorney General, the District Attorney of Los Angeles County, and the City Attorney of the City of Los Angeles. If Disney has a current registration with the California Secretary of State that identifies a Chief Executive Officer, President, or General Counsel, this Amended Notice is being addressed to, and served upon, one of those persons.

A description of the Noticing Parties, the Alleged Violator, and the Alleged Violations addressed by this Amended Notice follows:

- This Amended Notice is provided by Environmental World Watch, LLC ("EWW"), a California Limited Liability Co. and the individuals listed in Exhibit A to this Amended Notice, collectively (the "Noticing Parties"). EWW is acting in the public interest pursuant to H&S Code § 25249.7(d), and is dedicated to protecting the environment; improving human health and supporting environmentally sound practices.

- The individuals within the noticing parties are separately identified at Exhibit A and are persons acting on their own behalf, and are/were residents of the City of Los Angeles, City of Burbank, or City of Glendale and other Cities visiting Burbank, but mostly within the State of California.
- The Noticed Company's name and address is:

- Some of the violations addressed by this Amended Notice began on or after April 1, 1989, have occurred on numerous occasions each and every day since April 1, 1989, Oct 1, 1992, Sept 2011 and are ongoing and continuing.
- This Amended Notice covers both the "discharge" provision of Proposition 65, which is found at H&S Code § 25249.5, and the "warning" provision of Proposition 65, which is found at H&S Code § 25249.6.
- The Listed Chemicals were knowingly discharged or released into air *and* into water where such chemical passed or probably will pass into a source of drinking water from Disney's facility at or around 500 S. Buena Vista St., Burbank, CA 91521-0686, in the City of Burbank, in Los Angeles County, in the State of California (the "Facility").
- The Listed Chemicals were knowingly discharged or released into air or water from catch basins in the Facility parking lot where such chemical passed or probably will pass into a source of drinking water from Disney's Facility, from at least Sept 2011 till the present.
- More chemicals discharged, more sources of contaminated waste water have been found and more individuals exposed have surfaced recently, and they are the subject of this Amended Notice. These new Noticing Parties were exposed to the *new* Listed Chemicals with the new sources of their individual exposures for the violations addressed by this Amended Notice as inhalation, dermal and/or ingestion.
- In the course of doing business, Disney knowingly and intentionally has exposed, and continues to expose, individuals to the Listed Chemicals. No clear and reasonable warning is or has been provided by Disney to individuals regarding their individual exposure to the Listed Chemicals or regarding the fact that the Listed Chemicals are known to the State of California to be a carcinogens or reproductive toxicants.
- The carcinogens and reproductive toxicants subject to this Amended Notice and subject to discharge limitations at H&S Code § 25249.5, and subject to the warning requirements of H&S Code § 25249.6 and more specifically at Title 27 CCR §§ 25601 to 25603.3., is listed below:

1. Chromium VI (Hexavalent Chromium) - CAS #7778-50-9) and its compounds, listed as a carcinogen on February 27, 1987.
  2. Chromium VI CAS # (COMPOUNDS), listed as a reproductive toxicant December 19, 2008.
  3. Antimony – CAS # 1309-64-4 listed as a carcinogen Oct 1, 1990.
  4. Arsenic – CAS # (COMPOUNDS) listed as a carcinogen Feb 27, 1987.
  5. Lead – CAS # (COMPOUNDS) listed as a carcinogen Oct 1, 1992
- The aforementioned carcinogens and reproductive toxicants are on the Governor's list (Proposition 65 Chemical List) as published at Title 27 CCR § 27001. These carcinogens are known to the State of California to cause cancer, requiring special warning labels and care in handling and use.
  - The type of exposures alleged in this Amended Notice can also be occupational exposure (see Title 27 CCR §§ 25604 through 25604.2) and/or environmental exposure (see Title 27 CCR §§ 25605 through 25605.2) via inhalation, dermal and/or ingestion.
  - The Noticing Parties believe and so allege that Disney tolled any applicable statute of limitations by failing at any time in the past to disclose the discharge of the Listed Chemicals to any individual to whom Disney owed a warning that complied with Title 27 CCR §§ 25601 to 25603.3, inclusive.
  - The location of the alleged discharge and exposures are in and around the Disney Facility, including but not limited to downwind of the Facility waste water discharge operations into the Buena Vista catch basin on the southeast corner of Buena Vista St. and Riverside Drive, Burbank, Ca. 91521. These alleged exposures result from direct human contact via dermal, inhalation, and/or ingestion exposures with the Listed Chemicals as industrial waste water discharges from the Burbank Facility.
  - There is a further likelihood and danger that individuals did and would come into contact via dermal contact and exposure by inhalation, and/or ingestion of residues of discharged water containing the Amended Notice Listed Chemicals disposed by Disney along such previous identified routes, including but not limited to the Buena Vista catch basin and in and around the bus stop above said catch basin on Buena Vista Street as these Chemicals pass into storm drains and then into the Los Angeles River and drinking water of the State of California.

This information reveals that The Walt Disney Company discharged and exposed individuals to Chromium VI (Hexavalent Chromium) and its compounds, Antimony, Arsenic, and Lead, each a listed as a Proposition 65 chemical, without the necessary warnings as defined at California Health & Safety Code § 25249.5 and Title 27 CCR §§ 25601 to 25603.3, inclusive.

2. I am the expert for the noticing party and individual noticing parties.


