Greetings:

This office and the Mateel Environmental Justice Foundation ("Mateel") give you notice that the private companies listed on the attached service list have been, are, will be and threaten to be in violation of Cal. Health & Safety Code § 25249.6. Both this office and Mateel are private enforcers of Proposition 65, both may be contacted at the below listed address and telephone number, and I am a responsible individual at both Mateel and this office. The above referenced violations occur when California residents ingest or otherwise come into contact with maple syrup marketed or sold by the listed companies. Some specific examples of the maple syrup to which this notice pertains are attached on the Product List. Though a specific variety or SKU or product number is given as an example, this notice pertains to all maple syrup of which the named varieties are examples. This notice applies to all varieties and all other forms of maple syrup that the listed companies sell. This maple syrup is contaminated with lead, a chemical known to cause birth defects and other reproductive harm. People buy this maple syrup from the listed companies throughout California. They use the maple syrup to sweeten food such as pancakes, waffles or french toast. They use maple syrup in baking. When people ingest this maple syrup they also ingest (and are therefore exposed to) lead. When people come into contact in other ways with this maple syrup -- such as when touching it -- some of the lead dissolved in this maple syrup is absorbed through the skin, and enters through cuts and abrasions in the skin. The routes of exposure to lead from this maple syrup are, therefore, via the ingestion, dermal absorption, subcutaneous, and mucous membrane routes of exposure. The listed companies did not and do not provide people with clear and reasonable warnings before they expose California residents to lead. These violations have occurred every day since at least June 6, 2010, and will continue every day until the lead is removed from the maple syrup or until clear and reasonable warnings are given. These violations are alleged for occupational and consumer product exposures. We do not allege occupational exposure violations as to maple syrup made outside of California, except as to the listed companies' locations in California. Workers at these locations are exposed in the same way as consumers are -- by ingesting this maple syrup, or by touching it. This notice does not allege environmental exposure violations.



CERTIFICATE OF MERIT

I, William Verick, hereby declare: This Certificate of Merit accompanies the attached notice(s) of violation in which it is alleged the parties identified in the notices have violated Health and Safety Code section 25249.6 by failing to provide clear and reasonable warnings. I am the attorney for the noticing party. I have consulted with one or more persons with relevant and appropriate experience or expertise who has reviewed facts, studies, or other data regarding the exposure to the listed chemical that is the subject of the action. Based on the information obtained through those consultations, and on all other information in my possession, I believe there is a reasonable and meritorious case for the private action. I understand that "reasonable and meritorious case for the private action" means that the information provides a credible basis that all elements of the plaintiffs' case can be established and the information did not prove that the alleged violator will be able to establish any of the affirmative defenses set forth in the statute. The copy of this Certificate of Merit served on the Attorney General attaches to it factual information sufficient to establish the basis for this certificate, including the information identified in Health and Safety Code section 25249.7(h)(2), i.e., (1) the identity of the person(s) consulted with and relied on by the certifier, and (2) the facts, studies, or other data reviewed by those persons.



This notice alleges the violation of Proposition 65 with respect to occupational exposures governed by the California State Plan for Occupational Safety and Health. The State Plan incorporates the provisions of Proposition 65, as approved by Federal OSHA on June 6, 1997. This approval specifically placed certain conditions on Proposition 65, including that it does not apply to the conduct of manufacturers occurring outside the State of California. The approval also provides that an employer may use the means of compliances in the general hazard communication requirements to comply with Proposition 65. It also requires that supplemental enforcement is subject to the supervision of the California Occupational Safety and Health Administration. Accordingly, any settlement, civil complaint, or substantive court orders in this matter must be submitted to the Attorney General.
