To Whom It May Concern:

Altshuler Berzon LLP ("Firm") represents As You Sow, a 501(c)(3) non-profit corporation dedicated to, among other causes, the protection of the environment, toxics reduction, the promotion of and improvement of human health, the improvement of worker and consumer rights, environmental education, and corporate accountability. As You Sow is based in Oakland, California and was incorporated in 1992 under the laws of the State of California.

As You Sow has documented violations of California's Safe Drinking Water and Toxic Enforcement Act of 1986 ("Proposition 65"), Cal. Health & Safety Code §25249.5 et seq., by Dollar Tree Stores, Inc (the "Company"). This letter constitutes notice by As You Sow and the Firm to the Company of these violations. Specifically, the Company has violated and is violating Section 25249.6, which provides that "[n]o person in the course of doing business shall knowingly and intentionally expose any individual to a chemical known to the state to cause cancer or reproductive toxicity without first providing a clear and reasonable warning to such individual"

Pursuant to Section 25249.7(d) of the statute, this Firm intends to bring an enforcement action on behalf of As You Sow sixty (60) days after effective service of this notice unless the public enforcement agencies have commenced and are diligently prosecuting an action to rectify the violations discussed in this letter. The public enforcement agencies that have been served with copies of this notice of violations are identified in the attached Certificate of Service.

Alleged Violator: The name of the alleged violator covered by this notice is Dollar Tree Stores, Inc.

<u>Listed Chemicals:</u> These violations involve exposures to *p*-dichlorobenzene (also referred to as 1,4-dichlorobenzene or *para*-dichlorobenzene) from the product listed below. On January 1, 1989, the State of California officially listed *p*-dichlorobenzene as a chemical known to the State to cause cancer.

Consumer Product: The product that is the subject of this notice is IMS Moth Balls.

<u>Violations:</u> The alleged violator knowingly and intentionally has exposed and continues knowingly and intentionally to expose consumers within the State of California to *p*-dichlorobenzene at levels that, upon reasonable use of the product, exceed the No Significant Risk Level without providing clear and reasonable warning of this exposure. In particular, the product does not warn that it contains chemicals known to the State of California to cause cancer.

Route of Exposure: Use of the product identified in this notice results in human exposures to *p*-dichlorobenzene. The routes of exposure include: inhalation when consumers breathe near the product; and absorption through skin, including but not limited to through handling of the product.

<u>Duration of Violations:</u> Each of these ongoing violations has occurred on every day since at least April 15, 2013; as well as every day since the product was introduced in the California marketplace and following the one-year anniversary date of the listing at issue; and will continue every day until clear and reasonable warnings are provided to product purchasers and users or until this known toxic chemical is removed from the product.

Pursuant to Title 11, C.C.R. §3100, a certificate of merit is attached hereto. Pursuant to Title 27, C.C.R. §25903(b), a copy of "The Safe Drinking Water and Toxic Enforcement Act of 1986 (Proposition 65): A Summary" is also enclosed.

In keeping with its public interest mission and to rectify expeditiously these ongoing violations of California law, As You Sow is interested in seeking a constructive resolution of this matter without engaging in costly and protracted litigation.
