We represent Michael Murphy, a California citizen acting in the interest of the general public. This letter serves as notice that TSA - Top Shelf Anaheim (“Alleged Violator”) is in violation of “Proposition 65,” which is otherwise known as the Safe Drinking Water and Toxic Enforcement Act of 1986 and is codified at California Health & Safety Code section 25249.5 *et seq.* Specifically, this notice is being sent in regard to a violation of section 25249.6, which provides that “[n]o person in the course of doing business shall knowingly and intentionally expose any individual to a chemical known to the state to cause cancer or reproductive toxicity without giving clear and reasonable warning to such individual . . . .”

Michael Murphy has identified that the Alleged Violator has violated (and continues to violate) section 25249.6 by exposing consumers within the State of California to the chemicals listed below (which are present at unsafe levels in the products listed below) without providing proper warnings about exposure to those chemicals or the toxic effects of exposure to those chemicals, which are known to the state to cause cancer or reproductive toxicity.

This letter serves as notice to both the Alleged Violator and the appropriate public enforcement agencies that Michael Murphy intends to file a private enforcement action, pursuant to section 25249.7(d) 60 days after effective service of this notice unless the public enforcement agencies have commenced and are earnestly prosecuting an action in regard to the violation alleged herein.

**Violation:**

The Alleged Violator knowingly and intentionally exposed and continues to expose consumers within the State of California to the chemicals listed below without providing clear and reasonable warning of the exposure while employing more than 9 employees.<sup>1 35</sup>

**Consumer Product(s) in Violation of 25249.6 and Listed Chemical(s):**

Korova Fifty One Fifty Bar 500 mg (tested positive for Malathion, which was added to the list of chemicals known by the state to cause cancer on May 20, 2016; and Myclobutanil, which was added to the list of chemicals known by the state to cause reproductive toxicity on April 16, 1999).

Kushy Punch Indica Plum 100 mg (tested positive for Malathion, which was added to the list of chemicals known by the state to cause cancer on May 20, 2016).

Kiva Blueberry Terra Bites (tested positive for Malathion, which was added to the list of chemicals known by the state to cause cancer on May 20, 2016).

Kiva Espresso Terra Bites (tested positive for Malathion, which was added to the list of chemicals known by the state to cause cancer on May 20, 2016).

Kushy Punch Hybrid Tropical Punch 100 mg (tested positive for Carbaryl, which was added to the list of chemicals known by the state to cause cancer on February 5, 2010 and to the list of chemicals known by the state to cause reproductive toxicity on August 7, 2009; Malathion, which was added to the list of chemicals known by the state to cause cancer on May 20, 2016; and Myclobutanil, which was added to the list of chemicals known by the state to cause reproductive toxicity on April 16, 1999).

Kushy Punch TKO 200 mg (tested positive for Carbaryl, which was added to the list of chemicals known by the state to cause cancer on February 5, 2010 and to the list of chemicals known by the state to cause reproductive toxicity on August 7, 2009; and Malathion, which was added to the list of chemicals known by the state to cause cancer on May 20, 2016).

Korova Black Bar 1000mg (tested positive for Malathion, which was added to the list of chemicals known by the state to cause cancer on May 20, 2016; and Myclobutanil, which was added to the list of chemicals known by the state to cause reproductive toxicity on April 16, 1999).

Korova Mint Dip Cookie 250 mg (tested positive for Malathion, which was added to the list of chemicals known by the state to cause cancer on May 20, 2016; and Myclobutanil, which was added to the list of chemicals known by the state to cause reproductive toxicity on April 16, 1999).

Cheeba Chews Sativa 70 mg (tested positive for Myclobutanil, which was added to the list of chemicals known by the state to cause reproductive toxicity on April 16, 1999).

Cheeba Chews Hybrid 70 mg (tested positive for Malathion, which was added to the list of chemicals known by the state to cause cancer on May 20, 2016; and Myclobutanil, which was added to the list of chemicals known by the state to cause reproductive toxicity on April 16, 1999).

Bhang Bars Triple Fire-Dark Chocolate with Orange & Spice (tested positive for Malathion, which was added to the list of chemicals known by the state to cause cancer on May 20, 2016).

Korova Triple Chocolate Brownie 150 mg (tested positive for Myclobutanil, which was added to the list of chemicals known by the state to cause reproductive toxicity on April 16, 1999).

Cheeba Chews Deca Dose 175 mg (tested positive for Myclobutanil, which was added to the list of chemicals known by the state to cause reproductive toxicity on April 16, 1999).

**Route of Exposure:**

Each of the products listed above is a medical marijuana product, which has been designed to be consumed by individuals seeking relief from various medical issues. Accordingly, the primary route of exposure to the chemicals listed in the above products is through direct ingestion. Unfortunately, while consumers believe that these medical products are safe and healthy, in reality, they contain unsafe levels of a variety of chemicals that the state has deemed to be dangerous.

**Approximate Time of Violations:**

The violations are ongoing and have occurred on each date that you sold the products listed above starting approximately on July 1, 2015. The violations will continue every day until clear and reasonable warnings are provided to product purchasers and users or until the toxic chemical at issue is either removed from the products listed above or reduced to allowable levels.

4. Based on the information obtained through those consultations, and on all other information in my possession, I believe there is a reasonable and meritorious case for the private action. I understand that “reasonable and meritorious case for the private action” means that the information provides a credible basis that all elements of the plaintiffs’ case can be established and the information did not prove that the alleged violator will be able to establish any of the affirmative defenses set forth in the statute.

5. The copy of this Certificate of Merit served on the Attorney General attaches to it factual information sufficient to establish the basis for this certificate, including the information identified in health and Safety Code section 25249.7(h)(2), i.e., (1) the identity of the persons consulted with and relied on by the certifier, and (2) the facts, studies, or other data reviewed by those persons.

**Correction to 60-Day Notice and Certificate of Merit  
Regarding Malathion and Effective Date of its Listing as a Chemical  
Known to Cause Cancer**

I, Mark Morrison, hereby declare:

1. This Correction to 60-day Notice and Certificate of Merit accompanies a 60-day notice in which it is alleged that the parties identified in the notice have violated Health and Safety Code section 25249.6 by failing to provide clear and reasonable warnings.
2. I am an attorney for the noticing party.
3. On May 20, 2016, the chemical Malathion was added to the list of chemicals known to the State of California to cause cancer for purposes of the Safe Drinking Water and Toxic Enforcement Act of 1986 (Proposition 65).<sup>1</sup> Businesses are required to provide a ‘clear and reasonable’ warning before knowingly and intentionally exposing anyone to a listed chemical. This warning can be given by a variety of means, such as by labeling a consumer product, posting signs at the workplace, distributing notices at a rental housing complex, or publishing notices in a newspaper. Once a chemical is added to the list of chemicals known to cause cancer, businesses have 12 months to comply with warning requirements.<sup>2</sup>
4. The Plaintiff, Michael Murphy, accordingly does not allege there is any Proposition 65 violation for the failure to warn of the presence of Malathion as of May 5, 2017—the date that his NOTICE OF VIOLATION OF CALIFORNIA HEALTH AND SAFETY CODE SECTION 25249.6 (Proposition 65) was served on the Defendant.

## APPENDIX A

### OFFICE OF ENVIRONMENTAL HEALTH HAZARD ASSESSMENT CALIFORNIA ENVIRONMENTAL PROTECTION AGENCY

#### THE SAFE DRINKING WATER AND TOXIC ENFORCEMENT ACT OF 1986 (PROPOSITION 65): A SUMMARY

The following summary has been prepared by the California Office of Environmental Health Hazard Assessment (OEHHA), the lead agency for the implementation of the Safe Drinking Water and Toxic Enforcement Act of 1986 (commonly known as "Proposition 65"). A copy of this summary must be included as an attachment to any notice of violation served upon an alleged violator of the Act. The summary provides basic information about the provisions of the law, and is intended to serve only as a convenient source of general information. It is not intended to provide authoritative guidance on the meaning or application of the law. Please refer to the statute and OEHHA's implementing regulations (see citations below) for further information.

FOR INFORMATION CONCERNING THE BASIS FOR THE ALLEGATIONS IN THE NOTICE RELATED TO YOUR BUSINESS, CONTACT THE PERSON IDENTIFIED ON THE NOTICE.

The text of Proposition 65 (Health and Safety Code Sections 25249.5 through 25249.13) is available online at: <http://oehha.ca.gov/prop65/law/P65law72003.html>. Regulations that provide more specific guidance on compliance, and that specify procedures to be followed by the State in carrying out certain aspects of the law, are found in Title 27 of the California Code of Regulations, sections 25102 through 27001.<sup>1</sup> These implementing regulations are available online at: <http://oehha.ca.gov/prop65/law/P65Regs.html>.

#### *WHAT DOES PROPOSITION 65 REQUIRE?*

***The "Proposition 65 List."*** Under Proposition 65, the lead agency (OEHHA) publishes a list of chemicals that are known to the State of California to cause cancer and/or reproductive toxicity. Chemicals are placed on the Proposition 65 list if they are known to cause cancer and/or birth defects or other reproductive harm, such as damage to

female or male reproductive systems or to the developing fetus. This list must be updated at least once a year. The current Proposition 65 list of chemicals is available on the OEHHA website at: [http://www.oehha.ca.gov/prop65/prop65\\_list/Newlist.html](http://www.oehha.ca.gov/prop65/prop65_list/Newlist.html).

Only those chemicals that are on the list are regulated under Proposition 65. Businesses that produce, use, release or otherwise engage in activities involving listed chemicals must comply with the following:

***Clear and reasonable warnings.*** A business is required to warn a person before “knowingly and intentionally” exposing that person to a listed chemical unless an exemption applies. The warning given must be “clear and reasonable.” This means that the warning must: (1) clearly say that the chemical involved is known to cause cancer, or birth defects or other reproductive harm; and (2) be given in such a way that it will effectively reach the person before he or she is exposed to that chemical. Some exposures are exempt from the warning requirement under certain circumstances discussed below.

***Prohibition from discharges into drinking water.*** A business must not knowingly discharge or release a listed chemical into water or onto land where it passes or probably will pass into a source of drinking water. Some discharges are exempt from this requirement under certain circumstances discussed below.

#### *DOES PROPOSITION 65 PROVIDE ANY EXEMPTIONS?*

Yes. You should consult the current version of the statute and regulations (<http://www.oehha.ca.gov/prop65/law/index.html>) to determine all applicable exemptions, the most common of which are the following:

***Grace Periods.*** Proposition 65 warning requirements do not apply until 12 months after the chemical has been listed. The Proposition 65 discharge prohibition does not apply to a discharge or release of a chemical that takes place less than 20 months after the listing of the chemical.

***Governmental agencies and public water utilities.*** All agencies of the federal, state or local government, as well as entities operating public water systems, are exempt.

***Businesses with nine or fewer employees.*** Neither the warning requirement nor the discharge prohibition applies to a business that employs a total of nine or fewer employees. This includes all full and part-time employees, not just those present in California.

**Exposures that pose no significant risk of cancer.** For chemicals that are listed under Proposition 65 as known to the State to cause cancer, a warning is not required if the business causing the exposure can demonstrate that the exposure occurs at a level that poses “no significant risk.” This means that the exposure is calculated to result in not more than one excess case of cancer in 100,000 individuals exposed over a 70-year lifetime. The Proposition 65 regulations identify specific “No Significant Risk Levels” (NSRLs) for many listed carcinogens. Exposures below these levels are exempt from the warning requirement. See OEHHA’s website at: <http://www.oehha.ca.gov/prop65/getNSRLs.html> for a list of NSRLs, and Section 25701 *et seq.* of the regulations for information concerning how these levels are calculated.

**Exposures that will produce no observable reproductive effect at 1,000 times the level in question.** For chemicals known to the State to cause reproductive toxicity, a warning is not required if the business causing the exposure can demonstrate that the exposure will produce no observable effect, even at 1,000 times the level in question. In other words, the level of exposure must be below the “no observable effect level” divided by 1,000. This number is known as the Maximum Allowable Dose Level (MADL). See OEHHA’s website at: <http://www.oehha.ca.gov/prop65/getNSRLs.html> for a list of MADLs, and Section 25801 *et seq.* of the regulations for information concerning how these levels are calculated.

**Exposures to Naturally Occurring Chemicals in a Food.** Certain exposures to chemicals that naturally occur in foods (i.e., that do not result from any known human activity, including activity by someone other than the person causing the exposure) are exempt from the warning requirements of the law. If the chemical is a contaminant<sup>2</sup> it must be reduced to the lowest level feasible. Regulations explaining this exemption can be found in Section 25501.

**Discharges that do not result in a “significant amount” of the listed chemical entering any source of drinking water.** The prohibition from discharges into drinking water does not apply if the discharger is able to demonstrate that a “significant amount” of the listed chemical has not, does not, or will not pass into or probably pass into a source of drinking water, and that the discharge complies with all other applicable laws, regulations, permits, requirements, or orders. A “significant amount” means any detectable amount, except an amount that would meet the “no significant risk” level for chemicals that cause cancer or that is 1,000 times below the “no observable effect” level for chemicals that cause reproductive toxicity, if an individual were exposed to that amount in drinking water.

## *HOW IS PROPOSITION 65 ENFORCED?*

Enforcement is carried out through civil lawsuits. These lawsuits may be brought by the Attorney General, any district attorney, or certain city attorneys. Lawsuits may also be brought by private parties acting in the public interest, but only after providing notice of the alleged violation to the Attorney General, the appropriate district attorney and city attorney, and the business accused of the violation. The notice must provide adequate information to allow the recipient to assess the nature of the alleged violation. The notice must comply with the information and procedural requirements specified in Section 25903 of Title 27, sections 3100-3103 of Title 11. A private party may not pursue an independent enforcement action under Proposition 65 if one of the governmental officials noted above initiates an enforcement action within sixty days of the notice.

A business found to be in violation of Proposition 65 is subject to civil penalties of up to \$2,500 per day for each violation. In addition, the business may be ordered by a court to stop committing the violation.

A private party may not file an enforcement action based on certain exposures if the alleged violator meets specific conditions. For the following types of exposures, the Act provides an opportunity for the business to correct the alleged violation:

- An exposure to alcoholic beverages that are consumed on the alleged violator's premises to the extent onsite consumption is permitted by law;
- An exposure to a Proposition 65 listed chemical in a food or beverage prepared and sold on the alleged violator's premises that is primarily intended for immediate consumption on- or off-premises. This only applies if the chemical was not intentionally added to the food, and was formed by cooking or similar preparation of food or beverage components necessary to render the food or beverage palatable or to avoid microbiological contamination;
- An exposure to environmental tobacco smoke caused by entry of persons (other than employees) on premises owned or operated by the alleged violator where smoking is permitted at any location on the premises;
- An exposure to listed chemicals in engine exhaust, to the extent the exposure occurs inside a facility owned or operated by the alleged violator and primarily intended for parking non-commercial vehicles.

If a private party alleges that a violation occurred based on one of the exposures described above, the private party must first provide the alleged violator a notice of special compliance procedure and proof of compliance form.

A private party may not file an action against the alleged violator for these exposures, or recover in a settlement any payment in lieu of penalties or any reimbursement for costs and attorney's fees, if the notice of violation was served on or after October 5, 2013, and the alleged violator has done *all* of the following within 14 days of being served notice:

- Corrected the alleged violation;
- Agreed to pay a civil penalty of \$500 (subject to change as noted below) to the private party within 30 days; and
- Notified the private party serving the notice in writing that the violation has been corrected.

The written notification to the private-party must include a notice of special compliance procedure and proof of compliance form completed by the alleged violator as directed in the notice. On April 1, 2019, and every five years thereafter, the dollar amount of the civil penalty will be adjusted by the Judicial Council based on the change in the annual California Consumer Price Index. The Judicial Council will publish the dollar amount of the adjusted civil penalty at each five-year interval, together with the date of the next scheduled adjustment.

An alleged violator may satisfy these conditions only one time for a violation arising from the same exposure in the same facility or on the same premises. The satisfaction of these conditions does not prevent the Attorney General, a district attorney, a city attorney of a city greater than 750,000 in population, or any full-time city prosecutor with the consent of the district attorney, from filing an enforcement action against an alleged violator. The amount of any civil penalty for a violation shall be reduced to reflect any payment made by the alleged violator for the same alleged violation to a private-party.
