**Re: Notice Pursuant to Cal. Health & Safety Code §§ 25249.7(a) & (d)(1)
Violation or Threatened Violation of Proposition 65 Warning by Williams-Sonoma, Inc.
and Traeger Pellet Grills, LLC**

Dear Mr. Becerra & to whomever else it may concern:

I represent California consumer John Devlin and write on his behalf, pursuant to California Health & Safety Code §§ 25249.7(a) & (d)(1), to notify you as to Williams-Sonoma's and Traeger Pellet Grills' violation, or threatened violation, of § 25249.6, *i.e.*, Proposition 65. The violations alleged by this Notice consist of types of harm that may potentially result from exposures to the toxic chemicals carbon monoxide and wood dust, as a result of online sales made by Williams-Sonoma to California citizens.

NATURE OF ALLEGED VIOLATION

Duration of the Violations

The violations have been occurring since at least April 9, 2019, and are ongoing.

Provision of Proposition 65

This Notice of Violation covers the “warning provision” of Proposition 65, which is found at California Health and Safety Code Section 25249.6.

Listed Chemical(s)

The listed chemicals involved in these violations are carbon monoxide, known to the State of California to cause birth defects and other reproductive harm, and wood dust, known to the State of California to cause cancer. The chemicals were listed as known hazardous substances in 1989 and 2009, respectively.

Type of Product and Route of Exposure

The type of product causing these violations is wood pellets used for smoking food. The consumer is exposed to the Listed Chemical through inhalation. Handling the product causes the wood dust to become airborne and be inhaled by the consumer, while using the product for its intended purpose releases carbon monoxide upon combustion.

Description of Violation

Williams-Sonoma is an online retailer selling wood pellets used for smoking food to residents of California through its website (www.williams-sonoma.com). No clear and reasonable Proposition 65 warning is provided with these products, neither on the product pages nor at the point of sale, regarding the presence of the Listed Chemicals in the products. Traeger Pellet Grills is a manufacturer of products used in the smoking of food, which are sold by Williams-Sonoma.

RESOLUTION OF NOTICED CLAIMS

Based on the allegations set forth in this Notice, John Devlin intends to file a citizen enforcement lawsuit against Williams-Sonoma and Traeger Pellet Grills unless they agree in a binding written agreement to: (1) recall products already sold or otherwise provided to consumers; (2) provide clear and reasonable warnings for products sold or otherwise provided to consumers in the future to eliminate unknowing exposures or reformulate such products to eliminate Listed Chemicals exposures; and (3) pay an appropriate civil penalty based on the factors enumerated in California Health and Safety Code Section 25249.7(b). If Williams-Sonoma and Traeger Pellet Grills are interested in resolving this dispute without resort to expensive and time-consuming litigation, please feel free to contact me directly on behalf of John Devlin. It should be noted that neither John Devlin nor I can: (1) finalize any settlement until after the 60-day notice period has expired; nor (2) speak for the Attorney General or any

2. I am an attorney for the noticing party.
3. I have consulted with one or more persons with relevant and appropriate experience or expertise who has reviewed facts, studies, or other data regarding the alleged exposure to the listed chemical that is the subject of the action.
4. Based on the information obtained through those consultations, and on all other information in my possession, I believe there is a reasonable and meritorious case for the private action. I understand that “reasonable and meritorious case for the private action” means that the information provides a credible basis that all elements of the plaintiffs’ case can be established and the information did not prove that the alleged violator will be able to establish any of the affirmative defenses set forth in the statute.
5. The copy of this Certificate of Merit served on the Attorney General attaches to it factual information sufficient to establish the basis for this certificate, including the information identified in Health and Safety Code section 25249.7(h)(2), i.e., (1) the identity of the persons consulted with and relied on by the certifier, and (2) the facts, studies, or other data reviewed by those persons.
