Re: Notice Pursuant to Cal. Health & Safety Code §§ 25249.7(a) & (d)(1) Violation or Threatened Violation of Proposition 65 Warning by Raymond Vineyard & Cellar, Inc.

To Whom it may Concern and Public Prosecutors:

We represent California consumer Alejandra Stanzione ("AS" "plaintiff"), acting on her behalf and in the interest of the general public. The consumer/citizen seeks to promote awareness of exposures to toxic chemicals in products sold in California and, if possible, to improve public health and safety by reducing the hazardous substances contained in such items. The consumer/citizen seeks to promote awareness of exposures to toxic chemicals in products sold in California and, if possible, to improve public health and safety by reducing the hazardous substances contained in such items. As described below, citizen AS has detected violations of California SAFE DRINKING WATER AND TOXIC ENFORCEMENT ACT of 1986 ("Proposition 65" or "act"), codified at California Health and Safety Code §§ 25249.5 et seg. by collectively (the violators). This letter serves to provide plaintiff's notification of this violations to the violators and elected prosecutors. Is the plaintiff's intention to notify you as to ZORESTAR/URKWOOD GROUP LLC and AMAZON INC. violation, or threatened violation, of § 25249.6, i.e., Proposition 65. The violations alleged by this Notice consist of types of harm that may potentially result from exposures to the toxic chemical Wood dust, which was listed as a known hazardous substance in December 2009.

NATURE OF ALLEGED VIOLATION

Duration of the Violations

The violations have been occurring since at least February 13, 2018, and are ongoing.



Provision of Proposition 65

This Notice of Violation covers the "warning provision" of Proposition 65, which is found at California Health and Safety Code Section 25249.6.

Listed Chemical(s)

The listed chemical involved in these violations is Wood dust, known to the State of California to cause cancer.

The type of product causing these violation are pieces of unfinished wood. The consumer is exposed to the Listed Chemical by cutting, shaping and sanding wood releases wood dust into the air, where it can be inhaled. Wood dust also settles onto tables, floors and other surfaces. When disturbed, it can become airborne again, and can be inhaled.

The type of product is pictured below as it is offered for sale on the seller's and distributor's website.









Description of Violation

AMAZON INC is an online and on site/store retailer selling all type of products to residents of California through its website (www.amazon.com) and physical stores. One of those products is **Oak Wood Chips for electric smokers. Mini Hardwood Chips for Smoking and Grilling. Organic Pack, 4 Different types and flavors,** produced by a US company based in Seattle, Washington. No clear and reasonable Proposition 65 warning is provided with these products, neither on the product offering web pages from the seller nor in the packaging, regarding the presence of the Listed Chemical in the products.

RESOLUTION OF NOTICED CLAIMS

Based on the allegations set forth in this Notice, plaintiff AS intends to file a citizen enforcement lawsuit against ZORESTAR/URKWOOD GROUP LLC and AMAZON INC unless they agree in a binding written agreement to: (1) recall products already sold or otherwise provided to consumers; (2) provide clear and reasonable warnings for products sold or otherwise provided to consumers in the future to eliminate unknowing exposures or reformulate such products to eliminate Listed Chemicals exposures; and (3) pay an appropriate civil penalty based on the factors enumerated in California Health and Safety Code Section 25249.7(b). If ZORESTAR/URKWOOD GROUP LLC and AMAZON INC are interested in resolving this dispute without resort to expensive and time-consuming litigation, please feel free to contact us directly on behalf of the plaintiff. It should be noted that neither Alejandra Stanzione nor us can: (1) finalize any settlement until after the 60-day notice period has expired; nor (2) speak for the Attorney General or any District or City Attorney who received this Notice. Therefore, while reaching an agreement with the plaintiff on this matter will resolve its claims, such agreement may not satisfy the public prosecutors.

If the alleged Violator is interested in resolving this dispute without resorting to time-consuming and expensive litigation, please feel free to contact the counsel identified above.

We understand that "reasonable and meritorious case for the private action" means that the information provides a credible basis that all elements of the plaintiff's' case can be established and the information did not prove that the alleged violator will be able to establish any of the affirmative defenses set forth in the statute.
- 5. The copy of this Certificate of Merit served on the Attorney General attaches to it factual information sufficient to establish the basis for this certificate, including the information identified in Health and Safety Code section 25249.7(h)(2), i.e., (1) the identity of the persons consulted with and relied on by the certifier, and (2) the facts, studies, or other data reviewed by those persons.
