- 7. Wrong INCI name "Tocopherol (Vitamin E)" instead of "Tocopherol"
- 8. False "100% Grass Fed Beef Tallow" claim while listing five ingredients
- 9. Lot number "C048" printed ONLY on bottom of individual tubes MISSING from outer box (21 CFR 701.13(f))

ON EACH OF 3 TUBES (identical printing):

- 10. Net weight in ounces only NO GRAMS (21 CFR 701.11)
- 11. No complete manufacturer street address (only "Frederick, MD")
- 12. "Made in USA" claim with no street address on same panel
- 13. Wrong INCI name "100% Grass Fed Beef Tallow" instead of "Beef Tallow"
- 14. Wrong INCI name "Organic Virgin Coconut Oil" instead of "Cocos Nucifera (Coconut) Oil"
