**[PROPOSED] CONSENT JUDGMENT AS  
TO DEFENDANT SHAW INDUSTRIES,  
INC.**

1     **1. INTRODUCTION**

2           1.1. On July 24, 2008, plaintiff the Center for Environmental Health (“CEH”), a non-  
3 profit corporation acting in the public interest, filed a complaint titled *Center for Environmental*  
4 *Health v. Beaulieu Group, LLC, et al.*, Alameda County Superior Court Case Number 08-400091  
5 (the “CEH Action”), for civil penalties and injunctive relief pursuant to the provisions of Cal.  
6 Health & Safety Code § 25249.5, *et seq.* (“Proposition 65”). On September 2, 2008, CEH filed a  
7 First Amended Complaint (“Complaint”) in the CEH Action naming Shaw Industries, Inc.  
8 (“Defendant”) as a defendant.

9           1.2. Defendant is a corporation that employs 10 or more persons and employed 10 or  
10 more persons at all times relevant to the allegations of the Complaint, and that manufactures,  
11 distributes and/or sells Covered Products in the State of California or has done so in the past.

12           1.3. On or about June 23, 2008, CEH served Defendant and the appropriate public  
13 enforcement agencies with the requisite 60-day Notice (the “Notice”) alleging that Defendant was  
14 in violation of Proposition 65. CEH’s Notice and the Complaint in the CEH Action allege that  
15 Defendant exposes people who touch, use or otherwise handle the Covered Products to lead and  
16 lead compounds (collectively, “Lead”), chemicals known to the State of California to cause cancer,  
17 birth defects and other reproductive harm, without first providing clear and reasonable warning to  
18 such persons regarding the carcinogenicity and reproductive toxicity of Lead. The Notice and  
19 Complaint allege that Defendant’s conduct violates Health & Safety Code § 25249.6, the warning  
20 provision of Proposition 65. Defendant disputes such allegations and asserts that all of their  
21 Covered Products are safe and comply with all applicable laws.

22           1.4. Upon receipt of CEH’s Notice, Defendant contacted CEH in an effort to promptly  
23 resolve CEH’s claims. Based upon the ensuing discussions, Defendant reformulated the Products to  
24 reduce the lead levels to below fifty parts per million (“ppm”). As of May 1, 2009, Defendant  
25 stopped selling Covered Products in California that contain in excess of fifty ppm lead.

26           1.5. For purposes of this Consent Judgment only, the Parties stipulate that this Court has  
27 jurisdiction over the subject matter of the violations alleged in CEH’s Complaint and personal  
28 jurisdiction over Defendant as to the acts alleged in CEH’s Complaint, that venue is proper in the

1 County of Alameda, and that this Court has jurisdiction to enter this Consent Judgment as a full and  
2 final resolution of all claims which were or could have been raised in the Complaint based on the  
3 facts alleged therein.

4 1.6. The Parties enter into this Consent Judgment pursuant to a settlement of certain  
5 disputed claims between the Parties as alleged in the Complaint. By executing this Consent  
6 Judgment, the Parties do not admit any facts or conclusions of law. It is the Parties' intent that  
7 nothing in this Consent Judgment shall be construed as an admission by the Parties of any fact,  
8 conclusion of law, issue of law or violation of law, nor shall compliance with the Consent Judgment  
9 constitute or be construed as an admission by the Parties of any fact, conclusion of law, issue of  
10 law, or violation of law. Nothing in this Consent Judgment shall prejudice, waive or impair any  
11 right, remedy, argument or defense the Parties may have in this or any other or future legal  
12 proceedings.

13 **2. DEFINITIONS**

14 2.1. The "Effective Date" of this Consent Judgment shall be the date on which the  
15 Consent Judgment is entered as a judgment by the trial Court.

16 2.2. "Covered Products" shall mean (a) the products listed in Exhibit A to this Consent  
17 Judgment and (b) any other artificial turf products that Defendant or the entities listed in Exhibit C  
18 may manufacture after the Effective Date.

19 2.3. "Defendant Released Parties" shall mean Defendant, its parents, shareholders,  
20 divisions, subdivisions, subsidiaries, sister companies, affiliates, franchisees, cooperative members,  
21 and licensees; its distributors, wholesalers, and retailers who sell or install Covered Products; and  
22 the predecessors, successors, and assigns of any of them.

23 2.4. "Old Covered Products" shall mean Covered Products that were Sold in California  
24 before the Effective Date of this Consent Judgment.

25 2.5. "Sold in California" means any Covered Product that is sold in the State of  
26 California by Defendant or by any distributor, wholesaler or retailer that is authorized by  
27 Defendant, or by any of the entities listed on Exhibit C to this Judgment, to sell the Covered  
28 Products. For purposes of this Consent Judgment, the date of sale shall be the later of the

1 following: (a) the date of the sales contract between Defendant or any of the entities listed in  
2 Exhibit C and a customer, distributor, wholesaler, or retailer; (b) the date that Defendant or any of  
3 the entities listed in Exhibit C transport or dispatch the Covered Product into California; (3) the date  
4 that Defendant or any of the entities listed in Exhibit C deliver, or cause the delivery of, the  
5 Covered Product to the installation site.

6 **3. LEAD REDUCTION**

7 3.1. Product Reformulation. Immediately upon mutual execution of this Consent  
8 Judgment, no Covered Products Sold in California shall have a lead level higher than 50 ppm as  
9 determined pursuant to the testing protocol in Exhibit B.

10 **4. SETTLEMENT PAYMENTS**

11 4.1. Civil Penalty. Defendant shall pay to CEH \$5,000 as a civil penalty pursuant to  
12 Health and Safety Code § 25249.7(b). CEH shall apportion the payment in accordance with Health  
13 and Safety Code § 25249.12.

14 4.2. Monetary Payment in Lieu of Penalty. Defendant shall pay to CEH \$26,000 in lieu  
15 of any additional civil penalty pursuant to Health and Safety Code § 25249.7(b). CEH shall use  
16 such funds to continue its work protecting people from exposures to toxic chemicals. The payment  
17 required under this section shall be made payable to CEH.

18 4.3. Attorneys' Fees and Costs. Defendant shall pay \$54,000 to reimburse CEH and its  
19 attorneys for their reasonable investigation fees and costs, attorneys' fees, and any other costs  
20 incurred as a result of investigating, bringing this matter to Defendant's attention, litigating and  
21 negotiating a settlement in the public interest. The payment required under this section shall be  
22 made payable to Lexington Law Group, LLP.

23 4.4. Delivery of Payments. All payments made pursuant to this Section 6 shall be  
24 delivered to the Lexington Law Group, LLP at the address set forth in Section 11 below and shall be  
25 delivered within 15 days of entry of this Consent Judgment.

26 **5. MODIFICATION OF CONSENT JUDGMENT**

27 5.1. This Consent Judgment may be modified from time to time by express written  
28 agreement of the Parties with the approval of the Court; by an order of this Court on noticed motion

1 from Plaintiff or Defendant in accordance with law; or by the Court in accordance with its inherent  
2 authority to modify its own judgments.

3 5.2. Before filing an application with the Court for a modification to this Consent  
4 Judgment, the party seeking modification shall meet and confer with the other party to determine  
5 whether the modification may be achieved by consent. If a proposed modification is agreed upon,  
6 then the Parties will present the modification to the Court by means of a stipulated modification to  
7 the Consent Judgment.

8 **6. ENFORCEMENT**

9 6.1. CEH may, by motion or application for an order to show cause before this Court,  
10 enforce the terms and conditions contained in this Consent Judgment. To the extent that any such  
11 proceeding is premised on an alleged failure by Defendant to comply with Section 3.1 of this  
12 Consent Judgment, such proceeding must be supported by data from testing performed on flat tape  
13 yarn provided by Defendant to the National Food Laboratory, which Defendant shall provide upon  
14 reasonable request from CEH. In any such proceeding, CEH may seek whatever fines, costs,  
15 penalties, or remedies are provided by law for failure to comply with the Consent Judgment and,  
16 where said violations of this Consent Judgment constitute subsequent violations of Proposition 65  
17 or other laws independent of the Consent Judgment and/or those alleged in the Complaint, CEH is  
18 not limited to enforcement of the Consent Judgment, but may seek in another action whatever fines,  
19 costs, penalties, or remedies are provided for by law for failure to comply with Proposition 65 or  
20 other laws. In any action brought by CEH or another enforcer alleging subsequent violations of  
21 Proposition 65 or other laws, Defendant may assert any and all defenses that are available, including  
22 the *res judicata* or collateral estoppel effect of this Consent Judgment.

23 **7. CLAIMS COVERED AND RELEASES**

24 7.1. Full and Binding Resolution and Release. This Consent Judgment is a full, final, and  
25 binding resolution between CEH, on behalf of itself and in the public interest, and Defendant and a  
26 release by CEH, on behalf of itself and in the public interest, of any claims for violation of  
27 Proposition 65 or any other statutory or common law claims that have been or could have been  
28 asserted in the Proposition 65 Notice or Complaint against Defendant Released Parties for failure to

1 provide clear and reasonable warnings of exposure to Lead from the use of the Old Covered  
2 Products, or any other claim based on the facts or conduct alleged in the Proposition 65 Notice or  
3 Complaint, whether based on actions committed by Defendant or by any entity to whom Defendant  
4 distributes or sells Old Covered Products, or any entity that sells the Old Covered Products to  
5 consumers. CEH, on behalf of itself only, hereby releases and discharges Defendant Released  
6 Parties from any and all claims asserted, or that could have been asserted, under state or federal law  
7 in this litigation arising from or related to the Old Covered Products, failure to provide clear and  
8 reasonable warnings of exposure to Proposition 65-listed chemicals from the use of the Old  
9 Covered Products, or the facts alleged in CEH's Proposition 65 Notice or the Complaint.  
10 Compliance with the terms of this Consent Judgment resolves any issue now, in the past, and in the  
11 future, concerning compliance by Defendant, its parents, shareholders, divisions, subdivisions,  
12 subsidiaries, sister companies, affiliates, franchisees, cooperative members, and licensees; its  
13 distributors, wholesalers, and retailers who sell Covered Products; and the predecessors, successors,  
14 and assigns of any of them, with the requirements of Proposition 65 arising from exposures to Lead  
15 in or from the Covered Products. This Consent Judgment does not resolve any claims that CEH  
16 may assert with respect to products other than the Covered Products.

17 7.2. Unknown Claims. It is possible that other injuries or damages not now known to the  
18 parties arising out of the facts alleged in the Complaint will develop or be discovered, and this  
19 Consent Judgment is expressly intended to cover and include all such injuries or damages, including  
20 all rights of action therefor. CEH, on behalf of itself only, hereby expressly, knowingly, and  
21 voluntarily waives the provisions of Section 1542 of the California Civil Code, which provides as  
22 follows:

23 **“A GENERAL RELEASE DOES NOT EXTEND TO CLAIMS WHICH THE**  
24 **CREDITOR DOES NOT KNOW OR SUSPECT TO EXIST IN HIS OR HER**  
25 **FAVOR AT THE TIME OF EXECUTING THE RELEASE, WHICH IF**  
26 **KNOWN BY HIM OR HER MUST HAVE MATERIALLY AFFECTED HIS**  
27 **OR HER SETTLEMENT WITH THE DEBTOR.”**

1           7.3.    Affiliates and Subsidiaries. A list of the Defendant's subsidiaries, sister  
2 corporations, and affiliates that manufactured Covered Products or sold or installed those products  
3 as of April 30, 2009, is attached hereto as Exhibit C. Defendant and its subsidiaries, sister  
4 corporations, and affiliates will comply with the applicable provisions of this Consent Judgment,  
5 including the provisions of Section 3 (Lead Reduction). If any such company fails to so comply  
6 with the applicable provisions of this Consent Judgment, then in addition to CEH's other remedies,  
7 CEH reserves the right to bring action, seeking penalties, injunctive and other relief, directly against  
8 such company to redress that company's non-compliance.

9    **8.    PROVISION OF NOTICE**

10           8.1.    When any party is entitled to receive any notice under this Consent Judgment, the  
11 notice shall be sent by overnight courier service to the person and address set forth in this section.  
12 Any party may modify the person and address to whom the notice is to be sent by sending each  
13 other party notice by certified mail, return receipt requested. Said change shall take effect for any  
14 notice mailed at least five days after the date the return receipt is signed by the party receiving the  
15 change.

16           8.2.    Notices shall be sent by First Class Mail or overnight delivery to the following when

**9. SEVERABILITY**

9.1. In the event that any of the provisions of this Consent Judgment are held by a court to be unenforceable, the validity of the enforceable provisions shall not be adversely affected.

**10. GOVERNING LAW**

10.1. The terms of this Consent Judgment shall be governed by the laws of the State of California.

**11. COURT APPROVAL**

11.1. CEH will comply with the settlement notice provisions of Health and Safety Code § 25249.7(f) and Title 11 of the California Code of Regulations § 3003.

**12. ENTIRE AGREEMENT**

12.1. This Consent Judgment contains the sole and entire agreement and understanding of the Parties with respect to the entire subject matter hereof, and any and all prior discussions, negotiations, commitments and understandings related hereto. No representations, oral or otherwise, express or implied, other than those contained herein have been made by any party hereto. No other agreements not specifically referred to herein, oral or otherwise, shall be deemed to exist or to bind any of the Parties.

**13. RETENTION OF JURISDICTION**

13.1. This Court shall retain jurisdiction of this matter to implement and enforce the Consent Judgment, and to resolve any disputes that may arise as to the implementation of this Judgment.

**14. EXECUTION IN COUNTERPARTS**

14.1. The stipulations to this Consent Judgment may be executed in counterparts and by means of facsimile, which taken together shall be deemed to constitute one document.

**15. AUTHORITY TO STIPULATE TO CONSENT JUDGMENT**

15.1. Each signatory to this Consent Judgment certifies that he or she is fully authorized by the party he or she represents to stipulate to this Consent Judgment and to enter into and execute the Consent Judgment on behalf of the party represented and legally to bind that party.


