

SETTLEMENT AGREEMENT

1. INTRODUCTION

1.1 As You Sow and U.S. Toy Company

This Settlement Agreement is entered into by and between As You Sow (hereinafter "AYS") and U.S. Toy Company, Inc. (including d/b/a Constructive Playthings), (hereinafter "US TOY"), with AYS and US TOY collectively referred to as the "Parties." AYS is a California non-profit organization that seeks, among other goals, to promote awareness of exposures to toxic chemicals and improve human health by reducing or eliminating hazardous substances contained in consumer products. US TOY employs ten or more persons and is a person in the course of doing business for purposes of Proposition 65 (California Health & Safety Code §§25249.5 *et seq.*, hereinafter, "Proposition 65").

1.2 General Allegations

AYS has generally alleged that a customer of US TOY, Century Novelty Company, Incorporated ("Century Novelty"), sold in the State of California pirate eye patches containing di(2ethylhexyl)phthalate ("DEHP") without Proposition 65 warnings and has since determined that the pirate eye patches in question were manufactured for and distributed by US TOY. DEHP and other phthalates, including butyl benzyl phthalate ("BBP") and Di-n-butyl phthalate ("DBP"), are listed pursuant to Proposition 65 as chemicals known to the State of California to cause birth defects and other reproductive harm. DEHP, BBP, and DBP are collectively referred to herein as "Listed Chemicals."

1.3 Product Description

The products that are covered by this Settlement Agreement are defined, as follows: (1) as to Century Novelty, pirate eye patches sold to it by US TOY, which contain one or more of the Listed Chemicals, and 2) as to US TOY, all products listed on Exhibit A which contain one or more of the Listed Chemicals and are otherwise not Phthalate Free as that term is defined in Section 2.1 below. All of the latter items shall be referred to herein as the "Products."

1.4 Notice of Violation

On or about November 12, 2008, AYS served Century Novelty and various public enforcement agencies with a document entitled "60-Day Notice of Violation" (the "Notice") which provided Century Novelty and such public enforcers with notice that alleged that Century Novelty was in violation of California Health & Safety Code §25249.6 for failing to warn consumers and customers that the pirate eye patches it sold in California exposed users to DEHP. No public enforcer has diligently prosecuted the allegations set forth in the Notice.

1.5 No Admission

Nothing in this Settlement Agreement shall be construed as an admission by US TOY or Century Novelty of any allegation, fact, finding, issue of law, or violation of law; nor shall compliance with this Settlement Agreement constitute or be construed as an admission by US TOY or Century Novelty of any allegation, fact, finding, conclusion, issue of law or violation of law. However, this Section shall not diminish or otherwise affect the obligations, responsibilities and duties of US TOY under this Settlement Agreement.

1.6 Effective Date

For purposes of this Settlement Agreement, the term "Effective Date" shall mean the date this Settlement Agreement is fully executed.

2. INJUNCTIVE RELIEF: WARNINGS AND REFORMULATION

2.1 Reformulation Commitment

Prior to the Effective Date, US TOY shall ensure that any remaining inventory of pirate eye patches it previously supplied to Century Novelty have been destroyed or otherwise rendered incapable of being offered for sale in California. As of the Effective Date, US TOY shall also only distribute Products for sale in California that are Phthalate Free. For purposes of this Settlement Agreement, "Phthalate Free" shall mean a Product contains less than or equal to 1,000 parts per million ("ppm") of each of the Listed Chemicals, when analyzed pursuant to Environmental Protection Agency ("EPA") testing methodologies 3580A and 8270C.

2.2 Product Warnings

US TOY represents and warrants that, in the fall of 2008, it sent letters to all of its customers known to it to do business in California, advising them that: 1) the Products did not contain warnings necessary to continue to be offered for sale in California, 2) should not be sold in California unless they were retrofitted with required warning stickers, and 3) should otherwise be withdrawn from the California market. In the fall of 2008, US TOY also entered into a settlement agreement with another enforcer of Proposition 65 committing that a subset of the Products (inflatable vinyl children's' toys and/or children's' products) would be reformulated to be Phthalate Free by December 31, 2008 and that specified Proposition 65 warnings would be

provided in conjunction with the further shipment of any non-reformulated inventories of them to California prior to that time. US TOY represents and warrants that it has been and is in good faith compliance with the terms of that agreement.

3. PENALTIES PURSUANT TO HEALTH & SAFETY CODE §25249.7(b)

3.1 Civil Penalties.

US TOY shall pay \$1,500 in civil penalties pursuant to Health & Safety Code § 25249.7(b). This payments shall be made by check or wire transfer made payable to “Shute, Mihaly & Weinberger, Attorney Client Trust Account.” AYS shall distribute 75% of these funds to the State of California, Department of Toxic Substances and Control (DTSC) as required under Proposition 65. If the payments are made by check, they shall be delivered to Ellison Folk, Shute, Mihaly & Weinberger LLP, 396 Hayes Street, San Francisco, CA 94102.

3.2 Additional Settlement Payments.

US TOY shall pay \$6,000 in lieu of additional civil penalties to AYS. to be used for grants to California non-profit organizations and by AYS Foundation Environmental Enforcement Fund. These funds shall be used to reduce exposures to toxic chemicals, to fund environmental education programs, and to increase consumer, worker and community awareness of the health hazards posed by toxic chemicals in California. In deciding among the grantee proposals, the As You Sow Board of Directors (“Board”) takes into consideration a number of important factors, including: (1) the nexus between the harm done in the underlying case(s), and the grant program work; (2) the potential for toxics reduction, prevention, remediation or education benefits to California citizens from the proposal; (3) the budget requirements of the proposed grantee and the alternate funding sources available to it for its project; and (4) the Board’s assessment of the grantee’s chances for success in its program work. AYS shall ensure that all funds will be

disbursed and used in accordance with AYS' mission statement, articles of incorporation, and bylaws and applicable state and federal laws and regulations. This payments shall be made by check or wire transfer made payable to "Shute, Mihaly & Weinberger, Attorney Client Trust Account." If the payments are made by check, they shall be delivered to Ellison Folk, Shute, Mihaly & Weinberger LLP, 396 Hayes Street, San Francisco, CA 94102.

3.3 Timing of Payments.

The payments shall be delivered on or before ten days after the Effective Date.

4. REIMBURSEMENT OF FEES AND COSTS

The Parties have reached an accord and satisfaction on the compensation due to AYS and its counsel under the private attorney general doctrine and principles of contract law. Under these legal principles, US TOY shall reimburse AYS's counsel for fees and costs, incurred as a result of investigating, bringing this matter to Century Novelty's and US TOY's attention, and negotiating a settlement in the public interest as further specified below. Specifically, US TOY shall pay AYS and its counsel \$3,000 for all attorneys' fees, expert and investigation fees, and related costs. The payment shall be issued in a third separate check made payable to "Shute, Mihaly & Weinberger LLP" and shall be delivered on or before ten days after the Effective Date, at the following address Ellison Folk, Shute, Mihaly & Weinberger LLP, 396 Hayes Street, San Francisco, CA 94102. Except as specified in this paragraph, neither US TOY nor Century Novelty shall have any obligation to AYS or AYS's counsel for legal fees or costs (including investigative and settlement-related costs) associated with the matters covered herein.

5. RELEASE OF ALL CLAIMS

5.1 Releases of US TOY and Century Novelty

In further consideration of the promises and agreements herein contained, and for the payments to be made pursuant to Sections 3 and 4 above, AYS, on behalf of itself, its past and

current agents, representatives, attorneys, successors and/or assignees, and in the interest of the general public, hereby waives all rights to institute or participate in, directly or indirectly, any form of legal action and releases all claims, including, without limitation, all actions, and causes of action, in law or in equity, suits, liabilities, demands, obligations, damages, costs, fines, penalties, losses or expenses (including, but not limited to, investigation fees, expert fees and attorneys' fees) of any nature whatsoever, whether known or unknown, fixed or contingent (collectively "Claims"), against US TOY and Century Novelty, and their parent companies, corporate affiliates, subsidiaries, and their respective officers, directors, attorneys, representatives, shareholders, agents, and employees, and sister and parent entities (collectively "Releasees").

This release is limited to those claims that arise under Proposition 65 relative to Century Novelty and Century Novelty's Releasees only as to Listed Chemicals in pirate eye patches sold to Century Novelty by US TOY. As to US TOY and US TOY's Releasees, this release is limited to those claims that arise under Proposition 65 only as to Listed Chemicals in US TOY's Products and, except as to Century Novelty's sale of pirate eye patches sold to Century Novelty by US TOY, nothing in this Paragraph shall release or be deemed to provide a release to a downstream distributor or customer of US TOY which sold the Products in California without Proposition 65 warnings. The Parties further understand and agree that this release shall not extend upstream to any entities that manufactured the Products or any component parts thereof, or any distributors or suppliers who sold the Products or any component parts thereof to US TOY.

5.2 US TOY's Release of AYS

US TOY waives any and all claims against AYS, its attorneys and other representatives, for any and all actions taken or statements made (or those that could have been taken or made) by AYS and its attorneys and other representatives, whether in the course of investigating claims or otherwise seeking enforcement of Proposition 65 against it in this matter, and/or with respect to the Products.

6. SEVERABILITY

If, subsequent to the execution of this Settlement Agreement, any of the provisions of this Settlement Agreement are held by a court to be unenforceable, the validity of the enforceable provisions remaining shall not be adversely affected.

7. GOVERNING LAW

The terms of this Settlement Agreement shall be governed by the laws of the State of California and apply within the State of California. In the event that Proposition 65 is repealed or is otherwise rendered inapplicable by reason of law generally, or as to the Products, then US TOY may provide written notice to AYS of any asserted change in the law, and shall have no further obligations pursuant to this Settlement Agreement with respect to, and to the extent that, the Products are so affected.

8. NOTICES

Unless specified herein, all correspondence and notices required to be provided pursuant to this Settlement Agreement shall be in writing and personally delivered or sent by: (i) first-class, (registered or certified mail) return receipt requested; or (ii) overnight courier on any party by the

AYS agrees to comply with the reporting form requirements referenced in Health & Safety Code §25249.7(f).

11. **MODIFICATION**

This Settlement Agreement may be modified only by a written agreement of the Parties.

12. **AUTHORIZATION**

The undersigned are authorized to execute this Settlement Agreement on behalf of their respective Parties and have read, understood and agree to all of the terms and conditions of this Settlement Agreement.
