INTRODUCTION

12 2.1 The parties to this Consent Judgment ("Parties") are the Center for
13 Environmental Health ("CEH") and defendant BestFit International, Inc. ("Settling Defendant").
14 2.2 On June 24, 2009, CEH filed the action entitled *CEH v. Lulu NYC LLC, et al.*,
15 Case No. RG 09-459448, alleging Proposition 65 violations as to wallets, handbags, purses and
16 clutches. The Court has consolidated the *Lulu* matter with a number of other related Proposition
17 65 cases.

2.3 On or about March 27, 2012, CEH served a 60-Day Notice of Violation under
Proposition 65 (The Safe Drinking Water and Toxic Enforcement Act of 1986, California Health
& Safety Code §§ 25249.5, *et seq.*), alleging that Settling Defendant violated Proposition 65 by
exposing persons to Lead contained in footwear, without first providing a clear and reasonable
Proposition 65 warning. On December 5, 2012, CEH filed the action entitled *CEH v. Fashion Eden*, Case No. RG 12-658652, naming Settling Defendant as a "Footwear Defendant."

24 2.4 Settling Defendant manufactures, distributes and/or offers for sale Covered
25 Products in the State of California or has done so in the past.

26 2.5 For purposes of this Consent Judgment only, the Parties stipulate that this
27 Court has jurisdiction over the allegations of violations contained in the operative Complaint
28 applicable to Settling Defendant (the "Complaint") and personal jurisdiction over Settling

Defendant as to the acts alleged in the Complaint, that venue is proper in the County of Alameda,
 and that this Court has jurisdiction to enter this Consent Judgment.

3 2.6 Nothing in this Consent Judgment is or shall be construed as an admission by 4 the Parties of any fact, conclusion of law, issue of law or violation of law, nor shall compliance 5 with the Consent Judgment constitute or be construed as an admission by the Parties of any fact, 6 conclusion of law, issue of law, or violation of law. Nothing in this Consent Judgment shall 7 prejudice, waive or impair any right, remedy, argument or defense the Parties may have in any 8 other legal proceeding. This Consent Judgment is the product of negotiation and compromise and 9 is accepted by the Parties for purposes of settling, compromising and resolving issues disputed in 10 this action.

INJUNCTIVE RELIEF

3.1 Specification Compliance Date. To the extent it has not already done so, no
 more than 30 days after the Effective Date, Settling Defendant shall provide the Lead Limits to its
 Vendors of Covered Products and shall instruct each Vendor to use reasonable efforts to provide
 Covered Products that comply with the Lead Limits on a nationwide basis.

Lead Limits.

3.2

Commencing on the Effective Date, Settling Defendant shall not purchase, import,
Manufacture, or supply to an unaffiliated third party any Covered Product that will be sold or
offered for sale to California consumers that contains a material or is made of a component that
exceeds the following Lead Limits:

3.2.1 Paint or other Surface Coatings: 90 parts per million ("ppm").

3.2.2 Polyvinyl chloride ("PVC"): 200 ppm.

3.2.3 All other materials or components other than cubic zirconia (sometimes
called cubic zirconium, CZ), crystal, glass or rhinestones: 300 ppm.

3.3 Final Retail Compliance Date. Commencing on April 1, 2014, Settling
 Defendant shall not sell or offer for sale in California any Covered Product that exceeds the Lead
 Limits specified in Section 3.2. For purposes of this Section 3.3, when Settling Defendant's
 direct customer sells or offers for sale to California consumers a Covered Product after April 1,

CEH shall serve the Notice of Violation on Settling 13 Defendant within 45 days of the date the alleged violation(s) was or were observed, 14 provided, however, that: (i) CEH may have up to an additional 45 days to provide Settling 15 Defendant with the test data required by Section 4.2.2(d) below if it has not yet obtained it from its laboratory; and (ii) CEH may serve a Notice of Violation to a supplier of a 16 17 Covered Product so long as: (a) the identity of the supplier cannot be discerned from the 18 labeling of the Covered Product; and (b) the Notice of Violation to the supplier is served 19 within 45 days of the date the supplier is identified by CEH. 20Supporting Documentation. The Notice of Violation shall, at a minimum, 4.2.2 21 set forth for each Covered Product: (a) the date(s) the alleged violation(s) was observed, 22 (b) the location at which the Covered Product was offered for sale, (c) a description of the 23 Covered Product giving rise to the alleged violation, and of each material or component 24 that is alleged not to comply with the Lead Limits, including a picture of the Covered 25 Product and all identifying information on tags and labels, and (d) all test data obtained by 26 CEH regarding the Covered Product and related supporting documentation, including all 27 laboratory reports, quality assurance reports and quality control reports associated with 28 testing of the Covered Products. Such Notice of Violation shall be based at least in part

upon total acid digest testing performed by an independent accredited laboratory. Wipe, swipe, x-ray fluorescence, and swab testing are not by themselves sufficient to support a Notice of Violation, although any such testing may be used as additional support for a Notice. The Parties agree that the sample Notice of Violation attached hereto as Exhibit A is sufficient in form to satisfy the requirements of subsections (c) and (d) of this Section 4.2.2.

4.2.3 Additional Documentation. CEH shall promptly make available for inspection and/or copying upon request by and at the expense of Settling Defendant, all supporting documentation related to the testing of the Covered Products and associated quality control samples, including chain of custody records, all laboratory logbook entries for laboratory receiving, sample preparation, and instrumental analysis, and all printouts from all analytical instruments relating to the testing of Covered Product samples and any and all calibration, quality assurance, and quality control tests performed or relied upon in conjunction with the testing of the Covered Products, obtained by or available to CEH that pertains to the Covered Product's alleged noncompliance with Section 3 and, if available, any exemplars of Covered Products tested.

4.2.4 **Multiple Notices.** If Settling Defendant has received more than four Notices of Violation in any 12-month period, at CEH's option, CEH may seek whatever fines, costs, penalties, or remedies are provided by law for failure to comply with the Consent Judgment. For purposes of determining the number of Notices of Violation pursuant to this Section 4.2.4, the following shall be excluded:

(a) Multiple notices identifying Covered Products Manufactured for or
 sold to Settling Defendant from the same Vendor; and

(b) A Notice of Violation that meets one or more of the conditions of Section 4.3.3(b).

4.3 Notice of Election. Within 30 days of receiving a Notice of Violation
 pursuant to Section 4.2, including the test data required pursuant to 4.2.2(d), Settling Defendant
 shall provide written notice to CEH stating whether it elects to contest the allegations contained in

the Notice of Violation ("Notice of Election"). Failure to provide a Notice of Election shall be
 deemed an election to contest the Notice of Violation. Any contributions to the Fashion
 Accessory Testing Fund required under this Section 4.3 shall be made payable to The Center for
 Environmental Health and included with Settling Defendant's Notice of Election.

4.3.1 **Contested Notices.** If the Notice of Violation is contested, the Notice of Election shall include all then-available documentary evidence regarding the alleged violation, including any test data. Within 30 days the parties shall meet and confer to attempt to resolve their dispute. Should such attempts at meeting and conferring fail, CEH may file an enforcement motion or application pursuant to Section 4.1. If Settling Defendant withdraws its Notice of Election to contest the Notice of Violation before any motion concerning the violations alleged in the Notice of Violation is filed pursuant to Section 4.1, Settling Defendant shall make a contribution to the Proposition 65 Fashion Accessory Testing Fund in the amount of \$12,500 and shall comply with all of the nonmonetary provisions of Section 4.3.2. If, at any time prior to reaching an agreement or obtaining a decision from the Court, CEH or Settling Defendant acquires additional test or other data regarding the alleged violation, it shall promptly provide all such data or information to the other Party.

4.3.2 **Non-Contested Notices.** If the Notice of Violation is not contested, Settling Defendant shall include in its Notice of Election a detailed description of corrective action that it has undertaken or proposes to undertake to address the alleged violation. Any such correction shall, at a minimum, provide reasonable assurance that the Covered Product will no longer be offered by Settling Defendant or its customers for sale in California. If there is a dispute over the sufficiency of the proposed corrective action or its implementation, CEH shall promptly notify Settling Defendant and the Parties shall meet and confer before seeking the intervention of the Court to resolve the dispute. In addition to the corrective action, Settling Defendant shall make a contribution to the Fashion Accessory Testing Fund in the amount of \$10,000, unless one of the provisions of Section 4.3.3 applies.

5. **PAYMENTS**

4 5.1 **Payments by Settling Defendant.** Settling Defendant shall pay the total sum of 5 \$45,000 as a settlement payment, such payment to be made as set forth in this Section. On or 6 before September 1, 2013, Settling Defendant shall pay the sum of \$22,500 in three separate 7 checks as follows: (a) \$2,965 made payable to the Center for Environmental Health as a civil 8 penalty; (b) \$4,450 made payable to the Center for Environmental Health as a payment in lieu of 9 additional civil penalty; and (c) \$15,085 made payable to the Lexington Law Group as partial 10 reimbursement of attorneys' fees and costs. On or before November 1, 2013, Settling Defendant 11 shall make a second payment of \$22,500 in three separate checks as follows: (a) \$2,965 made 12 payable to the Center for Environmental Health as a civil penalty; (b) \$4,450 made payable to the 13 Center for Environmental Health as a payment in lieu of additional civil penalty; and (c) \$15,085 14 made payable to the Lexington Law Group as partial reimbursement of attorneys' fees and costs. 15 Any failure by Settling Defendant to comply with the payment terms herein shall be subject to a 16 stipulated late fee in the amount of \$100 for each day after the delivery date the payment is 17 received. The late fees required under this Section shall be recoverable, together with reasonable 18 attorneys' fees, in an enforcement proceeding brought pursuant to Section 4.1 of this Consent 19 Judgment. The settlement payments for Settling Defendant shall be delivered to the offices of the 20 Lexington Law Group (Attn: Eric Somers), 503 Divisadero Street, San Francisco, California 21 94117, and allocated as set forth below between the following categories: 22 5.2 \$5,930 as a civil penalty pursuant to Health & Safety Code § 25249.7(b).

23 CEH shall apportion this payment in accordance with Health & Safety Code § 25249.12 (25% to 24 CEH and 75% to the State of California's Office of Environmental Health Hazard Assessment). 25 5.2.1 \$8,900 as a payment in lieu of civil penalty to CEH pursuant to Health & 26 Safety Code § 25249.7(b), and California Code of Regulations, Title 11, § 3203(b). CEH shall 27 use such funds to continue its work educating and protecting people from exposures to toxic 28 chemicals, including heavy metals. 2 environmental justice groups working to educate and protect people from exposures to toxic 3 chemicals. This Consent Judgment may be modified from time to 9 time by express written agreement of the Parties with the approval of the Court, or by an order of 10 this Court upon motion and in accordance with law. 11 6.2 Meet and Confer. Any Party seeking to modify this Consent Judgment shall 12 attempt in good faith to meet and confer with all affected Parties prior to filing a motion to 13 modify the Consent Judgment. 14 7. CLAIMS COVERED AND RELEASED 15 7.1 This Consent Judgment is a full, final and binding resolution between CEH on 16 behalf of itself and the public interest and Settling Defendant, and its parents, subsidiaries, 17 affiliated entities that are under common ownership, directors, officers, employees, and attorneys 18 ("Defendant Releasees"), and each entity to whom they directly or indirectly distribute or sell 19 Covered Products, including but not limited to distributors, wholesalers, customers, retailers, 20 franchisees, cooperative members, licensors, and licensees ("Downstream Defendant Releasees") 21 of any violation of Proposition 65 that was or could have been asserted in the Complaint against 22 Settling Defendant, Defendant Releasees, and Downstream Defendant Releasees, based on failure 23 to warn about alleged exposure to Lead contained in Covered Products that were sold by Settling 24 Defendant prior to the Effective Date. 25 7.2 Compliance with the terms of this Consent Judgment by Settling Defendant 26 constitutes compliance with Proposition 65 with respect to Lead in Settling Defendant's Covered 27 Products. 28 7.3 Nothing in this Section 7 affects CEH's right to commence or prosecute an DOCUMENT PREPARED -10-ON RECYCLED PAPER CONSENT JUDGMENT - BESTFIT INTERNATIONAL, INC. - LEAD CASE NO. 10. ATTORNEYS' FEES

5 10.1 Should CEH prevail on any motion, application for an order to show cause or 6 other proceeding to enforce a violation of this Consent Judgment, CEH shall be entitled to its 7 reasonable attorneys' fees and costs incurred as a result of such motion or application. Should 8 Settling Defendant prevail on any motion application for an order to show cause or other 9 proceeding, Settling Defendant may be awarded its reasonable attorneys' fees and costs as a result 10 of such motion or application upon a finding by the Court that CEH's prosecution of the motion 11 or application lacked substantial justification. For purposes of this Consent Judgment, the term 12 substantial justification shall carry the same meaning as used in the Civil Discovery Act of 1986, 13 Code of Civil Procedure §§ 2016, et seq.

14 10.2 Except as otherwise provided in this Consent Judgment, each Party shall bear
15 its own attorneys' fees and costs.

16 10.3 Nothing in this Section 10 shall preclude a Party from seeking an award of
17 sanctions pursuant to law.

18

11. TERMINATION

19 11.1 This Consent Judgment shall be terminable by CEH or by Settling Defendant
20 at any time after January 1, 2019, upon the provision of 30 days advanced written notice; such
21 termination shall be effective upon the subsequent filing of a notice of termination with Superior
22 Court of Alameda County.

11.2 Should this Consent Judgment be terminated pursuant to this Section, it shall
be of no further force or effect as to the terminated parties; provided, however that if CEH is the
terminating Party, the provisions of Sections 5 and 7 shall survive any termination and provided
further that if Settling Defendant is the terminating Party, the provisions of Sections 5 and 7.1
shall survive any termination.

12. OTHER TERMS

2 12.1 The terms of this Consent Judgment shall be governed by the laws of the State
3 of California.

4 12.2 This Consent Judgment shall apply to and be binding upon CEH and Settling
5 Defendant, and the successors or assigns of any of them.


