1 Plaintiff Public Interest Alliance LLC ("PIA") and defendant J.A. Cosmetics US, Inc. ("JA")
2 have agreed to the terms of the mutually executed settlement memorialized in the proposed Consent
3 Judgment (the "Consent Judgments") attached as Exhibit F to the Declaration of Jeffrey M. Judd in
4 Support of Motion to Approve Proposition 65 Settlement and Consent Judgment as to Defendant JA,
5 filed herewith, and PIA has moved this Court for an Order approving the settlement and Consent
6 Judgment.

7 Upon consideration of the papers submitted and the arguments presented, the Court finds that
8 the settlement agreements memorialized in the Consent Judgment meets the criteria established by
9 California Health & Safety Code section 25249.7, subsection (f)(4), in that:

- 10 1. The injunctive relief required under the Consent Judgment complies with Proposition 65;
- 11 2. The reimbursement of fees and costs provided by the Consent Judgment is reasonable under
12 California law; and
- 13 3. The civil penalty amount to be paid under the Consent Judgment is reasonable.

14 Accordingly, the Motion for Approval of Proposition 65 Settlement and Consent Judgment as
15 to Defendant J.A. Cosmetics US, Inc. is GRANTED.

16 **IT IS SO ORDERED.**
