This Consent Judgment is entered into by and between Plaintiff As You Sow (“As You Sow” or “Plaintiff”) and River Canyon Retreat Inc., doing business as Earth Circle Organics (“Earth Circle” or “Defendant”), to resolve claims against the Defendant raised in the Complaint in the above-captioned action, filed on \_\_\_\_\_, 2017. This Consent Judgment shall be effective upon entry. As You Sow and Earth Circle (collectively “the Parties”) agree to the terms and conditions set forth below.

**1. GENERAL PROVISIONS**

**1.1 Parties**

As You Sow is a non-profit corporation dedicated to, among other causes, the protection of the environment, the promotion of human health, the improvement of worker and consumer rights, environmental education, and corporate accountability. Earth Circle, since July 18, 2013, has employed 10 or more persons and has been a person in the course of doing business for purposes of the Safe Drinking Water and Toxic Enforcement Act of 1986, California Health & Safety Code § 25249.5, *et seq.* (“Proposition 65”).

**1.2 Allegations**

As You Sow alleges that Earth Circle has manufactured, imported, distributed, and/or sold in the State of California certain products containing at least one chemical known to the State of California to cause birth defects and other reproductive harm.

**1.3 Product Description**

The products covered by this Consent Judgment are defined as Earth Circle Foods Raw & Wildcrafted Dulse (in both leaf and flake form) (“Dulse”) and Earth Circle Organics Balinese Cacao Nibs (“Cacao Nibs”). The Dulse and Cacao Nibs are collectively referred to herein as the “Covered Products.” Solely for purposes of this Consent Judgment, the Parties agree that the Covered Products are or were manufactured, imported, distributed, sold, and/or offered for sale by Earth Circle in the State of California.

**1.4 Notices of Violation**

On July 18, 2014, As You Sow served Earth Circle and various public enforcement agencies with a document entitled *Notice of Violation of California Health & Safety Code § 25249.5, et seq.*, alleging that Earth Circle was in violation of California Health & Safety Code § 25249.6 for failing to warn consumers that Cacao Nibs expose users in California to cadmium, a reproductive toxin. No public enforcer has diligently prosecuted the allegations set forth in this Notice.

On September 17, 2014, As You Sow served Earth Circle and various public enforcement agencies with a document entitled *Notice of Violation of California Health & Safety Code § 25249.5, et seq.*, alleging that Earth Circle was in violation of California Health & Safety Code § 25249.6 for failing to warn consumers that Dulse exposes users in California to cadmium, a reproductive toxin. No public enforcer has diligently prosecuted the allegations set forth in this Notice.

**1.5 No Admission**

Earth Circle denies the material, factual, and legal allegations contained in As You Sow’s Notices of Violation and maintains that the Covered Products sold and distributed in California have been and are in compliance with all laws. Nothing in this Consent Judgment shall be construed as an admission by Earth Circle of any fact, finding, issue of law, or violation of law, nor shall compliance with this Consent Judgment constitute or be construed as an admission by Earth Circle of any fact, finding, conclusion, issue of law, or violation of law. However, this Section shall not diminish or otherwise affect the obligations, responsibilities, and duties under this Consent Judgment.

**1.6 Effective Date**

The term “Effective Date,” as used herein, shall be 15 days from the date the Parties sign this Consent Judgment.

**2.1 Product Warnings**

No later than the Effective Date, Earth Circle shall provide the following warning statement on the packaging of all Covered Products produced, distributed, and/or sold in the State of California:

**WARNING:** This Product contains a chemical known to the State of California to cause birth defects or other reproductive harm.

**2.2** On or prior to August 30, 2018, Earth Circle shall replace the warning in Paragraph 2.1 with the following warning statement, which shall be placed on the packaging of all Covered Products produced, distributed, and/or sold in the State of California:

 **WARNING:** This product can expose you to chemicals including cadmium, which is known to the State of California to cause birth defects or other reproductive harm. For more information go to [www.P65Warnings.ca.gov](http://www.P65Warnings.ca.gov).

**2.3** Earth Circle shall prominently affix or print the warning statement, as set forth in Paragraph 2.1 and 2.2, on the Covered Products' packaging and labeling. The warning statement shall be displayed with such conspicuousness, as compared with other words, statements, designs, or devices on the packaging or labeling of the Covered Products, so as to render the warning statement likely to be read and understood by an ordinary individual under customary conditions of purchase and use.

**2.4** The Parties agree that the content and the placement of the warning statement as shown in Exhibit A hereto meets the requirements of Paragraph 2.3 of this Consent Judgment. The Parties further agree that the content and the placement of the warning statement as shown in Exhibit B hereto meets the requirements of Paragraph 2.3 of this Consent Judgment, provided that the formatting of the word "WARNING" shall be changed so that it has the same size, font, and spacing as the other text in the warning statement, and is not obscured by any text in the remainder of the warning statement.

**2.5** If Earth Circle sells either or both of the Covered Products (wholesale or retail) to customers located in California via an internet site over which it exercises or has the right to exercise control, Earth Circle shall also prominently display the respective warning statements, as

1 set forth in Paragraph 2.1 and 2.2, on the internet site in conjunction with the Covered Product(s).  
2 The warning statement shall be displayed in the same type size as the surrounding, non-heading  
3 text, either: (a) on the same page, without scrolling, as the order form for the Covered Product(s);  
4 (b) on the same page, without scrolling, as the price for the Covered Product(s); or (c) in a dialogue  
5 box that appears and is visible when a California address for delivery is provided by the consumer,  
6 so long as the dialogue box appears prior to the completion of the internet sale and requires the  
7 consumer affirmatively to accept receipt of the warning statement set forth in the dialogue box (the  
8 warning statement in the dialogue box shall be displayed in the same type size as the surrounding,  
9 non-heading text on the screen at the time of the appearance of the dialogue box), as a condition  
10 precedent to completing the sale.

11       **2.6**     If Earth Circle sells either or both of the Covered Products (wholesale or retail)  
12 through the website of any internet retailer, or has actual knowledge that either or both of the  
13 Covered Products are sold through the website of any internet retailer, Earth Circle shall send by  
14 first class mail or overnight delivery, prior to the Effective Date, a letter requesting that the internet  
15 retailer provide a warning statement in the same manner as required under Paragraph 2.5. In the  
16 letter, Earth Circle shall request that the internet retailer respond with a written acknowledgement  
17 that it will comply with Earth Circle's request. If Earth Circle complies with its obligation to send  
18 the letter request described in this Paragraph, Earth Circle shall not be in violation of this Consent  
19 Judgment if an internet retailer fails to provide the warnings required under Paragraph 2.5.

20       **2.7**     Notwithstanding the above, if As You Sow gives notice to Earth Circle that an  
21 internet retailer is selling the Covered Product(s) after the Effective Date without adequate  
22 warning, as specified in Paragraphs 2.5 and 2.6, Earth Circle shall notify the retailer that it must  
23 provide adequate warning within 60 days of As You Sow's notice to Earth Circle. If the internet  
24 retailer does not provide adequate warning within 60 days of As You Sow's notice to Earth Circle,  
25 Earth Circle shall no longer sell the Covered Product(s) to that retailer, until such retailer provides  
26 written acknowledgement that it will provide the warnings required under Paragraph 2.5.

27       **2.8**     If Earth Circle sells either or both of the Covered Products (wholesale or retail) via  
28 mail order to customers located in California, Earth Circle shall prominently display the warning

1 statement as required in Paragraph 2.1 or 2.2 in the mail order catalogue in conjunction with the  
2 description and/or listing of the Covered Product(s). The warning statement shall appear either on  
3 the same page as the order form for the Covered Product(s), or on the same page upon which the  
4 price is listed, in the same type size as the surrounding, non-heading text. The warning statement  
5 shall be added in the first print run of the mail order catalogue on or after the Effective Date.

6 **3. ADDITIONAL PRODUCTS**

7 **3.1** No later than the Effective Date, Earth Circle will provide to As You Sow additional  
8 products sent to a laboratory for testing of cadmium and lead levels in the products. Testing shall  
9 be conducted as set forth in paragraphs 3.2 and 3.3 below.

10 **3.2** Testing for lead and cadmium content under Paragraph 3.1 shall be performed using  
11 the protocols set forth in EPA Methods 6020, 6020a. The laboratory must digest at least 0.5 grams  
12 of each sample with a level of detection of at least 4 parts per billion. The sample preparation  
13 method must use a microwave- or heat-assisted acid digestion method. In the event testing  
14 protocols change such that those in EPA Methods 6020, 6020a are not commonly performed by  
15 testing laboratories, the Parties will agree to alternative protocols.

16 **3.3** Testing for lead and cadmium content under Paragraph 3.2 shall be performed by an  
17 independent third-party laboratory certified by the California Environmental Laboratory  
18 Accreditation Program for the analysis of heavy metals or an independent third-party laboratory  
19 registered with the United States Environmental Protection Agency.

20 **3.4** As You Sow agrees to deliver full laboratory reports for the products described in  
21 Section 3.1, with results of testing for lead and cadmium content under this Section, including all  
22 accompanying quality assurance/quality control (“QA/QC”) documentation, to Earth Circle within  
23 15 days of receipt of the results by As You Sow from the laboratory.

24 **3.5** Product warnings consistent with Paragraphs 2.1 – 2.8 of this Consent Judgment are  
25 required for each of the products for which: (a) any test result obtained from the process set forth in  
26 section 3.1 to 3.4 above demonstrates that the product contains cadmium in excess of 4.1  
27 micrograms per serving size listed on the product’s packaging (i.e., the concentration of cadmium  
28 in the product times the serving size in grams), and/or (b) any test result obtained from the process

1 set forth in section 3.1 to 3.4 above demonstrates that a product contains lead in excess of 0.5  
2 micrograms per serving size listed on the product's packaging (i.e., the concentration of lead in the  
3 product times the serving size in grams). Any warning statement provided under Paragraph 2.2  
4 shall identify cadmium if the product contains cadmium in excess of 4.1 micrograms per serving  
5 size (as listed on the product's packaging), and lead if the product contains lead in excess of 0.5  
6 micrograms per serving size (as listed on the product's packaging). The serving size shall not be  
7 changed from its current size unless agreed upon by both parties.

8       **3.6**     If test results indicate lead and/or cadmium content above the levels set forth in  
9 paragraph 3.5 above, As You Sow shall file a 60-day Notice of Violation with respect to that  
10 product ("Additionally Noticed Product(s)"). If the California Attorney General and public  
11 prosecutors do not pursue a case with regard to the Additionally Noticed Products, the Parties will  
12 amend this Consent Judgment to include the Additionally Noticed Products, and the Additionally  
13 Noticed Products will be deemed to be Covered Products under this Consent Judgment, including  
14 for purposes of the injunctive relief set forth in this Consent Judgment.

15       **3.7**     If this Consent Judgment is not amended to add Additionally Noticed Products  
16 pursuant to paragraph 3.6 within 90 days of the Effective Date of this Consent Judgment, the  
17 Consent Judgment will not be amended according to paragraph 3.6 and As You Sow will seek  
18 judicial approval of this Consent Judgment.

19 **4.     MONETARY RELIEF**

20       **4.1**     As reimbursement for As You Sow's attorneys' fees and costs and for civil penalties  
21 and additional settlement payments, Earth Circle agrees to make a total payment of \$65,960.00  
22 ("Total Monetary Relief") according to the following breakdown:

23       **4.2     Civil Penalties:** Earth Circle shall pay a total of \$11,500 as a civil penalty pursuant  
24 to California Health & Safety Code § 25249.12(c)(1) & (d), with 75% of the funds to be remitted to  
25 the California Office of Environmental Health Hazard Assessment by As You Sow.

26       **4.3     Additional Settlement Payment:** Earth Circle shall pay \$8,500 to be used by  
27 As You Sow for grants to California non-profit organizations and by the As You Sow  
28 Environmental Enforcement Fund. These funds shall be used to reduce or remediate exposures to

1 toxic chemicals and to increase consumer, worker, and community awareness of the health hazards  
2 posed by toxic chemicals in California. In deciding among grant proposals, the As You Sow Board  
3 of Directors ("Board") takes into consideration a number of important factors, including: (1) the  
4 nexus between the harm done in the underlying case(s) and the grant program work; (2) the  
5 potential for toxics reduction, prevention, remediation, or educational benefits to California citizens  
6 from the proposal; (3) the budget requirements of the proposed grantee and the alternate funding  
7 sources available to it for its project; and, (4) the Board's assessment of the proposed grantee's  
8 chances for success in its program work. As You Sow shall ensure that all funds will be disbursed  
9 and used in accordance with As You Sow's mission statement, articles of incorporation, bylaws,  
10 and applicable state and federal laws and regulations.

11 **4.4 Attorneys' Fees and Costs:** Earth Circle shall pay \$45,960 for attorneys' fees and  
12 costs.

13 **4.5 Schedule of Payment:** The funds set forth above shall be paid according to the  
14 following schedule and in the following form of payment, except that Earth Circle may accelerate  
15 any of these payments at any time if it so chooses:

16 a. \$21,480 within 60 days of the date the Court approves this Consent  
17 Judgment in the form of: one check made payable to As You Sow in the amount of \$20,000 and  
18 one check made payable to Altshuler Berzon in the amount of \$1,480.

19 b. \$11,480 within six (6) months of the date the Court approves this Consent  
20 Judgment in the form of: one check made payable to Altshuler Berzon in the amount of \$8,500 and  
21 one check made payable to Shute, Mihaly & Weinberger in the amount of \$6,480.

22 c. \$11,000 within twelve (12) months of the date the Court approves this  
23 Consent Judgment in the form of: one check made payable to Altshuler Berzon in the amount of  
24 \$5,500 and one check made payable to Shute, Mihaly & Weinberger in the amount of \$5,500.

25 d. \$11,000 within eighteen (18) months of the date the Court approves this  
26 Consent Judgment in the form of: one check made payable to Altshuler Berzon in the amount of  
27 \$5,500 and one check made payable to Shute, Mihaly & Weinberger in the amount of \$5,500.  
28



1 e. \$11,000 within twenty-four (24) months of the date the Court approves this  
2 Consent Judgment in the form of: one check made payable to Altshuler Berzon in the amount of  
3 \$5,500 and one check made payable to Shute, Mihaly & Weinberger in the amount of \$5,500.

4 **5. CLAIMS COVERED AND RELEASED**

5 **5.1 As You Sow's Release of Earth Circle**

6 As to cadmium and/or lead in the Covered Products, this Consent Judgment is a full, final,  
7 and binding resolution between Earth Circle and As You Sow, on behalf of itself and in the public  
8 interest, of any violation of Proposition 65 that was or could have been asserted by As You Sow,  
9 and its past and current agents, representatives, attorneys, successors and/or assignees, against  
10 Earth Circle, and each of its parents, subsidiaries, affiliated entities under common ownership,  
11 directors, officers, members, shareholders, equity holders, employees, and attorneys, for products  
12 sold before the date the Court enters this Consent Judgment.

13 Furthermore, this Consent Judgment is a full, final, and binding resolution between Earth  
14 Circle and each entity to whom Earth Circle directly or indirectly distributes or sells the Covered  
15 Products including, but not limited to, downstream distributors, wholesalers, customers, retailers,  
16 franchisees, cooperative members, and licensees, based on their failure to warn about alleged  
17 exposures to cadmium in Cacao Nibs and/or Dulse manufactured, imported, distributed, sold,  
18 and/or offered for sale by Earth Circle in California, for products sold before the Effective Date.

19 This release is not on behalf of the People of the State of California, per Cal. Code Regs. tit. 11, §  
20 3205(a)(1). **5.2 Earth Circle's Release of As You Sow**

21 Earth Circle and its past and current agents, representatives, attorneys, successors, and/or  
22 assignees hereby waive any and all claims against As You Sow and its parents, subsidiaries,  
23 officers, directors, employees, agents, insurers and representatives, and its successors and assigns  
24 ("As You Sow Releasees"), for any and all actions taken or statements made (or those that could  
25 have been taken or made) by As You Sow and its attorneys and other representatives, whether in  
26 the course of investigating Proposition 65 claims or seeking to enforce Proposition 65 against  
27 them in this matter or with respect to the Covered Products.

28 **6. SEVERABILITY**

1 If, subsequent to the execution of this Consent Judgment, any of the provisions of this  
2 Consent Judgment are deemed by a court to be unenforceable, the validity of the remaining  
3 enforceable provisions shall not be adversely affected.

4 **7. GOVERNING LAW**

5 The terms of this Consent Judgment shall be governed by the laws of the State of California  
6 and apply within the State of California. Nothing in this Consent Judgment shall be interpreted to  
7 relieve the Parties of any obligation to comply with any pertinent state or federal toxics control  
8 law.

9 **8. MODIFICATION**

10 This Consent Judgment may be modified only by a written agreement of the Parties.

11 **9. ENFORCEMENT OF CONSENT JUDGMENT**

12 No party may apply to the Court to enforce this Consent Judgment, unless that Party has  
13 first provided 30 days written notice (“Notice Period”) pursuant to Section 11 of this Consent  
14 Judgment to the other Party of any alleged violations of this Consent Judgment. Additionally, the  
15 Parties agree to meet and confer to resolve any alleged violations of this Consent Judgment during  
16 the 30-day notice period, and further agree not to apply to the Court to enforce this Consent  
17 Judgment until expiration of the Notice Period. If the prevailing party in any action enforcing this  
18 Consent Judgment seeks to recover its reasonable attorneys’ fees and costs, it shall do so under the  
19 provisions of Code of Civil Procedure §1021.5.

20 **10. DURATION OF CONSENT JUDGMENT**

21 This Consent Judgment shall terminate seven years after the Effective Date unless the term  
22 of this Consent Judgment is extended by agreement of the Parties.

23 **11. PROVISION OF NOTICE**

24 Unless specified herein, all correspondence, payments and notices required to be provided  
25 pursuant to this Consent Judgment shall be in writing and (i) personally delivered; (ii) sent by first-  
26 class registered or certified mail with return receipt requested; or (iii) sent by overnight courier, to  
27 one Party by the other Party at the following addresses:

5 understood, and agreed to all of the terms and conditions contained herein.


