

SETTLEMENT AGREEMENT BETWEEN ISABEL RUGGERI AND SAINTY INTERNATIONAL, LLC

1. RECITALS

1.1 This Settlement Agreement (“Agreement”) is entered into by and between Isabel Ruggeri (“Ruggeri”) and Sainty International, LLC (“Sainty”). Ruggeri and Sainty shall hereinafter collectively be referred to as the “Parties.”

1.2 Ruggeri is a citizen of the State of California with an interest in protecting the environment, improving human health and the health of ecosystems, and supporting environmentally sound practices, which includes promoting awareness of exposure to toxic chemicals and reducing exposure to hazardous substances found in consumer products.

1.3 Ruggeri alleges that Sainty manufactured, distributed, supplied, and/or sold tape measures, including but not limited to the “Tempest” tape measures (hereinafter, the “Products”) in the State of California causing users in California to be exposed to hazardous levels of lead without providing “clear and reasonable warnings”, in violation of Proposition 65. Lead is subject to Proposition 65 warning requirements because it is listed as known to cause birth defects and other reproductive harm.

1.4 On June 30, 2015, a Sixty-Day Notice of Violation (“60-Day Notice”), along with a Certificate of Merit, was provided by Ruggeri to Sainty and various public enforcement agencies regarding the alleged violation of Proposition 65 with respect to the Products.

1.5 Sainty denies all allegations in Ruggeri’s 60-Day Notice and maintains that Sainty has not violated Proposition 65. Sainty further alleges that it is exempt from the applicable Proposition 65 requirements. This Agreement shall not be construed as an admission of liability by Sainty but to the contrary as a compromise of claims that are expressly contested and denied. However, nothing in this section shall affect the Parties’ obligations, duties, and responsibilities under this Agreement.

1.6 The Parties enter into this Agreement in order to resolve the controversy described above in a manner consistent with prior Proposition 65 settlements and consent judgments that were entered on behalf of the public interest and to avoid prolonged and costly litigation between them.

1.7 The "Effective Date" shall be the date upon which a complete and fully executed copy of the Agreement is delivered to each Party's counsel.

2. INJUNCTIVE RELIEF

2.1 **Reformulation Standard**

As of the Effective Date, Sainty shall not distribute, supply, sell or offer for sale in California the Products if they contain more than 100 parts per million of lead in their accessible surfaces when analyzed pursuant to Environmental Protection Agency testing methodologies 3050B or equivalent. As of the Effective Date, if the Products do not meet this Reformulation Standard, then clear and reasonable Proposition 65 warnings must accompany each unit, as described below in paragraph 2.2.

2.2 **Proposition 65 Warnings**

If the Products do not meet the Reformulation Standard described above in paragraph 2.1, then Sainty shall not distribute, supply, sell or offer for sale in California the Products unless clear and reasonable Proposition 65 warnings are provided with each unit with the following warning with the capitalized and emboldened wording:

"WARNING: This product contains lead, a chemical known to the State of California to cause cancer and birth defects or other reproductive harm."

Each unit shall carry said warning directly on each unit or its label or package in a sufficiently conspicuous manner reasonably calculated to be seen by the ordinary consumer.

3. PAYMENTS

3.1 Civil Penalty Pursuant To Proposition 65

In settlement of all claims referred to in this Agreement, Sainty shall pay a total civil penalty of one thousand five hundred dollars (\$1,500.00) to be apportioned in accordance with *Health and Safety Code* section 25249.12(c)(1) and (d), with 75% (\$1,125.00) paid to State of California Office of Environmental Health Hazard Assessment (“OEHHA”), and the remaining 25% (\$375.00) paid to Ruggeri.

Sainty shall issue two (2) checks for the civil penalty: (1) a check or money order made payable to “Law Offices of Lucas T. Novak in Trust for OEHHA” in the amount of \$1,125.00; and (2) a check or money order made payable to “Law Offices of Lucas T. Novak in Trust for Isabel Ruggeri” in the amount of \$375.00. Sainty shall remit the payments within five (5) business days of the Effective Date, to:

3.2 Reimbursement Of Ruggeri’s Fees And Costs

Sainty shall reimburse Ruggeri’s reasonable experts’ and attorney’s fees and costs incurred in prosecuting the instant action, for all work performed through execution of this Agreement. Accordingly, Sainty shall issue a check or money order made payable to “Law Offices of Lucas T. Novak” in the amount of eight thousand five hundred dollars (\$8,500.00). Sainty shall remit the payment in three installments as follows: \$2, 833 on or before January 25, 2016; \$2833 on or before February 25, 2016; and, \$2834 on or before March 25, 2016, to:

4. RELEASES

4.1 Ruggeri's Release Of Sainty

Ruggeri, acting in her individual capacity, her past and current agents, representatives, attorneys, successors and assignees, in consideration of the promises and monetary payments contained herein, hereby releases Sainty, its parents, subsidiaries, shareholders, directors, members, officers, employees, attorneys, successors and assignees, as well as its downstream distributors, retailers, and franchisees (collectively "Released Parties"), from any alleged Proposition 65 violation claims asserted in Ruggeri's 60-Day Notice regarding the Products distributed, supplied, sold, and/or offered for sale by Sainty in California before and up to the Effective Date.

4.2 Sainty's Release Of Ruggeri

Sainty, its parents, subsidiaries, shareholders, directors, members, officers, employees, attorneys, successors and assignees, and on behalf of the Released Parties, by this Agreement, waive all rights to institute any form of legal action against Ruggeri, her past and current agents, representatives, attorneys, experts, successors and assignees, for actions or statements made or undertaken, whether in the course of investigating claims or seeking enforcement of Proposition 65 against Sainty in this matter.

4.3 Waiver Of Unknown Claims

Each of the Parties acknowledges that it is familiar with Section 1542 of California Civil Code which provides as follows:

"A general release does not extend to claims which the creditor does not know or suspect to exist in his or her favor at the time of executing the release, which if known by him or her must have materially affected his or her settlement with the debtor."

Each of the Parties waives and relinquishes any right or benefit it has or may have under Section 1542 of California Civil Code or any similar provision under the statutory

or non-statutory law of any other jurisdiction to the full extent that it may lawfully waive all such rights and benefits. The Parties acknowledge that each may subsequently discover facts in addition to, or different from, those that it believes to be true with respect to the claims released herein. The Parties agree that this Agreement and the releases contained herein shall be and remain effective in all respects notwithstanding the discovery of such additional or different facts.

5. SEVERABILITY

Should any part or provision of this Agreement for any reason be declared by a Court to be invalid, void or unenforceable, the remaining portions and provisions shall continue in full force and effect.

6. GOVERNING LAW

The terms of this Agreement shall be governed by the laws of the State of California.

7. NOTICES

All correspondence and notices required to be provided under this Agreement shall be in writing and delivered personally or sent by first class or certified mail addressed as follows:

Any photocopy of the executed Agreement shall have the same force and effect as the originals.
