INTRODUCTION 1.

The Parties 1.1

This Stipulation and [Proposed] Order Re Consent Judgment ("Consent Judgment") is hereby entered into by and between Kingpun Cheng acting on behalf of the public interest (hereinafter "Cheng") and Control Devices, LLC, (hereinafter "Control Devices" or 5 "Defendant"). Collectively Control Devices and Cheng shall be referred to hereafter as the 6 "Parties" and each of them as a "Party." Cheng is an individual residing in California who seeks 7 to promote awareness of exposures to toxic chemicals and improve human health by reducing or 8 eliminating hazardous substances contained in consumer products. Cheng alleges that Defendant 9 employs ten or more persons and is a person in the course of doing business for purposes of 10 Proposition 65, Cal. Health & Safety Code §§ 25249.6 et seq. 11

Allegations and Representations 1.2

Cheng alleges that Defendant has offered for sale in the State of California and has sold in 13 California plumbing parts, including brass float valves, which contain lead, and that such sales 14 have not been accompanied by Proposition 65 warnings. Lead is listed under Proposition 65 as a 15 chemical known to the State of California to cause cancer and birth defects or other reproductive 16 harm. Cheng has cited Control Devices' "Bob Float Valve B0080MGGZ4", hereafter ("Bob 17 Float Valve") as a specific example of products that are the subject of his allegations. 18

Covered Products Description 1.3

20 The products that are covered by this Consent Judgment are defined as all plumbing 21 related products and parts that are manufactured, sold, or distributed for sale in California by 22 Control Devices and/or Releasees (as defined in Section 5.1 below). All such items shall be 23 referred to herein as the "Covered Products." 24

Notices of Violation/Complaint 1.4

26 A) On or about July 21, 2015, Cheng served Control Devices, Amazon.com, Inc., and 27 various public enforcement agencies with a document entitled "60-Day Notice of Violation" 28

pursuant to Health & Safety Code §25249.7(d) (the "Notice"), alleging that Control Devices and
 Amazon.com were in violation of Proposition 65 for failing to warn consumers and customers
 that the Covered Products exposed users in California to listed chemicals. No public enforcer
 diligently prosecuted the claims threatened in the Notice within sixty days plus service time
 relative to the provision of the Notice to them by Cheng.

B) On June 6, 2016, Cheng, acting in the interest of the general public in the State of
California, filed a complaint in the Superior Court of San Diego County alleging violations of
Health & Safety Code §25249.6 (the "Complaint") based on the alleged failure to warn of
exposures to lead contained in Covered Products manufactured, distributed, or sold by Control
Devices.

1.5 <u>Stipulation as to Jurisdiction/No Admission</u>

For purposes of this Consent Judgment only, the Parties stipulate that this Court has jurisdiction over Defendant as to the allegations contained in the complaint filed in this matter, that venue is proper in the County of San Diego, and that this Court has jurisdiction to approve, enter, and oversee the enforcement of this Consent Judgment as a full and final binding resolution of all claims which were, or could have been, raised in the Complaint based on the facts alleged therein and/or in the Notices.

Defendant denies the material allegations contained in Cheng's Notice and Complaint.
Nothing in this Consent Judgment shall be construed as an admission by Defendant of any fact,
finding, issue of law, or violation of law; nor shall compliance with this Consent Judgment
constitute or be construed as an admission by Defendant of any fact, finding, conclusion, issue of
law, or violation of law, such being specifically denied by Defendant. However, this section shall
not diminish or otherwise affect the obligations, responsibilities, and duties of Defendant under
this Consent Judgment.

INJUNCTIVE RELIEF: PROPOSITION 65 WARNINGS

2.

Commitment to Warn

Commencing One Hundred and Eighty (180) days after the Effective Date, Control 10 Devices shall not ship, sell, or offer to sell in California a Covered Product(s) that is/are 11 manufactured, distributed or sold by Control Devices containing more than 300 parts per million 12 lead or without a warning as set forth in Section 2.2. Commencing One Hundred and Eighty 13 14 (180) days after the Effective Date in California, Covered Products manufactured, distributed or 15 sold by Control Devices, which contain more than 300 parts per million lead, shall include a warning as provided in Section 2.2.

> 2.2 Health Hazard Warning

Where required under Section 2.1 above, Control Devices shall provide a Proposition 65 warning, substantively, as follows:

WARNING: This product contains or produces a chemical known to the State of California to cause cancer and birth defects (or other reproductive harm). (California Health and Safety Code 25249.5 et seq.)

2.3 Placement of Health Hazard Warning

Defendant shall provide the warning language set forth in Section 2.2 either:

- With the unit package of the Covered Products, or affixed to the Covered Products. (a)
- Such warning shall be affixed to or printed on each Covered Product's label or package or the 28

Covered Product itself. If printed on the label, the warning shall be contained in the same section that states other safety warnings, if any, concerning the use of the Covered Product; Control Devices may continue to utilize, on an ongoing basis, unit packaging containing substantively the same Proposition 65 warnings as those set forth in Section 2.2 above, but only to the extent such packaging materials have already been printed within one hundred and eighty days of the Effective Date, or

In the owner's or operator's manual or instructions of another product in which the (b) Covered Product is a component, but only if the other product: (i) may cause serious injury or bodily harm unless used as directed; (ii) is sophisticated, difficult to understand or install, set-up, or assemble; or (iii) has one or more features a consumer must read about in order to know how to program or use the Covered Product. If the warning is given in the owner's or operator's manual or instructions pursuant to this subsection, it shall be located in one of the following places in the manual or instructions: the outside of the front cover; the inside of the front cover; the first page other than the cover; or the outside of the back cover. The warning shall be printed or stamped in the manual or instructions or contained in a durable label or sticker affixed to the manual or instructions in a font no smaller than the font used for other chemically-related safety warnings in the manual or instructions. Alternatively, the warning may be included in a safety warning section of the owner's or operator's manual or instructions. Control Devices may continue to utilize, on an ongoing basis, owner's or operator's manuals or instructions containing substantively the same Proposition 65 warnings and without the additional admonitions as those set forth in Section 2.2 above, but only to the extent such manuals or instructions have already been printed within one hundred and eighty days of the Effective Date. Owner's or operator's manual or instructions warnings may only be allowed if the owner's or operator's manual or

instructions is sold in the same package and at the same time as the other product and not for Covered Products sold separately, or

(c) Any other method reasonably calculated to provide a sufficient warning under Proposition 65, including but not limited to inclusion of a separate piece of paper containing the warning with each unit sold, and/or provision of a warning in an electronic format, which will appear when a consumer buys any Covered Product on an internet site or otherwise through electronic commerce, or

9 (d) At the point of retail sale, if the Covered Product is sold in a retail store or similar 10 establishment, i.e. by posting of Proposition 65 language on or near store shelving, or at or near 11 the entrance to the store.

The requirements for warnings set forth above are imposed pursuant to the terms of this Consent Judgment. The Parties recognize that these are not the exclusive methods of providing a warning under Proposition 65 and its implementing regulations and that they may or may not be appropriate in other circumstances.

2.4 Changes in Law Affecting Health Hazard Warnings

If Proposition 65 warnings for lead or lead compounds should no longer be required, Defendant and Releasees shall have no further warning obligations pursuant to this Consent Judgment. Except in the event that a change in the law requires modification or ceases to require such warnings in the event that Defendant or Releasees cease(s) to implement or substantively modifies the warnings required under this Consent Judgment, Defendant and Releasees shall provide written notice to Cheng (through counsel) of its intent to do so, and of the basis for its intent, no less than thirty (30) days in advance.

5. <u>RELEASE OF ALL CLAIMS</u>

5.1 Cheng's Release of Defendant, Releasees, and Downstream Releasees

5 As to those matters raised in the Complaint and in the Notice of Violation, Cheng, on 6 behalf of himself and on behalf of the public interest, hereby waives and releases any and all 7 claims against Defendant, its parent companies, corporate affiliates, subsidiaries, predecessors, successors and assigns (collectively "Releasees") and each of its suppliers, distributors, 8 9 wholesalers, licensors, licensees, auctioneers, retailers (including but not limited to 10 Amazon.com), franchisees, dealers, customers, owners, purchasers, users (collectively "Downstream Releasees") and their respective officers, directors, attorneys, representatives, 11 12 shareholders, agents, and employees, and sister and parent entities for injunctive relief or 13 damages, penalties, fines, sanctions, mitigation, fees (including fees of attorneys, experts, and 14 others), costs, expenses, or any other sum incurred or claimed, for the alleged failure of 15 Defendant, Releasees or Downstream Releasees to provide clear, accurate and reasonable 16 warnings under Proposition 65 and/or under Business and Professions Code §17200, et seq. about 17 exposure to any listed chemicals arising from the sale, distribution, or use of any Covered 18 Products sold, manufactured or distributed by Defendant, Releasees or Downstream Releasees in 19 California prior to One Hundred and Eighty (180) days after the Effective Date. Compliance with 20 the Consent Judgment by Defendant or a Release shall constitute compliance with Proposition 21 65 by all Defendants, Releasees, or Downstream Releasees with respect to the presence of listed 22 chemicals in the Covered Products as set forth in the Notice of Violation. Plaintiff agrees that 23 any and all claims in the Complaint are resolved with prejudice by this Consent Judgment.

In addition to the foregoing, Cheng, on behalf of himself, his past and current agents,
 representatives, attorneys, and successors and/or assignees, and <u>not</u> in his representative capacity,
 hereby waives all rights to institute or participate in, directly or indirectly, any form of legal
 action and releases any other Claims that he could make against Defendant, Releasees or

5.2 Defendant's Release of Cheng

matter, and/or with respect to the Covered Products.
