1 **1. INTRODUCTION**

2 **1.1 Parties**

3 This consent judgment (“**Consent Judgment**”) is entered into by and between plaintiff
4 Shefa LMV, Inc. (“**Shefa**” or “**Plaintiff**”) and Like Dreams, Inc., (“**Defendant**,” with Shefa and
5 **Defendant** individually referred to as a “**Party**” and collectively as the “**Parties.**”)

6 **1.2 Plaintiff**

7 Shefa is a public benefit, non-profit corporation that seeks to promote awareness of
8 exposures to toxic chemicals and to improve human health by reducing or eliminating hazardous
9 substances contained in consumer products.

10 **1.3 Settling Defendant**

11 Defendant employs ten (10) or more persons and is a person in the course of doing business
12 for purposes of the Safe Drinking Water and Toxic Enforcement Act of 1986, Health and Safety
13 Code §25249.6 *et seq.* (“**Proposition 65**”).

14 **1.4 Products Covered**

15 The products covered by this Consent Judgment are bags and purses that are made with a
16 plastic skin including, but not limited to the bags designed in the same style as H17101320,
17 H17110132, H17110130, E170904, which may appear in the colors silver, rose gold, clear plastic,
18 black, taupe, blush, white, blue, pink, red, gray, beige, multi-color, and multi-print, that are
19 manufactured, sold, or distributed for sale in California by Defendant that contain Diisononyl
20 Phthalate (“DINP”) (collectively, the “**Covered Products**”).

21 **1.5 General Allegations**

22 Shefa alleges that Defendant manufactures, imports, sells, or distributes, for sale in the state
23 of California, the Covered Products without first providing a clear and reasonable warning required
24 by Proposition 65. DINP (CAS # 28553-12-0) is a chemical listed under Proposition 65 as a
25 chemical known to the state to cause cancer.

26 **1.6 Notice of Violation**

27 On September 21, 2018 Shefa served Defendant and the requisite public enforcement
28

1 agencies with a 60-Day Notice of Violation (the “**Notice**”) alleging that Defendant violated
2 Proposition 65 when it failed to warn its customers and consumers in California that the Covered
3 Products expose users to DINP. To the best of the Parties’ knowledge, no public enforcer has
4 commenced and is diligently prosecuting the allegations set forth in the Notice.

5 **1.7 Complaint**

6 On May 6, 2019, Shefa filed the instant complaint in the Superior Court in and for the
7 County of Los Angeles against Defendant and DOES 1-100, alleging violations of California
8 Health & Safety Code § 25249.6, based on exposures to DINP contained in the Covered Products
9 sold in the State of California (the “**Complaint**”).

10 **1.8 No Admission**

11 Defendant denies the material, factual, and legal allegations contained in the Notice and
12 Complaint and maintains that all the products it has manufactured, sold, or distributed for sale in
13 California, including the Covered Products, have been, and are, in compliance with all laws.
14 Nothing in this Consent Judgment shall be construed as an admission by Defendant of any fact,
15 finding, conclusion of law, issue of law, or violation of law; nor shall compliance with this Consent
16 Judgment constitute or be construed as an admission by Defendant of any fact, finding, conclusion
17 of law, issue of law, or violation of law, the same being specifically denied by Defendant. This
18 section shall not, however, diminish or otherwise affect Defendant’s obligations, responsibilities,
19 and duties under this Consent Judgment.

20 **1.9 Consent to Jurisdiction**

21 For purposes of this Consent Judgment only, the Parties stipulate that this Court has
22 jurisdiction over Defendant as to the allegations in the Complaint, that venue is proper in the
23 County of Los Angeles, the Defendant agrees that they employs or have employed ten or more
24 persons during time periods relevant to the Complaint and that this Court has jurisdiction over the
25 Parties to enter and enforce the provisions of this Consent Judgment pursuant to Proposition 65.

26 **1.10 Effective Date**

27 For purposes of this Consent Judgment, the term “**Effective Date**” shall mean the date the
28

1 Consent Judgment is approved and entered by the Court.

2 **2. INJUNCTIVE RELIEF: COMPLIANT PRODUCTS AND WARNINGS**

3 **2.1 Reformulation Standards**

4 As of the Effective Date, Defendant shall not manufacture for sale in California any Covered
5 Products unless such Covered Products contain DINP in concentrations less than or equal to 1000
6 parts per million (“ppm”) when analyzed pursuant to U.S. Environmental Protection Agency testing
7 methodologies 3580A and 8270C or any other scientifically reliable methodology for determining
8 the concentration of DINP in the Covered Products, or alternatively Defendant shall provide
9 Proposition 65 warnings on the Covered Products.

10 **2.2 Warning Standards**

11 Defendant agrees, promises, and represents that, as of the Effective Date, to the extent they
12 ship or sell Covered Products that do not meet the reformulation standards set forth above in
13 Section 2.1, Defendant will provide warnings on such Covered Products that comply with
14 Proposition 65. The warnings shall be provided in a conspicuous and prominent manner such that
15 they will be likely to be read or seen by the consumer prior to or at the time of the sale or purchase.
16 The Parties agree that the warning set forth below shall constitute compliance with Proposition 65
17 with respect to any Covered Products that are not reformulated:

18 (a) the text, **“WARNING: This product can expose you to chemicals, including**
19 **Diisononyl Phthalate (DINP), which is known to the State of California to cause cancer.**
20 **For more information go to www.P65Warnings.ca.gov.”** accompanied by and placed to
21 the right of a symbol consisting of a black exclamation point in a yellow equilateral triangle
22 with a bold black outline sized to be no smaller than the word, “WARNING” as provided by
23 regulations adopted on or about August 30, 2016; or

25 (b) the text, **“WARNING: Cancer - www.P65Warnings.ca.gov.”** accompanied
26 by and placed to the right of a symbol consisting of a black exclamation point in a yellow
27 equilateral triangle with a bold black outline sized to be no smaller than the word,
28

1 “WARNING” as provided by regulations adopted on or about August 30, 2016.

2 The triangular warning symbol specified in Section 2.2(a) and 2.2(b) shall be in yellow with
3 a black exclamation mark; *provided however*, the symbol may be printed in black and white if the
4 Covered Product label is not printed against a yellow background.

5 **2.3 Covered Products in the Stream of Commerce.**

6 Any Covered Products that have been distributed, shipped, or sold by Defendant prior to the
7 Effective Date, shall not be subject to the requirements of Section 2.1.

8 **3. MONETARY SETTLEMENT TERMS**

9 **3.1 Payment from Defendant.** Within ten (10) business days of the Effective Date,
10 Defendant shall make the Total Settlement Payment of \$24,500.00.

11 **3.2 Allocation of Payments.** The Total Settlement Payment shall be paid in three (3)
12 separate checks made payable and allocated as follows:

13 **3.2.1 Civil Penalty.** Defendant shall pay \$3,000.00 as a civil penalty
14 pursuant to Health & Safety Code § 25249.7(b). The civil penalty shall be apportioned in
15 accordance with Health & Safety Code § 25249.12 (25% to Shefa and 75% to the State of
16 California’s Office of Environmental Health Hazard Assessment (“OEHHA”)). Accordingly, the
17 OEHHA portion of the civil penalty payment in the amount of \$2,250.00 shall be made payable to
18 OEHHA and associated with taxpayer identification number 68-0284486. This payment shall be
19 delivered as follows:

The Shefa portion of the civil penalty payment in the amount of \$750.00 shall be made payable to Shefa LMV, Inc. and associated with taxpayer identification number 81-0907002. This payment shall be delivered to the Law Office of Daniel N. Greenbaum, 7120 Hayvenhurst Ave, Suite 320, Van Nuys, CA 91406.

3.2.2 Attorney's Fees and Costs. A reimbursement of Shefa's attorney's fees and costs in the amount of \$21,500.00 payable to the "Law Office of Daniel N. Greenbaum," and associated with taxpayer identification number 46-4580172. This payment shall be delivered to the Law Office of Daniel N. Greenbaum, 7120 Hayvenhurst Ave, Suite 320, Van Nuys, CA 91406.

4. CLAIMS COVERED AND RELEASED

4.1 Public Release

This Consent Judgment is a full, final, and binding resolution between Shefa and Defendant of any violation of Proposition 65 that was or could have been asserted by Shefa, acting on behalf of itself and in a representative capacity in the public interest under Health & Safety Code § 25249.7, against Defendant, its parents, subsidiaries, affiliated entities, manufacturers, suppliers, directors, officers, employees, attorneys, and the predecessors, successors, or assigns of each of them, and each entity to whom Defendant directly or indirectly exports, distributes or sells the Covered Products, including, without limitation, distributors, wholesalers, customers, retailers, franchisees, cooperative members, and licensees, including but not limited to Ross Stores, Inc. and T.J. Maxx, ("**Releasees**"), based on failure to warn of alleged exposures to DINP from Covered Products manufactured, sold, or distributed for sale in California by Defendant prior to the Effective Date. The release in this Section 4.1 applies to all Covered Products that Defendant manufactured, distributed, or sold prior to the Effective Date, regardless of the date any other Releasee distributes or sells the Covered Products.

Compliance with the terms of this Consent Judgment shall constitute compliance with Proposition 65 by Defendant and the Releasees with respect to DINP in Covered Products

1 manufactured, sold, or distributed on and after the Effective Date.

2 **4.2 Shefa's Individual Release of Claims**

3 In further consideration of the promises and agreements herein contained, Shefa, on its own
4 behalf and on behalf of its past and current agents, representatives, attorneys, successors, and/or
5 assignees, hereby waives all rights to institute or participate in, directly or indirectly, any form of
6 legal action, and releases all claims that it may have against Defendant and Releasees, including,
7 without limitation, all actions and causes of action, suits, liabilities, demands, obligations, damages,
8 costs, fines, penalties, losses, or expenses, including, without limitation, investigation fees, expert
9 fees, and attorneys' fees arising under Proposition 65 for unwarned exposures to DINP from
10 Covered Products manufactured, sold, or distributed for sale by Defendant prior to the Effective
11 Date. The releases in Section 4.2 are provided in Shefa's individual capacity and are not releases on
12 behalf of the public.

13 **4.3 Defendant's Release of Shefa**

14 Defendant, on its own behalf and on behalf of its past and current agents, representatives,
15 attorneys, successors, and assignees, hereby waives any and all claims that it may have against
16 Shefa and its attorneys and other representatives, for any and all actions taken or statements made
17 by Shefa and its attorneys and other representatives in the course of investigating the claims set
18 forth in the Complaint or otherwise seeking to enforce Proposition 65 against it in this matter.

19 **4.4 Release of Unknown Claims**

20 It is possible that other claims not known to the Parties arising out of the facts contained in
21 the Notice, or alleged in the Complaint, relating to the Covered Products, will hereafter be
22 discovered or developed. Shefa, on behalf of itself only, acknowledges that this Consent Judgment
23 is expressly intended to cover and include all such claims through and including the Effective Date,
24 including all rights of action therefor. Shefa acknowledges that the claims released in Sections 4.1
25 and 4.2 may include unknown claims, and nevertheless Shefa intends to release such claims, and in
26 doing so waives California Civil Code § 1542, which reads as follows:

27 **A GENERAL RELEASE DOES NOT EXTEND TO CLAIMS WHICH THE**
28 **CREDITOR OR RELEASING PARTY DOES NOT KNOW OR SUSPECT TO**

1 **EXIST IN HIS OR HER FAVOR AT THE TIME OF EXECUTING THE RELEASE,**
2 **WHICH IF KNOWN BY HIM OR HER WOULD HAVE MATERIALLY**
3 **AFFECTED HIS OR HER SETTLEMENT WITH THE DEBTOR OR RELEASED**
4 **PARTY.**

5 Shefa understands and acknowledges that the significance and consequence of this waiver of
6 California Civil Code § 1542 is that, even if Shefa suffers future damages arising out of or resulting
7 from, or related directly or indirectly to, in whole or in part, the Covered Products, including but not
8 limited to any exposure to, or failure to warn with respect to exposure to, the Covered Products,
9 Shefa will not be able to make any claim for those damages against Defendant or any of the
10 Releasees.

11 **5. COURT APPROVAL**

12 This Consent Judgment is not effective until it is approved and entered by the Court.

13 **6. GOVERNING LAW**

14 The terms of this Consent Judgment shall be governed by the laws of the State of California
15 and apply within the State of California. In the event that Proposition 65 is repealed or is otherwise
16 rendered inapplicable by reason of law generally, or as to the Covered Products, then Defendant
17 may provide written notice to Shefa of any asserted change in the law, and with the exception of
18 Sections 3.1 and 3.2 above, have no further obligations pursuant to this Consent Judgment, with
19 respect to, and to the extent that, the Covered Products are so affected. None of the terms of this
20 Consent Judgment shall have any application to Covered Products sold outside of the State of
21 California.

22 **7. NOTICE**

23 Unless specified herein, all correspondence and notices required to be provided pursuant to
24 this Consent Judgment shall be in writing and sent by: (i) personal delivery; (ii) first-class,
25 registered or certified mail, return receipt requested; or (iii) a recognized overnight courier on any
26 Party by the other at the following addresses:

8. COUNTERPARTS; FACSIMILE AND PDF SIGNATURES

This Consent Judgment may be executed in counterparts, and by facsimile or portable document format (PDF) signature, each of which shall be deemed an original, and all of which, when taken together, shall constitute one and the same document.

9. COMPLIANCE WITH HEALTH & SAFETY CODE § 25249.7(f)

Plaintiff agrees to comply with the reporting form requirements referenced in California Health & Safety Code § 25249.7(f).

10. POST EXECUTION ACTIVITIES

The Parties acknowledge that, pursuant to California Health & Safety Code § 25249.7(f), Shefa is obligated to file a noticed motion to obtain judicial approval of this Consent Judgment. Upon the Parties' execution of this Consent Judgment, Shefa promptly shall proceed to submit this Consent Judgment to the Court with a motion seeking Court approval.

11. MODIFICATION

This Consent Judgment may only be modified by a written instrument executed by the Party or Parties to be bound thereby, and after approval by the Court upon a noticed motion. Any motion to modify shall be served on all Parties and the Office of the Attorney General.

12. DISPUTE RESOLUTION

If Shefa determines at a future date that a violation of this Consent Judgment has occurred,

1 Shefa shall provide notice to Defendant. Prior to bringing any action to enforce any requirement of
2 this Consent Judgment, the party alleging a violation of this Consent Judgment shall provide the
3 other party with written notice of the grounds for such allegation together with all supporting
4 information as well as a complete demand for the relief sought. The Parties shall then meet and
5 confer regarding the basis for the allegation to resolve the matter informally, including providing
6 the party alleged to be in violation with a reasonable opportunity of at least thirty (30) days to cure
7 any alleged violation. Should such attempt at informal resolution fail, the party alleging a violation
8 may file its lawsuit seeking the proposed relief.

9 **13. AUTHORIZATION**

10 The undersigned are authorized to execute this Consent Judgment on behalf of their
11 respective Parties and have read, understood, and agree to all of the terms and conditions of this
12 Consent Judgment.



3 Motion for Court Approval of Settlement Agreement and Entry of Consent Judgment as to Defendant Like
4 Dreams, Inc., came for hearing before this Court in Department 57, the Honorable Steven J. Kleifield
5 presiding. Counsel for Plaintiff did [not] appear; counsel for Defendant did [not] appear.

7 GRANTED Plaintiff's Motion pursuant to and in accordance with Health & Safety Code

11 Safety Code § 25249.7;

12 b. The reimbursement of fees and costs to be paid pursuant to the Settlement Agreement
13 is reasonable under California law; and

14 c. The civil penalty amount to be paid pursuant to Settlement Agreement is reasonable.
