#### SETTLEMENT AND RELEASE AGREEMENT

### 1. <u>INTRODUCTION</u>

## 1.1. Ecological Alliance, LLC and Fiskars Brands, Inc.

This Settlement Agreement is entered into by and between Ecological Alliance, LLC ("Ecological"), on the one hand, and Fiskars Brands, Inc. ("Fiskars"), parent company to Carolina Knife & Tool, on the other hand, with Ecological and Fiskars collectively referred to as the "Parties."

### 1.2. General Allegations

Ecological alleges that Fiskars manufactured and distributed and offered for sale in the State of California tool combo sets containing Di-n-butyl Phthalate ("DBP"), and that such sales have not included warnings pursuant to the Safe Drinking Water and Toxic Enforcement Act of 1986, California Health & Safety Code sections 25249.6 et seq. ("Proposition 65"). California has identified and listed DBP under Proposition 65 as a chemical known to the State of California to cause cancer, birth defects or other reproductive harm.

### 1.3. Product Description

The products that are covered by this Settlement Agreement are defined as tool combo sets that Fiskars has sold, offered for sale or distributed in California and that contain DBP. All such items shall be referred to herein as the "Products."

## 1.4. Notice of Violation

On June 17, 2019, Ecological served Carolina Knife & Tool, Fry's Electronics, Inc., and the requisite public enforcement agencies eligible to initiate Proposition 65 actions on behalf of the People of the State of California with a document entitled "60-Day Notice of Violation" ("Notice") that provided Fiskars and such public enforcers with notice that Fiskars, through its

subsidiary Carolina Knife & Tool, was allegedly in violation of California Health & Safety Code section 25249.6 for failing to warn consumers and customers that the Products exposed users in California to DBP. To the best of the Parties' knowledge, no public enforcer has commenced or is diligently prosecuting the allegations set forth in the Notice.

### 1.5. No Admission

The Parties enter into this Settlement Agreement to settle disputed claims between them as set forth herein and in the Notice concerning the Products' compliance with Proposition 65.

Fiskars denies the material factual and legal allegations contained in Ecological's Notice and maintains that all products that it has imported, manufactured for sale distribution or sold in California, including the Products, have been and are in compliance with Proposition 65 or any other statutory, regulatory, common law or equitable doctrine. Nothing in this Settlement Agreement shall be construed as an admission by Fiskars of any fact, finding, concession, issue of law, or violation of law; nor shall compliance with this Settlement Agreement constitute or be construed as an admission by Fiskars of any fact, finding, conclusion, issue of law, or violation of law, such being specifically denied by Fiskars on its behalf. However, nothing in this section shall diminish or otherwise affect the obligations, responsibilities, and duties of Fiskars under this Settlement Agreement.

#### 1.6. Effective Date

For purposes of this Settlement Agreement, the term "Effective Date" shall mean the date this Settlement Agreement is fully executed by the Parties.

### 2. <u>INJUNCTIVE RELIEF: REFORMULATION AND WARNINGS</u>

As of the Effective Date, Fiskars shall manufacture, import, or otherwise source for authorized sale in California only Reformulated Products, as defined pursuant to Section 2.1

below, unless such Products are labeled with a clear and reasonable Proposition 65 warning pursuant to Section 2.2 below. Products that were supplied by Fiskars prior to the Effective Date shall be deemed exempted from the requirements of this Section 2 and shall be permitted to be sold through as previously manufactured, packaged and labeled.

## 2.1. Reformulation Standards

"Reformulated Products" are defined as the Accessible Components (meaning any component of the Products that could be touched by a person during reasonably foreseeable use) of those Products containing DBP in concentrations of 0.1 percent (1,000 parts per million) or less when analyzed pursuant to U.S. Environmental Protection Agency testing methodologies 3580A and 8270C or any other methodology utilized by federal or state agencies for the purpose of determining the DBP content in a solid substance.

# 2.2. Warning Language

A Proposition 65 warning is not required on the Products that were supplied by Fiskars prior to the Effective Date of this Settlement Agreement. Such Products shall be permitted to be sold through as previously manufactured, packaged and labeled.

Where required, Fiskars shall provide Proposition 65 warnings on the Product's label as follows:

- (a) Fiskars may use either of the following warning statements in full compliance with this Section:
  - (1) **WARNING**: This product can expose you to chemicals including DBP, which are known to the State of California to cause cancer, birth defects or other reproductive harm. For more information go to <a href="https://www.P65Warnings.ca.gov">www.P65Warnings.ca.gov</a>

- (2) WARNING: Cancer and Reproductive Harm www.P65Warnings.ca.gov.
- (b) If Fiskars uses either of the above warning statements to effectuate its compliance, it shall also include a symbol consisting of a black exclamation point in a yellow equilateral triangle with a bold black outline. Where the label is otherwise not printed using the color yellow, the symbol may be printed in black and white. The symbol shall be placed to the left of the text of the warning, in a size no smaller than the height of the word "WARNING."
- (c) The requirements for warnings, set forth in subsection (a) above are imposed pursuant to the terms of this Settlement Agreement. The Parties recognize that these are not the exclusive methods of providing a warning under Proposition 65 and its implementing regulations.
- (d) If Proposition 65 warnings for DBP should no longer be required, Fiskars shall have no further obligations pursuant to this Settlement Agreement.

## 3. <u>COMPLIANCE WITH SETTLEMENT TERMS.</u>

The Parties agree that compliance with the terms of this Settlement Agreement by Fiskars shall be deemed to be compliance with Proposition 65 by all Releasees with respect to any exposures to DBP in the Products manufactured, distributed, or sold by Fiskars after the Effective Date of the Settlement Agreement.

# 4. PENALTIES PURSUANT TO HEALTH & SAFETY CODE SECTION 25249.7(b)

In settlement of all the claims referred to in this Settlement Agreement and in accordance with Section 6 below, Fiskars shall pay a total of \$500 in civil penalties in accordance with this Section. The penalty payment will be allocated in accordance with California Health & Safety

Code section 25249.12(c)(1) & (d), with 75% of the funds (\$375) remitted to the California

Office of Environmental Health Hazard Assessment ("OEHHA") and the remaining 25% of the

penalty (\$125) remitted to Ecological. Payment shall be made by wire as set forth in Section 6,

and Ecological's counsel shall be responsible for delivering OEHHA's portion of any penalty

payment made under this Settlement Agreement to OEHHA.

5. REIMBURSEMENT OF FEES AND COSTS

The Parties reached an accord on the compensation due to Ecological and its counsel

under the private attorney general doctrine and principles of contract law. Under these legal

principles, Fiskars shall reimburse Ecological's counsel for fees and costs, incurred as a result of

investigating and bringing this matter to Fiskars' attention. As set forth in Section 6 below,

Fiskars shall pay, via wire, Ecological's counsel \$18,000 for all attorneys' fees, expert and

investigation fees, and related costs associated with this matter and the Notice.

6. PAYMENT INFORMATION

Within ten (10) businesses days following the Effective Date, Fiskars shall make a total

payment of Eighteen Thousand Five Hundred Dollars (\$18,500) for all civil penalties and

attorney's fees / costs as required by Sections 4 and 5 above by wire transfer to Plaintiff's counsel

Other than this payment, each side is to bear its own attorneys' fees and costs.

## 7. RELEASE OF ALL CLAIMS

### 7.1. Release of Fiskars, Downstream Customers and Upstream Vendors

In further consideration of the promises and agreements herein contained, and for the payments to be made pursuant to Sections 4 and 5 above, Ecological, on behalf of itself, its past and current agents, representatives, attorneys, successors and/or assignees, hereby waives all rights to institute or participate in, directly or indirectly, any form of legal action and releases all claims relating to the Products, including, without limitation, all actions, and causes of action, in law or in equity, suits, liabilities, demands, obligations, damages, costs, fines, penalties, losses or expenses (including, but not limited to, investigation fees, expert fees and attorneys' fees) of any nature whatsoever, whether known or unknown, fixed or contingent (collectively "Claims"), against (a) Fiskars, (b) each of Fiskars' downstream distributors, wholesalers, vendors, licensors, licensees, auctioneers, retailers, franchisees, dealers, shareholders, cooperative members, customers, owners, purchasers, and users, (c) Fry's Electronics, Inc., and their corporate affiliates, subsidiaries, and each of their officers, directors, attorneys, representatives, shareholders, agents, employees, and sister and parent entities, and (d) Fiskars' parent companies, corporate affiliates, subsidiaries, and their respective officers, directors, attorneys, representatives, shareholders, agents, and employees, and sister and parent entities (collectively "Releasees").

Ecological also, on behalf of itself, its past and current agents, representatives, attorneys, successors, and/or assignees and *not* in its representative capacity, provides a general release herein which shall be effective as a full and final accord and satisfaction, as a bar to all actions, causes of action, obligations, costs, expenses, attorneys' fees, damages, losses, claims, liabilities and demands of any nature, character or kind, known or unknown, suspected or unsuspected,

against Fiskars and the Releasees. Ecological acknowledges that it is familiar with California Civil Code section 1542, which provides as follows:

A GENERAL RELEASE DOES NOT EXTEND TO CLAIMS THAT THE CREDITOR OR RELEASING PARTY DOES NOT KNOW OR SUSPECT TO EXIST IN HIS OR HER FAVOR AT THE TIME OF EXECUTING THE RELEASE AND THAT, IF KNOWN BY HIM OR HER, WOULD HAVE MATERIALLY AFFECTED HIS OR HER SETTLEMENT WITH THE DEBTOR OR RELEASED PARTY.

Ecological, in its capacity only, and on behalf of itself, its past and current agents, representatives, attorneys, successors, and/or assignees expressly waives and relinquishes any and all rights and benefits which it may have under, or which may be conferred on it by the provisions of California Civil Code section 1542 as well as under any other state or federal statute or common law principle of similar effect, to the fullest extent that it may lawfully waive such rights or benefits pertaining to the released matters.

### 7.2. Fiskars' Release of Ecological

Fiskars waives any and all claims against Ecological, its attorneys and other representatives, for any and all actions taken or statements made (or those that could have been taken or made) by Ecological and its attorneys and other representatives, whether in the course of investigating claims or otherwise seeking enforcement of Proposition 65 against it in this matter, and/or with respect to the Products.

#### 8. GOVERNING LAW

The terms of this Settlement Agreement shall be governed by the laws of the State of California and apply within the State of California. In the event that Proposition 65 is repealed or is otherwise rendered inapplicable by reason of law generally, or as to the Products, then Fiskars shall have no further obligations pursuant to this Settlement Agreement.

# 9. <u>NOTICES</u>

Unless specified herein, all correspondence and notices required to be provided pursuant to this Settlement Agreement shall be in writing and personally delivered or sent by: (i) first-class, (registered or certified mail) return receipt requested; or (ii) overnight courier on any party by the other party at the following addresses:

# 10. COUNTERPARTS; FACSIMILE/E-SIGNATURES

This Settlement Agreement may be executed in counterparts and by facsimile or esignatures, each of which shall be deemed an original, and all of which, when taken together, shall constitute one and the same document.

### 11. COMPLIANCE WITH HEALTH & SAFETY CODE SECTION 25249.7(f)

Ecological agrees to comply with the reporting form requirements referenced in California Health & Safety Code § 25249.7(f).

#### 12. ENTIRE AGREEMENT

This Settlement Agreement contains the sole and entire agreement and understanding of the Parties with respect to the entire subject matter hereof, and all related prior discussions, negotiations, commitments and understandings. No other agreements, oral or otherwise, exist to bind either of the Parties.

# 13. MODIFICATION

This Settlement Agreement may be modified only by a written agreement signed by the Parties.

# 14. <u>AUTHORIZATION</u>

The undersigned are authorized to execute this Settlement Agreement on behalf of their respective Parties and have read, understood and agree to all of the terms and conditions of this Settlement Agreement.
