

**SETTLEMENT AGREEMENT BETWEEN APS&EE, LLC AND MSC  
INDUSTRIAL SUPPLY CO.**

**1. RECITALS**

**1.1 The Parties**

**1.1.1** This Settlement Agreement (“Agreement”) is entered into by and between APS&EE, LLC (“APS&EE”) and MSC Industrial Supply Co. (“MSC”). APS&EE and MSC shall hereinafter collectively be referred to as the “Parties”.

**1.1.2** APS&EE represents that it is an organization based in California with an interest in protecting the environment, improving human health and the health of ecosystems, and supporting environmentally sound practices, which includes promoting awareness of exposure to toxic chemicals and reducing exposure to hazardous substances found in consumer products.

**1.1.3** APS&EE alleges that MSC is a person in the course of doing business as the term is defined in California *Health & Safety Code* section 25249.6 et seq. (“Proposition 65”).

**1.2 Allegations**

**1.2.1** APS&EE alleges that MSC distributed, sold or made available for sale in the State of California MSC Anchor Bolts manufactured, distributed or sold by Edward W. Daniel, LLC, Lindstrom Metric, Inc., Lindstrom, LLC, LindFast Solutions Group, and Metric Enterprises, Inc., including Eye Bolt, Gibraltar, ½-5”, and Hex Head bolt, Value Collection, ¾-10, and listed in Exhibit A, attached to and included as part of this Agreement (hereinafter, the “Product(s)”), causing users in California to be exposed to hazardous levels of lead without providing “clear and reasonable warnings”, in violation of Proposition 65. Lead is potentially subject to Proposition 65 warning requirements because it is listed under that statute as known to the State of California to cause cancer and birth defects or other reproductive harm.

**1.2.2** On January 17, 2020, APS&EE alleges that it served a Sixty-Day Notice of Violation (“60-Day Notice”), along with a Certificate of Merit, to MSC, MSC Industrial Direct Co., Inc., and the various public enforcement agencies regarding the alleged violation of Proposition 65 with respect to the Products.

**1.3 No Admissions**

MSC denies all allegations in APS&EE’s 60-Day Notice and maintains that the Products have been, and are, in compliance with all laws, and that MSC has not violated Proposition 65. This Agreement shall not be construed as an admission of liability by MSC but to the contrary as a compromise of claims that are expressly contested and denied. However, nothing in this section shall affect the Parties’ obligations, duties, and responsibilities under this Agreement.

**1.4 Compromise**

The Parties enter into this Agreement in order to resolve the controversy described above in a manner consistent with prior Proposition 65 settlements and consent judgments that were entered on behalf of the public interest and to avoid prolonged and costly litigation between them.

**1.5 Effective Date**

The “Effective Date” shall be the date upon which a complete and fully executed copy of the Agreement is delivered to each Party’s counsel.

**2. INJUNCTIVE RELIEF**

**2.1 Reformulation Standard**

Within sixty (60) days of the Effective Date, MSC shall not distribute, sell or offer for sale the Products in California unless (a) the galvanizing solution in which the Products are submerged contains no more than 100 parts per million (0.01%) of Lead (“Reformulated Product”), or (b) the Product is distributed, sold, or offered for sale with a clear and reasonable warning as described below in Section 2.2.

## **2.2 Proposition 65 Warnings**

Whenever a clear and reasonable warning is required under Section 2.1, MSC shall use a warning with the capitalized and emboldened wording substantially similar to the following:

**WARNING:** This product can expose you to Lead, which is known to the State of California to cause cancer and birth defects or other reproductive harm. For more information go to [www.P65Warnings.ca.gov](http://www.P65Warnings.ca.gov)

OR

**WARNING:** Cancer and Reproductive Harm.  
[www.P65Warnings.ca.gov](http://www.P65Warnings.ca.gov)

The warning shall be accompanied by a symbol consisting of a black exclamation point in a yellow equilateral triangle with a bold black outline. Where the label for the product is not printed using the color yellow, the symbol may be printed in black and white. The symbol shall be placed to the left of the text of the warning, in a size no smaller than the height of the word “WARNING”.

The Products shall carry said warning directly on each unit, label, or package with such conspicuousness as compared with other words, statements or designs as to render it likely to be read and understood by an ordinary consumer prior to sale. A Product that is sold by MSC on the internet to persons located in California shall also provide the warning message by a clearly marked hyperlink on the product display page, or otherwise prominently displayed to the purchaser before the purchaser completes his or her purchase of the Product.

## **2.3 Sell-through for Existing Inventory**

The injunctive requirements of Section 2 shall not apply to any Products in MSC’s inventory on or before the Effective Date, which Products are subject to the releases provided in Section 4.1.

### **3. PAYMENTS**

#### **3.1 Civil Penalty Pursuant To Proposition 65**

In settlement of all claims referred to in this Agreement, MSC shall pay a total civil penalty of one thousand five hundred dollars (\$1,500) to be apportioned in accordance with *Health and Safety Code* section 25249.12(c)(1) and (d), with 75% (\$1,125) for State of California Office of Environmental Health Hazard Assessment (“OEHHA”), and the remaining 25% (\$375) for APS&EE.

MSC shall cause to be issued on its behalf two (2) checks for the civil penalty: (1) a check or money order made payable to “OEHHA” in the amount of \$1,125; and (2) a check or money order made payable to “Law Offices of Lucas T. Novak” in the amount of \$375. MSC shall have the payments remitted within ten (10) business days of the Effective Date, to:

#### **3.2 Reimbursement Of APS&EE’s Fees And Costs**

MSC shall reimburse APS&EE’s reasonable experts’ and attorney’s fees and costs incurred in prosecuting the instant action, for all work performed through execution of this Agreement. Accordingly, MSC shall cause to be issued on its behalf a check or money order made payable to “Law Offices of Lucas T. Novak” in the amount of fifteen thousand dollars (\$15,000). MSC shall have the payment remitted within ten (10) business days of the Effective Date, to:

#### **4. RELEASES**

##### **4.1 APS&EE's Release Of MSC**

APS&EE, in consideration of the promises and monetary payments contained herein, hereby releases MSC, its parents, subsidiaries, shareholders, directors, members, officers, employees, attorneys, successors and assignees, as well as its upstream and downstream suppliers, manufacturers, wholesalers, distributors, retailers, and franchisees, including but not limited to, MSC Industrial Direct Co., Inc., Edward W. Daniel, LLC, Lindstrom Metric, Inc., Lindstrom, LLC, LindFast Solutions Group, and Metric Enterprises, Inc. (collectively "Released Parties"), from any alleged Proposition 65 violation claims asserted in APS&EE's Notice regarding failure to warn about Lead exposure from the Products that MSC or MSC Industrial Direct Co. Inc. has sold, caused to be sold, and/or offered for sale in California before and up to sixty (60) days after the Effective Date.

##### **4.2 MSC's Release Of APS&EE**

MSC, and on behalf of the Released Parties, by this Agreement, waives all rights to institute any form of legal action against APS&EE, its shareholders, directors, members, officers, employees, attorneys, experts, successors and assignees for actions or statements made or undertaken, whether in the course of investigating claims or seeking enforcement of Proposition 65 against MSC relating to the Products in this matter.

##### **4.3 Waiver Of Unknown Claims**

Each of the Parties acknowledges that it is familiar with Section 1542 of California Civil Code, which provides as follows:

A GENERAL RELEASE DOES NOT EXTEND TO CLAIMS THAT THE CREDITOR OR RELEASING PARTY DOES NOT KNOW OR SUSPECT TO EXIST IN HIS OR HER FAVOR AT THE TIME OF EXECUTING THE RELEASE AND THAT, IF KNOWN BY HIM OR HER, WOULD HAVE MATERIALLY AFFECTED HIS OR HER SETTLEMENT WITH THE DEBTOR OR RELEASED PARTY.

Each of the Parties waives and relinquishes any right or benefit it has or may have under Section 1542 of California Civil Code or any similar provision under the statutory or non-statutory law of any other jurisdiction to the full extent that it may lawfully waive all such rights and benefits. The Parties acknowledge that each may subsequently discover facts in addition to, or different from, those that it believes to be true with respect to the claims released herein. The Parties agree that this Agreement and the releases contained herein shall be and remain effective in all respects notwithstanding the discovery of such additional or different facts.

**5. SEVERABILITY**

Should any part or provision of this Agreement for any reason be declared by a Court to be invalid, void or unenforceable, the remaining portions and provisions shall continue in full force and effect.

**6. GOVERNING LAW**

The terms of this Agreement shall be governed by the laws of the State of California. In the event that Proposition 65 is repealed, preempted, or is otherwise rendered inapplicable by reason of law generally, or as to the Products, then MSC shall have no further obligations pursuant to this Agreement.

**7. NOTICES**

All correspondence and notices required to be provided under this Agreement shall be in writing and delivered personally or sent by first class or certified mail addressed as follows:
