**[PROPOSED] CONSENT JUDGMENT**

(Health & Safety Code § 25249.6, *et seq.* and  
Code of Civil Procedure § 664.6)

1 **1. INTRODUCTION**

2 **1.1 Parties**

3 This Consent Judgment is entered into by and between plaintiff Paul Wozniak (Wozniak)  
4 and defendant Etsy, Inc. (Etsy), with Wozniak and Etsy each referred to individually as a “Party”  
5 and collectively as the “Parties.”

6 **1.2 Plaintiff**

7 Wozniak is a resident of the State of California who seeks to promote awareness of  
8 exposures to toxic chemicals, and to improve human health by reducing or eliminating harmful  
9 substances contained in consumer products.

10 **1.3 Defendant**

11 Etsy employs ten or more persons. Further, for the purposes of this litigation only, Plaintiff  
12 alleges that Etsy is a person in the course of doing business for purposes of the Safe Drinking  
13 Water and Toxic Enforcement Act of 1986, California Health & Safety Code § 25249.5, *et seq.*  
14 (Proposition 65).

15 **1.4 General Allegations**

16 Wozniak alleges that Etsy imports, sells and/or distributes for sale in California certain toy  
17 figurines, solder wire, fishing sinkers and ingots, and that it does so without providing the health  
18 hazard warning that Wozniak alleges is required by Proposition 65. Lead is listed pursuant to  
19 Proposition 65 as a chemical known to the State of California to cause birth defects and other  
20 reproductive harm.

21 **1.5 Product Description**

22 The products covered by this Consent Judgment are limited to the toy figurines, solder  
23 wire, fishing sinkers (including fishing sinkers/weights sold as part of tackle boxes kits or sets)  
24 and ingots that contain lead and are offered for sale on etsy.com as set forth specifically on  
25 **Exhibit A** (hereinafter referred to as the “Product” or “Products”).

26 **1.6 Notices of Violation**

27 On June 15, 2021, Wozniak alleges that he served Etsy and requisite public enforcement  
28 agencies with several 60-Day Notices of Violation (Notices), alleging that Etsy violated

1 Proposition 65 when it failed to warn its customers or other consumers in California that toy  
2 figurines, solder wire, fishing sinkers and ingots expose users to lead. To the best of the Parties'  
3 knowledge, no public enforcer has commenced and is diligently prosecuting the allegations set  
4 forth in the Notices.

5 **1.7 Complaint**

6 On September, 7, 2021, Wozniak commenced the instant action (Complaint), naming Etsy  
7 as the only named defendant for the alleged violations of Proposition 65. On November 12, 2021,  
8 Etsy filed an answer to the Complaint.

9 **1.8 No Admission**

10 Etsy denies all material, factual and legal allegations contained in the Notices and  
11 maintains that all Products that were sold and distributed in California have been and are in  
12 compliance with all laws and further contends that it has no obligations under Proposition 65 to  
13 provide warnings on any third party sellers' Products. Etsy asserts that it is not a retailer and has  
14 no retail location in California or anywhere in the world. Nothing in this Consent Judgment shall  
15 be construed as an admission by Etsy of any fact, finding, issue of law or violation of law; nor  
16 shall compliance with this Consent Judgment constitute or be construed as an admission by Etsy  
17 of any fact, finding, conclusion, issue of law or violation of law. This Section 1.8 shall not,  
18 however, diminish or otherwise affect the obligations, responsibilities, and duties under this  
19 Consent Judgment.

20 **1.9 Jurisdiction**

21 For purposes of this Consent Judgment only, the Parties stipulate that this Court has  
22 jurisdiction over Etsy as to the allegations contained in the Complaint, that venue is proper in the  
23 County of San Francisco, and that the Court has jurisdiction to enter and enforce the provisions of  
24 this Consent Judgment pursuant to law including Proposition 65 and Code of Civil Procedure §  
25 664.6.

1           **1.10 Effective and Compliance Dates**

2           For purposes of this Consent Judgment, the term “Effective Date” shall mean the date this  
3           Consent Judgment is entered by the Court. For purposes of this Consent Judgment, the term  
4           “Compliance Date” shall mean 90 calendar days after the Effective Date.

5           **2. INJUNCTIVE RELIEF: REFORMULATION OR WARNINGS**

6           **2.1 Injunctive Relief**

7           Pursuant to the terms set forth below, with respect to Products sold in California, Etsy, at  
8           its option, agrees to either: (a) require suppliers and vendors to provide only Reformulated  
9           Products; (b) require its suppliers and vendors of Products sold on etsy.com to provide clear and  
10          reasonable Proposition 65 warnings for the Products as set forth in Section 2.3, below; or (c) cease  
11          selling the Products to consumers in California, and/or delist the Products offered for sale from  
12          etsy.com as set forth in Section 2.4. The Parties understand and agree that some Products may  
13          appear on etsy.com that contain no warning, but are not available for sale to California consumers  
14          (sales cannot be completed) and that this complies with Section 2.1(c) above.

15          **2.2 Reformulation Standards**

16          A “Reformulated Product” (a) contains lead in concentrations that do not exceed 90 parts  
17          per million, equivalent to 0.009%, in any exterior parts analyzed pursuant to U.S. Environmental  
18          Protection Agency (EPA) methodologies 3050B and 6010B, or (b) yields a result of no more than  
19          1.0 micrograms of lead when sampled according to NIOSH 9100 protocol and analyzed according  
20          to EPA 6010B. In addition to the above tests, Etsy may use equivalent methods utilized by any  
21          California or federal agency to determine lead content in a solid substance.

22          **2.3 Clear and Reasonable Warnings (Products Sold Online)**

23          Each warning shall be prominently placed with such conspicuousness as compared with  
24          other words, statements, designs, or devices as to render it likely to be read and understood by an  
25          ordinary individual under customary conditions of purchase or use.

26                  **(a) Warning.** The warning shall consist of the following or statement  
27          (Warning):  
28

1                   **⚠ WARNING:** This product can expose you to chemicals including lead, which  
2                   is known to the State of California to cause birth defects or other  
3                   reproductive harm. For more information go to  
4                   www.P65Warnings.ca.gov.

5                   or

6                   **⚠ WARNING:** This product can expose you to chemicals including lead, which  
7                   is known to the State of California to cause cancer and birth  
8                   defects or other reproductive harm. For more information go to  
9                   www.P65Warnings.ca.gov.

10                   **(b) Short-Form Warning.** Etsy and its online suppliers and vendors selling  
11                   Products on etsy.com, may use the following short-form warning as set forth in this Section 2.3  
12                   (Short-Form Warning) so long as it is allowed under Proposition 65’s implementing regulations:

13                   **⚠ WARNING:** Reproductive Harm – www.P65Warnings.ca.gov

14                   or

15                   **⚠ WARNING:** Cancer and Reproductive Harm – [www.P65Warnings.ca.gov](http://www.P65Warnings.ca.gov)

16                   If any of the Products are offered for sale on etsy.com to California consumers after the  
17                   Compliance Date, such Product listings shall contain a warning (as set forth above) which is  
18                   displayed to the purchaser prior to completion of the transaction without requiring the potential  
19                   buyer to use considerable effort to be made aware of the health hazard advisory. The warning (or a  
20                   clearly and reasonably marked hyperlink to the warning using the signal word “**⚠ Warning**” or “  
21                   **⚠ Product Warning**”) given in conjunction with the online sale of the Products may appear  
22                   either: (a) prominently placed on the page in which the Product’s image, price and add-to-cart are  
23                   displayed; (b) on the same page as the order confirmation for the Products (e.g., review cart URL);  
24                   or (c) on the page displayed to the purchaser during the checkout process for any shipment  
25                   recipient with a California address.

## 26                   **2.4 Option to Delist**

27                   On or before the Compliance Date, Etsy may, at its option, comply with the injunctive  
28                   commitments set forth in Section 2.3 above by delisting a Product such that the item is then  
unavailable for online sale for shipment to an address in California. If it does so, the previously

delisted Product may be reinstated for sale online to California consumers if it complies with Sections 2.1 through 2.3 prior to the date of such relisting.

## **2.5 Right to Cure**

As of the time of this Consent Judgment, neither Wozniak nor his counsel have any specific knowledge of the presence of any other products sold on the site operated by Etsy that, in their opinion, fail to comply with Proposition 65's warning requirement. Wozniak represents and warrants neither he nor his agents or attorneys have assigned or otherwise transferred, or attempted to assign, or transfer, any claim or claims against Etsy. Wozniak further warrants that neither he nor his agents or attorneys are aware of any other potential private enforcer or attorney who intends to bring litigation based on the subject matter of the Consent Judgment.

To the extent Wozniak identifies any product in the future, whether or not subject to this Consent Judgment, which he believes is not in compliance with Proposition 65 or this Consent Judgment, Wozniak agrees to advise Etsy of such potential violation in the manner set forth in Section 8, and provide Etsy with 45 calendar days (calculated from the date notice is provided electronically) to cure any alleged violation, provide a Proposition 65 warning, or take other action to ensure that the product is not sold in California. Such notice to Etsy shall contain information sufficient for Etsy to identify the product and the product's supplier such as the Etsy I.D. Number, the Product SKU number, the name of the Product, and/or the supplier of the product as well as a screenshot of the product's online listing. If the alleged non-compliance is cured, Wozniak shall take no further action to enforce Proposition 65 or this Consent Judgment with respect to the alleged failure to comply with Proposition 65 or the terms of this Consent Judgment, and the matter shall be deemed to be resolved. Further, so long as Etsy cures the alleged non-compliance relating to a Product subject to this Consent Judgment within the 45 days, Etsy shall not be in breach or violation of this Consent Judgment in any respect. In the event Wozniak advises Etsy of any alleged non-compliant product as discussed herein, Wozniak shall not be entitled to financial remuneration, provided Etsy timely remedies the non-compliant product as discussed herein.

1 **3. MONETARY SETTLEMENT TERMS**

2 **3.1 Civil Penalty Payments**

3 Pursuant to California Health & Safety Code § 25249.7(b), and in settlement of all claims  
4 referred to in the Notices, Complaint, and this Consent Judgment, Etsy agrees to pay \$20,000 in  
5 civil penalties. Etsy's civil penalty payment will be allocated according to California Health &  
6 Safety Code § 25249.12(c)(1) and (d), with seventy-five percent (75%) of the penalty paid to the  
7 California Office of Environmental Health Hazard Assessment (OEHHA), and the remaining  
8 twenty-five percent (25%) of the penalty payment retained by Wozniak. Etsy shall issue its  
9 payment in two checks made payable to (a) "OEHHA" in the amount of \$15,000; and (b) "Paul  
10 Wozniak" in the amount of \$5,000. Wozniak's counsel shall send the portions of the penalties  
11 paid by Etsy to OEHHA and Wozniak.

12 **3.2 Reimbursement of Attorneys' Fees and Costs**

13 The Parties acknowledge that Wozniak and his counsel offered to resolve this dispute  
14 without reaching terms on their fees and costs and allowing this provision to be adjudicated by the  
15 court. Shortly after the other settlement terms had been finalized, the Parties then negotiated the  
16 reasonable compensation to be paid to Wozniak's counsel under general contract principles,  
17 Proposition 65 and the private attorney general doctrine codified at California Code of Civil  
18 Procedure § 1021.5 for all work performed through the mutual execution of this Consent  
19 Judgment and court approval of the same, but exclusive of fees and costs on appeal, if any. Etsy  
20 agrees to pay \$90,000 by a check made payable to "Chanler, LLC" for all fees and costs incurred  
21 in investigating, bringing this matter to Etsy's attention, litigating, and negotiating a settlement in  
22 the public interest.

23 **3.3 Payment Timing; Payments Held in Trust**

24 Etsy shall deliver its civil penalty and attorneys' fee reimbursement payments to its counsel  
25 within thirty (30) days of the date that this Consent Judgment is fully executed by the Parties, and  
26 Etsy receives a current W-9 from Plaintiff, Chanler LLC, and OEHHA, whichever date is later.  
27 Etsy's counsel shall provide Wozniak's counsel with written confirmation within three (3) days of  
28 its receipt of the settlement funds. The checks due under Sections 3.1 and 3.2 of this Consent

Judgment shall be delivered to Wozniak's counsel to the address in Section 3.4 by overnight courier, with a tracking number, such that payment is received by plaintiff's counsel on or before five (5) days after the Effective Date.

## **4. CLAIMS COVERED AND RELEASED**

### **4.1 Wozniak's Release of Proposition 65 Claims**

Wozniak, acting on his own behalf and in the public interest, releases Etsy and its direct and indirect subsidiaries, affiliated entities under common ownership, directors, officers, employees, and attorneys (collectively, Releasees) and each entity to whom Etsy directly or indirectly distributes or sells the Products including, but not limited to, its downstream distributors, wholesalers, customers, retailers, franchisers, cooperative members, licensors and licensees (collectively, Downstream Releasees) for any violations arising under Proposition 65 for unwarned exposures to lead from the Products manufactured, imported, distributed or sold by any seller on etsy.com prior to the Compliance Date which shall also be effective as a full and final accord and satisfaction, as a bar to all actions, causes of action, obligations, costs, expenses, attorneys' fees, damages, losses, claims, liabilities and demands of Wozniak, arising out of alleged or actual exposures to lead in Products manufactured, imported, distributed or sold by Etsy before the Compliance Date. Compliance with the terms of this Consent Judgment constitutes compliance with Proposition 65 by Etsy with respect to the alleged or actual failure to warn about exposures to lead from the Products.

### **4.2 Etsy's Release of Wozniak**

Etsy, on its own behalf and on behalf of its past and current agents, representatives, attorneys, successors and/or assignees, hereby waive any and all claims against Wozniak and his



1 attorneys and other representatives, for any and all actions taken or statements made (or those that  
2 could have been taken or made) by Wozniak and his attorneys and other representatives in the  
3 course of investigating claims, seeking to enforce Proposition 65 against it in this matter, or with  
4 respect to the Products.

5 **5. COURT APPROVAL**

6 This Consent Judgment shall be null and void if, for any reason, it is not approved and  
7 entered by the Court within one year after it has been fully executed by all Parties. Wozniak and  
8 Etsy agree to support the entry of this agreement as a judgment, and to obtain the Court's approval  
9 of their settlement in an expedited manner as allowed by law. The Parties acknowledge that,  
10 pursuant to California Health & Safety Code § 25249.7(f)(4), a noticed motion is required for  
11 judicial approval of this Consent Judgment. In furtherance of obtaining such approval, the Parties  
12 agree to mutually employ their best efforts, and those of their counsel, to support the entry of this  
13 agreement as a judgment, and to obtain judicial approval of their settlement in a timely manner.  
14 For purposes of this section, "best efforts" shall include, at a minimum, supporting the motion for  
15 approval, assist in drafting as needed, jointly requesting the Court to have the motion heard on  
16 shortened time as allowed, responding to any objection that any third-party may file or lodge, and  
17 appearing at the hearing before the Court if so requested.

18 **6. SEVERABILITY**

19 If, subsequent to the Court's approval and entry of this Consent Judgment as a judgment,  
20 any provision of this Consent Judgment is held by a court to be unenforceable, the validity of the  
21 remaining provisions shall not be adversely affected.

22 **7. GOVERNING LAW**

23 The terms of this Consent Judgment shall be governed by the laws of the State of California  
24 and apply within the State of California. In the event that Proposition 65 is repealed, preempted,  
25 or is otherwise rendered inapplicable by reason of law generally, or as to the Products, then Etsy  
26 may provide Wozniak with written notice of any asserted change in the law, and shall have no  
27 further injunctive obligations pursuant to this Consent Judgment, with respect to, and to the extent  
28 that, the Products are affected by such a change in the law. Nothing in this Consent Judgment

1 shall be interpreted to relieve Etsy from its obligation to comply with any pertinent state or federal  
2 law or regulation.

3 The Parties agree that if the Office of Environmental Health Hazard Assessment (OEHHA)  
4 changes its warning regulations, then the Settling Entity may either conform with the revised  
5 regulations or continue to conform with the terms provided in this Consent Judgment if the new  
6 implementing regulations so allow.

7 **8. NOTICE**

8 Unless specified herein, all correspondence and notice required or permitted by this  
9 Consent Judgment shall be in writing and sent by: (a) personal delivery; (b) first-class registered  
10 or certified mail, return receipt requested; or (c) a recognized overnight courier to any Party by the
