## PROPOSITION 65 SETTLEMENT AGREEMENT

## 1. INTRODUCTION

#### 1.1 The Parties

This Settlement Agreement ("Agreement") is entered into by and between Keep America Safe and Beautiful ("KASB") and Lodge Manufacturing Company and Lodge Cast Iron (collectively, "Lodge"), with KASB and Lodge each individually referred to as a "Party" and, collectively, the "Parties." KASB is a California-based non-profit organization proceeding in the public interest pursuant to California Health & Safety Code § 25249.7(d) to ensure that chemicals known to the State of California to cause cancer, birth defects or other reproductive harm are disclosed in or eliminated from consumer products sold in California. KASB alleges Lodge is a person in the course of doing business for purposes of California Health & Safety Code § 25249.11(b).

## 1.2 Consumer Product Description

KASB alleges that Lodge manufactures, imports, sells and distributes for sale in California kitchen tools containing Bisphenol A ("BPA") including, but not limited to, *Lodge Polycarbonate Red and Black Pan Scraper*, *Set of 4, UPC 0 75536 05030 0, ASIN B00JFGLJ3C*, without providing the health hazard warning that KASB alleges is required by California Health & Safety Code § 25249.5 *et seq.* ("Proposition 65"). Kitchen tools are referred to hereinafter as the "Products." BPA is listed pursuant to Proposition 65 as a chemical known to the State of California to cause developmental and female reproductive toxicity.

## 1.3 Notice of Violation

On July 9, 2021, KASB served Lodge, the California Attorney General, and the requisite public enforcement agencies with a 60-Day Notice of Violation ("Notice"), alleging Lodge violated Proposition 65 by failing to warn its customers and consumers in California that its Products can expose users to BPA. No public enforcer has commenced and is diligently prosecuting an action to enforce the allegations in the Notice.

#### 1.4 No Admission

Lodge denies the factual and legal allegations contained in the Notice and maintains that all products it has sold or distributed for sale in California, including the Products, have been, and are, in compliance with all laws. Nothing in this Agreement shall constitute or be construed as, nor shall compliance with this Agreement constitute or be construed as, an admission by Lodge of any fact, finding, conclusion of law, issue of law, or violation of law. This section shall not, however, diminish or otherwise affect Lodge's obligations, responsibilities, and duties under this Agreement.

#### 1.5 Effective Date

For purposes of this Agreement, "**Effective Date**" shall mean the date this Agreement is fully executed by all Parties.

#### 2. INJUNCTIVE RELIEF: REFORMULATION AND INTERIM WARNINGS

#### 2.1 Reformulation Commitment

Commencing by January 15, 2023, and continuing thereafter, all Products Lodge manufactures, imports, sells, ships, or distributes for sale in or into California, directly or through one or more third party retailers or e-commerce marketplaces, shall meet the Reformulation Standard for either BPA-Free Products or Reformulated Products, as defined by Section 2.2. In the interim, commencing on the Effective Date, all Products that are not BPA-Free Products or Reformulated Products which are distributed, shipped, sold, and offered for sale in or into California that have not already left the possession of Lodge must be accompanied by a clear and reasonable warning pursuant to Section 2.3.

#### 2.2 Reformulation Standards

Commencing by January 15, 2023, Lodge agrees all Products it manufactures, imports, ships, or distributes for sale in or into California shall meet the Reformulation Standard for either BPA-Free Products or Reformulated Products in compliance with this Section. For purposes of this Agreement, "BPA-Free Products" are defined as Products containing no detectable amount of BPA when analyzed pursuant to ATS 367 Rev. 0 by LC/MS/MS, or other

methodologies utilized by federal or state government agencies to determine BPA content in a solid substance, by a laboratory accredited by the State of California, a federal agency, or a nationally recognized accrediting organization ("Accredited Laboratory"). Many BPA-free polycarbonate ("PC") replacement products leach chemicals having significant level of estrogenic activity ("EA"). As such, for purposes of this Agreement, "Reformulated Products" are defined as Products containing no detectable amount of Bisphenol S ("BPS"), Bisphenol F ("BPF"), and Bisphenol ("BPAF") when analyzed pursuant to ATS 367 Rev. 0 by LC/MS/MS, or other methodologies utilized by federal or state government agencies to determine BPS, BPF, and BPAF content in a solid substance, by a laboratory accredited by an Accredited Laboratory.

# 2.3 Clear and Reasonable Warnings

Commencing on or before the Effective Date, Lodge shall provide clear and reasonable warnings for all Products that are not BPA-Free or Reformulated Products provided for sale to customers in California in accordance with this Section pursuant to Title 27 California Code of Regulations § 25600, et seq. Each warning shall be prominently placed with such conspicuousness as compared with other words, statements, or designs as to render it likely to be read and understood by an ordinary individual under customary conditions before purchase or use and shall be provided in a manner such that it is clearly associated with the specific Product to which the warning applies.

- (a) Warning. The Warning shall consist of the following statement:
- ▲ WARNING: This product can expose you to BPA, which is known to the State of California to cause birth defect and other reproductive harm. For more information go to www.P65Warnings.ca.gov.
- (b) Short-Form Warning. Lodge may, but is not required to, use the following short-form warning as set forth in this subsection 2.3(b) ("Short-Form Warning") as follows:

**△WARNING**: Reproductive Harm - www.P65Warnings.ca.gov.

- (c) Foreign Language Requirement. Where a consumer product sign, label or shelf tag used to provide a warning includes consumer information in language(s) other than English, the warning must also be provided in the other language(s) in addition to English.
- (d) On-Product Warnings. If, after the Effective Date, Lodge sells Products that are neither BPA-Free Products nor Reformulated Products, Lodge shall affix a warning to the Product label or otherwise directly on Products provided for sale to consumers located in California and to customers with retail outlets in California or nationwide distribution. For the purpose of this agreement, "Product label" means a display of written, printed or graphic material printed on or affixed to each of the Products or its immediate container or wrapper. A warning provided pursuant to section 2.3(a) or (b) must print the word "WARNING:" in all capital letters and in bold font. The warning symbol to the left of the word "WARNING:" must be a black exclamation point in a yellow equilateral triangle with a black outline, except if the labeling does not use the color yellow, the symbol may be in black and white. The entire warning shall appear in at least 6-point type and no smaller than the largest type size used for other consumer information on the Products.
- (e) Internet Warnings. If, after the Effective Date, Lodge sells Products that are neither BPA-Free Products nor Reformulated Products via the internet, through its own website, affiliated websites or a third party website, to consumers located in California or to customers with nationwide distribution and e-commerce websites, Lodge shall provide warnings for each Product both on the Product label in accordance with Section 2.3(d), and by prominently displaying, or requiring the warning to be prominently displayed on affiliated websites, third party websites or by retail customers, to the consumer during the purchase of the Products without requiring customers to seek out the warning. The warning or a clearly marked hyperlink to the warning using the word "WARNING" given in conjunction with the sale of the Products via the internet shall appear either: (a) on the same web page on which the Products; (c) on the same displayed; (b) on the same web page as the virtual cart displaying the Products; (c) on the same

page as the price for the Products; or (d) on one or more web pages displayed to a purchaser during the checkout process. The warning shall appear in any of the above instances adjacent to or immediately following the display, description, or price of the Products for which it is given in the same type size or larger than other consumer information provided for the Products. The internet warning may use the Short-Form Warning content described in Section 2.3(b) if the warning provided on the Product label also uses the Short-Form Warning content.

#### 2.4 Customer Notification.

No later than the Effective Date, Lodge shall send a letter, electronic or otherwise ("Notification Letter") to: (1) each retailer or distributor in California to which it supplied Products between July 9, 2020 and July 9, 2021; and (2) any other retailer or distributor that Lodge reasonably understands or believes has any inventory of Products, which Lodge supplied between July 9, 2018 and July 9, 2021, for sale to consumers in California. The Notification Letter shall advise the recipient that the Products contain BPA, a chemical known to the State of California to cause developmental and female reproductive toxicity. The Notification letter shall inform the recipient that all Products must have a label attached to the packaging of each Product expressly referring to the Product, which contains one of the warning statements in Section 2.3 (a) or Section 2.3 (b), before it is sold in the California market or to a customer in California.

## 3. MONETARY SETTLEMENT TERMS

#### 3.1 Civil Penalty

Pursuant to Health and Safety Code § 25249.7(b), Lodge agrees to pay a civil penalty of \$9,000 within five (5) business days of the Effective Date. Lodge's civil penalty payment will be allocated according to Health and Safety Code §§ 25249.12(c)(1) and (d), with seventy-five percent (75%) of the penalty paid to the California Office of Environmental Health Hazard Assessment ("**OEHHA**"), and the remaining twenty-five percent (25%) retained by KASB. Lodge shall issue its payment in two checks made payable to: (a) "OEHHA" in the amount of

\$6,750; and (b) "Keep America Safe and Beautiful" in the amount of \$2,250. KASB's counsel shall deliver to OEHHA and KASB their respective portion of the penalty payment.

## 3.2 Certification to Compliance with Reformulation Standard

On or before January 15, 2023, an officer of Lodge shall provide Seven Hills LLP with a written attested declaration stating, as of January 15, 2023, and continuing thereafter, any and all Products manufactured or imported by Lodge for sale to (a) consumers in California directly including through its own website, affiliated websites or a third party website, to consumers located in California, and (b) customers with nationwide distribution and e-commerce websites, are BPA-Free or Reformulated Products as defined by Section 2.2. Along with its attested declaration, Lodge shall provide a recent test result performed after the date of the Notice, showing the Products were tested and analyzed according to the parameters set forth in the preceding Section 2.2 and are BPA-Free or Reformulated Products. Failure to comply with this section shall render this agreement null and void.

# 3.3 Reimbursement of Attorneys' Fees and Costs

KASB and its counsel offered to resolve the allegations in the Notice without reaching terms on the amount of reimbursement of attorneys' fees and costs. Shortly after the Parties finalized the other material settlement terms, they negotiated and reached an accord on the amount of reimbursement to be paid to KASB's counsel, under general contract principles and the private attorney general doctrine, codified at California Code of Civil Procedure § 1021.5, for all work performed through the mutual execution and reporting of this Agreement to the Office of the California Attorney General. Within five (5) days of the Effective Date, Lodge agrees to issue a check in the amount of \$24,000 payable to "Seven Hills LLP" for all fees and costs incurred investigating, bringing this matter to Lodge's attention, negotiating a settlement in the public interest, and reporting its terms to Office of the California Attorney General pursuant to Section 9.

## 4. CLAIMS COVERED AND RELEASED

#### 4.1 KASB's Release of Lodge

This Agreement is a full, final and binding resolution between KASB, as an individual and *not* on behalf of the public, and Lodge, of any violation of Proposition 65 that was or could have been asserted by KASB on behalf of itself, its past and current agents, representatives, attorneys, successors, and/or assignees, against Lodge, its parents, subsidiaries, affiliated entities under common ownership including: directors, officers, employees, attorneys, and each entity to whom Lodge directly or indirectly distributes or sells Products, including, but not limited, to downstream distributors, wholesalers, customers, retailers, franchisees, cooperative members, and licensees (collectively, "Releasees"), based on their failure to warn about alleged exposures to BPA contained in the Products that were manufactured, distributed, sold and/or offered for sale by Lodge in California before the Effective Date, as alleged in the Notice.

In further consideration of the promises and agreements herein contained, KASB as an individual and *not* on behalf of the public, on behalf of itself, its past and current agents, representatives, attorneys, successors, and/or assignees, hereby waives all of KASB's rights to institute or participate in, directly or indirectly, any form of legal action and releases all claims that KASB may have, including, without limitation, all actions, and causes of action, in law or in equity, suits, liabilities, demands, obligations, damages, costs, fines, penalties, losses, or expenses including, but not exclusively, investigation fees, expert fees, and attorneys' fees arising under Proposition 65 with respect to BPA in the Products manufactured, distributed, sold

and/or offered for sale by Lodge, before the Effective Date (collectively, "Claims"), against Lodge and Releasees.

The Parties further understand and agree that this Section 4.1 release shall not extend upstream to any entities that manufactured the Products or any component parts thereof, or any distributors or suppliers who sold the Products or any component parts thereof to Lodge.

Nothing in this Section affects KASB's right to commence or prosecute an action under Proposition 65 against a Releasee that does not involve Lodge's Products.

#### 4.2 Lodge's Release of KASB

Lodge, on behalf of itself, its past and current agents, representatives, attorneys, successors, and assignees, hereby waives any and all claims against KASB and its attorneys and other representatives, for any and all actions taken or statements made (or those that could have been taken or made) by KASB and its attorneys and other representatives, whether in the course of investigating claims or otherwise seeking to enforce Proposition 65 against it in this matter with respect to the Products.

## 5. <u>SEVERABILITY</u>

If, subsequent to the execution of this Agreement, any provision of this Agreement is deemed by a court to be unenforceable, the validity of the remaining provisions shall not be adversely affected.

#### 6. GOVERNING LAW

The terms of this Agreement shall be governed by the laws of the State of California and apply within California. In the event that Proposition 65 is repealed, preempted, or is otherwise rendered inapplicable by reason of law generally, or as to the Products, then Lodge may provide KASB with written notice of any asserted change in the law, and shall have no further injunctive obligations pursuant to this Agreement, with respect to, and to the extent that, the Products are so affected. Nothing in this Agreement shall be interpreted to relieve Lodge from its obligation to comply with any pertinent state or federal law or regulation.

Unless specified herein, all correspondence and notice required by this Agreement shall be in writing and sent by email and either (i) first-class registered or certified mail, return receipt requested; or (ii) a recognized overnight courier to any Party by the other at the following addresses:

# 9. <u>COMPLIANCE WITH REPORTING REQUIREMENTS</u>

KASB and its counsel agree to comply with the reporting form requirements referenced in California Health and Safety Code § 25249.7(f).

## 10. ENTIRE AGREEMENT

This Agreement contains the sole and entire agreement and understanding of the Parties with respect to the entire subject matter hereof, and any and all prior discussions, negotiations,

commitments, or understandings related thereto, if any, are hereby merged herein and therein. There are no warranties, representations, or other agreements between the Parties except as expressly set forth herein. No representations, oral or otherwise, express or implied, other than those specifically referred to in this Agreement have been made by any Party hereto. No other agreements not specifically contained or referenced herein, oral or otherwise, shall be deemed to exist or to bind any of the Parties hereto.

# 11. MODIFICATION

This Agreement may be modified only by a written agreement of the Parties.

# 12. <u>AUTHORIZATION</u>

The undersigned are authorized to execute this Agreement on behalf of their respective Parties and have read, understood, and agreed to all of the terms and conditions of this Agreement.
