# SETTLEMENT AGREEMENT

### 1. INTRODUCTION

### 1.1 Parties

This Settlement Agreement is entered into by and between Dennis Johnson ("Johnson") and Home Essentials & Beyond, Inc., ("Home Essentials"), with Johnson and Home Essentials each individually referred to as a "Party" and collectively as the "Parties." Johnson is an individual residing in the State of California who seeks to promote awareness of exposures to toxic chemicals and to improve human health by reducing or eliminating hazardous substances used in consumer products. Johnson alleges that Home Essentials is a person in the course of doing business for purposes of the Safe Drinking Water and Toxic Enforcement Act of 1986, California Health and Safety Code section 25249.6 et seq. ("Proposition 65").

### 1.2 General Allegations

Johnson alleges that Home Essentials manufactures, sells, and distributes for sale in California, glassware with exterior decorations containing lead. Lead is listed pursuant to Proposition 65 as a chemical known to cause birth defects and other reproductive harm. Johnson alleges that Home Essentials failed to provide the health hazard warning required by Proposition 65 for exposures to lead.

# 1.3 Product Description

The products covered by this Settlement Agreement are specifically defined as, and limited to: (i) *Pour Me Something Strong "Margaritaville" Stemless*Wine Glass; UPC: 7 86460 08033 1; (ii) Livin' My Life In Flop Flops "Margaritaville" Stemless Wine Glass; UPC: 7 86460 08033 1; and (iii) At Home "Every Cork Tells a Story" Stemless Wine Glass; UPC: 7 86460 00751 2; that are manufactured, sold, or distributed for sale in California by Home Essentials (hereinafter referred to collectively as "Products").

### 1.4 Notices of Violation

On December 9, 2020, Johnson served Big Lots Stores, Inc. ("Big Lots") and the requisite public enforcement agencies with a 60-Day Notice of Violation, alleging that it violated Proposition 65 when they failed to warn its customers and consumers in California of the health hazards associated with exposures to lead from the *At Home* "Every Cork Tells a Story" Stemless Wine Glass.

On September 24, 2021, Johnson served At Home Group, Inc., At Home Procurement Inc., At Home Stores, LLC (collectively "At Home") and the requisite public enforcement agencies with a 60-Day Notice of Violation, alleging that they violated Proposition 65 when they failed to warn their customers and consumers in California of the health hazards associated with exposures to lead from the "Margaritaville" products.

The December 9, 2020 and September 24, 2021 Notices of Violation shall hereinafter be referred to as the "Notices."

Home Essentials was thereafter identified as the manufacturer/supplier of the Products, and indicated its desire to resolve certain claims and allegations contained in the Notices. No public enforcer has commenced and is diligently prosecuting the allegations set forth in the Notices.

### 1.5 No Admission

Home Essentials denies the material, factual, and legal allegations contained in the Notices and maintains that all of the products that it has sold and distributed in California, including the Products, have been, and are, in compliance with all laws. Nothing in this Settlement Agreement shall be construed as an admission by Home Essentials of any fact, finding, conclusion, issue of law, or violation of law, nor shall compliance with this Settlement Agreement constitute or be construed as an admission by Home Essentials of any fact, finding, conclusion, issue of law, or violation of law, such being specifically denied by Home Essentials. This Section shall not, however, diminish

or otherwise affect Home Essentials' obligations, responsibilities, and duties under this Settlement Agreement.

### 1.6 Effective Date

For purposes of this Settlement Agreement, the term "Effective Date" shall mean March 28, 2022.

### 2. INJUNCTIVE RELIEF

#### 2.1 Reformulation Standards

"Reformulated Products" are defined as those Products that: (a) contain no more than 90 parts per million ("ppm") lead in any decoration, colored artwork, designs and/or marking on the surface of the Products when analyzed pursuant to U.S. Environmental Protection Agency testing methodologies 3050B or equivalent methodologies utilized by federal or state agencies for the purpose of determining lead content in a solid substance; (b) yield no more than 1.0 microgram of lead on any surface sampled and analyzed pursuant to the NIOSH 9100 testing protocol; and (c) yield a result of non-detect (defined as no more than 25 ppm by weight of lead) for any decorations located in the upper 20 millimeters of a Product, i.e., the "Lip-and-Rim" area when analyzed pursuant to EPA testing methodologies 3050B and 6010B, or equivalent methodologies used by state and federal agencies to determine lead content in a solid substance.

If the decoration is tested after it is affixed to the Product, the percentage of the lead by weight must related only to the decorating materials and must not include any quantity attributable to non-decorating material (e.g., ceramic substrate).

# 2.2 Reformulation/Warning Commitment

As of the Effective Date, Home Essentials shall not manufacture, import, distribute, sell or offer the Products for sale in the State of California unless they are Reformulated Products pursuant to Section 2.1 or bear a warning pursuant to Section 2.3.

### 2.3 Warnings

As of the Effective Date, all Products Home Essentials sells and/or distributes for sale in California that do not qualify as Reformulated Products, shall bear a clear and reasonable warning pursuant to this Section. Home Essentials further agrees that the warning will be prominently placed with such conspicuousness when compared with other words, statements, designs or devices as to render it likely to be read and understood by an ordinary individual under customary conditions of purchase or use. For purposes of this Consent Judgment, a clear and reasonable warning for the Products shall contain one of the following statements:

⚠ **WARNING**: Reproductive Harm- www.P65Warnings.ca.gov

OR

MARNING: This product can expose you to chemicals including lead, which is known to the State of California to cause birth defects or other reproductive harm. For more information go to <a href="https://www.P65Warnings.ca.gov">www.P65Warnings.ca.gov</a>

# 2.4 Point of Sale and Internet Warnings

The warning requirements of Section 2.3 shall also be satisfied if Home Essentials or its retailers, including but not limited to Big Lots, provides warnings to Customers at the point-of-sale. Customers purchasing Products directly from California retail stores shall receive the Proposition 65 warning via register display and on customers' printed receipts.

If Home Essentials or its retailers including, but not limited to Big Lots, sells Products via their own proprietary internet website to customers located in California, the warning requirements of this section, and Section 2.3, shall be satisfied if the foregoing warning appears either: (a) on the same web page on which a Product is displayed and/or described; (b) on the same page as the price for the Product; (c) on one or more web pages displayed to a California purchaser prior to completion of the checkout process; or (d) via the "product details" section of the Product page. Alternatively, a symbol consisting of a black exclamation point in a yellow or white equilateral triangle may appear adjacent to or

immediately following the display, description, price, or checkout listing of the Product, if the warning statement appears elsewhere on the same web page in a manner that clearly associates it with the product(s) to which the warning applies.

### 3. MONETARY SETTLEMENT TERMS

# 3.1 Civil Penalty Payment

Pursuant to Health and Safety Code section 25249.7(b)(2), and as consideration for the releases contained in Sections 4.1 and 4.2 below, Home Essentials agrees to pay \$2,000 in civil penalties no later than the Effective Date. The penalty payment will be allocated in accordance with California Health and Safety Code section 25249.12(c)(1) & (d), with 75% of the penalty amount remitted to the California Office of Environmental Health Hazard Assessment ("OEHHA") and the remaining 25% of the penalty amount paid to Johnson and delivered to the address in Section 3.3 herein. Home Essentials will provide its payment in two checks as follows: (1) "OEHHA" in the amount of \$1,500; and (2) "Dennis Johnson" in the amount of \$500.

### 3.2 Attorneys' Fees and Costs

The Parties acknowledge that Johnson and his counsel offered to resolve this dispute without reaching terms on the amount of fees and costs to be reimbursed to them, thereby leaving the issue to be resolved after the material terms of the agreement had been settled. Shortly after the other settlement terms had been reached, Home Essentials expressed a desire to resolve the attorney's fees and costs. The Parties reached an accord on the compensation due to Johnson's counsel under general contract principles and the private attorney general doctrine codified at Code of Civil Procedure section 1021.5 for all work performed in this matter. Under these legal principles, on or before the Effective Date, Home Essentials agrees to pay \$21,000, in the form of a check made payable to "Voorhees & Bailey, LLP," for all fees and costs incurred investigating, bringing this matter to the attention of Home Essentials' management, and negotiating a settlement.

# 4. CLAIMS COVERED AND RELEASED

# 4.1 Johnson's Release of Proposition 65 Claims

Johnson acting on his own behalf, and not on behalf of the public, releases Home Essentials, its parents, subsidiaries, affiliated entities under common ownership, directors, officers, agents employees, attorneys, and each entity to whom Home Essentials directly or indirectly distributes or sells Products, including, but not limited to, downstream distributors, wholesalers, customers, retailers including, but not limited to Big Lots and At Home and Burlington Stores, Inc., franchisees, cooperative members, and licensees (collectively, "Releasees"), from all claims for violations of Proposition 65 through the Effective Date based on unwarned exposures to lead in the Products. The Parties further understand and agree that this Section 4.1 release shall not extend upstream to any entities that manufactured the Products or any component parts thereof, or any distributors or suppliers who sold the Products or any component parts thereof to Home Essentials.

### 4.2 Johnson's Individual Release of Claims

Johnson, in his individual capacity only and not in his representative capacity, provides a release herein which shall be effective as a full and final accord and satisfaction, as a bar to all actions, causes of action, obligations, costs, expenses, attorneys' fees, damages, losses, claims, liabilities, and demands of Johnson of any nature, character, or kind, whether known or unknown, suspected or unsuspected, limited to and arising out of alleged or actual exposures to lead in the Products manufactured,

imported, distributed, or sold by Home Essentials prior to the Effective Date. The Parties further understand and agree that this Section 4.2 release shall not extend upstream to any entities that manufactured the Products, or any component parts thereof, or any distributors or suppliers who sold the Products, or any component parts thereof to Home Essentials. Nothing in this Section affects Johnson's right to commence or prosecute an action under Proposition 65 against a Releasee that does not involve Home Essentials' Products.

#### 4.3 Home Essentials' Release of Johnson

Home Essentials, on its own behalf, and on behalf of its past and current agents, representatives, attorneys, successors, and/or assignees, hereby waives any and all claims against Johnson and his attorneys and other representatives, for any and all actions taken, or statements made by Johnson and his attorneys and other representatives, whether in the course of investigating claims, seeking to enforce Proposition 65 against it in this matter, or with respect to the Products.

### 5. SEVERABILITY

If, subsequent to the execution of this Settlement Agreement, any provision of this Settlement Agreement is deemed by a court to be unenforceable, the validity of the remaining provisions shall not be adversely affected.

### 6. GOVERNING LAW

The terms of this Settlement Agreement shall be governed by the laws of the State of California and apply within the State of California. In the event that Proposition 65 is repealed or is otherwise rendered inapplicable by reason of law generally, or as to the Products, then Home Essentials may provide written notice to Johnson of any asserted change in the law and shall have no further injunctive obligations pursuant to this Settlement Agreement with respect to, and to the extent that, the Products are so affected.

# 7. **NOTICE**

Unless specified herein, all correspondence and notice required to be provided pursuant to this Settlement Agreement shall be in writing and sent by: (a) personal delivery; (b) first-class, registered or certified mail, return receipt requested; or (c) a recognized overnight courier on any Party by the other at the following addresses:

This Settlement Agreement may be executed in counterparts and by facsimile or portable document format (PDF) signature, each of which shall be deemed an original, and all of which, when taken together, shall constitute one and the same document.

# 9. COMPLIANCE WITH HEALTH & SAFETY CODE § 25249.7(f)

Johnson and his attorneys agree to comply with the reporting form requirements referenced in California Health and Safety Code section 25249.7(f).

# 10. MODIFICATION

This Settlement Agreement may be modified only by written agreement of the Parties.
