SETTLEMENT AGREEMENT

1. <u>INTRODUCTION</u>

- 1.1 The Parties. This Settlement Agreement is entered into by and between Donatus McCoy ("McCoy"), Alok International, Inc., and Alok Industries Ltd. (collectively, "Alok"). Together, McCoy and Alok are collectively referred to as the "Parties." McCoy is an individual who resides in the State of California, and seeks to promote awareness of exposures to toxic chemicals and to improve human health by reducing or eliminating hazardous substances contained in consumer products. McCoy alleges that Alok is a person in the course of doing business for purposes of the Safe Drinking Water and Toxic Enforcement Act of 1986, Health & Safety Code § 25249.6, et seq. ("Proposition 65").
- 1.2 General Allegations. McCoy alleges that Alok has exposed individuals to di(2-ethylhexyl) phthalate (DEHP) from its sales of *Hotel Style*TM pillowcase cases, UPC # 881813601154, without first providing users and consumers of the product with a clear and reasonable health hazard exposure warning as required pursuant to Proposition 65. DEHP is listed pursuant to Proposition 65 as a chemical known to the State of California to cause cancer and birth defects or other reproductive harm.
- 1.3 Product Description. The products covered by this Settlement Agreement are Hotel Style™ pillowcase cases, UPC # 881813601154, (the "Products") that have been imported, distributed, offered for sale and/or sold in California by Alok.
- 1.4 Notice of Violation. On October 7, 2021, McCoy served Walmart, Inc., Walmart Apollo, LLC (collectively, "Walmart"), Alok, and various public enforcement agencies with a document entitled "Notice of Violation of California Health & Safety Code § 25249.6, et seq." (the "Notice"). The Notice provided Alok and such others, including public enforcers, with notice that alleged that Alok was in violation of California Health & Safety Code § 25249.6, for failing to warn California consumers and customers that use of the Products will expose them to DEHP. No public enforcer has diligently prosecuted the allegations set forth in the Notice.



- 1.5 No Admission. Alok denies the material factual and legal allegations contained in the Notice and maintains that all products that are or have been sold and distributed in California, including the Products, have been and are in compliance with all laws. Nothing in this Settlement Agreement shall be construed as an admission by Alok of any fact, finding, issue of law, or violation of law; nor shall compliance with this Settlement Agreement constitute or be construed as an admission by Alok of any fact, finding, conclusion, issue of law or violation of law, such being specifically denied by Alok. However, this § 1.5 shall not diminish or otherwise affect the obligations, responsibilities and duties under this Settlement Agreement. Notwithstanding the allegations in the Notice, Alok maintains that it has not knowingly manufactured, or caused to be manufactured, the Products for sale in California in violation of Proposition 65.
- 1.6 Effective Date. For purposes of this Settlement Agreement, the term "Effective Date" shall mean the date this Agreement is last executed by the Parties.

2. <u>INJUNCTIVE RELIEF: REFORMULATION AND/OR WARNINGS</u>

- 2.1 Reformulation of Products. As of the Effective Date, and continuing thereafter, Products that Alok directly manufactures, imports, distributes, sells, or offers for sale in California shall either be: (a) reformulated Products pursuant to § 2.2, below; or (b) labeled with a clear and reasonable exposure warning pursuant to §§ 2.3 and 2.4, below. For purposes of this Settlement Agreement, a "Reformulated Product" is a Product that is in compliance with the standard set forth in § 2.2, below. The warning requirement set forth in §§ 2.3 and 2.4 shall not apply to any Reformulated Product.
- 2.2 Reformulation Standard. "Reformulated Products" shall mean Products that contain concentrations less than or equal to 0.1% (1,000 parts per million (ppm)) of DEHP when analyzed pursuant to U.S. Environmental Protection Agency testing methodologies 3580A and 8270C or other methodology utilized by federal or state government agencies for the purpose of determining the phthalate content in a solid substance.
- 2.3 Clear and Reasonable Warning. As of the Effective Date, and continuing thereafter, Alok shall provide a clear and reasonable exposure warning as set forth in this §§ 2.3



and 2.4 for all Products that Alok manufacturers, imports, distributes, sells, or offers for sale in California that is not a Reformulated Product. There shall be no obligation for Alok to provide an exposure warning for Products that entered the stream of commerce prior to the Effective Date or for 120 days thereafter. The warning shall consist of either the Warning or Alternative Warning described in §§ 2.3(a) or (b), respectively:

(a) Warning. The "Warning" shall consist of the statement:

⚠ WARNING: This vinyl storage case can expose you to chemicals including di(2-ethylhexyl) phthalate (DEHP), which are known to the State of California to cause cancer and birth defects or other reproductive harm. For more information go to www.P65Warnings.ca.gov.

(b) Alternative Warning: Alok may, but is not required to, use the alternative short-form warning as set forth in this § 2.3(b) ("Alternative Warning") as follows:

⚠ WARNING: Cancer and Reproductive Harm - www.P65Warnings.ca.gov.

2.4 A Warning or Alternative Warning provided pursuant to § 2.3 must print the word "WARNING:" in all capital letters and in bold font, followed by a colon. The warning symbol to the left of the word "WARNING:" must be a black exclamation point in a yellow equilateral triangle with a black outline, except that if the sign or label for the Products does not use the color yellow, the symbol may be in black and white. The symbol must be in a size no smaller than the height of the word "WARNING:". The Warning or Alternative Warning shall be affixed to or printed on the Products' packaging or labeling, or on a placard, shelf tag, sign or electronic device or automatic process, provided that the Warning or Alternative Warning is displayed with such conspicuousness, as compared with other words, statements, or designs as to render it likely to be read and understood by an ordinary individual under customary conditions of purchase or use. The Warning or Alternative Warning may be contained in the same section of the packaging, labeling, or instruction booklet that states other safety warnings, if any, concerning the use of the Product and shall be at least the same size as those other safety warnings.

In addition to affixing the Warning or Alternative Warning to the Product's packaging or labeling, Alok shall post the Warning or Alternative Warning on any Internet sales website

owned, operated, or controlled by Alok on which it offers Products for sale to consumers in California, as well as websites where Alok has the ability to control the application of warnings, by including either the Warning or Alternative Warning, or a clearly marked hyperlink using the word "WARNING," on the product display page, or by otherwise prominently displaying the Warning or Alternative Warning to the purchaser prior to completing the purchase. Alok shall also comply with 27, California Code of Regulations, Section 25600.2(b), as applicable.

2.5 Compliance with Warning Regulations. The Parties agree that Alok shall be deemed to be in compliance with this Settlement Agreement by either adhering to § 2 of this Settlement Agreement or by complying with warning requirements adopted by the State of California's Office of Environmental Health Hazard Assessment ("OEHHA") applicable to the Product and the exposures at issue after the Effective Date. If "consumer information," as that term is defined in Title 27, California Code of Regulations, Section 25600.1(c) as it may be amended from time to time, is provided in a foreign language, Alok shall provide the Warning or Alternative Warning in the foreign language in accordance with applicable warning regulations adopted by OEHHA.

3. PENALTIES PURSUANT TO HEALTH & SAFETY CODE § 25249.7(b)

In settlement of all the claims referred to in this Settlement Agreement, Alok shall pay \$500.00 as a Civil Penalty in accordance with this Section. The Civil Penalty payment shall be allocated in accordance with California Health & Safety Code §§ 25249.12(c)(1) and (d), with 75% of the Penalty remitted to OEHHA and the remaining 25% of the Penalty remitted to McCoy. The Civil Penalty payment(s) shall be delivered to the addresses identified in § 3.2, below. For all amounts due and owing that are not received within the payment times set forth below, Alok shall pay a late civil penalty payment fee equal to \$100/day to be allocated in accordance with California Health & Safety Code § 25249.12(c)(1) and (d).

3.1 Civil Penalty. Within ten (10) days of the Effective Date, Alok shall issue two (2) separate checks for the Civil Penalty payment to (a) "OEHHA" in the amount of \$375.00; and to

(b) "Donatus McCoy" in the amount of \$125.00. The Civil Penalty payment(s) shall be delivered to the addresses identified in § 3.2, below.

3.2 Payment Procedures.

- (a) Issuance of Payments. Payments shall be delivered as follows:

(b) Copy of Payments to OEHHA. Alok agrees to provide McCoy's counsel with a copy of the checks payable to OEHHA, simultaneous with its penalty payments to McCoy, to be delivered to the address provided in § 3.2(a)(i), as proof of payment to OEHHA.

- (c) Tax Documentation. Alok agrees to provide a completed IRS 1099 for its payments to, and McCoy agrees to provide IRS W-9 forms for, each of the following payees under this Settlement Agreement:
 - (i) "Donatus McCoy" whose address and tax identification number shall be provided within five (5) days after this Settlement Agreement is fully executed by the Parties;
 - (ii) "Brodsky Smith" (EIN: 23-2971061) at the address provided in Section 3.2(a)(i); and
 - (iii) "Office of Environmental Health Hazard Assessment" 1001 I Street, Sacramento, CA 95814.
- (d) Payment Via Agent or Attorney. For the avoidance of doubt, any payment Alok is required to make under this Settlement Agreement, and any tax documentation Alok is required to provide in connection with such payments, may be made or provided by Alok either directly or via Alok's agent or attorney with the same force and effect as if made by Alok itself.

4. REIMBURSEMENT OF FEES AND COSTS

The Parties acknowledge that McCoy and his counsel offered to reach preliminary agreement on the material terms of this dispute before reaching terms on the amount of fees and costs to be reimbursed to them. The Parties thereafter reached an accord on the compensation due to McCoy and his counsel under general contract principles and the private attorney general doctrine and principles codified at California Code of Civil Procedure § 1021.5, for all work performed through the mutual execution of this agreement. Under these legal principles, Alok shall reimburse McCoy's counsel for fees and costs incurred as a result of investigating and bringing this matter to the attention of Alok, and negotiating a settlement in the public interest. Within ten (10) days of the Effective Date, Alok shall issue a check payable to "Brodsky Smith" in the amount of \$7,000.00 for delivery to the address identified in § 3.2(a)(i), above.

5. RELEASE OF ALL CLAIMS

Release of Alok and Downstream Customers and Entities. This Settlement 5.1 Agreement is a full, final and binding resolution between McCoy, acting on his own behalf, and Alok, of any violation of Proposition 65 that was or could have been asserted by McCoy or on behalf of his past and current agents, representatives, attorneys, successors, and/or assigns ("Releasors") for alleged failure to provide warnings for alleged exposures to DEHP from use of the Products, and Releasors hereby release any such claims now and forever, without any right of recourse against Alok and its parents, subsidiaries, affiliated entities, shareholders, marketplaces, directors, officers, agents, employees, attorneys, successors and assignees, and each entity to whom Alok directly or indirectly distributes or sells the Products, including but not limited to, downstream distributors, wholesalers, customers, third-party internet marketplaces and retailers, including but not limited to Walmart, Wal-Mart Stores Inc., Wal-Mart Stores East, Inc., Wal-Mart Stores East, LP, Walmart Apollo, LLC, Wal-Mart.com USA LLC, and each of their respective direct or indirect corporate parents, subsidiaries, affiliates, as well as their past, present and future owners, shareholders, directors, officers, employees, attorneys, insurers, representatives,, franchisees, cooperative members, successors, assigns and licensees (collectively, the "Releasees"), from all claims, liabilities, alleged liabilities, and potential liabilities for violations of Proposition 65 from the beginning of time through the Effective Date based on exposure to DEHP or any other chemical listed under Proposition 65 from use of the Products.

In further consideration of the promises and agreements herein contained, and for the payments to be made pursuant to §§ 3 and 4 above, McCoy, on behalf of himself, his past and current agents, representatives, attorneys, successors and/or assignees, hereby covenants not to sue and waives any right to institute, participate in, directly or indirectly, any form of legal action and releases all claims that he may have, including without limitation, all actions and causes of action in law and in equity, all obligations, expenses (including without limitation all attorneys' fees, expert fees, and investigation fees, and costs), damages, losses, liabilities and demands against any of the Releasees of any nature, character, or kind, whether known or unknown, suspected or

unsuspected, limited to and arising out of the alleged or actual exposure to DEHP from use of the Products.

- 5.2 Alok's Release of McCoy. Alok, on behalf of itself, its past and current agents, representatives, attorneys, successors and/or assignees, hereby waives any and all claims against McCoy, his attorneys and other representatives, for any and all actions taken or statements made (or those that could have been taken or made) by McCoy and/or his attorneys and other representatives, whether in the course of investigating claims or otherwise seeking to enforce Proposition 65 against it in this matter or with respect to exposure to DEHP from use of the Products.
- 5.3 California Civil Code § 1542. It is possible that other claims not known to the Parties arising out of the facts alleged in the Notice and relating to the Products will develop or be discovered. McCoy on behalf of himself only, on one hand, and Alok, on the other hand, acknowledge that this Agreement is expressly intended to cover and include all such claims up through the Effective Date, including all rights of action therefor. The Parties acknowledge that the claims released in §§ 5.1 and 5.2, above, may include unknown claims, and nevertheless waive California Civil Code § 1542 as to any such unknown claims. California Civil Code § 1542 reads as follows:

A GENERAL RELEASE DOES NOT EXTEND TO CLAIMS THAT THE CREDITOR OR RELEASING PARTY DOES NOT KNOW OR SUSPECT TO EXIST IN HIS OR HIS FAVOR AT THE TIME OF EXECUTING THE RELEASE AND THAT, IF KNOWN BY HIM OR HIS, WOULD HAVE MATERIALLY AFFECTED HIS OR HIS SETTLEMENT WITH THE DEBTOR OR RELEASED PARTY.

McCoy and Alok each acknowledge and understand the significance and consequences of this specific waiver of California Civil Code § 1542.

5.4 Deemed Compliance with Proposition 65. The Parties agree that compliance by Alok with this Settlement Agreement constitutes compliance with Proposition 65 with respect to exposure to DEHP from use of the Products.



5.5. Public Benefit. It is Alok's understanding that the commitments it has agreed to herein, and actions to be taken by Alok under this Settlement Agreement, would confer a significant benefit to the general public, as set forth in Code of Civil Procedure § 1021.5 and Cal. Admin. Code tit. 11, § 3201. As such, it is the intent of Alok that to the extent any other private party initiates an action alleging a violation of Proposition 65 with respect to Alok's failure to provide a warning concerning exposure to DEHP prior to use of the Products it has manufactured, distributed, sold, or offered for sale in California, or will manufacture, distribute, sell, or offer for sale in California, such private party action would not confer a significant benefit on the general public as to those Products addressed in this Settlement Agreement, provided that Alok is in material compliance with this Settlement Agreement.

6. <u>SEVERABILITY</u>

If, subsequent to the execution of this Settlement Agreement, any of the provisions of this Settlement Agreement are deemed by a court to be unenforceable, the validity of the enforceable provisions remaining shall not be adversely affected but only to the extent the deletion of the provision deemed unenforceable does not materially affect, or otherwise result in the effect of the Settlement Agreement being contrary to the intent of the Parties in entering into this Settlement Agreement.

7. **GOVERNING LAW**

The terms of this Settlement Agreement shall be governed by the law of the State of California and apply within the State of California. In the event that Proposition 65 is repealed or is otherwise rendered inapplicable or limited by reason of law generally, or as to the Products, Alok shall provide written notice to McCoy of any asserted change in the law, and shall have no further obligations pursuant to this Settlement Agreement with respect to, and to the extent that, a Product is so affected.

8. NOTICES

Unless specified herein, all correspondence and notices required to be provided pursuant to this Settlement Agreement shall be in writing and personally delivered or sent by: (i) first-class

9. <u>COUNTERPARTS: SIGNATURES</u>

This Settlement Agreement may be executed in counterparts and by facsimile or .pdf signature, each of which shall be deemed an original, and all of which, when taken together, shall constitute one and the same document.

10. COMPLIANCE WITH HEALTH & SAFETY CODE § 25249.7(f)

McCoy agrees to comply with the reporting requirements referenced in Health & Safety Code § 25249.7(f).

11. MODIFICATION

This Settlement Agreement may be modified only by a written agreement of the Parties.

12. ENTIRE AGREEMENT

This Settlement Agreement contains the sole and entire agreement of the Parties and any and all prior negotiations and understandings related hereto shall be deemed to have been merged within it. No representations or terms of agreement other than those contained herein exist or have been made by any Party with respect to the other Party or the subject matter hereof.
