1. <u>INTRODUCTION</u>

1.1 <u>The Parties</u>

This [Proposed] Consent Judgment is hereby entered into by and between Berj Parseghian, acting on behalf of the public interest (hereinafter "Parseghian") and LONGRUN, LLC (hereinafter "LONGRUN" or "Defendant"). Collectively Parseghian and LONGRUN shall be referred to hereafter as the "Parties" and each of them as a "Party." Parseghian is an individual residing in California who seeks to promote awareness of exposures to toxic chemicals and improve human health by reducing or eliminating hazardous substances contained in consumer products. Defendant is a person in the course of doing business for purposes of Proposition 65, Cal. Health & Safety Code §§ 25249.6 et seq.

1.2 <u>Allegations and Representations</u>

Parseghian alleges that Defendant has offered for sale in the State of California and has sold in California, products, which contain lead and cadmium, and that such sales have not been accompanied by Proposition 65 warnings. Lead is listed under Proposition 65 as a chemical known to the State of California to cause cancer and birth defects or other reproductive harm. The State of California has also listed cadmium as a chemical known to cause cancer, developmental toxicity and reproductive harm. Defendant denies the allegations and contends that there is no exposure and no violation under Proposition 65 for an alleged failure to warn.

1.3 <u>Covered Product Description</u>

The product that is covered by this Consent Judgment are identified as Keto and Co Flatbread and Pizza - Keto Bread Mix; UPC #: 8 57227 00741 7. All such items shall be referred to
herein as the "Covered Product."

 1.4.1 On or about November 24, 2021, Parseghian served LONGRUN and various public enforcement agencies with a document entitled "60-Day Notice of Violation" pursuant to Health & Safety Code §25249.7(d) (the "Notice"), alleging that LONGRUN was in violation of Proposition 65 for failing to warn consumers and customers that the Covered Product exposed users in California to lead and cadmium. No public enforcer diligently prosecuted the claims threatened in the Notice within sixty days plus service time relative to the provision of the Notice to them by Parseghian.

1.4.2 On May 16, 2022, Parseghian, acting in the interest of the general public in the State
of California, filed a complaint in the Superior Court of Los Angeles County alleging violations of
Health & Safety Code §25249.6 (the "Complaint") based on the alleged failure to warn of exposures
to lead and cadmium contained in the Covered Product manufactured, distributed, or sold by
Defendant.

1.5 Effective Date

For purposes of this Consent Judgment, the term "Effective Date" shall mean the date this Consent Judgment is entered as a judgment of the Court.

For purposes of this Consent Judgment, the term "Execution Date" shall mean the date this Consent Judgment is signed by all parties in Clause 16 below.

2. <u>STIPULATION TO JURISDICTION/NO ADMISSION</u>

For purposes of this Consent Judgment only, the Parties stipulate that this Court has jurisdiction over Defendant as to the allegations contained in the complaint filed in this matter, that venue is proper in the County of Los Angeles, and that this Court has jurisdiction to approve, enter, and oversee the enforcement of this Consent Judgment as a full and final binding resolution of all claims which were or could have been raised in the Complaint based on the facts alleged therein and/or in the Notice.

Nothing in this Consent Judgment shall be construed as an admission by Defendant of any

fact, finding, issue of law, or violation of law; nor shall compliance with this Consent Judgment constitute or be construed as an admission by Defendant of any fact, finding, conclusion, issue of law, or violation of law, such being specifically denied by Defendant, including, but not limited to, any admission related to exposure of failure to warn. However, this section shall not diminish or otherwise affect the obligations, responsibilities, and duties of Defendant under this Consent Judgment.

INJUNCTIVE RELIEF: WARNINGS, REFORMULATION AND TESTING

3.1 Beginning on the Effective Date, LONGRUN shall be permanently enjoined from manufacturing for sale in the State of California, "Distributing into the State of California," or directly selling in the State of California, any Covered Product that expose a person to a "Daily Lead Exposure Level" of more than 0.5 micrograms of lead per day or to a "Daily Cadmium Exposure Level" of more than 4.1 micrograms of cadmium per day, unless it meets the warning requirements under Section 3.2.

3.1.1 As used in this Consent Judgment, the term "Distributing into the State of California" shall mean to directly ship a Covered Product into California for sale in California or to sell a 18 Covered Product to a distributor that LONGRUN knows or has reason to know will sell the Covered 19 Product in California. The injunctive relief in Section 3 does not apply to any Covered Product that 20 has left the possession, and is no longer under the control of LONGRUN prior to the Effective Date 21 and all claims as to such Covered Product are released in this Consent Judgment. 22

3.1.2 For purposes of this Consent Judgment, the "Daily Lead Exposure Level" and the 23 "Daily Cadmium Exposure Level" shall be measured in micrograms, and shall be calculated using the 24 25 following formula: micrograms of lead or cadmium per gram of product, multiplied by grams of 26 product per serving of the product as stated on the label, multiplied by servings of the product per day 27 stated on the label, which equals micrograms of lead or cadmium exposure per day. 1 contains no recommended daily servings, then the number of recommended daily servings shall be
2 one.

3.2 Clear and Reasonable Warnings

If LONGRUN is required to provide a warning pursuant to Section 3.1, one of the following warnings must be utilized ("Warning"):

Option 1:

WARNING: Consuming this product can expose you to chemicals including [lead and/or cadmium], which [is or are] known to the State of California to cause [cancer and] birth defects or other reproductive harm. For more information go to www.P65Warnings.ca.gov/food

Option 2:

WARNING: [Cancer and] Reproductive Harm - http://www.p65warnings.ca.gov/food

LONGRUN shall use the phrase "cancer and" in the Warning if LONGRUN has reason to believe that the "Daily Lead Exposure Level" is greater than 15 micrograms of lead or if LONGRUN has reason to believe that another Proposition 65 chemical is present which may require a cancer warning. LONGRUN may reference lead, cadmium, or both in the warning, depending on what chemical causes an exposure above the thresholds set in Section 3.1

19 The Warning shall be securely affixed to or printed upon the label of each Covered Product 20 and it must be set off from other surrounding information. In addition, for any Covered Product sold 21 over the internet, the Warning shall appear on the checkout page in full text or through a clearly 22 marked hyperlink using the word **"WARNING"** in all capital and bold letters when a California 23 delivery address is indicated for any purchase of any Covered Product. If a hyperlink is used, the 24 hyperlink must go directly to a page prominently displaying either the Option 1 Warning or the 25 26 Option 2 Warning without content that detracts from the Warning. An asterisk or other identifying 27 method must be utilized to identify which products on the checkout page are subject to the Warning. 28

The Warning shall be at least the same size as the largest of any other health or safety warnings also appearing on the website or on the label and the word **"WARNING"** shall be in all capital letters and in bold print. No statements intended to or likely to have the effect of diminishing the impact of the Warning on the average lay person shall accompany the Warning. Further, no statements may accompany the Warning that state or imply that the source of the listed chemical has an impact on or results in a less harmful effect of the listed chemical. For the Option 2 Warning, a symbol consisting of a black exclamation point in a yellow equilateral triangle with a bold black outline shall be placed to the left of the text of the Warning, in a size no smaller than the height of the word **"WARNING."**

LONGRUN must display the above Warning with such conspicuousness, as compared with other words, statements or designs on the label, or on its website, if applicable, to render the Warning likely to be read and understood by an ordinary individual under customary conditions of purchase or use of the product.

For purposes of this Consent Judgment, the term "label" means a display of written, printed or graphic material that is printed on or affixed to a Covered Product or its immediate container or wrapper.

PAYMENTS PURSUANT TO HEALTH & SAFETY CODE §25249.7(b)

20 With regard to all claims that have been raised or which could be raised with respect to failure 21 to warn pursuant to Proposition 65 with regard to lead and cadmium in the Covered Product, 22 Defendant shall pay a civil penalty of \$5,000.00 pursuant to Health and Safety Code section 23 25249.7(b), to be apportioned in accordance with California Health & Safety Code § 25192, with 75% 24 25 of these funds remitted to the State of California's Office of Environmental Health Hazard 26 Assessment and the remaining 25% of the penalty remitted to Parseghian, as provided by California 27 Health & Safety Code § 25249.12(d) and the instructions directly below. 28 6

interest. Defendant shall pay Parseghian's counsel \$45,000.00 for all attorneys' fees, expert and investigation fees and related costs associated with this matter and the Notice. Within thirty (30) calendar days of the Effective Date, Defendant shall mail a check payable to "KJT Law Group," via certified mail to the address for Parseghian's counsel referenced above.

RELEASE OF ALL CLAIMS

6.1 Parseghian's Release of Defendant, Releasees, and Downstream Releasees

As to those matters raised in the Complaint and in the Notice of Violation, Parseghian, on behalf of himself, and on behalf of the public interest, hereby waives and releases any and all claims against Defendant its parent companies, corporate affiliates, subsidiaries, predecessors, successors and assigns (collectively "Releasees") and each of its distributors, wholesalers, licensors, licensees, auctioneers, retailers, franchisees, dealers, customers, owners, purchasers, users (collectively "Downstream Releasees") and their respective officers, directors, attorneys, representatives, 14 shareholders, agents, and employees, and sister and parent entities for injunctive relief or damages, penalties, fines, sanctions, mitigation, fees (including fees of attorneys, experts, and others), costs, expenses, or any other sum incurred or claimed, for the alleged failure of Defendant, Releasees or Downstream Releasees to provide clear, accurate and reasonable warnings under Proposition 65. about exposure to lead and cadmium arising from the sale, distribution, or use of any Covered Product sold, manufactured or distributed by Defendant, Releasees or Downstream Releasees in California. Compliance with the Consent Judgment by Defendant or a Release shall constitute compliance with Proposition 65 by that Defendant, Releasee, or Downstream Releasee with respect to the presence of lead and cadmium in the Covered Product. Plaintiff agrees that any and all claims in the Complaint are resolved with prejudice by this Consent Judgment.

26 In addition to the foregoing, Parseghain, on behalf of himself, his past and current agents, 27 representatives, attorneys, and successors and/or assignees, and <u>not</u> in his representative capacity, 28

hereby waives all rights to institute or participate in, directly or indirectly, any form of legal action and
releases any other Claims that he could make against Defendant, Releasees or Downstream Releasees
with respect to violations of Proposition 65 based upon the Covered Product. With respect to the
foregoing waivers and releases in this paragraph, Parseghain hereby specifically waives any and all
rights and benefits which he now has, or in the future may have, conferred by virtue of the provisions
of Section 1542 of the California Civil Code, which provides as follows:

A GENERAL RELEASE DOES NOT EXTEND TO CLAIMS THAT THE CREDITOR OR RELEASING PARTY DOES NOT KNOW OR SUSPECT TO EXIST IN HIS OR HER FAVOR AT THE TIME OF EXECUTING THE RELEASE AND THAT, IF KNOWN BY HIM OR HER, WOULD HAVE MATERIALLY AFFECTED HIS OR HER SETTLEMENT WITH THE DEBTOR OR RELEASED PARTY.

6.2 Defendant's Release of Parseghian

Defendant waives any and all claims against Parseghian, his attorneys and other representatives, for any and all actions taken or statements made (or those that could have been taken or made) by Parseghian and his attorneys and other representatives, in the course of investigating claims or otherwise seeking enforcement of Proposition 65 against them in this matter, and/or with respect to the Covered Product.

7. <u>SEVERABILITY AND MERGER</u>

If, subsequent to the execution of this Consent Judgment, any of the provisions of this document are held by a court to be unenforceable, the validity of the enforceable provisions remaining shall not be adversely affected.

This Consent Judgment contains the sole and entire agreement of the Parties and any and all prior negotiations and understandings related hereto shall be deemed to have been merged within it. No representations or terms of agreement other than those contained herein exist or have been made by any Party with respect to the other Party or the subject matter hereof.
