

# 1. <u>INTRODUCTION</u>

# 1.1 <u>The Parties</u>

This [Proposed] Consent Judgment is hereby entered into by and between Berj Parseghian, 3 acting on behalf of the public interest (hereinafter "Parseghian") and WILDE BRANDS, INC. 4 (hereinafter "WILDE BRANDS" or "Defendant"). Collectively Parseghian and WILDE BRANDS 5 shall be referred to hereafter as the "Parties" and each of them as a "Party." Parseghian is an 6 individual residing in California who seeks to promote awareness of exposures to toxic chemicals and 7 improve human health by reducing or eliminating hazardous substances contained in consumer 8 products. Defendant is a person in the course of doing business for purposes of Proposition 65, Cal. 9 Health & Safety Code §§ 25249.6 et seq. 10

### 1.2 <u>Allegations and Representations</u>

Parseghian alleges that Defendant has offered for sale in the State of California and has sold in California, Protein Chips, which contain lead, and that such sales have not been accompanied by Proposition 65 warnings. Lead is listed under Proposition 65 as a chemical known to the State of California to cause cancer and birth defects or other reproductive harm. Defendant denies the allegations and contends that there is no exposure and no violation under Proposition 65 for an alleged failure to warn.

# 1.3 Covered Products Description

The products covered by this Consent Judgment are identified as Wilde Brands Protein
Chips including, but not limited to: Wilde Protein Chips - Golden Mustard - BBQ Pork; UPC #: 8
56802 00835 1. All such items in the Wilde Brands Protein Chips line shall be referred to herein as
the "Covered Product."

# 1.4 Notices of Violation/Complaint

1.4.1 On or about December 20, 2021, Parseghian served WILDE BRANDS and various
public enforcement agencies with a document entitled "60-Day Notice of Violation" pursuant to
Health & Safety Code §25249.7(d) (the "Notice"), alleging that WILDE BRANDS was in violation of
Proposition 65 for failing to warn consumers and customers that the Covered Product exposed users

in California to lead. No public enforcer diligently prosecuted the claims threatened in the Notice within sixty days plus service time relative to the provision of the Notice to them by Parseghian.

1.4.2 On April 14, 2022, Parseghian, acting in the interest of the general public in the State of California, filed a complaint in the Superior Court of Los Angeles County alleging violations of Health & Safety Code §25249.6 (the "Complaint") based on the alleged failure to warn of exposures to lead contained in the Covered Product manufactured, distributed, or sold by Defendant.

### 1.5 Effective Date

For purposes of this Consent Judgment, the term "Effective Date" shall mean the date this Consent Judgment is entered as a judgment of the Court.

For purposes of this Consent Judgment, the term "Execution Date" shall mean the date this Consent Judgment is signed by all parties in Clause 16 below.

# STIPULATION TO JURISDICTION/NO ADMISSION

For purposes of this Consent Judgment only, the Parties stipulate that this Court has jurisdiction over Defendant as to the allegations contained in the complaint filed in this matter, that venue is proper in the County of Los Angeles, and that this Court has jurisdiction to approve, enter, and oversee the enforcement of this Consent Judgment as a full and final binding resolution of all claims which were or could have been raised in the Complaint based on the facts alleged therein and/or in the Notice.

Nothing in this Consent Judgment shall be construed as an admission by Defendant of any fact, finding, issue of law, or violation of law; nor shall compliance with this Consent Judgment constitute or be construed as an admission by Defendant of any fact, finding, conclusion, issue of law, or violation of law, such being specifically denied by Defendant, including, but not limited to, any admission related to exposure of failure to warn. However, this section shall not diminish or otherwise affect the obligations, responsibilities, and duties of Defendant under this Consent Judgment.

# **INJUNCTIVE RELIEF: WARNINGS, REFORMULATION AND TESTING**

**3.1** Beginning on the Effective Date, WILDE BRANDS shall be permanently enjoined from manufacturing for sale in the State of California, "Distributing into the State of California," or directly selling in the State of California, any Covered Product that expose a person to a "Daily Lead Exposure Level" of more than 0.5 micrograms of lead per day unless it meets the warning requirements under Section 3.2.

**3.1.1** As used in this Consent Judgment, the term "Distributing into the State of California" shall mean to directly ship a Covered Product into California for sale in California or to sell a Covered Product to a distributor that WILDE BRANDS knows or has reason to know will sell the Covered Product in California. The injunctive relief in Section 3 does not apply to any Covered Product that has left the possession and is no longer under the control of WILDE BRANDS prior to the Effective Date and all claims as to such Covered Products are released in this Consent Judgment.

**3.1.2** For purposes of this Consent Judgment, the "Daily Lead Exposure Level" shall be measured in micrograms, and shall be calculated using the following formula: micrograms of lead per gram of product, multiplied by grams of product per serving of the product (using the largest serving size appearing on the product label), multiplied by servings of the product per day (using the largest number of recommended daily servings appearing on the label), which equals micrograms of lead exposure per day. If the label contains no recommended daily servings, then the number of recommended daily servings shall be one.

# 3.2 Clear and Reasonable Warnings

If WILDE BRANDS is required to provide a warning pursuant to Section 3.1, one of the following warnings must be utilized ("Warning"):

# Option 1:

**WARNING:** Consuming this product can expose you to chemicals including lead, which is known to the State of California to cause [cancer and], birth defects or other reproductive harm. For more information go to <u>www.P65Warnings.ca.gov/food</u>

Option 2:

WARNING: [Cancer and] Reproductive Harm - http://www.p65warnings.ca.gov/food

WILDE BRANDS shall use the phrase "cancer and" in the Warning if WILDE BRANDS has reason to believe that the "Daily Lead Exposure Level" is greater than 15 micrograms of lead.

The Warning shall be securely affixed to or printed upon the label of each Covered Product and it must be set off from other surrounding information. In addition, for any Covered Product sold over the internet, the Warning shall appear prior to completion of purchase in full text or through a clearly marked hyperlink using the word "WARNING" in all capital and bold letters when a California delivery address is indicated for any purchase of any Covered Product. If a hyperlink is used, the hyperlink must go directly to a page prominently displaying either the Option 1 Warning or the Option 2 Warning without content that detracts from the Warning. An asterisk or other identifying method must be utilized to identify which products on the checkout page are subject to the Warning.

15 The Warning shall be at least the same size as the largest of any other health or safety 16 warnings also appearing on the website or on the label and the word **"WARNING"** shall be in all capital letters and in bold print. No statements intended to or likely to have the effect of diminishing 18 the impact of the Warning on the average lay person shall accompany the Warning. Further, no statements may accompany the Warning that state or imply that the source of the listed chemical has 19 an impact on or results in a less harmful effect of the listed chemical. 20

21 WILDE BRANDS must display the above Warning with such conspicuousness, as compared with other words, statements or designs on the label, or on its website, if applicable, to render the 22 23 Warning likely to be read and understood by an ordinary individual under customary conditions of 24 purchase or use of the product.

25 For purposes of this Consent Judgment, the term "label" means a display of written, printed or 26 graphic material that is printed on or affixed to a Covered Product or its immediate container or 27 wrapper.

# PAYMENTS PURSUANT TO HEALTH & SAFETY CODE §25249.7(b)

With regard to all claims that have been raised or which could be raised with respect to failure to warn pursuant to Proposition 65 with regard to lead in the Covered Product, Defendant shall pay a civil penalty of five thousand dollars (\$5,000.00) pursuant to Health and Safety Code section 25249.7(b), to be apportioned in accordance with California Health & Safety Code § 25192, with 75% of these funds remitted to the State of California's Office of Environmental Health Hazard Assessment and the remaining 25% of the penalty remitted to Parseghian, as provided by California Health & Safety Code § 25249.12(d) and the instructions directly below.

Defendant shall issue two separate checks for the penalty payment: (a) one check made payable to "OEHHA" (tax identification number: 68-0284486) in an amount representing 75% of the total penalty (i.e., \$3,750.00) and (b) one check in an amount representing 25% of the total penalty (i.e., \$1,250.00) made payable directly to Parseghian. Defendant shall mail these payments within ten (10) days following the Effective Date, at which time such payments shall be mailed to the following addresses respectively:

### 5. <u>REIMBURSEMENT OF FEES AND COSTS</u>

The parties reached an accord on the compensation due to Parseghian and his counsel under the private attorney general doctrine and principles of contract law. Under these legal principles, Defendant shall reimburse Parseghian's counsel for fees and costs, incurred as a result of investigating, bringing this matter to Defendant attention, and negotiating a settlement in the public interest. Defendant shall pay Parseghian's counsel forty thousand dollars (\$40,000.00) for all attorneys' fees, expert and investigation fees and related costs associated with this matter and the Notice. Defendant shall mail a check payable to "KJT Law Group," via certified mail to the address for Parseghian's counsel referenced above within ten (10) days following the Effective Date. Other than the payment required hereunder, each side is to bear its own attorneys' fees and costs.

### RELEASE OF ALL CLAIMS

#### 6.1 Parseghian's Release of Defendant, Releasees, Upstream and Downstream Releasees

14 As to those matters raised in the Complaint and in the Notice of Violation, Parseghian, on 15 behalf of himself, and on behalf of the public interest, hereby waives and releases any and all claims 16 against Defendant its parent companies, corporate affiliates, subsidiaries, predecessors, successors, 17 and any other upstream entities in the distribution chain for the Covered Product (collectively 18 "Releasees") and each of its distributors, wholesalers, licensors, licensees, auctioneers, retailers, 19 franchisees, dealers, customers, owners, purchasers, and users including, but not limited to, Whole 20 Foods Market California, Inc. and all related entities (collectively "Downstream Releasees") and their 21 respective officers, directors, attorneys, representatives, shareholders, agents, and employees, and 22 sister and parent entities for injunctive relief or damages, penalties, fines, sanctions, mitigation, fees 23 (including fees of attorneys, experts, and others), costs, expenses, or any other sum incurred or 24 claimed, for the alleged failure of Defendant, Releasees or Downstream Releasees to provide clear, 25 accurate and reasonable warnings under Proposition 65 about exposure to lead arising from the sale, 26 distribution, or use of any Covered Products sold, manufactured or distributed by Defendant, 27 Releasees or Downstream Releasees in California prior to the Effective Date. Compliance with the 28

Consent Judgment by Defendant or a Releasee shall constitute compliance with Proposition 65 by that Defendant, Releasee, or Downstream Releasee with respect to the presence of lead in the Covered Products, up through the Effective Date. Plaintiff agrees that any and all claims in the Complaint are resolved with prejudice by this Consent Judgment.

In addition to the foregoing, Parseghian, on behalf of himself, his past and current agents, representatives, attorneys, and successors and/or assignees, and <u>not</u> in her representative capacity, hereby waives all rights to institute or participate in, directly or indirectly, any form of legal action and releases any other Claims that he could make against Defendant, Releasees or Downstream Releasees arising after the Effective Date with respect to violations of Proposition 65 based upon the Covered Products. With respect to the foregoing waivers and releases in this paragraph, Parseghian hereby specifically waives any and all rights and benefits which he now has, or in the future may have, conferred by virtue of the provisions of Section 1542 of the California Civil Code, which provides as follows:

#### A GENERAL RELEASE DOES NOT EXTEND TO CLAIMS WHICH THE CREDITOR DOES NOT KNOW OR SUSPECT TO EXIST IN HIS FAVOR AT THE TIME OF EXECUTING THE RELEASE, WHICH IF KNOWN BY HIM OR HER MUST HAVE MATERIALLY AFFECTED HIS OR HER SETTLEMENT WITH THE DEBTOR.

# 6.2 Defendant's Release of Parseghian

Defendant waives any and all claims against Parseghian, his attorneys and other
 representatives, for any and all actions taken or statements made (or those that could have been taken
 or made) by Parseghian and his attorneys and other representatives, in the course of investigating
 claims or otherwise seeking enforcement of Proposition 65 against them in this matter, and/or with
 respect to the Covered Products.
 **5.** SEVERABILITY AND MERGER
 If, subsequent to the execution of this Consent Judgment, any of the provisions of this

26 document are held by a court to be unenforceable, the validity of the enforceable provisions

# **GOVERNING LAW**

The terms of this Consent Judgment shall be governed by the laws of the State of California and apply within the State of California. Compliance with the terms of this Consent Judgment resolves any issue, now or in the future, as to the requirements of Proposition 65 with respect to alleged exposures to lead arising from the Covered Products. In the event that Proposition 65 is repealed or is otherwise rendered inapplicable by reason of law generally, or as to the Covered Products, then Defendant shall provide written notice to Parseghian of any asserted change in the law, and shall have no further obligations pursuant to this Consent Judgment with respect to, and to the extent that, the Covered Products are so affected.
