# SETTLEMENT AGREEMENT BETWEEN APS&EE, LLC AND MEICHENG HOLDINGS LTD.

## 1. RECITALS

#### 1.1 The Parties

- 1.1.1 This Settlement Agreement ("Agreement") is entered into by and between APS&EE, LLC ("APS&EE") and Meicheng Holdings Ltd. ("MHL"). APS&EE and MHL shall hereinafter collectively be referred to as the "Parties."
- 1.1.2 APS&EE is an organization based in California with an interest in protecting the environment, improving human health and the health of ecosystems, and supporting environmentally sound practices, which includes promoting awareness of exposure to toxic chemicals and reducing exposure to hazardous substances found in consumer products.
- 1.1.3 APS&EE alleges that MHL is a person in the course of doing business as the term is defined in California *Health & Safety Code* section 25249.6 et seq. ("Proposition 65").

## 1.2 Allegations

- 1.2.1 APS&EE alleges that MHL sold the English Mug Co. mugs with exterior decorations (hereinafter, the "Products") in the State of California causing users in California to be exposed to hazardous levels of Lead without providing "clear and reasonable warnings," in violation of Proposition 65. Lead is listed as known to cause cancer and birth defects or other reproductive harm.
- 1.2.2 On February 15, 2022, APS&EE sent a Sixty-Day Notice of Violation (the "Notice"), along with a Certificate of Merit, to Eaton Dining, later identified as MHL, The TJX Companies, Inc., and the various public enforcement agencies regarding the alleged violation of Proposition 65 with respect to the Products.

#### 1.3 No Admissions

MHL denies all allegations in APS&EE's Notice and maintains that the Products have been, and are, in compliance with all laws, and that MHL has not violated Proposition 65. This Agreement shall not be construed as an admission of liability by MHL but to the contrary as a compromise of claims that are expressly contested and denied. However, nothing in this section shall affect the Parties' obligations, duties, and responsibilities under this Agreement.

## 1.4 Compromise

The Parties enter into this Agreement in order to resolve the controversy described above in a manner consistent with prior Proposition 65 settlements and consent judgments that were entered in the public interest and to avoid prolonged and costly litigation between them.

#### 1.5 Effective Date

The "Effective Date" shall be the date upon which a complete and fully executed copy of the Agreement is delivered to each Party or its counsel.

## 2. <u>INJUNCTIVE RELIEF</u>

## 2.1 Reformulation Standard

As of the Effective Date, MHL shall not manufacture, distribute, sell, offer for sale, or cause to have the Products sold in California unless (a) the Product contains no more than 1.0 microgram of lead based on a wipe sample collected using NIOSH Method 9100 from the part of the Product that contains the Exterior Decorations, or (b) the Product is accompanied by a clear and reasonable warning as described below in Section 2.2. "Exterior Decorations" is defined as all colored artwork, designs and/or markings on the exterior surface of the Products.

## 2.2 Proposition 65 Warnings

**2.2.1** For any Products that are not Reformulated Products, such Products shall be accompanied by a clear and reasonable warning. MHL shall provide the following warning statements as follows:

"WARNING: This product can expose you to Lead which is known to the State of California to cause cancer and birth defects or other reproductive harm. For more information go to www.P65Warnings.ca.gov.

If MHL has reason to believe the Products may expose consumers to additional chemicals listed under Proposition 65, then it may replace "Lead which is" with "chemicals, including Lead, which are" in the warning statement. The warning shall be accompanied by a symbol consisting of a black exclamation point in a yellow equilateral triangle with a bold black outline. Where the label for the product is not printed using the color yellow, the symbol may be printed in black and white. The symbol shall be placed to the left of the text of the warning, in a size no smaller than the height of the word "WARNING".

The Products shall carry said warning directly on each unit, label, or package, with such conspicuousness as compared with other words, statements or designs as to render it likely to be read and understood by an ordinary consumer prior to sale. A Product that is sold by MHL on the internet to persons located in California shall also provide the warning message by a clearly marked hyperlink on the product display page, or otherwise prominently displayed to the purchaser before the purchaser completes his or her purchase of the Product. For Products that MHL provides for a downstream entity to sell on the internet to California consumers, MHL shall include an instruction that the entity comply with the warning requirements of this section.

## 3. PAYMENTS

## 3.1 Civil Penalty Pursuant To Proposition 65

In settlement of all claims referred to in this Agreement, MHL shall pay a total civil penalty of five hundred dollars (\$500.00) to be apportioned in accordance with *Health and Safety Code* section 25249.12(c)(1) and (d), with 75% (\$375.00) for State of California Office of Environmental Health Hazard Assessment ("OEHHA"), and the remaining 25% (\$125.00) for APS&EE.

MHL shall issue these payments collectively as part of the total payment

described below in Section 3.2 via wire transfer to Law Offices of Lucas T. Novak. After receipt of the wire transfer, Law Offices of Lucas T. Novak shall be responsible for forwarding the respective payments to OEHHA and APS&EE.

## 3.2 Reimbursement Of APS&EE's Fees And Costs

MHL shall reimburse APS&EE's reasonable experts' and attorney's fees and costs incurred in prosecuting the instant action, for all work performed through execution of this Agreement, in the amount of sixteen thousand dollars (\$16,000.00). Accordingly, along with the civil penalty described above in Section 3.1, MHL shall remit total payment via wire transfer to Law Offices of Lucas T. Novak in the amount of sixteen thousand five hundred dollars (\$16,500.00) within ten (10) business days of the Effective Date. APS&EE will provide wiring instructions and appropriate W-9 form for Law Offices of Lucas T. Novak prior to the Effective Date.

## 4. <u>RELEASES</u>

## 4.1 APS&EE's Release of Proposition 65 Claims

APS&EE, in consideration of the promises and monetary payments contained herein, hereby releases MHL, its parents, subsidiaries, shareholders, directors, members, officers, employees, attorneys, successors and assignees, and all entities to whom they directly or indirectly distribute or sell Products, including but not limited to, downstream distributors, retailers, and franchisees, including The TJX Companies, Inc., its parents, subsidiaries, and affiliates (collectively "Released Parties"), from any alleged Proposition 65 violation claims asserted in APS&EE's Notice regarding failure to warn about Lead exposure from the Products that MHL has sold and/or caused to be sold in California before and up to the Effective Date.

#### 4.2 MHL's Release of APS&EE

MHL, by this Agreement, waives all rights to institute any form of legal action against APS&EE, its shareholders, directors, members, officers, employees, attorneys, experts, successors and assignees for actions or statements made or undertaken in connection with the course of investigating or seeking enforcement of Proposition 65

with respect to lead in the Products against MHL in this matter. If any Released Party should institute any such action, then APS&EE's release of said Released Party in this Agreement shall be rendered void and unenforceable.

#### 4.3 Waiver of Unknown Claims

APS&EE acknowledges that it is familiar with California Civil Code Section 1542 which provides:

A GENERAL RELEASE DOES NOT EXTEND TO CLAIMS THAT THE CREDITOR OR RELEASING PARTY DOES NOT KNOW OR SUSPECT TO EXIST IN HIS OR HER FAVOR AT THE TIME OF EXECUTING THE RELEASE AND THAT, IF KNOWN BY HIM OR HER, WOULD HAVE MATERIALLY AFFECTED HIS OR HER SETTLEMENT WITH THE DEBTOR OR RELEASED PARTY.

APS&EE waives and relinquishes any right or benefit it has or may have under California Civil Code Section 1542 or any similar provision under the statutory or non-statutory law of any other jurisdiction to the full extent that it may lawfully waive all such rights and benefits. APS&EE acknowledge that each may subsequently discover facts in addition to, or different from, those that it believes to be true with respect to the claims released herein. APS&EE agrees that this Agreement and the releases contained herein shall be and remain effective in all respects notwithstanding the discovery of such additional or different facts.

## 5. <u>SEVERABILITY</u>

Should any part or provision of this Agreement for any reason be declared by a Court to be invalid, void or unenforceable, the remaining portions and provisions shall continue in full force and effect.

## 6. **GOVERNING LAW**

The terms of this Agreement shall be governed by the laws of the State of California.

Any photocopy of the executed Agreement shall have the same force and effect as the originals.
