1 **1. INTRODUCTION**

2 **1.1** On May 5, 2022, Plaintiff Environmental Research Center, Inc. (“ERC”), a non-
3 profit corporation, as a private enforcer and in the public interest, initiated this action by filing
4 a Complaint for Injunctive and Declaratory Relief and Civil Penalties pursuant to the
5 provisions of California Health and Safety Code section 25249.5 *et seq.* (“Proposition 65”),
6 against 88 Acres Foods, Inc. (“88 Acres”) and Does 1-100. On May 16, 2022, a First Amended
7 Complaint was filed (the operative Complaint, hereinafter referred to as “Complaint”). In this
8 action, ERC alleges that a number of products manufactured, distributed, or sold by 88 Acres
9 contain lead, a chemical listed under Proposition 65 as a carcinogen and reproductive toxin,
10 and expose consumers to this chemical at a level requiring a Proposition 65 warning. These
11 products (referred to hereinafter individually as a “Covered Product” or collectively as
12 “Covered Products”) are: 88 Acres Rich 'N' Bold Double Dark Chocolate Seed + Oat Bar and
13 88 Acres Sweet 'N' Salty Dark Chocolate Sea Salt Seed + Oat Bar.

14 **1.2** ERC and 88 Acres are hereinafter referred to individually as a “Party” or
15 collectively as the “Parties.”

16 **1.3** ERC is a 501 (c)(3) California non-profit corporation dedicated to, among other
17 causes, helping safeguard the public from health hazards by reducing the use and misuse of
18 hazardous and toxic chemicals, facilitating a safe environment for consumers and employees,
19 and encouraging corporate responsibility.

20 **1.4** For purposes of this Consent Judgment, the Parties agree that 88 Acres is a
21 business entity that has employed ten or more persons at all times relevant to this action and
22 qualifies as a “person in the course of doing business” within the meaning of Proposition 65. 88
23 Acres manufactures, distributes, and/or sells the Covered Products.

24 **1.5** The Complaint is based on allegations contained in ERC’s Notices of Violation
25 dated February 23, 2022 and March 4, 2022 that were served on the California Attorney
26 General, other public enforcers, and 88 Acres (“Notices”). True and correct copies of the 60-
27 Day Notices dated February 23, 2022 and March 4, 2022 are attached hereto as *Exhibits A*
28 and *B* and each is incorporated herein by reference. More than 60 days have passed since the

1 Notices were served on the Attorney General, public enforcers, and 88 Acres and no
2 designated governmental entity has filed a Complaint against 88 Acres with regard to the
3 Covered Products or the alleged violations.

4 **1.6** ERC’s Notices and Complaint allege that use of the Covered Products by
5 California consumers exposes them to lead without first receiving clear and reasonable
6 warnings from 88 Acres, which is in violation of California Health and Safety Code section
7 25249.6. 88 Acres denies all material allegations contained in the Notices and Complaint.

8 **1.7** The Parties have entered into this Consent Judgment in order to settle,
9 compromise, and resolve disputed claims and thus avoid prolonged and costly litigation.
10 Nothing in this Consent Judgment nor compliance with this Consent Judgment shall constitute
11 or be construed as an admission by any of the Parties or by any of their respective officers,
12 directors, shareholders, employees, agents, parent companies, subsidiaries, divisions,
13 franchisees, licensees, customers, suppliers, distributors, wholesalers, or retailers of any fact,
14 issue of law, or violation of law.

15 **1.8** Except as expressly set forth herein, nothing in this Consent Judgment shall
16 prejudice, waive, or impair any right, remedy, argument, or defense the Parties may have in
17 any current or future legal proceeding unrelated to these proceedings.

18 **1.9** The Effective Date of this Consent Judgment is the date on which it is entered
19 as a Judgment by this Court.

20 **2. JURISDICTION AND VENUE**

21 For purposes of this Consent Judgment and any further court action that may become
22 necessary to enforce this Consent Judgment, the Parties stipulate that this Court has subject matter
23 jurisdiction over the allegations of violations contained in the Complaint and personal jurisdiction
24 over 88 Acres as to the acts alleged in the Complaint, that venue is proper in Alameda County,
25 and that this Court has jurisdiction to enter this Consent Judgment as a full and final resolution of
26 all claims up through and including the Effective Date that were or could have been asserted in
27 this action based on the facts alleged in the Notices and Complaint.

1 **3. INJUNCTIVE RELIEF, REFORMULATION, TESTING AND WARNINGS**

2 **3.1** Beginning on the Effective Date, 88 Acres shall be permanently enjoined from
3 manufacturing for sale in the State of California, “Distributing into the State of California,” or
4 directly selling in the State of California, any Covered Product that exposes a person to a
5 “Daily Lead Exposure Level” of more than 0.5 micrograms of lead per day unless it meets the
6 warning requirements under Section 3.2.

7 **3.1.1** As used in this Consent Judgment, the term “Distributing into the State
8 of California” shall mean to directly ship a Covered Product into California for sale in
9 California or to sell a Covered Product to a distributor that 88 Acres knows or has reason to
10 know will sell the Covered Product in California.

11 **3.1.2** For purposes of this Consent Judgment, the “Daily Lead Exposure
12 Level” shall be measured in micrograms, and shall be calculated using the following formula:
13 micrograms of lead per gram of product, multiplied by grams of product per serving of the
14 product (using the largest serving size appearing on the product label), multiplied by servings
15 of the product per day (using the largest number of recommended daily servings appearing on
16 the label), which equals micrograms of lead exposure per day. If the label contains no
17 recommended daily servings, then the number of recommended daily servings shall be one.

18 **3.1.3** In calculating the Daily Lead Exposure Level for a Covered Product, 88
19 Acres shall be allowed to deduct the amount of lead which is deemed “naturally occurring” in the
20 ingredients listed in **Table 1** that are contained in that Covered Product under the following
21 conditions: For each year that 88 Acres claims entitlement to a “naturally occurring” allowance
22 for lead, 88 Acres shall provide ERC with the following information: (a) 88 Acres must produce
23 to ERC a written list of each ingredient in the Covered Product, and the amount, measured in
24 grams, of each such ingredient contained therein, for which a “naturally occurring” allowance is
25 claimed; (b) 88 Acres must provide ERC with documentation of laboratory testing, conducted
26 during the year for which the “naturally occurring” allowance is claimed, that complies with
27 Sections 3.4.3 and 3.4.4 and that shows the amount of lead, if any, contained in each ingredient
28 listed in **Table 1** that is contained in the Covered Product and for which 88 Acres intends to

deduct “naturally occurring” lead; (c) If the laboratory testing reveals the presence of lead in any of the ingredients listed in **Table 1** that are contained in the Covered Product, 88 Acres shall be entitled to deduct the amount of lead contained in each such ingredient, up to the full amount of the allowance for each such ingredient as shown in **Table 1**, but not to exceed the total amount of lead contained in such ingredient; and (d) If the Covered Product does not contain any of the ingredients listed in **Table 1**, 88 Acres shall not be entitled to a deduction for “naturally occurring” lead in the Covered Product for those ingredients. The information required by Sections 3.1.3(a) and (b) shall be provided to ERC within thirty (30) days of the Effective Date, or anniversary thereof, for any year that 88 Acres shall claim entitlement to the “naturally occurring” allowance:

TABLE 1

Calcium (elemental)	Up to 0.8 micrograms/gram
Ferrous Fumarate	Up to 0.4 micrograms/gram
Zinc Oxide	Up to 8.0 micrograms/gram
Magnesium Oxide	Up to 0.4 micrograms/gram
Magnesium Carbonate	Up to 0.332 micrograms/gram
Magnesium Hydroxide	Up to 0.4 micrograms/gram
Zinc Gluconate	Up to 0.8 micrograms/gram
Potassium Chloride	Up to 1.1 micrograms/gram
Cocoa Powder	Up to 1.0 microgram/gram
Chocolate Liquor	Up to 1.0 microgram/gram
Cocoa Butter	Up to 0.1 micrograms/gram

3.2 Clear and Reasonable Warnings

If 88 Acres is required to provide a warning pursuant to Section 3.1, the following warning must be utilized (“Warning”):

WARNING: Consuming this product can expose you to chemicals including lead which is known to the State of California to cause [cancer and] birth defects or other reproductive

1 harm. For more information go to www.P65Warnings.ca.gov/food.

2 88 Acres shall use the phrase “cancer and” in the Warning if 88 Acres has reason to
3 believe that the “Daily Lead Exposure Level” is greater than 15 micrograms of lead as determined
4 pursuant to the quality control methodology set forth in Section 3.4 or if 88 Acres has reason to
5 believe that another Proposition 65 chemical is present which may require a cancer warning.

6 The Warning shall be securely affixed to or printed upon the label of each Covered
7 Product and it must be set off from other surrounding information and enclosed in a box. In
8 addition, for any Covered Product sold over the internet, the Warning shall appear on the
9 checkout page when a California delivery address is indicated for any purchase of any Covered
10 Product. An asterisk or other identifying method must be utilized to identify which products on
11 the checkout page are subject to the Warning. In no event shall any internet or website
12 Warning be contained in or made through a link.

13 The Warning shall be at least the same size as the largest of any other health or safety
14 warnings also appearing on the website or on the label and the word “**WARNING**” shall be in all
15 capital letters and in bold print. No statements intended to or likely to have the effect of
16 diminishing the impact of the Warning on the average lay person shall accompany the Warning.
17 Further no statements may accompany the Warning that state or imply that the source of the listed
18 chemical has an impact on or results in a less harmful effect of the listed chemical.

19 88 Acres must display the above Warning with such conspicuousness, as compared with
20 other words, statements or designs on the label, or on its website, if applicable, to render the
21 Warning likely to be read and understood by an ordinary individual under customary conditions
22 of purchase or use of the product.

23 For purposes of this Consent Judgment, the term “label” means a display of written,
24 printed or graphic material that is printed on or affixed to a Covered Product or its immediate
25 container or wrapper.

26 **3.3 Conforming Covered Products**

27 A Conforming Covered Product is a Covered Product for which the “Daily Lead Exposure
28 Level” is no greater than 0.5 micrograms of lead per day as determined by the exposure

1 methodology set forth in Section 3.1.2 and the quality control methodology described in Section
2 3.4, and that is not known by 88 Acres to contain other chemicals that violate Proposition 65's
3 safe harbor thresholds.

4 **3.4 Testing and Quality Control Methodology**

5 **3.4.1** Beginning within one year of the Effective Date, 88 Acres shall arrange
6 for lead testing of the Covered Products at least once a year for a minimum of four consecutive
7 years by arranging for testing of three (3) randomly selected samples of each of the Covered
8 Products, in the form intended for sale to the end-user, which 88 Acres intends to sell or is
9 manufacturing for sale in California, directly selling to a consumer in California or
10 "Distributing into the State of California." If tests conducted pursuant to this Section
11 demonstrate that no Warning is required for a Covered Product during each of four consecutive
12 years, then the testing requirements of this Section will no longer be required as to that
13 Covered Product.

14 **3.4.2** For purposes of measuring the "Daily Lead Exposure Level," the highest
15 lead detection result of the three (3) randomly selected samples of the Covered Products will
16 be controlling.

17 **3.4.3** All testing pursuant to this Consent Judgment shall be performed using a
18 laboratory method that complies with the performance and quality control factors appropriate
19 for the method used, including limit of detection and limit of quantification, sensitivity,
20 accuracy and precision that meets the following criteria: Inductively Coupled Plasma-Mass
21 Spectrometry ("ICP-MS") achieving a limit of quantification of less than or equal to 0.005
22 mg/kg.

23 **3.4.4** All testing pursuant to this Consent Judgment shall be performed by an
24 independent third party laboratory certified by the California Environmental Laboratory
25 Accreditation Program or an independent third-party laboratory that is registered with the
26 United States Food & Drug Administration.

27 **3.4.5** Nothing in this Consent Judgment shall limit 88 Acres's ability to
28 conduct, or require that others conduct, additional testing of the Covered Products, including

1 the raw materials used in their manufacture.

2 **3.4.6** During each yearly testing period required by Section 3.4.1, when the
3 required randomly selected testing for a Covered Product results in a "Daily Lead Exposure
4 Level" that is more than 0.5 micrograms of lead per day, 88 Acres shall have the right to test
5 other lots of that Covered Product, from which lots no randomly selected samples were tested
6 pursuant to Section 3.4.1, to determine if those lots may be excepted from the Warning
7 requirements of Section 3.2 during that yearly testing period. For each such lot that is tested,
8 88 Acres shall test at least two randomly selected samples of the Covered Product from that
9 lot, and the highest lead detection result will be controlling in determining the "Daily Lead
10 Exposure Level." Lots that result in a "Daily Lead Exposure Level" of less than .5 micrograms
11 of lead per day may be sold in California without a Warning.

12 **3.4.7** Within thirty (30) days of ERC's written request, 88 Acres shall deliver
13 lab reports obtained pursuant to Section 3.4 to ERC. 88 Acres shall retain all test results and
14 documentation for a period of five years from the date of each test.

15 **4. SETTLEMENT PAYMENT**

16 **4.1** In full satisfaction of all potential civil penalties, additional settlement
17 payments, attorney's fees, and costs, 88 Acres shall make a total payment of \$50,000.00
18 ("Total Settlement Amount") to ERC within 5 days of the Effective Date ("Due Date"). 88
19 Acres shall make this payment by wire transfer to ERC's account, for which ERC will give 88
20 Acres the necessary account information. The Total Settlement Amount shall be apportioned as
21 follows:

22 **4.2** \$5,000.00 shall be considered a civil penalty pursuant to California Health and
23 Safety Code section 25249.7(b)(1). ERC shall remit 75% (\$3,750.00) of the civil penalty to the
24 Office of Environmental Health Hazard Assessment ("OEHHA") for deposit in the Safe
25 Drinking Water and Toxic Enforcement Fund in accordance with California Health and Safety
26 Code section 25249.12(c). ERC will retain the remaining 25% (\$1,250.00) of the civil penalty.

27 **4.3** \$11,189.16 shall be distributed to ERC as reimbursement to ERC for reasonable
28 costs incurred in bringing this action.

1 **4.4** \$33,810.84 shall be distributed to ERC for its in-house legal fees. Except as
2 explicitly provided herein, each Party shall bear its own fees and costs.

3 **4.5** In the event that 88 Acres fails to remit the Total Settlement Amount owed
4 under Section 4 of this Consent Judgment on or before the Due Date, 88 Acres shall be deemed
5 to be in material breach of its obligations under this Consent Judgment. ERC shall provide
6 written notice of the delinquency to 88 Acres via electronic mail. If 88 Acres fails to deliver
7 the Total Settlement Amount within five (5) days from the written notice, the Total Settlement
8 Amount shall accrue interest at the statutory judgment interest rate provided in the California
9 Code of Civil Procedure section 685.010. Additionally, 88 Acres agrees to pay ERC's
10 reasonable attorney's fees and costs for any efforts to collect the payment due under this
11 Consent Judgment.

12 **5. MODIFICATION OF CONSENT JUDGMENT**

13 **5.1** This Consent Judgment may be modified only as to injunctive terms (i) by
14 written stipulation of the Parties and upon entry by the Court of a modified consent judgment
15 or (ii) by motion of either Party pursuant to Section 5.3 and upon entry by the Court of a
16 modified consent judgment.

17 **5.2** If 88 Acres seeks to modify this Consent Judgment under Section 5.1, then 88
18 Acres must provide written notice to ERC of its intent ("Notice of Intent"). If ERC seeks to
19 meet and confer regarding the proposed modification in the Notice of Intent, then ERC must
20 provide written notice to 88 Acres within thirty (30) days of receiving the Notice of Intent. If
21 ERC notifies 88 Acres in a timely manner of ERC's intent to meet and confer, then the Parties
22 shall meet and confer in good faith as required in this Section. The Parties shall meet in person
23 or via telephone within thirty (30) days of ERC's notification of its intent
24 to meet and confer. Within thirty (30) days of such meeting, if ERC disputes the proposed
25 modification, ERC shall provide to 88 Acres a written basis for its position. The Parties shall
26 continue to meet and confer for an additional thirty (30) days in an effort to resolve any
27 remaining disputes. Should it become necessary, the Parties may agree in writing to different
28 deadlines for the meet-and-confer period.

1 **5.3** In the event that 88 Acres initiates or otherwise requests a modification under
2 Section 5.1, and the meet and confer process leads to a joint motion or application for a
3 modification of the Consent Judgment, 88 Acres shall reimburse ERC its costs and reasonable
4 attorney’s fees for the time spent in the meet-and-confer process and filing and arguing the
5 motion or application.

6 **6. RETENTION OF JURISDICTION, ENFORCEMENT OF CONSENT**
7 **JUDGMENT**

8 **6.1** This Court shall retain jurisdiction of this matter to enforce, modify, or
9 terminate this Consent Judgment.

10 **6.2** Only ERC may enforce the terms of this Consent Judgment. If ERC alleges that
11 any Covered Product fails to qualify as a Conforming Covered Product (for which ERC alleges
12 that no Warning has been provided), then ERC shall inform 88 Acres in a reasonably prompt
13 manner of its test results, including information sufficient to permit 88 Acres to identify the
14 Covered Products at issue. 88 Acres shall, within thirty (30) days following such notice,
15 provide ERC with testing information, from an independent third-party laboratory meeting the
16 requirements of Sections 3.4.3 and 3.4.4, demonstrating 88 Acres’s compliance with the
17 Consent Judgment. The Parties shall first attempt to resolve the matter prior to ERC taking any
18 further legal action.

19 **7. APPLICATION OF CONSENT JUDGMENT**

20 This Consent Judgment may apply to, be binding upon, and benefit the Parties and their
21 respective officers, directors, shareholders, employees, agents, parent companies, subsidiaries,
22 divisions, franchisees, licensees, customers (excluding private labelers), distributors, wholesalers,
23 retailers, predecessors, successors, and assigns. This Consent Judgment shall have no
24 application to any Covered Product that is distributed or sold exclusively outside the State of
25 California and that is not used by California consumers.

26 **8. BINDING EFFECT, CLAIMS COVERED AND RELEASED**

27 **8.1** This Consent Judgment is a full, final, and binding resolution between ERC,
28 on behalf of itself and in the public interest, and 88 Acres and its respective officers, directors,

1 shareholders, employees, agents, parent companies, subsidiaries, divisions, suppliers,
2 franchisees, licensees, customers (not including private label customers of 88 Acres),
3 distributors, wholesalers, retailers, and all other upstream and downstream entities in the
4 distribution chain of any Covered Product, and the predecessors, successors, and assigns of any
5 of them (collectively, “Released Parties”).

6 **8.2** ERC, acting in the public interest, releases the Released Parties from any
7 and all claims for violations of Proposition 65 up through the Effective Date based on exposure
8 to lead from the Covered Products as set forth in the Notices of Violation. ERC, on behalf of
9 itself only, hereby fully releases and discharges the Released Parties from any and all claims,
10 actions, causes of action, suits, demands, liabilities, damages, penalties, fees, costs, and
11 expenses asserted, or that could have been asserted from the handling, use, or consumption of
12 the Covered Products, as to any alleged violation of Proposition 65 or its implementing
13 regulations arising from the failure to provide Proposition 65 warnings on the Covered
14 Products manufactured and Placed into the Stream of Commerce on or before the Effective
15 Date. For purposes of this Consent Judgment, the term “Placed into the Stream of Commerce”
16 means that manufactured Covered Products have been put into final packaging for consumer
17 sale and are no longer in the possession of or under the control of 88 Acres. regarding lead u.

18 **8.3** ERC on its own behalf only, and 88 Acres on its own behalf only, further
19 waive and release any and all claims they may have against each other for all actions or
20 statements made or undertaken in the course of seeking or opposing enforcement of
21 Proposition 65 in connection with the Notices and Complaint up through and including the
22 Effective Date, provided, however, that nothing in Section 8 shall affect or limit any Party’s
23 right to seek to enforce the terms of this Consent Judgment.

24 **8.4** It is possible that other claims not known to the Parties, arising out of the facts
25 alleged in the Notices and Complaint, and relating to the Covered Products, will develop or be
26 discovered. ERC on behalf of itself only, and 88 Acres on behalf of itself only, acknowledge
27 that this Consent Judgment is expressly intended to cover and include all such claims up
28 through and including the Effective Date, including all rights of action therefore. ERC and 88

1 Acres acknowledge that the claims released in Sections 8.2 and 8.3 above may include
2 unknown claims, and nevertheless waive California Civil Code section 1542 as to any such
3 unknown claims. California Civil Code section 1542 reads as follows:

4 A GENERAL RELEASE DOES NOT EXTEND TO CLAIMS THAT THE
5 CREDITOR OR RELEASING PARTY DOES NOT KNOW OR SUSPECT TO
6 EXIST IN HIS OR HER FAVOR AT THE TIME OF EXECUTING THE RELEASE
7 AND THAT, IF KNOWN BY HIM OR HER, WOULD HAVE MATERIALLY
8 AFFECTED HIS OR HER SETTLEMENT WITH THE DEBTOR OR RELEASED
9 PARTY.

8 ERC on behalf of itself only, and 88 Acres on behalf of itself only, acknowledge and
9 understand the significance and consequences of this specific waiver of California Civil Code
10 section 1542.

11 **8.5** Compliance with the terms of this Consent Judgment shall be deemed to
12 constitute compliance with Proposition 65 by any of the Released Parties regarding alleged
13 exposures to lead in the Covered Products as set forth in the Notices and Complaint.

14 **8.6** Nothing in this Consent Judgment is intended to apply to any occupational or
15 environmental exposures arising under Proposition 65, nor shall it apply to any of 88 Acres's
16 products other than the Covered Products.

17 **9. SEVERABILITY OF UNENFORCEABLE PROVISIONS**

18 In the event that any of the provisions of this Consent Judgment are held by a court to be
19 unenforceable, the validity of the remaining enforceable provisions shall not be adversely
20 affected.

21 **10. GOVERNING LAW**

22 The terms and conditions of this Consent Judgment shall be governed by and construed in
23 accordance with the laws of the State of California.

24 **11. PROVISION OF NOTICE**

25 All notices required to be given to either Party to this Consent Judgment by the other shall
26 be in writing and sent to the following agents listed below via first-class mail or via electronic
27 mail where required. Courtesy copies via email may also be sent.

12. COURT APPROVAL

12.1 Upon execution of this Consent Judgment by the Parties, ERC shall notice a Motion for Court Approval. The Parties shall use their best efforts to support entry of this

1 Consent Judgment.

2 **12.2** If the California Attorney General objects to any term in this Consent Judgment,
3 the Parties shall use their best efforts to resolve the concern in a timely manner, and if possible
4 prior to the hearing on the motion.

5 **12.3** If this Stipulated Consent Judgment is not approved by the Court, it shall be
6 void and have no force or effect.

7 **13. EXECUTION AND COUNTERPARTS**

8 This Consent Judgment may be executed in counterparts, which taken together shall be
9 deemed to constitute one document. A facsimile or .pdf signature shall be construed to be as valid
10 as the original signature.

11 **14. DRAFTING**

12 The terms of this Consent Judgment have been reviewed by the respective counsel for
13 each Party prior to its signing, and each Party has had an opportunity to fully discuss the terms
14 and conditions with legal counsel. The Parties agree that, in any subsequent interpretation and
15 construction of this Consent Judgment, no inference, assumption, or presumption shall be drawn,
16 and no provision of this Consent Judgment shall be construed against any Party, based on the fact
17 that one of the Parties and/or one of the Parties' legal counsel prepared and/or drafted all or any
18 portion of the Consent Judgment. It is conclusively presumed that all of the Parties participated
19 equally in the preparation and drafting of this Consent Judgment.

20 **15. GOOD FAITH ATTEMPT TO RESOLVE DISPUTES**

21 If a dispute arises with respect to either Party's compliance with the terms of this Consent
22 Judgment entered by the Court, the Parties shall meet and confer in person, by telephone, and/or
23 in writing and endeavor to resolve the dispute in an amicable manner. No action or motion may
24 be filed in the absence of such a good faith attempt to resolve the dispute beforehand.

25 **16. ENFORCEMENT**

26 ERC may, by motion or order to show cause before the Superior Court of Alameda
27 County, enforce the terms and conditions contained in this Consent Judgment. In any action
28 brought by ERC to enforce this Consent Judgment, ERC may seek whatever fines, costs,

1 penalties, or remedies as are provided by law for failure to comply with the Consent Judgment.
2 To the extent the failure to comply with the Consent Judgment constitutes a violation of
3 Proposition 65 or other laws, ERC shall not be limited to enforcement of this Consent
4 Judgment, but may seek in another action whatever fines, costs, penalties, or remedies as are
5 provided by law for failure to comply with Proposition 65 or other laws.

6 **17. ENTIRE AGREEMENT, AUTHORIZATION**

7 **17.1** This Consent Judgment contains the sole and entire agreement and
8 understanding of the Parties with respect to the entire subject matter herein, including any and
9 all prior discussions, negotiations, commitments, and understandings related thereto. No
10 representations, oral or otherwise, express or implied, other than those contained herein have
11 been made by any Party. No other agreements, oral or otherwise, unless specifically referred to
12 herein, shall be deemed to exist or to bind any Party.

13 **17.2** Each signatory to this Consent Judgment certifies that he or she is fully
14 authorized by the Party he or she represents to stipulate to this Consent Judgment.

15 **18. REQUEST FOR FINDINGS, APPROVAL OF SETTLEMENT AND ENTRY OF**
16 **CONSENT JUDGMENT**

17 This Consent Judgment has come before the Court upon the request of the Parties. The
18 Parties request the Court to fully review this Consent Judgment and, being fully informed
19 regarding the matters which are the subject of this action, to:

20 (1) Find that the terms and provisions of this Consent Judgment represent a fair and
21 equitable settlement of all matters raised by the allegations of the Complaint that the matter has
22 been diligently prosecuted, and that the public interest is served by such settlement; and

23 (2) Make the findings pursuant to California Health and Safety Code section
24 25249.7(f)(4), approve the Settlement, and approve this Consent Judgment.

25 (3) Retain jurisdiction, pursuant to Section 664.6 of the Code of Civil Procedure, after
26 the Consent Judgment is entered in order to enforce, modify, or terminate this Consent Judgment.





NOTICE OF VIOLATIONS OF CALIFORNIA HEALTH & SAFETY CODE SECTION 25249.5 *ET SEQ.* (PROPOSITION 65)

Dear Alleged Violator and the Appropriate Public Enforcement Agencies:

I am the Executive Director of Environmental Research Center, Inc. (“ERC”). ERC is a California non-profit corporation dedicated to, among other causes, helping safeguard the public from health hazards by bringing about a reduction in the use and misuse of hazardous and toxic chemicals, facilitating a safe environment for consumers and employees, and encouraging corporate responsibility.

ERC has identified violations of California’s Safe Drinking Water and Toxic Enforcement Act of 1986 (“Proposition 65”), which is codified at California Health & Safety Code §25249.5 *et seq.*, with respect to the product identified below. These violations have occurred and continue to occur because the alleged Violator identified below failed to provide required clear and reasonable warnings with this product. This letter serves as a notice of these violations to the alleged Violator and the appropriate public enforcement agencies. Pursuant to Section 25249.7(d) of the statute, ERC intends to file a private enforcement action in the public interest 60 days after effective service of this notice unless the public enforcement agencies have commenced and are diligently prosecuting an action to rectify these violations.

General Information about Proposition 65. A copy of a summary of Proposition 65, prepared by the Office of Environmental Health Hazard Assessment, is attached with the copy of this letter served to the alleged Violator identified below.

Alleged Violator. The name of the company covered by this notice that violated Proposition 65 (hereinafter the “Violator”) is:

88 Acres Foods, Inc.

Consumer Product and Listed Chemical. The product that is the subject of this notice and the chemical in that product identified as exceeding allowable levels is:

88 Acres Rich 'N' Bold Double Dark Chocolate Seed + Oat Bar – Cadmium

Cadmium was officially listed as a chemical known to cause developmental toxicity and male reproductive toxicity on May 1, 1997, while cadmium and cadmium compounds were listed as chemicals known to the State of California to cause cancer on October 1, 1987.

It should be noted that ERC may continue to investigate other products that may reveal further violations and result in subsequent notices of violations.

Route of Exposure. The consumer exposures that are the subject of this notice result from the recommended use of this product. Consequently, the route of exposure to this chemical has been and continues to be through ingestion.

Approximate Time Period of Violations. Ongoing violations have occurred every day since at least February 23, 2019, as well as every day since the product was introduced into the California marketplace, and will continue every day until clear and reasonable warnings are provided to product purchasers and users or until this known toxic chemical is either removed from or reduced to allowable levels in the product. Proposition 65 requires that a clear and reasonable warning be provided prior to exposure to the identified chemical. The method of warning should be a warning that appears on the product label. The Violator violated Proposition 65 because it failed to provide persons ingesting this product with appropriate warnings that they are being exposed to this chemical.

Consistent with the public interest goals of Proposition 65 and a desire to have these ongoing violations of California law quickly rectified, ERC is interested in seeking a constructive resolution of this matter that includes an enforceable written agreement by the Violator to: (1) reformulate the identified product so as to eliminate further exposures to the identified chemical, or provide appropriate warnings on the labels of this product; (2) pay an appropriate civil penalty; and (3) provide clear and reasonable warnings compliant with Proposition 65 to all persons located in California who purchased the above product in the last three years. Such a resolution will prevent further unwarned consumer exposures to the identified chemical, as well as an expensive and time-consuming litigation.



THE SAFE DRINKING WATER AND TOXIC ENFORCEMENT ACT OF 1986 (PROPOSITION 65): A SUMMARY

The following summary has been prepared by the California Office of Environmental Health Hazard Assessment (OEHHA), the lead agency for the implementation of the Safe Drinking Water and Toxic Enforcement Act of 1986 (commonly known as “Proposition 65”). A copy of this summary must be included as an attachment to any notice of violation served upon an alleged violator of the Act. The summary provides basic information about the provisions of the law, and is intended to serve only as a convenient source of general information. It is not intended to provide authoritative guidance on the meaning or application of the law. The reader is directed to the statute and OEHHA implementing regulations (see citations below) for further information.

FOR INFORMATION CONCERNING THE BASIS FOR THE ALLEGATIONS IN THE NOTICE RELATED TO YOUR BUSINESS, CONTACT THE PERSON IDENTIFIED ON THE NOTICE.

The text of Proposition 65 (Health and Safety Code Sections 25249.5 through 25249.13) is available online at: <http://oehha.ca.gov/prop65/law/P65law72003.html>. Regulations that provide more specific guidance on compliance, and that specify procedures to be followed by the State in carrying out certain aspects of the law, are found in Title 27 of the California Code of Regulations, sections 25102 through 27001.¹ These implementing regulations are available online at: <http://oehha.ca.gov/prop65/law/P65Regs.html>.

WHAT DOES PROPOSITION 65 REQUIRE?

The “Proposition 65 List.” Under Proposition 65, the lead agency (OEHHA) publishes a list of chemicals that are known to the State of California to cause cancer and/or reproductive toxicity. Chemicals are placed on the Proposition 65 list if they are known to cause cancer and/or birth defects or other reproductive harm, such as damage to

female or male reproductive systems or to the developing fetus. This list must be updated at least once a year. The current Proposition 65 list of chemicals is available on the OEHHA website at: http://www.oehha.ca.gov/prop65/prop65_list/Newlist.html.

Only those chemicals that are on the list are regulated under Proposition 65. Businesses that produce, use, release or otherwise engage in activities involving listed chemicals must comply with the following:

Clear and reasonable warnings. A business is required to warn a person before “knowingly and intentionally” exposing that person to a listed chemical unless an exemption applies. The warning given must be “clear and reasonable.” This means that the warning must: (1) clearly make known that the chemical involved is known to cause cancer, or birth defects or other reproductive harm; and (2) be given in such a way that it will effectively reach the person before he or she is exposed to that chemical. Some exposures are exempt from the warning requirement under certain circumstances discussed below.

Prohibition from discharges into drinking water. A business must not knowingly discharge or release a listed chemical into water or onto land where it passes or probably will pass into a source of drinking water. Some discharges are exempt from this requirement under certain circumstances discussed below.

DOES PROPOSITION 65 PROVIDE ANY EXEMPTIONS?

Yes. You should consult the current version of the statute and regulations (<http://www.oehha.ca.gov/prop65/law/index.html>) to determine all applicable exemptions, the most common of which are the following:

Grace Period. Proposition 65 warning requirements do not apply until 12 months after the chemical has been listed. The Proposition 65 discharge prohibition does not apply to a discharge or release of a chemical that takes place less than 20 months after the listing of the chemical.

Governmental agencies and public water utilities. All agencies of the federal, state or local government, as well as entities operating public water systems, are exempt.

Businesses with nine or fewer employees. Neither the warning requirement nor the discharge prohibition applies to a business that employs a total of nine or fewer employees. This includes all employees, not just those present in California.

Exposures that pose no significant risk of cancer. For chemicals that are listed under Proposition 65 as known to the State to cause cancer, a warning is not required if the business causing the exposure can demonstrate that the exposure occurs at a level that poses “no significant risk.” This means that the exposure is calculated to result in not more than one excess case of cancer in 100,000 individuals exposed over a 70-year lifetime. The Proposition 65 regulations identify specific “No Significant Risk Levels” (NSRLs) for many listed carcinogens. Exposures below these levels are exempt from the warning requirement. See OEHHA's website at: <http://www.oehha.ca.gov/prop65/getNSRLs.html> for a list of NSRLs, and Section 25701 *et seq.* of the regulations for information concerning how these levels are calculated.

Exposures that will produce no observable reproductive effect at 1,000 times the level in question. For chemicals known to the State to cause reproductive toxicity, a warning is not required if the business causing the exposure can demonstrate that the exposure will produce no observable effect, even at 1,000 times the level in question. In other words, the level of exposure must be below the “no observable effect level” divided by 1,000. This number is known as the Maximum Allowable Dose Level (MADL). See OEHHA's website at: <http://www.oehha.ca.gov/prop65/getNSRLs.html> for a list of MADLs, and Section 25801 *et seq.* of the regulations for information concerning how these levels are calculated.

Exposures to Naturally Occurring Chemicals in Food. Certain exposures to chemicals that naturally occur in foods (i.e., that do not result from any known human activity, including activity by someone other than the person causing the exposure) are exempt from the warning requirements of the law. If the chemical is a contaminant² it must be reduced to the lowest level feasible. Regulations explaining this exemption can be found in Section 25501.

Discharges that do not result in a “significant amount” of the listed chemical entering any source of drinking water. The prohibition from discharges into drinking water does not apply if the discharger is able to demonstrate that a “significant amount” of the listed chemical has not, does not, or will not pass into or probably pass into a source of drinking water, and that the discharge complies with all other applicable laws, regulations, permits, requirements, or orders. A “significant amount” means any detectable amount, except an amount that would meet the “no significant risk” level for chemicals that cause cancer or that is 1,000 times below the “no observable effect” level for chemicals that cause reproductive toxicity, if an individual were exposed to that amount in drinking water.

HOW IS PROPOSITION 65 ENFORCED?

Enforcement is carried out through civil lawsuits. These lawsuits may be brought by the Attorney General, any district attorney, or certain city attorneys. Lawsuits may also be brought by private parties acting in the public interest, but only after providing notice of the alleged violation to the Attorney General, the appropriate district attorney and city attorney, and the business accused of the violation. The notice must provide adequate information to allow the recipient to assess the nature of the alleged violation. The notice must comply with the information and procedural requirements specified in Section 25903 of Title 27 and sections 3100-3103 of Title 11. A private party may not pursue an independent enforcement action under Proposition 65 if one of the governmental officials noted above initiates an enforcement action within sixty days of the notice.

A business found to be in violation of Proposition 65 is subject to civil penalties of up to \$2,500 per day for each violation. In addition, the business may be ordered by a court to stop committing the violation.

A private party may not file an enforcement action based on certain exposures if the alleged violator meets specific conditions. For the following types of exposures, the Act provides an opportunity for the business to correct the alleged violation:

- An exposure to alcoholic beverages that are consumed on the alleged violator's premises to the extent onsite consumption is permitted by law;
- An exposure to a Proposition 65 listed chemical in a food or beverage prepared and sold on the alleged violator's premises that is primarily intended for immediate consumption on- or off-premises. This only applies if the chemical was not intentionally added to the food, and was formed by cooking or similar preparation of food or beverage components necessary to render the food or beverage palatable or to avoid microbiological contamination;
- An exposure to environmental tobacco smoke caused by entry of persons (other than employees) on premises owned or operated by the alleged violator where smoking is permitted at any location on the premises;
- An exposure to listed chemicals in engine exhaust, to the extent the exposure occurs inside a facility owned or operated by the alleged violator and primarily intended for parking non-commercial vehicles.

If a private party alleges that a violation occurred based on one of the exposures described above, the private party must first provide the alleged violator a notice of special compliance procedure and proof of compliance form.

NOTICE OF VIOLATIONS OF CALIFORNIA HEALTH & SAFETY CODE SECTION 25249.5 *ET SEQ.* (PROPOSITION 65)

Dear Alleged Violator and the Appropriate Public Enforcement Agencies:

I am the Executive Director of Environmental Research Center, Inc. (“ERC”). ERC is a California non-profit corporation dedicated to, among other causes, helping safeguard the public from health hazards by bringing about a reduction in the use and misuse of hazardous and toxic chemicals, facilitating a safe environment for consumers and employees, and encouraging corporate responsibility.

ERC has identified violations of California’s Safe Drinking Water and Toxic Enforcement Act of 1986 (“Proposition 65”), which is codified at California Health & Safety Code §25249.5 *et seq.*, with respect to the product identified below. These violations have occurred and continue to occur because the alleged Violator identified below failed to provide required clear and reasonable warnings with this product. This letter serves as a notice of these violations to the alleged Violator and the appropriate public enforcement agencies. Pursuant to Section 25249.7(d) of the statute, ERC intends to file a private enforcement action in the public interest 60 days after effective service of this notice unless the public enforcement agencies have commenced and are diligently prosecuting an action to rectify these violations.

General Information about Proposition 65. A copy of a summary of Proposition 65, prepared by the Office of Environmental Health Hazard Assessment, is attached with the copy of this letter served to the alleged Violator identified below.

Alleged Violator. The name of the company covered by this notice that violated Proposition 65 (hereinafter the “Violator”) is:

88 Acres Foods, Inc.

Consumer Product and Listed Chemicals. The product that is the subject of this notice and the chemicals in that product identified as exceeding allowable levels are:

88 Acres Sweet 'N' Salty Dark Chocolate Sea Salt Seed + Oat Bar – Lead, Cadmium

On February 27, 1987, the State of California officially listed lead as a chemical known to cause developmental toxicity, and male and female reproductive toxicity. On October 1, 1992, the State of California officially listed lead and lead compounds as chemicals known to cause cancer.

Cadmium was officially listed as a chemical known to cause developmental toxicity and male reproductive toxicity on May 1, 1997, while cadmium and cadmium compounds were listed as chemicals known to the State of California to cause cancer on October 1, 1987.

It should be noted that ERC may continue to investigate other products that may reveal further violations and result in subsequent notices of violations.

Route of Exposure. The consumer exposures that are the subject of this notice result from the recommended use of this product. Consequently, the route of exposure to these chemicals has been and continues to be through ingestion.

Approximate Time Period of Violations. Ongoing violations have occurred every day since at least March 4, 2019, as well as every day since the product was introduced into the California marketplace, and will continue every day until clear and reasonable warnings are provided to product purchasers and users or until these known toxic chemicals are either removed from or reduced to allowable levels in the product. Proposition 65 requires that a clear and reasonable warning be provided prior to exposure to the identified chemicals. The method of warning should be a warning that appears on the product label. The Violator violated Proposition 65 because it failed to provide persons ingesting this product with appropriate warnings that they are being exposed to these chemicals.

Consistent with the public interest goals of Proposition 65 and a desire to have these ongoing violations of California law quickly rectified, ERC is interested in seeking a constructive resolution of this matter that includes an enforceable written agreement by the Violator to: (1) reformulate the identified product so as to eliminate further exposures to the identified chemicals, or provide appropriate warnings on the labels of this product; (2) pay an appropriate civil penalty; and (3) provide clear and reasonable warnings compliant with Proposition 65 to all persons located in California who purchased the above product in the last three years. Such a resolution will prevent further unwarned consumer exposures to the identified chemicals, as well as an expensive and time-consuming litigation.



THE SAFE DRINKING WATER AND TOXIC ENFORCEMENT ACT OF 1986 (PROPOSITION 65): A SUMMARY

The following summary has been prepared by the California Office of Environmental Health Hazard Assessment (OEHHA), the lead agency for the implementation of the Safe Drinking Water and Toxic Enforcement Act of 1986 (commonly known as "Proposition 65"). A copy of this summary must be included as an attachment to any notice of violation served upon an alleged violator of the Act. The summary provides basic information about the provisions of the law, and is intended to serve only as a convenient source of general information. It is not intended to provide authoritative guidance on the meaning or application of the law. The reader is directed to the statute and OEHHA implementing regulations (see citations below) for further information.

FOR INFORMATION CONCERNING THE BASIS FOR THE ALLEGATIONS IN THE NOTICE RELATED TO YOUR BUSINESS, CONTACT THE PERSON IDENTIFIED ON THE NOTICE.

The text of Proposition 65 (Health and Safety Code Sections 25249.5 through 25249.13) is available online at: <http://oehha.ca.gov/prop65/law/P65law72003.html>. Regulations that provide more specific guidance on compliance, and that specify procedures to be followed by the State in carrying out certain aspects of the law, are found in Title 27 of the California Code of Regulations, sections 25102 through 27001.¹ These implementing regulations are available online at: <http://oehha.ca.gov/prop65/law/P65Regs.html>.

WHAT DOES PROPOSITION 65 REQUIRE?

The "Proposition 65 List." Under Proposition 65, the lead agency (OEHHA) publishes a list of chemicals that are known to the State of California to cause cancer and/or reproductive toxicity. Chemicals are placed on the Proposition 65 list if they are known to cause cancer and/or birth defects or other reproductive harm, such as damage to

female or male reproductive systems or to the developing fetus. This list must be updated at least once a year. The current Proposition 65 list of chemicals is available on the OEHHA website at: http://www.oehha.ca.gov/prop65/prop65_list/Newlist.html.

Only those chemicals that are on the list are regulated under Proposition 65. Businesses that produce, use, release or otherwise engage in activities involving listed chemicals must comply with the following:

Clear and reasonable warnings. A business is required to warn a person before “knowingly and intentionally” exposing that person to a listed chemical unless an exemption applies. The warning given must be “clear and reasonable.” This means that the warning must: (1) clearly make known that the chemical involved is known to cause cancer, or birth defects or other reproductive harm; and (2) be given in such a way that it will effectively reach the person before he or she is exposed to that chemical. Some exposures are exempt from the warning requirement under certain circumstances discussed below.

Prohibition from discharges into drinking water. A business must not knowingly discharge or release a listed chemical into water or onto land where it passes or probably will pass into a source of drinking water. Some discharges are exempt from this requirement under certain circumstances discussed below.

DOES PROPOSITION 65 PROVIDE ANY EXEMPTIONS?

Yes. You should consult the current version of the statute and regulations (<http://www.oehha.ca.gov/prop65/law/index.html>) to determine all applicable exemptions, the most common of which are the following:

Grace Period. Proposition 65 warning requirements do not apply until 12 months after the chemical has been listed. The Proposition 65 discharge prohibition does not apply to a discharge or release of a chemical that takes place less than 20 months after the listing of the chemical.

Governmental agencies and public water utilities. All agencies of the federal, state or local government, as well as entities operating public water systems, are exempt.

Businesses with nine or fewer employees. Neither the warning requirement nor the discharge prohibition applies to a business that employs a total of nine or fewer employees. This includes all employees, not just those present in California.

Exposures that pose no significant risk of cancer. For chemicals that are listed under Proposition 65 as known to the State to cause cancer, a warning is not required if the business causing the exposure can demonstrate that the exposure occurs at a level that poses “no significant risk.” This means that the exposure is calculated to result in not more than one excess case of cancer in 100,000 individuals exposed over a 70-year lifetime. The Proposition 65 regulations identify specific “No Significant Risk Levels” (NSRLs) for many listed carcinogens. Exposures below these levels are exempt from the warning requirement. See OEHHA's website at: <http://www.oehha.ca.gov/prop65/getNSRLs.html> for a list of NSRLs, and Section 25701 *et seq.* of the regulations for information concerning how these levels are calculated.

Exposures that will produce no observable reproductive effect at 1,000 times the level in question. For chemicals known to the State to cause reproductive toxicity, a warning is not required if the business causing the exposure can demonstrate that the exposure will produce no observable effect, even at 1,000 times the level in question. In other words, the level of exposure must be below the “no observable effect level” divided by 1,000. This number is known as the Maximum Allowable Dose Level (MADL). See OEHHA's website at: <http://www.oehha.ca.gov/prop65/getNSRLs.html> for a list of MADLs, and Section 25801 *et seq.* of the regulations for information concerning how these levels are calculated.

Exposures to Naturally Occurring Chemicals in Food. Certain exposures to chemicals that naturally occur in foods (i.e., that do not result from any known human activity, including activity by someone other than the person causing the exposure) are exempt from the warning requirements of the law. If the chemical is a contaminant² it must be reduced to the lowest level feasible. Regulations explaining this exemption can be found in Section 25501.

Discharges that do not result in a “significant amount” of the listed chemical entering any source of drinking water. The prohibition from discharges into drinking water does not apply if the discharger is able to demonstrate that a “significant amount” of the listed chemical has not, does not, or will not pass into or probably pass into a source of drinking water, and that the discharge complies with all other applicable laws, regulations, permits, requirements, or orders. A “significant amount” means any detectable amount, except an amount that would meet the “no significant risk” level for chemicals that cause cancer or that is 1,000 times below the “no observable effect” level for chemicals that cause reproductive toxicity, if an individual were exposed to that amount in drinking water.

HOW IS PROPOSITION 65 ENFORCED?

Enforcement is carried out through civil lawsuits. These lawsuits may be brought by the Attorney General, any district attorney, or certain city attorneys. Lawsuits may also be brought by private parties acting in the public interest, but only after providing notice of the alleged violation to the Attorney General, the appropriate district attorney and city attorney, and the business accused of the violation. The notice must provide adequate information to allow the recipient to assess the nature of the alleged violation. The notice must comply with the information and procedural requirements specified in Section 25903 of Title 27 and sections 3100-3103 of Title 11. A private party may not pursue an independent enforcement action under Proposition 65 if one of the governmental officials noted above initiates an enforcement action within sixty days of the notice.

A business found to be in violation of Proposition 65 is subject to civil penalties of up to \$2,500 per day for each violation. In addition, the business may be ordered by a court to stop committing the violation.

A private party may not file an enforcement action based on certain exposures if the alleged violator meets specific conditions. For the following types of exposures, the Act provides an opportunity for the business to correct the alleged violation:

- An exposure to alcoholic beverages that are consumed on the alleged violator's premises to the extent onsite consumption is permitted by law;
- An exposure to a Proposition 65 listed chemical in a food or beverage prepared and sold on the alleged violator's premises that is primarily intended for immediate consumption on- or off-premises. This only applies if the chemical was not intentionally added to the food, and was formed by cooking or similar preparation of food or beverage components necessary to render the food or beverage palatable or to avoid microbiological contamination;
- An exposure to environmental tobacco smoke caused by entry of persons (other than employees) on premises owned or operated by the alleged violator where smoking is permitted at any location on the premises;
- An exposure to listed chemicals in engine exhaust, to the extent the exposure occurs inside a facility owned or operated by the alleged violator and primarily intended for parking non-commercial vehicles.

If a private party alleges that a violation occurred based on one of the exposures described above, the private party must first provide the alleged violator a notice of special compliance procedure and proof of compliance form.
