25 **1. INTRODUCTION**

26 **1.1** On October 16, 2023, Plaintiff Environmental Research Center, Inc. (“ERC”), a
27 non-profit corporation, as a private enforcer and in the public interest, initiated this action by
28 filing a Complaint for Injunctive and Declaratory Relief and Civil Penalties (the “Complaint”)

1 pursuant to the provisions of California Health and Safety Code section 25249.5 *et seq.*
2 (“Proposition 65”), against Vivri USA, LLC (“Vivri”) and Does 1-100. In this action, ERC
3 alleges that a number of products manufactured, distributed, or sold by Vivri contain lead
4 and/or cadmium and/or mercury, chemicals listed under Proposition 65 as carcinogens and/or
5 reproductive toxins, and expose consumers to these chemicals at a level requiring a Proposition
6 65 warning. These products (referred to hereinafter individually as a “Covered Product” or
7 collectively as “Covered Products”) are: (1) Vivri Spinach & Cheese Cream Meal Soup (lead),
8 (2) Vivri Corn Cream Meal Soup (lead), (3) Vivri Keto Meal Shake Gerry's Coconut Horchata
9 (lead), (4) Vivri Shake Me! Strawberry Sensation Complete Meal Replacement (lead), (5)
10 Vivri Shake Me! Chocolate Delight Complete Meal Replacement (lead), (6) Vivri Shake Me!
11 Vanilla Extravaganza Complete Meal Replacement (lead), (7) Vivri Creamy Portobello Soup
12 Complete Meal Replacement (lead), (8) Vivri Vegan Shake Me! Chocolate Fusion Complete
13 Meal Replacement (lead, cadmium, mercury), and (9) Vivri Shake Me! Cookies & Cream
14 Complete Meal Replacement (lead).

15 **1.2** ERC and Vivri are hereinafter referred to individually as a “Party” or
16 collectively as the “Parties.”

17 **1.3** ERC is a 501 (c)(3) California non-profit corporation dedicated to, among other
18 causes, helping safeguard the public from health hazards by reducing the use and misuse of
19 hazardous and toxic chemicals, facilitating a safe environment for consumers and employees,
20 and encouraging corporate responsibility.

21 **1.4** For purposes of this Consent Judgment, the Parties agree that Vivri is a business
22 entity that has employed ten or more persons at times relevant to this action, and, for purposes of
23 this Consent Judgment, qualifies as a “person in the course of doing business” within the
24 meaning of Proposition 65. Vivri manufactures, distributes, and/or sells the Covered Products.

25 **1.5** The Complaint is based on allegations contained in ERC’s Notices of Violation
26 dated May 4, 2023 and May 12, 2023 that were served on the California Attorney General,
27 other public enforcers, and Vivri (“Notices”). True and correct copies of the 60-Day Notices
28 dated May 4, 2023 and May 12, 2023 are attached hereto as **Exhibits A** and **B** and each is

1 incorporated herein by reference. More than 60 days have passed since the Notices were served
2 on the Attorney General, public enforcers, and Vivri and no designated governmental entity
3 has filed a Complaint against Vivri with regard to the Covered Products or the alleged
4 violations.

5 **1.6** ERC's Notices and Complaint allege that use of the Covered Products by
6 California consumers exposes them to lead and/or cadmium and/or mercury without first
7 receiving clear and reasonable warnings from Vivri, which is in violation of California Health
8 and Safety Code section 25249.6. Vivri denies all material allegations contained in the Notices
9 and Complaint.

10 **1.7** The Parties have entered into this Consent Judgment in order to settle,
11 compromise, and resolve disputed claims and thus avoid prolonged and costly litigation.
12 Nothing in this Consent Judgment nor compliance with this Consent Judgment shall constitute
13 or be construed as an admission by any of the Parties or by any of their respective officers,
14 directors, shareholders, employees, agents, parent companies, subsidiaries, divisions,
15 franchisees, licensees, customers, suppliers, distributors, wholesalers, or retailers of any fact,
16 issue of law, or violation of law.

17 **1.8** Except as expressly set forth herein, nothing in this Consent Judgment shall
18 prejudice, waive, or impair any right, remedy, argument, or defense the Parties may have in
19 any current or future legal proceeding unrelated to these proceedings.

20 **1.9** The Effective Date of this Consent Judgment is the date on which it is entered
21 as a Judgment by this Court.

22 **2. JURISDICTION AND VENUE**

23 For purposes of this Consent Judgment and any further court action that may become
24 necessary to enforce this Consent Judgment, the Parties stipulate that this Court has subject matter
25 jurisdiction over the allegations of violations contained in the Complaint and personal jurisdiction
26 over Vivri as to the acts alleged in the Complaint, that venue is proper in Alameda County, and
27 that this Court has jurisdiction to enter this Consent Judgment as a full and final resolution of all
28 claims up through and including the Effective Date that were or could have been asserted in this

1 action based on the facts alleged in the Notices and Complaint.

2 **3. INJUNCTIVE RELIEF, REFORMULATION, TESTING AND WARNINGS**

3 **3.1** Beginning on the Effective Date, Vivri shall be permanently enjoined from
4 manufacturing for sale in the State of California, “Distributing into the State of California,” or
5 directly selling in the State of California, any Covered Product that exposes a person to a
6 “Daily Lead Exposure Level” of more than 0.5 micrograms of lead per day and/or “Daily
7 Cadmium Exposure Level” of more than 4.1 micrograms of cadmium per day and/or “Daily
8 Mercury Exposure Level” of more than 0.3 micrograms of mercury per day unless it meets the
9 warning requirements under Section 3.2.

10 **3.1.1** As used in this Consent Judgment, the term “Distributing into the State
11 of California” shall mean to directly ship a Covered Product into California for sale in
12 California or to sell a Covered Product to a distributor that Vivri knows or has reason to know
13 will sell the Covered Product in California.

14 **3.1.2** For purposes of this Consent Judgment, the “Daily Lead Exposure
15 Level” shall be measured in micrograms, and shall be calculated using the following formula:
16 micrograms of lead per gram of product, multiplied by grams of product per serving of the
17 product (using the largest serving size appearing on the product label), multiplied by servings
18 of the product per day (using the largest number of recommended daily servings appearing on
19 the label), which equals micrograms of lead exposure per day. If the label contains no
20 recommended daily servings, then the number of recommended daily servings shall be one.

21 **3.1.3** For purposes of this Consent Judgment, the “Daily Cadmium Exposure
22 Level” shall be measured in micrograms, and shall be calculated using the following formula:
23 micrograms of cadmium per gram of product, multiplied by grams of product per serving of
24 the product (using the largest serving size appearing on the product label), multiplied by
25 servings of the product per day (using the largest number of recommended daily servings
26 appearing on the label), which equals micrograms of cadmium exposure per day. If the label
27 contains no recommended daily servings, then the number of recommended daily servings
28 shall be one.

1 **3.1.4** For purposes of this Consent Judgment, the “Daily Mercury Exposure
2 Level” shall be measured in micrograms, and shall be calculated using the following formula:
3 micrograms of mercury per gram of product, multiplied by grams of product per serving of the
4 product (using the largest serving size appearing on the product label), multiplied by servings
5 of the product per day (using the largest number of recommended daily servings appearing on
6 the label), which equals micrograms of mercury exposure per day. If the label contains no
7 recommended daily servings, then the number of recommended daily servings shall be one.

8 **3.2 Clear and Reasonable Warnings**

9 If Vivri is required to provide a warning pursuant to Section 3.1, one of the following
10 warnings must be utilized (“Warning”):

11 **WARNING:** Consuming this product can expose you to chemicals including [lead] [and]
12 [cadmium] [and] [mercury] which is [are] known to the State of California to cause [cancer
13 and] birth defects or other reproductive harm. For more information go to
www.P65Warnings.ca.gov/food.

14 or

15 **OPTION 2:**

16  **WARNING:** [Cancer and] Reproductive Harm – www.P65Warnings.ca.gov/food.

17 Vivri shall use the phrase “cancer and” in the Warning if Vivri has reason to believe that
18 the “Daily Lead Exposure Level” is greater than 15 micrograms of lead as determined pursuant to
19 the quality control methodology set forth in Section 3.4 or if Vivri has reason to believe that
20 another Proposition 65 chemical is present which may require a cancer warning. For the Option 2
21 Warning, a symbol consisting of a black exclamation point in a yellow equilateral triangle with a
22 bold black outline shall be placed to the left of the text of the Warning, in a size no smaller than
23 the height of the word “**WARNING,**” and the word “**WARNING**” shall be in all capital letters
24 and bold print. Where the sign, label or shelf tag for the product is not printed using the color
25 yellow, the symbol may be printed in black and white. As identified in the brackets, the Warning
26 shall appropriately reflect whether there is lead, cadmium, mercury, or multiple chemicals present
27 in each of the Covered Products, but if there is a chemical present at a level that requires a cancer
28

1 warning, the chemical requiring use of the phrase “cancer and” in the Warning shall always be
2 identified.

3 The Warning shall be securely affixed to or printed upon the label of each Covered
4 Product and it must be set off from other surrounding information and enclosed in a box. In
5 addition, for any Covered Product sold over the internet, the Warning shall appear on the
6 checkout page when a California delivery address is indicated for any purchase of any Covered
7 Product. An asterisk or other identifying method must be utilized to identify which products on
8 the checkout page are subject to the Warning. In no event shall any internet or website
9 Warning be contained in or made through a link.

10 The Warning shall be at least the same size as the largest of any other health or safety
11 warnings also appearing on the website or on the label and the word “**WARNING**” shall be in all
12 capital letters and in bold print. No statements intended to or likely to have the effect of
13 diminishing the impact of the Warning on the average lay person shall accompany the Warning.
14 Further no statements may accompany the Warning that state or imply that the source of the listed
15 chemical has an impact on or results in a less harmful effect of the listed chemical.

16 Vivri must display the above Warning with such conspicuousness, as compared with other
17 words, statements or designs on the label, or on its website, if applicable, to render the Warning
18 likely to be read and understood by an ordinary individual under customary conditions of
19 purchase or use of the product. Where a sign or label used to provide the Warning for a Covered
20 Product includes consumer information about the Covered Product in a language other than
21 English, the Warning must also be provided in that language in addition to English.

22 For purposes of this Consent Judgment, the term “label” means a display of written,
23 printed or graphic material that is printed on or affixed to a Covered Product or its immediate
24 container or wrapper.

25 **3.3 Conforming Covered Products**

26 A Conforming Covered Product is a Covered Product for which the “Daily Lead Exposure
27 Level” is no greater than 0.5 micrograms of lead per day and/or the “Daily Cadmium Exposure
28 Level” is no greater than 4.1 micrograms of cadmium per day and/or the “Daily Mercury

1 Exposure Level” is no greater than 0.3 micrograms of mercury per day as determined by the
2 exposure methodology set forth in Section 3.1.2 and the quality control methodology described in
3 Section 3.4, and that is not known by Vivri to contain other chemicals that violate Proposition
4 65’s safe harbor thresholds.

5 **3.4 Testing and Quality Control Methodology**

6 **3.4.1** Beginning within one year of the Effective Date, Vivri shall arrange for
7 lead and cadmium and mercury testing of the Covered Products at least once a year for a
8 minimum of five consecutive years by arranging for testing of three (3) randomly selected
9 samples of each of the Covered Products, in the form intended for sale to the end-user, which
10 Vivri intends to sell or is manufacturing for sale in California, directly selling to a consumer in
11 California or “Distributing into the State of California.” If tests conducted pursuant to this
12 Section demonstrate that no Warning is required for a Covered Product during each of five
13 consecutive years, then the testing requirements of this Section will no longer be required as to
14 that Covered Product. However, if during or after the five-year testing period, Vivri changes
15 ingredient suppliers for any of the Covered Products and/or reformulates any of the Covered
16 Products, Vivri shall test that Covered Product annually for at least four (4) consecutive years
17 after such change is made.

18 **3.4.2** For purposes of measuring the “Daily Lead Exposure Level” and/or the
19 “Daily Cadmium Exposure Level” and/or the “Daily Mercury Exposure Level,” the highest
20 lead and/or cadmium and/or mercury detection result of the three (3) randomly selected
21 samples of the Covered Products will be controlling.

22 **3.4.3** All testing pursuant to this Consent Judgment shall be performed using a
23 laboratory method that complies with the performance and quality control factors appropriate
24 for the method used, including limit of detection and limit of quantification, sensitivity,
25 accuracy and precision that meets the following criteria: Inductively Coupled Plasma-Mass
26 Spectrometry (“ICP-MS”) achieving a limit of quantification of less than or equal to 0.005
27 mg/kg.

28 **3.4.4** All testing pursuant to this Consent Judgment shall be performed by an

1 independent third party laboratory certified by the California Environmental Laboratory
2 Accreditation Program or an independent third-party laboratory that is registered with the
3 United States Food & Drug Administration.

4 **3.4.5** Nothing in this Consent Judgment shall limit Vivri's ability to conduct,
5 or require that others conduct, additional testing of the Covered Products, including the raw
6 materials used in their manufacture.

7 **3.4.6** Within thirty (30) days of ERC's written request, Vivri shall deliver lab
8 reports obtained pursuant to Section 3.4 to ERC. Vivri shall retain all test results and
9 documentation for a period of five years from the date of each test.

10 **3.4.7** The testing requirements of Section 3.4 do not apply to any Covered
11 Product for which Vivri has provided the Warning specified in Section 3.2 continuously and
12 uninterrupted after the Effective Date; however, in the event Vivri ceases to provide the
13 Warning specified in Section 3.2, Vivri shall be required to comply with the testing
14 requirements of this Section 3.4 beginning immediately after the date the Warning ceases to be
15 provided or one year after the Effective Date, whichever date is later.

16 **4. SETTLEMENT PAYMENT**

17 **4.1** In full satisfaction of all potential civil penalties, additional settlement
18 payments, attorney's fees, and costs, Vivri shall make a total payment of \$65,000.00 ("Total
19 Settlement Amount") to ERC within 10 days of the Effective Date ("Due Date"). Vivri shall
20 make this payment by wire transfer to ERC's account, for which ERC will give Vivri the
21 necessary account information. The Total Settlement Amount shall be apportioned as follows:

22 **4.2** \$10,500.00 shall be considered a civil penalty pursuant to California Health and
23 Safety Code section 25249.7(b)(1). ERC shall remit 75% (\$7,875.00) of the civil penalty to the
24 Office of Environmental Health Hazard Assessment ("OEHHA") for deposit in the Safe
25 Drinking Water and Toxic Enforcement Fund in accordance with California Health and Safety
26 Code section 25249.12(c). ERC will retain the remaining 25% (\$2,625.00) of the civil penalty.

27 **4.3** \$4,102.99 shall be distributed to ERC as reimbursement to ERC for reasonable
28 costs incurred in bringing this action.

1 **4.4** \$17,215.00 shall be distributed to Michael Freund & Associates as
2 reimbursement of ERC’s attorney fees, while \$33,182.01 shall be distributed to ERC for its in-
3 house legal fees. Except as explicitly provided herein, each Party shall bear its own fees and
4 costs.

5 **4.5** In the event that Vivri fails to remit the Total Settlement Amount owed under
6 Section 4 of this Consent Judgment on or before the Due Date, Vivri shall be deemed to be in
7 material breach of its obligations under this Consent Judgment. ERC shall provide written
8 notice of the delinquency to Vivri via electronic mail. If Vivri fails to deliver the Total
9 Settlement Amount within five (5) days from the written notice, the Total Settlement Amount
10 shall accrue interest at the statutory judgment interest rate provided in the California Code of
11 Civil Procedure section 685.010. Additionally, Vivri agrees to pay ERC’s reasonable
12 attorney’s fees and costs for any efforts to collect the payment due under this Consent
13 Judgment.

14 **5. MODIFICATION OF CONSENT JUDGMENT**

15 **5.1** This Consent Judgment may be modified only as to injunctive terms (i) by
16 written stipulation of the Parties and upon entry by the Court of a modified consent judgment
17 or (ii) by motion of either Party pursuant to Section 5.3 and upon entry by the Court of a
18 modified consent judgment.

19 **5.2** If Vivri seeks to modify this Consent Judgment under Section 5.1, then Vivri
20 must provide written notice to ERC of its intent (“Notice of Intent”). If ERC seeks to meet and
21 confer regarding the proposed modification in the Notice of Intent, then ERC must provide
22 written notice to Vivri within thirty (30) days of receiving the Notice of Intent. If ERC notifies
23 Vivri in a timely manner of ERC’s intent to meet and confer, then the Parties shall meet and
24 confer in good faith as required in this Section. The Parties shall meet in person, via remote
25 meeting, or by telephone within thirty (30) days of ERC’s notification of its intent to meet and
26 confer. Within thirty (30) days of such meeting, if ERC disputes the proposed modification,
27 ERC shall provide to Vivri a written basis for its position. The Parties shall continue to meet
28 and confer for an additional thirty (30) days in an effort to resolve any remaining disputes.

1 Should it become necessary, the Parties may agree in writing to different deadlines for the
2 meet-and-confer period.

3 **5.3** In the event that Vivri initiates or otherwise requests a modification under
4 Section 5.1, and the meet and confer process leads to a joint motion or joint application for a
5 modification of the Consent Judgment, Vivri shall reimburse ERC its costs and reasonable
6 attorney's fees for the time spent in the meet-and-confer process and filing and arguing the
7 motion or application.

8 **6. RETENTION OF JURISDICTION, ENFORCEMENT OF CONSENT**
9 **JUDGMENT**

10 **6.1** This Court shall retain jurisdiction of this matter to enforce, modify, or
11 terminate this Consent Judgment.

12 **6.2** If ERC alleges that any Covered Product fails to qualify as a Conforming
13 Covered Product (for which ERC alleges that no Warning has been provided), then ERC shall
14 inform Vivri in a reasonably prompt manner of its test results, including information sufficient
15 to permit Vivri to identify the Covered Products at issue. Vivri shall, within thirty (30) days
16 following such notice, provide ERC with testing information, from an independent third-party
17 laboratory meeting the requirements of Sections 3.4.3 and 3.4.4, demonstrating Vivri's
18 compliance with the Consent Judgment. The Parties shall first attempt to resolve the matter
19 prior to ERC taking any further legal action.

20 **7. APPLICATION OF CONSENT JUDGMENT**

21 This Consent Judgment may apply to, be binding upon, and benefit the Parties and their
22 respective officers, directors, shareholders, employees, agents, parent companies, subsidiaries,
23 divisions, franchisees, licensees, customers (excluding private labelers), distributors, wholesalers,
24 retailers, predecessors, successors, and assigns. This Consent Judgment shall have no application
25 to any Covered Product that is distributed or sold exclusively outside the State of California and
26 that is not used by California consumers.

27 **8. BINDING EFFECT, CLAIMS COVERED AND RELEASED**

28 **8.1** This Consent Judgment is a full, final, and binding resolution between ERC,

1 on behalf of itself and in the public interest, and Vivri and its respective officers, directors,
2 shareholders, employees, agents, parent companies, subsidiaries, divisions, suppliers,
3 franchisees, licensees, customers (not including private label customers of Vivri), distributors,
4 wholesalers, retailers, and all other upstream and downstream entities in the distribution chain
5 of any Covered Product, and the predecessors, successors, and assigns of any of them
6 (collectively, “Released Parties”).

7 **8.2** ERC, acting in the public interest, releases the Released Parties from any
8 and all claims for violations of Proposition 65 up through the Effective Date based on exposure
9 to lead and/or cadmium and/or mercury from the Covered Products as set forth in the Notices
10 of Violation. ERC, on behalf of itself only, hereby fully releases and discharges the Released
11 Parties from any and all claims, actions, causes of action, suits, demands, liabilities, damages,
12 penalties, fees, costs, and expenses asserted, or that could have been asserted from the
13 handling, use, or consumption of the Covered Products, as to any alleged violation of
14 Proposition 65 or its implementing regulations arising from the failure to provide Proposition
15 65 warnings on the Covered Products regarding lead and/or cadmium and/or mercury up to and
16 including the Effective Date.

17 **8.3** ERC on its own behalf only, and Vivri on its own behalf only, further waive
18 and release any and all claims they may have against each other for all actions or statements
19 made or undertaken in the course of seeking or opposing enforcement of Proposition 65 in
20 connection with the Notices and Complaint up through and including the Effective Date,
21 provided, however, that nothing in Section 8 shall affect or limit any Party’s right to seek to
22 enforce the terms of this Consent Judgment.

23 **8.4** It is possible that other claims not known to the Parties, arising out of the facts
24 alleged in the Notices and Complaint, and relating to the Covered Products, will develop or be
25 discovered. ERC on behalf of itself only, and Vivri on behalf of itself only, acknowledge that
26 this Consent Judgment is expressly intended to cover and include all such claims up through
27 and including the Effective Date, including all rights of action therefore. ERC and Vivri
28 acknowledge that the claims released in Sections 8.2 and 8.3 above may include unknown

1 claims, and nevertheless waive California Civil Code section 1542 as to any such unknown
2 claims. California Civil Code section 1542 reads as follows:

3 A GENERAL RELEASE DOES NOT EXTEND TO CLAIMS THAT THE
4 CREDITOR OR RELEASING PARTY DOES NOT KNOW OR SUSPECT TO
5 EXIST IN HIS OR HER FAVOR AT THE TIME OF EXECUTING THE RELEASE
6 AND THAT, IF KNOWN BY HIM OR HER, WOULD HAVE MATERIALLY
7 AFFECTED HIS OR HER SETTLEMENT WITH THE DEBTOR OR RELEASED
8 PARTY.

9 ERC on behalf of itself only, and Vivri on behalf of itself only, acknowledge and understand
10 the significance and consequences of this specific waiver of California Civil Code section
11 1542.

12 **8.5** Compliance with the terms of this Consent Judgment shall be deemed to
13 constitute compliance with Proposition 65 by any of the Released Parties regarding alleged
14 exposures to lead and/or cadmium and/or mercury in the Covered Products as set forth in the
15 Notices and Complaint.

16 **8.6** Nothing in this Consent Judgment is intended to apply to any occupational or
17 environmental exposures arising under Proposition 65, nor shall it apply to any of Vivri's
18 products other than the Covered Products.

19 **9. SEVERABILITY OF UNENFORCEABLE PROVISIONS**

20 In the event that any of the provisions of this Consent Judgment are held by a court to be
21 unenforceable, the validity of the remaining enforceable provisions shall not be adversely
22 affected.

23 **10. GOVERNING LAW**

24 The terms and conditions of this Consent Judgment shall be governed by and construed in
25 accordance with the laws of the State of California.

26 **11. PROVISION OF NOTICE**

27 All notices required to be given to either Party to this Consent Judgment by the other shall
28 be in writing and sent to the following agents listed below via first-class mail or via electronic
29 mail where required. Courtesy copies via email may also be sent.

1 **12. COURT APPROVAL**

2 **12.1** Upon execution of this Consent Judgment by the Parties, ERC shall notice a
3 Motion for Court Approval. The Parties shall use their best efforts to support entry of this
4 Consent Judgment.

5 **12.2** If the California Attorney General objects to any term in this Consent Judgment,
6 the Parties shall use their best efforts to resolve the concern in a timely manner, and if possible
7 prior to the hearing on the motion.

8 **12.3** If this Stipulated Consent Judgment is not approved by the Court, it shall be

1 void and have no force or effect.

2 **13. EXECUTION AND COUNTERPARTS**

3 This Consent Judgment may be executed in counterparts, which taken together shall be
4 deemed to constitute one document. A facsimile or .pdf signature shall be construed to be as valid
5 as the original signature.

6 **14. DRAFTING**

7 The terms of this Consent Judgment have been reviewed by the respective counsel for
8 each Party prior to its signing, and each Party has had an opportunity to fully discuss the terms
9 and conditions with legal counsel. The Parties agree that, in any subsequent interpretation and
10 construction of this Consent Judgment, no inference, assumption, or presumption shall be drawn,
11 and no provision of this Consent Judgment shall be construed against any Party, based on the fact
12 that one of the Parties and/or one of the Parties' legal counsel prepared and/or drafted all or any
13 portion of the Consent Judgment. It is conclusively presumed that all of the Parties participated
14 equally in the preparation and drafting of this Consent Judgment.

15 **15. GOOD FAITH ATTEMPT TO RESOLVE DISPUTES**

16 If a dispute arises with respect to either Party's compliance with the terms of this Consent
17 Judgment entered by the Court, the Parties shall meet and confer in person, via remote meeting,
18 by telephone, and/or in writing and endeavor to resolve the dispute in an amicable manner. No
19 action or motion may be filed in the absence of such a good faith attempt to resolve the dispute
20 beforehand.

21 **16. ENFORCEMENT**

22 ERC may, by motion or order to show cause before the Superior Court of Alameda
23 County, enforce the terms and conditions contained in this Consent Judgment. In any action
24 brought by ERC to enforce this Consent Judgment, ERC may seek whatever fines, costs,
25 penalties, or remedies as are provided by law for failure to comply with the Consent Judgment.
26 To the extent the failure to comply with the Consent Judgment constitutes a violation of
27 Proposition 65 or other laws, ERC shall not be limited to enforcement of this Consent
28 Judgment, but may seek in another action whatever fines, costs, penalties, or remedies as are

1 provided by law for failure to comply with Proposition 65 or other laws.

2 **17. ENTIRE AGREEMENT, AUTHORIZATION**

3 **17.1** This Consent Judgment contains the sole and entire agreement and
4 understanding of the Parties with respect to the entire subject matter herein, including any and
5 all prior discussions, negotiations, commitments, and understandings related thereto. No
6 representations, oral or otherwise, express or implied, other than those contained herein have
7 been made by any Party. No other agreements, oral or otherwise, unless specifically referred to
8 herein, shall be deemed to exist or to bind any Party.

9 **17.2** Each signatory to this Consent Judgment certifies that he or she is fully
10 authorized by the Party he or she represents to stipulate to this Consent Judgment.

11 **18. REQUEST FOR FINDINGS, APPROVAL OF SETTLEMENT AND ENTRY OF**
12 **CONSENT JUDGMENT**

13 This Consent Judgment has come before the Court upon the request of the Parties. The
14 Parties request the Court to fully review this Consent Judgment and, being fully informed
15 regarding the matters which are the subject of this action, to:

18 been diligently prosecuted, and that the public interest is served by such settlement; and







**NOTICE OF VIOLATION OF
CALIFORNIA HEALTH & SAFETY CODE SECTION 25249.5 ET SEQ.
(PROPOSITION 65)**

Dear Alleged Violator and the Appropriate Public Enforcement Agencies:

I represent Environmental Research Center, Inc. (“ERC”), 3111 Camino Del Rio North, Suite 400, San Diego, CA 92108; Tel. (619) 500-3090. ERC’s Executive Director is Chris Heptinstall. ERC is a California non-profit corporation dedicated to, among other causes, helping safeguard the public from health hazards by bringing about a reduction in the use and misuse of hazardous and toxic chemicals, facilitating a safe environment for consumers and employees, and encouraging corporate responsibility.

ERC has identified violations of California’s Safe Drinking Water and Toxic Enforcement Act of 1986 (“Proposition 65”), which is codified at California Health & Safety Code §25249.5 *et seq.*, with respect to the products identified below. These violations have occurred and continue to occur because the alleged Violator identified below failed to provide required clear and reasonable warnings with these products. This letter serves as a notice of these violations to the alleged Violator and the appropriate public enforcement agencies. Pursuant to Health and Safety Code Section 25249.7(d), ERC intends to file a private enforcement action in the public interest 60 days after effective service of this notice unless the public enforcement agencies have commenced and are diligently prosecuting an action to rectify these violations.

General Information about Proposition 65. A copy of a summary of Proposition 65, prepared by the Office of Environmental Health Hazard Assessment, is enclosed with this letter served to the alleged Violator identified below.

Alleged Violator. The name of the company covered by this notice that violated Proposition 65 (hereinafter the “Violator”) is:

Vivri USA, LLC

Consumer Products and Listed Chemical. The products that are the subject of this notice and the chemical in those products identified as exceeding allowable levels are:

- 1. Vivri Spinach & Cheese Cream Meal Soup - Lead**
- 2. Vivri Corn Cream Meal Soup - Lead**
- 3. Vivri Keto Meal Shake Gerry's Coconut Horchata - Lead**
- 4. Vivri Shake Me! Strawberry Sensation Complete Meal Replacement - Lead**
- 5. Vivri Shake Me! Chocolate Delight Complete Meal Replacement - Lead**

On February 27, 1987, the State of California officially listed lead as a chemical known to cause developmental toxicity, and male and female reproductive toxicity. On October 1, 1992, the State of California officially listed lead and lead compounds as chemicals known to cause cancer.

It should be noted that ERC may continue to investigate other products that may reveal further violations and result in subsequent notices of violations.

Route of Exposure. The consumer exposures that are the subject of this notice result from the recommended use of these products. Consequently, the route of exposure to this chemical has been and continues to be through ingestion.

Approximate Time Period of Violations. Ongoing violations have occurred every day since at least May 4, 2020, as well as every day since the products were introduced into the California marketplace, and will continue every day until clear and reasonable warnings are provided to product purchasers and users or until this known toxic chemical is either removed from or reduced to allowable levels in the products. Proposition 65 requires that a clear and reasonable warning be provided prior to exposure to the identified chemical. The method of warning should be a warning that appears on the product label. The Violator violated Proposition 65 because it failed to provide persons ingesting these products with appropriate warnings that they are being exposed to this chemical.

Consistent with the public interest goals of Proposition 65 and a desire to have these ongoing violations of California law quickly rectified, ERC is interested in seeking a constructive resolution of this matter that includes an enforceable written agreement by the Violator to: (1) reformulate the identified products so as to eliminate further exposures to the identified chemical, or provide appropriate warnings on the labels of these products; (2) pay an appropriate civil penalty; and (3) provide clear and reasonable warnings compliant with Proposition 65 to all persons located in California who purchased the above products in the last three years. Such a resolution will prevent further unwarned consumer exposures to the identified chemical, as well as an expensive and time-consuming litigation.



THE SAFE DRINKING WATER AND TOXIC ENFORCEMENT ACT OF 1986 (PROPOSITION 65): A SUMMARY

The following summary has been prepared by the California Office of Environmental Health Hazard Assessment (OEHHA), the lead agency for the implementation of the Safe Drinking Water and Toxic Enforcement Act of 1986 (commonly known as "Proposition 65"). A copy of this summary must be included as an attachment to any notice of violation served upon an alleged violator of the Act. The summary provides basic information about the provisions of the law, and is intended to serve only as a convenient source of general information. It is not intended to provide authoritative guidance on the meaning or application of the law. The reader is directed to the statute and OEHHA implementing regulations (see citations below) for further information.

FOR INFORMATION CONCERNING THE BASIS FOR THE ALLEGATIONS IN THE NOTICE RELATED TO YOUR BUSINESS, CONTACT THE PERSON IDENTIFIED ON THE NOTICE.

The text of Proposition 65 (Health and Safety Code Sections 25249.5 through 25249.13) is available online at: <http://oehha.ca.gov/prop65/law/P65law72003.html>. Regulations that provide more specific guidance on compliance, and that specify procedures to be followed by the State in carrying out certain aspects of the law, are found in Title 27 of the California Code of Regulations, sections 25102 through 27001.¹ These implementing regulations are available online at: <http://oehha.ca.gov/prop65/law/P65Regs.html>.

WHAT DOES PROPOSITION 65 REQUIRE?

The "Proposition 65 List." Under Proposition 65, the lead agency (OEHHA) publishes a list of chemicals that are known to the State of California to cause cancer and/or reproductive toxicity. Chemicals are placed on the Proposition 65 list if they are known to cause cancer and/or birth defects or other reproductive harm, such as damage to

female or male reproductive systems or to the developing fetus. This list must be updated at least once a year. The current Proposition 65 list of chemicals is available on the OEHHA website at: http://www.oehha.ca.gov/prop65/prop65_list/Newlist.html.

Only those chemicals that are on the list are regulated under Proposition 65. Businesses that produce, use, release or otherwise engage in activities involving listed chemicals must comply with the following:

Clear and reasonable warnings. A business is required to warn a person before “knowingly and intentionally” exposing that person to a listed chemical unless an exemption applies. The warning given must be “clear and reasonable.” This means that the warning must: (1) clearly make known that the chemical involved is known to cause cancer, or birth defects or other reproductive harm; and (2) be given in such a way that it will effectively reach the person before he or she is exposed to that chemical. Some exposures are exempt from the warning requirement under certain circumstances discussed below.

Prohibition from discharges into drinking water. A business must not knowingly discharge or release a listed chemical into water or onto land where it passes or probably will pass into a source of drinking water. Some discharges are exempt from this requirement under certain circumstances discussed below.

DOES PROPOSITION 65 PROVIDE ANY EXEMPTIONS?

Yes. You should consult the current version of the statute and regulations (<http://www.oehha.ca.gov/prop65/law/index.html>) to determine all applicable exemptions, the most common of which are the following:

Grace Period. Proposition 65 warning requirements do not apply until 12 months after the chemical has been listed. The Proposition 65 discharge prohibition does not apply to a discharge or release of a chemical that takes place less than 20 months after the listing of the chemical.

Governmental agencies and public water utilities. All agencies of the federal, state or local government, as well as entities operating public water systems, are exempt.

Businesses with nine or fewer employees. Neither the warning requirement nor the discharge prohibition applies to a business that employs a total of nine or fewer employees. This includes all employees, not just those present in California.

Exposures that pose no significant risk of cancer. For chemicals that are listed under Proposition 65 as known to the State to cause cancer, a warning is not required if the business causing the exposure can demonstrate that the exposure occurs at a level that poses “no significant risk.” This means that the exposure is calculated to result in not more than one excess case of cancer in 100,000 individuals exposed over a 70-year lifetime. The Proposition 65 regulations identify specific “No Significant Risk Levels” (NSRLs) for many listed carcinogens. Exposures below these levels are exempt from the warning requirement. See OEHHA's website at: <http://www.oehha.ca.gov/prop65/getNSRLs.html> for a list of NSRLs, and Section 25701 *et seq.* of the regulations for information concerning how these levels are calculated.

Exposures that will produce no observable reproductive effect at 1,000 times the level in question. For chemicals known to the State to cause reproductive toxicity, a warning is not required if the business causing the exposure can demonstrate that the exposure will produce no observable effect, even at 1,000 times the level in question. In other words, the level of exposure must be below the “no observable effect level” divided by 1,000. This number is known as the Maximum Allowable Dose Level (MADL). See OEHHA's website at: <http://www.oehha.ca.gov/prop65/getNSRLs.html> for a list of MADLs, and Section 25801 *et seq.* of the regulations for information concerning how these levels are calculated.

Exposures to Naturally Occurring Chemicals in Food. Certain exposures to chemicals that naturally occur in foods (i.e., that do not result from any known human activity, including activity by someone other than the person causing the exposure) are exempt from the warning requirements of the law. If the chemical is a contaminant² it must be reduced to the lowest level feasible. Regulations explaining this exemption can be found in Section 25501.

Discharges that do not result in a “significant amount” of the listed chemical entering any source of drinking water. The prohibition from discharges into drinking water does not apply if the discharger is able to demonstrate that a “significant amount” of the listed chemical has not, does not, or will not pass into or probably pass into a source of drinking water, and that the discharge complies with all other applicable laws, regulations, permits, requirements, or orders. A “significant amount” means any detectable amount, except an amount that would meet the “no significant risk” level for chemicals that cause cancer or that is 1,000 times below the “no observable effect” level for chemicals that cause reproductive toxicity, if an individual were exposed to that amount in drinking water.

² See Section 25501(a)(4).

HOW IS PROPOSITION 65 ENFORCED?

Enforcement is carried out through civil lawsuits. These lawsuits may be brought by the Attorney General, any district attorney, or certain city attorneys. Lawsuits may also be brought by private parties acting in the public interest, but only after providing notice of the alleged violation to the Attorney General, the appropriate district attorney and city attorney, and the business accused of the violation. The notice must provide adequate information to allow the recipient to assess the nature of the alleged violation. The notice must comply with the information and procedural requirements specified in Section 25903 of Title 27 and sections 3100-3103 of Title 11. A private party may not pursue an independent enforcement action under Proposition 65 if one of the governmental officials noted above initiates an enforcement action within sixty days of the notice.

A business found to be in violation of Proposition 65 is subject to civil penalties of up to \$2,500 per day for each violation. In addition, the business may be ordered by a court to stop committing the violation.

A private party may not file an enforcement action based on certain exposures if the alleged violator meets specific conditions. For the following types of exposures, the Act provides an opportunity for the business to correct the alleged violation:

- An exposure to alcoholic beverages that are consumed on the alleged violator's premises to the extent onsite consumption is permitted by law;
- An exposure to a Proposition 65 listed chemical in a food or beverage prepared and sold on the alleged violator's premises that is primarily intended for immediate consumption on- or off-premises. This only applies if the chemical was not intentionally added to the food, and was formed by cooking or similar preparation of food or beverage components necessary to render the food or beverage palatable or to avoid microbiological contamination;
- An exposure to environmental tobacco smoke caused by entry of persons (other than employees) on premises owned or operated by the alleged violator where smoking is permitted at any location on the premises;
- An exposure to listed chemicals in engine exhaust, to the extent the exposure occurs inside a facility owned or operated by the alleged violator and primarily intended for parking non-commercial vehicles.

If a private party alleges that a violation occurred based on one of the exposures described above, the private party must first provide the alleged violator a notice of special compliance procedure and proof of compliance form.

Dear Alleged Violator and the Appropriate Public Enforcement Agencies:

I represent Environmental Research Center, Inc. (“ERC”), 3111 Camino Del Rio North, Suite 400, San Diego, CA 92108; Tel. (619) 500-3090. ERC’s Executive Director is Chris Heptinstall. ERC is a California non-profit corporation dedicated to, among other causes, helping safeguard the public from health hazards by bringing about a reduction in the use and misuse of hazardous and toxic chemicals, facilitating a safe environment for consumers and employees, and encouraging corporate responsibility.

ERC has identified violations of California’s Safe Drinking Water and Toxic Enforcement Act of 1986 (“Proposition 65”), which is codified at California Health & Safety Code §25249.5 *et seq.*, with respect to the products identified below. These violations have occurred and continue to occur because the alleged Violator identified below failed to provide required clear and reasonable warnings with these products. This letter serves as a notice of these violations to the alleged Violator and the appropriate public enforcement agencies. Pursuant to Health and Safety Code Section 25249.7(d), ERC intends to file a private enforcement action in the public interest 60 days after effective service of this notice unless the public enforcement agencies have commenced and are diligently prosecuting an action to rectify these violations.

General Information about Proposition 65. A copy of a summary of Proposition 65, prepared by the Office of Environmental Health Hazard Assessment, is enclosed with this letter served to the alleged Violator identified below.

Alleged Violator. The name of the company covered by this notice that violated Proposition 65 (hereinafter the “Violator”) is:

Vivri USA, LLC

Consumer Products and Listed Chemicals. The products that are the subject of this notice and the chemicals in those products identified as exceeding allowable levels are:

- 1. Vivri Shake Me! Vanilla Extravaganza Complete Meal Replacement - Lead**
- 2. Vivri Creamy Portobello Soup Complete Meal Replacement - Lead**
- 3. Vivri Vegan Shake Me! Chocolate Fusion Complete Meal Replacement – Lead, Cadmium, Mercury**
- 4. Vivri Shake Me! Cookies & Cream Complete Meal Replacement - Lead**

On February 27, 1987, the State of California officially listed lead as a chemical known to cause developmental toxicity, and male and female reproductive toxicity. On October 1, 1992, the State of California officially listed lead and lead compounds as chemicals known to cause cancer.

Cadmium was officially listed as a chemical known to cause developmental toxicity and male reproductive toxicity on May 1, 1997, while cadmium and cadmium compounds were listed as chemicals known to the State of California to cause cancer on October 1, 1987.

On July 1, 1990, the State of California officially listed mercury and mercury compounds as chemicals known to cause developmental toxicity and male and female reproductive toxicity.

It should be noted that ERC may continue to investigate other products that may reveal further violations and result in subsequent notices of violations.

Route of Exposure. The consumer exposures that are the subject of this notice result from the recommended use of these products. Consequently, the route of exposure to these chemicals has been and continues to be through ingestion.

Approximate Time Period of Violations. Ongoing violations have occurred every day since at least May 12, 2020, as well as every day since the products were introduced into the California marketplace, and will continue every day until clear and reasonable warnings are provided to product purchasers and users or until these known toxic chemicals are either removed from or reduced to allowable levels in the products. Proposition 65 requires that a clear and reasonable warning be provided prior to exposure to the identified chemicals. The method of warning should be a warning that appears on the product label. The Violator violated Proposition 65 because it failed to provide persons ingesting these products with appropriate warnings that they are being exposed to these chemicals.

Consistent with the public interest goals of Proposition 65 and a desire to have these ongoing violations of California law quickly rectified, ERC is interested in seeking a constructive resolution of this matter that includes an enforceable written agreement by the Violator to: (1) reformulate the identified products so as to eliminate further exposures to the identified chemicals, or provide appropriate warnings on the labels of these products; (2) pay an appropriate civil penalty; and (3) provide clear and reasonable warnings compliant with Proposition 65 to all persons located in California who purchased the above products in the last three years. Such a resolution will prevent further unwarned consumer exposures to the identified chemicals, as well as an expensive and time-consuming litigation.



THE SAFE DRINKING WATER AND TOXIC ENFORCEMENT ACT OF 1986 (PROPOSITION 65): A SUMMARY

The following summary has been prepared by the California Office of Environmental Health Hazard Assessment (OEHHA), the lead agency for the implementation of the Safe Drinking Water and Toxic Enforcement Act of 1986 (commonly known as "Proposition 65"). A copy of this summary must be included as an attachment to any notice of violation served upon an alleged violator of the Act. The summary provides basic information about the provisions of the law, and is intended to serve only as a convenient source of general information. It is not intended to provide authoritative guidance on the meaning or application of the law. The reader is directed to the statute and OEHHA implementing regulations (see citations below) for further information.

FOR INFORMATION CONCERNING THE BASIS FOR THE ALLEGATIONS IN THE NOTICE RELATED TO YOUR BUSINESS, CONTACT THE PERSON IDENTIFIED ON THE NOTICE.

Regulations that provide more specific guidance on compliance, and that specify procedures to be followed by the State in carrying out certain aspects of the law, are found in Title 27 of the California Code of Regulations, sections 25102 through 27001.¹ These implementing regulations are available online at: <http://oehha.ca.gov/prop65/law/P65Regs.html>.

WHAT DOES PROPOSITION 65 REQUIRE?

The "Proposition 65 List." Under Proposition 65, the lead agency (OEHHA) publishes a list of chemicals that are known to the State of California to cause cancer and/or reproductive toxicity. Chemicals are placed on the Proposition 65 list if they are known to cause cancer and/or birth defects or other reproductive harm, such as damage to

female or male reproductive systems or to the developing fetus. This list must be updated at least once a year. The current Proposition 65 list of chemicals is available on the OEHHA website at: http://www.oehha.ca.gov/prop65/prop65_list/Newlist.html.

Only those chemicals that are on the list are regulated under Proposition 65. Businesses that produce, use, release or otherwise engage in activities involving listed chemicals must comply with the following:

Clear and reasonable warnings. A business is required to warn a person before “knowingly and intentionally” exposing that person to a listed chemical unless an exemption applies. The warning given must be “clear and reasonable.” This means that the warning must: (1) clearly make known that the chemical involved is known to cause cancer, or birth defects or other reproductive harm; and (2) be given in such a way that it will effectively reach the person before he or she is exposed to that chemical. Some exposures are exempt from the warning requirement under certain circumstances discussed below.

Prohibition from discharges into drinking water. A business must not knowingly discharge or release a listed chemical into water or onto land where it passes or probably will pass into a source of drinking water. Some discharges are exempt from this requirement under certain circumstances discussed below.

DOES PROPOSITION 65 PROVIDE ANY EXEMPTIONS?

Yes. You should consult the current version of the statute and regulations (<http://www.oehha.ca.gov/prop65/law/index.html>) to determine all applicable exemptions, the most common of which are the following:

Grace Period. Proposition 65 warning requirements do not apply until 12 months after the chemical has been listed. The Proposition 65 discharge prohibition does not apply to a discharge or release of a chemical that takes place less than 20 months after the listing of the chemical.

Governmental agencies and public water utilities. All agencies of the federal, state or local government, as well as entities operating public water systems, are exempt.

Businesses with nine or fewer employees. Neither the warning requirement nor the discharge prohibition applies to a business that employs a total of nine or fewer employees. This includes all employees, not just those present in California.

Exposures that pose no significant risk of cancer. For chemicals that are listed under Proposition 65 as known to the State to cause cancer, a warning is not required if the business causing the exposure can demonstrate that the exposure occurs at a level that poses “no significant risk.” This means that the exposure is calculated to result in not more than one excess case of cancer in 100,000 individuals exposed over a 70-year lifetime. The Proposition 65 regulations identify specific “No Significant Risk Levels” (NSRLs) for many listed carcinogens. Exposures below these levels are exempt from the warning requirement. See OEHHA's website at: <http://www.oehha.ca.gov/prop65/getNSRLs.html> for a list of NSRLs, and Section 25701 *et seq.* of the regulations for information concerning how these levels are calculated.

Exposures that will produce no observable reproductive effect at 1,000 times the level in question. For chemicals known to the State to cause reproductive toxicity, a warning is not required if the business causing the exposure can demonstrate that the exposure will produce no observable effect, even at 1,000 times the level in question. In other words, the level of exposure must be below the “no observable effect level” divided by 1,000. This number is known as the Maximum Allowable Dose Level (MADL). See OEHHA's website at: <http://www.oehha.ca.gov/prop65/getNSRLs.html> for a list of MADLs, and Section 25801 *et seq.* of the regulations for information concerning how these levels are calculated.

Exposures to Naturally Occurring Chemicals in Food. Certain exposures to chemicals that naturally occur in foods (i.e., that do not result from any known human activity, including activity by someone other than the person causing the exposure) are exempt from the warning requirements of the law. If the chemical is a contaminant² it must be reduced to the lowest level feasible. Regulations explaining this exemption can be found in Section 25501.

Discharges that do not result in a “significant amount” of the listed chemical entering any source of drinking water. The prohibition from discharges into drinking water does not apply if the discharger is able to demonstrate that a “significant amount” of the listed chemical has not, does not, or will not pass into or probably pass into a source of drinking water, and that the discharge complies with all other applicable laws, regulations, permits, requirements, or orders. A “significant amount” means any detectable amount, except an amount that would meet the “no significant risk” level for chemicals that cause cancer or that is 1,000 times below the “no observable effect” level for chemicals that cause reproductive toxicity, if an individual were exposed to that amount in drinking water.

HOW IS PROPOSITION 65 ENFORCED?

Enforcement is carried out through civil lawsuits. These lawsuits may be brought by the Attorney General, any district attorney, or certain city attorneys. Lawsuits may also be brought by private parties acting in the public interest, but only after providing notice of the alleged violation to the Attorney General, the appropriate district attorney and city attorney, and the business accused of the violation. The notice must provide adequate information to allow the recipient to assess the nature of the alleged violation. The notice must comply with the information and procedural requirements specified in Section 25903 of Title 27 and sections 3100-3103 of Title 11. A private party may not pursue an independent enforcement action under Proposition 65 if one of the governmental officials noted above initiates an enforcement action within sixty days of the notice.

A business found to be in violation of Proposition 65 is subject to civil penalties of up to \$2,500 per day for each violation. In addition, the business may be ordered by a court to stop committing the violation.

A private party may not file an enforcement action based on certain exposures if the alleged violator meets specific conditions. For the following types of exposures, the Act provides an opportunity for the business to correct the alleged violation:

- An exposure to alcoholic beverages that are consumed on the alleged violator's premises to the extent onsite consumption is permitted by law;
- An exposure to a Proposition 65 listed chemical in a food or beverage prepared and sold on the alleged violator's premises that is primarily intended for immediate consumption on- or off-premises. This only applies if the chemical was not intentionally added to the food, and was formed by cooking or similar preparation of food or beverage components necessary to render the food or beverage palatable or to avoid microbiological contamination;
- An exposure to environmental tobacco smoke caused by entry of persons (other than employees) on premises owned or operated by the alleged violator where smoking is permitted at any location on the premises;
- An exposure to listed chemicals in engine exhaust, to the extent the exposure occurs inside a facility owned or operated by the alleged violator and primarily intended for parking non-commercial vehicles.

If a private party alleges that a violation occurred based on one of the exposures described above, the private party must first provide the alleged violator a notice of special compliance procedure and proof of compliance form.
