1. INTRODUCTION

1.1 On June 6, 2025, Plaintiff Environmental Research Center, Inc. (“ERC”), a non-profit corporation, as a private enforcer and in the public interest, initiated this action by filing a Complaint for Injunctive and Declaratory Relief and Civil Penalties pursuant to the provisions of California Health and Safety Code section 25249.5 *et seq.* (“Proposition 65”),

1 against Azuretale Inc., individually and dba BetterAlt (“Azuretale”) and Does 1-100.
2 Subsequently, on August 25, 2025, a First Amended Complaint was filed (the operative
3 Complaint, hereinafter referred to as “Complaint”). In this action, ERC alleges that a number
4 of products manufactured, distributed, or sold by Azuretale contain perfluorooctanoic acid
5 (PFOA) and/or lead, chemicals listed under Proposition 65 as carcinogens and/or reproductive
6 toxins, and expose consumers to these chemicals at a level requiring a Proposition 65 warning.
7 These products (referred to hereinafter individually as a “Covered Product” or collectively as
8 “Covered Products”) are: (1) BetterAlt Muscle Pro Loaded Plant Protein Ashwagandha Safed
9 Musli Iced Coffee Flavor (PFOA, lead), (2) BetterAlt Ova Care+ Cordyceps Magnesium
10 Ashoka (lead), (3) BetterAlt Debloat Greens Blend Spirulina Probiotic Blend Mint (lead), (4)
11 BetterAlt Psyllium Husk Powder Isabgol Lemon Flavor (lead), and (5) BetterAlt Boost Beet
12 Root Powder (lead).

13 All of the Covered Products may also be referred to as “Lead Covered Product(s).”
14 Additionally, the following Covered Product may also be referred to as a “PFOA Covered
15 Product”: BetterAlt Muscle Pro Loaded Plant Protein Ashwagandha Safed Musli Iced Coffee
16 Flavor.

17 **1.2** ERC and Azuretale are hereinafter referred to individually as a “Party” or
18 collectively as the “Parties.”

19 **1.3** ERC is a 501 (c)(3) California non-profit corporation dedicated to, among other
20 causes, helping safeguard the public from health hazards by reducing the use and misuse of
21 hazardous and toxic chemicals, facilitating a safe environment for consumers and employees,
22 and encouraging corporate responsibility.

23 **1.4** For purposes of this Consent Judgment, the Parties agree that Azuretale is a
24 business entity that has employed ten or more persons at all times relevant to this action and
25 qualifies as a “person in the course of doing business” within the meaning of Proposition 65.
26 Azuretale manufactures, distributes, and/or sells the Covered Products.

27 **1.5** The Complaint is based on alleged allegations contained in ERC’s Notices of
28 Violation dated March 26, 2025, May 6, 2025, and June 13, 2025, that were served on the

1 California Attorney General, other public enforcers, and Azuretale (“First Three Notices”).
2 True and correct copies of the First Three Notices, dated March 26, 2025, May 6, 2025, and
3 June 13, 2025, are attached hereto as **Exhibits A, B, and C** and each is incorporated herein by
4 reference. More than 60 days have passed since the First Three Notices were served on the
5 Attorney General, public enforcers, and Azuretale and no designated governmental entity has
6 filed a Complaint against Azuretale with regard to the Covered Products or the alleged
7 violations.

8 **1.6** On August 28, 2025, ERC served a Fourth Notice of Violation on the California
9 Attorney General, other public enforcers, and Azuretale (“Fourth Notice”). A true and correct
10 copy of the Fourth Notice is attached hereto as **Exhibit D** and incorporated by reference. The
11 parties stipulate that the Complaint be deemed amended as of October 30, 2025 to include the
12 products set forth in ERC’s Fourth Notice. This Consent Judgment shall apply to all Covered
13 Products set forth in Paragraph 1.1, effective 60 days after August 28, 2025, provided no
14 public enforcer is diligently pursuing the allegations set forth in ERC’s Fourth Notice. On
15 October 30, 2025 more than 60 days will have passed since ERC’s Fourth Notice was served
16 on the Attorney General, public enforcers, and Azuretale. The First Three Notices and the
17 Fourth Notice are hereafter collectively referred to as “Notices.”

18 **1.7** ERC’s Notices and Complaint allege that use of the Covered Products by
19 California consumers exposes them to PFOA and/or lead without first receiving clear and
20 reasonable warnings from Azuretale, which is in violation of California Health and Safety
21 Code section 25249.6. Azuretale denies all material allegations contained in the Notices and
22 Complaint.

23 **1.8** The Parties have entered into this Consent Judgment in order to settle,
24 compromise, and resolve disputed claims and thus avoid prolonged and costly litigation.
25 Nothing in this Consent Judgment nor compliance with this Consent Judgment shall constitute
26 or be construed as an admission by any of the Parties or by any of their respective officers,
27 directors, shareholders, employees, agents, parent companies, subsidiaries, divisions,
28 franchisees, licensees, customers, suppliers, distributors, wholesalers, or retailers of any fact,

1 issue of law, or violation of law.

2 **1.9** Except as expressly set forth herein, nothing in this Consent Judgment shall
3 prejudice, waive, or impair any right, remedy, argument, or defense the Parties may have in
4 any current or future legal proceeding unrelated to these proceedings.

5 **1.10** The Effective Date of this Consent Judgment is the date on which it is entered as
6 a Judgment by this Court.

7 **2. JURISDICTION AND VENUE**

8 For purposes of this Consent Judgment and any further court action that may become
9 necessary to enforce this Consent Judgment, the Parties stipulate that this Court has subject matter
10 jurisdiction over the allegations of violations contained in the Complaint and personal jurisdiction
11 over Azuretale as to the acts alleged in the Complaint, that venue is proper in Alameda County,
12 and that this Court has jurisdiction to enter this Consent Judgment as a full and final resolution of
13 all claims up through and including the Effective Date that were or could have been asserted in
14 this action based on the facts alleged in the Notices and Complaint.

15 **3. INJUNCTIVE RELIEF, REFORMULATION, TESTING AND WARNINGS**

16 **3.1** Beginning on the Effective Date, Azuretale shall be permanently enjoined from
17 manufacturing for sale in the State of California, “Distributing into the State of California,” or
18 directly selling in the State of California, any Lead Covered Product that exposes a person to a
19 “Daily Lead Exposure Level” of more than 0.5 micrograms of lead per day and/or any PFOA
20 Covered Product that exposes a person to a detectable level of PFOA that can be
21 reliably achieved using industry standard methods for testing, unless the Lead Covered Product
22 and/or PFOA Covered Product meets the warning requirements under Section 3.2.

23 **3.1.1** As used in this Consent Judgment, the term “Distributing into the State
24 of California” shall mean to directly ship a Covered Product into California for sale in
25 California or to sell a Covered Product to a distributor that Azuretale knows or has reason to
26 know will sell the Covered Product in California.

27 **3.1.2** For purposes of this Consent Judgment, the “Daily Lead Exposure
28 Level” shall be measured in micrograms, and shall be calculated using the following formula:

1 micrograms of lead per gram of product, multiplied by grams of product per serving of the
2 product (using the largest serving size appearing on the product label), multiplied by servings
3 of the product per day (using the largest number of recommended daily servings appearing on
4 the label), which equals micrograms of lead exposure per day. If the label contains no
5 recommended daily servings, then the number of recommended daily servings shall be one.

6 **3.2 Clear and Reasonable Warnings**

7 If Azuretale is required to provide a warning pursuant to Section 3.1, the following
8 warning must be utilized (“Warning”):

9 **WARNING:** Consuming this product can expose you to chemicals including [lead] [and]
10 [perfluorooctanoic acid] which is [are] known to the State of California to cause [cancer
11 and] birth defects or other reproductive harm. For more information go to
www.P65Warnings.ca.gov/food.

12 The Warning shall begin either with the word “**WARNING,**” as indicated above, or the
13 words “**CA WARNING**” or “**CALIFORNIA WARNING,**” in all capital letters and bold print.
14 Azuretale shall use the phrase “cancer and” in the Warning if Azuretale has reason to believe that
15 the “Daily Lead Exposure Level” is greater than 15 micrograms of lead as determined pursuant to
16 the quality control methodology set forth in Section 3.4 and/or if there is a detectable level of
17 PFOA that is reliably achieved using industry standard methods for testing or if Azuretale has
18 reason to believe that another Proposition 65 chemical is present which may require a cancer
19 warning. As identified in the brackets, the warning shall appropriately reflect whether there is
20 lead, PFOA (only for the PFOA Covered Product), or both chemicals present in each of the
21 Covered Products, but if there is a chemical present at a level that requires a cancer warning, the
22 chemical requiring use of the phrase “cancer and” in the Warning shall always be identified.

23 The Warning shall be securely affixed to or printed upon the label of each Covered
24 Product and it must be set off from other surrounding information and enclosed in a box. In
25 addition, for any Covered Product sold over the internet, the Warning shall appear on the
26 checkout page when a California delivery address is indicated for any purchase of any Covered
27 Product. An asterisk or other identifying method must be utilized to identify which products on
28 the checkout page are subject to the Warning. In no event shall any internet or website

Warning be contained in or made through a link.

The Warning shall be at least the same size as the largest of any other health or safety warnings also appearing on the website or on the label and in no event less than six (6) point type. No statements intended to or likely to have the effect of diminishing the impact of the Warning on the average lay person shall accompany the Warning. Further no statements may accompany the Warning that state or imply that the source of the listed chemical has an impact on or results in a less harmful effect of the listed chemical.

Azuretale must display the above Warning with such conspicuousness, as compared with other words, statements or designs on the label, or on its website, if applicable, to render the Warning likely to be read and understood by an ordinary individual under customary conditions of purchase or use of the product. Where a sign or label used to provide the Warning for a Covered Product includes consumer information about the Covered Product in a language other than English, the Warning must also be provided in that language in addition to English.

For purposes of this Consent Judgment, the term “label” means a display of written, printed or graphic material that is printed on or affixed to a Covered Product or its immediate container or wrapper.

3.3 Conforming Covered Products

A Conforming Covered Product is a Lead Covered Product for which the “Daily Lead Exposure Level” is no greater than 0.5 micrograms of lead per day and, with respect to the PFOA Covered Product, has no detectable level of PFOA as determined by the exposure methodology set forth in Section 3.1.2 and the quality control methodology described in Section 3.4, and that is not known by Azuretale to contain other chemicals that violate Proposition 65’s safe harbor thresholds.

3.4 Testing and Quality Control Methodology

3.4.1 Beginning within one year of the Effective Date, Azuretale shall arrange for lead and PFOA testing of the Covered Products at least once a year for a minimum of five consecutive years by arranging for testing of three (3) randomly selected samples of each of the Covered Products, in the form intended for sale to the end-user, which Azuretale intends to

1 sell or is manufacturing for sale in California, directly selling to a consumer in California or
2 “Distributing into the State of California.” If tests conducted pursuant to this Section
3 demonstrate that no Warning is required for a Covered Product during each of five consecutive
4 years, then the testing requirements of this Section will no longer be required as to that
5 Covered Product. However, if during or after the five-year testing period, Azuretale changes
6 ingredient suppliers for any of the Covered Products and/or reformulates any of the Covered
7 Products, Azuretale shall test that Covered Product annually for at least four (4) consecutive
8 years after such change is made.

9 **3.4.2** For purposes of measuring the “Daily Lead Exposure Level,” the highest
10 lead detection result of the three (3) randomly selected samples of the Covered Products will
11 be controlling.

12 **3.4.3** All testing pursuant to this Consent Judgment shall be performed using a
13 laboratory method that complies with the performance and quality control factors appropriate
14 for the method used, including limit of detection and limit of quantification, sensitivity,
15 accuracy and precision that meets the following criteria: Inductively Coupled Plasma-Mass
16 Spectrometry (“ICP-MS”) achieving a limit of quantification of less than or equal to 0.005
17 mg/kg for lead and the lowest level that can be reliably detected using available technologies
18 for PFOA.

19 **3.4.4** All testing pursuant to this Consent Judgment shall be performed by an
20 independent third party laboratory certified by the California Environmental Laboratory
21 Accreditation Program or an independent third-party laboratory that is registered with the
22 United States Food & Drug Administration.

23 **3.4.5** Nothing in this Consent Judgment shall limit Azuretale’s ability to
24 conduct, or require that others conduct, additional testing of the Covered Products, including the
25 raw materials used in their manufacture.

26 **3.4.6** Within thirty (30) days of ERC’s written request, Azuretale shall deliver
27 lab reports obtained pursuant to Section 3.4 to ERC. Azuretale shall retain all test results and
28 documentation for a period of five years from the date of each test.

1 **3.4.7** The testing and reporting requirements of Section 3.4 do not apply to
2 any Covered Product for which Azuretale has provided the Warning specified in Section 3.2
3 continuously and uninterrupted after the Effective Date; however, in the event Azuretale ceases
4 to provide the Warning specified in Section 3.2 for any Covered Product, Azuretale may only
5 do so after it has tested such Covered Product, and Azuretale shall be required to comply with
6 the testing requirements of this section beginning immediately after the date the Warning
7 ceases to be provided, unless Azuretale can show to the satisfaction of ERC that the cessation
8 in providing the Warning was a temporary error that was resolved when discovered.

9 **3.5** Nothing in Section 3 of this Consent Judgment shall prevent or preclude ERC from
10 obtaining and relying upon its own testing for purposes of enforcement, so long as such testing
11 meets the requirements of Sections 3.4.3 and 3.4.4. Nothing in Section 3.4 of this Consent
12 Judgment is intended by either party to set a precedent for the level of lead, PFOA, or other
13 chemicals that are permissible in consumer products under Proposition 65.

14 **3.6. Grace Period for Existing Inventory of Products**

15 The injunctive requirements of Section 3 shall not apply to Covered Products that are
16 already in the “Stream of Commerce” as of the Effective Date, which Products are expressly
17 subject to and part of the releases provided in Section 8. For purposes of this Consent Judgment,
18 a Covered Product that is in the “Stream of Commerce” means that the Covered Product has
19 been manufactured for final sale and is no longer in the possession of or under the control of
20 Azuretale as of the Effective Date.

21 **4. SETTLEMENT PAYMENT**

22 **4.1** In full satisfaction of all potential civil penalties, additional settlement payments,
23 attorney’s fees, and costs, Azuretale shall make a total payment of \$50,000.00 (“Total
24 Settlement Amount”) to ERC within 10 days of the Effective Date (“Due Date”). Azuretale
25 shall make this payment by wire transfer to ERC’s account, for which ERC will give Azuretale
26 the necessary account information. The Total Settlement Amount shall be apportioned as
27 follows:

28 **4.2** \$5,000.00 shall be considered a civil penalty pursuant to California Health and

1 Safety Code section 25249.7(b)(1). ERC shall remit 75% (\$3,750.00) of the civil penalty to the
2 Office of Environmental Health Hazard Assessment (“OEHHA”) for deposit in the Safe
3 Drinking Water and Toxic Enforcement Fund in accordance with California Health and Safety
4 Code section 25249.12(c). ERC will retain the remaining 25% (\$1,250.00) of the civil penalty.

5 **4.3** \$6,468.68 shall be distributed to ERC as reimbursement to ERC for reasonable
6 costs incurred in bringing this action.

7 **4.4** \$38,531.32 shall be distributed to ERC for its in-house legal fees. Except as
8 explicitly provided herein, each Party shall bear its own fees and costs.

9 **4.5** In the event that Azuretale fails to remit the Total Settlement Amount owed
10 under Section 4 of this Consent Judgment on or before the Due Date, Azuretale shall be
11 deemed to be in material breach of its obligations under this Consent Judgment. ERC shall
12 provide written notice of the delinquency to Azuretale via electronic mail. If Azuretale fails to
13 deliver the Total Settlement Amount within five (5) days from the written notice, the Total
14 Settlement Amount shall accrue interest at the statutory judgment interest rate provided in the
15 California Code of Civil Procedure section 685.010, and Azuretale shall forfeit any release
16 provisions in Section 8 that are for the benefit of Azuretale and the Released Parties (as defined
17 in Section 8.1) until such time as the Total Settlement Amount is paid in full. Additionally,
18 Azuretale agrees to pay ERC’s reasonable attorneys’ fees and costs for any efforts to collect
19 the payment due under this Consent Judgment.

20 **5. MODIFICATION OF CONSENT JUDGMENT**

21 **5.1** This Consent Judgment may be modified only as to injunctive terms (i) by
22 written stipulation of the Parties and upon entry by the Court of a modified consent judgment
23 or (ii) by motion of either Party pursuant to Section 5.3, and based upon an agreement to
24 modify the Consent Judgment, and upon entry by the Court of a modified consent judgment.

25 **5.2** If Azuretale seeks to modify this Consent Judgment under Section 5.1, then
26 Azuretale must provide written notice to ERC of its intent (“Notice of Intent”). If ERC seeks
27 to meet and confer regarding the proposed modification in the Notice of Intent, then ERC must
28 provide written notice to Azuretale within thirty (30) days of receiving the Notice of Intent. If

1 ERC notifies Azuretale in a timely manner of ERC's intent to meet and confer, then the Parties
2 shall meet and confer in good faith as required in this Section. The Parties shall meet in
3 person, via remote meeting, or by telephone within thirty (30) days of ERC's notification of its
4 intent to meet and confer. Within thirty (30) days of such meeting, if ERC disputes the
5 proposed modification, ERC shall provide to Azuretale a written basis for its position. The
6 Parties shall continue to meet and confer for an additional thirty (30) days in an effort to
7 resolve any remaining disputes. Should it become necessary, the Parties may agree in writing
8 to different deadlines for the meet-and-confer period.

9 **5.3** In the event that Azuretale initiates or otherwise requests a modification under
10 Section 5.1, and the meet and confer process leads to an agreed upon motion or stipulation for
11 a modification of the Consent Judgment, Azuretale shall reimburse ERC its costs and
12 reasonable attorney's fees for the time spent in the meet-and-confer process and filing the
13 motion.

14 **6. RETENTION OF JURISDICTION, ENFORCEMENT OF CONSENT** 15 **JUDGMENT**

16 **6.1** This Court shall retain jurisdiction of this matter to enforce, modify, or terminate
17 this Consent Judgment.

18 **6.2** If ERC alleges that any Covered Product fails to qualify as a Conforming
19 Covered Product (for which ERC alleges that no Warning has been provided), then ERC shall
20 inform Azuretale in a reasonably prompt manner of its test results, including information
21 sufficient to permit Azuretale to identify the Covered Products at issue. Azuretale shall, within
22 thirty (30) days following such notice, provide ERC with testing information, from an
23 independent third-party laboratory meeting the requirements of Sections 3.4.3 and 3.4.4,
24 demonstrating Azuretale's compliance with the Consent Judgment. The Parties shall first
25 attempt to resolve the matter prior to ERC taking any further legal action.

26 **7. APPLICATION OF CONSENT JUDGMENT**

27 This Consent Judgment may apply to, be binding upon, and benefit the Parties and their
28 respective officers, directors, shareholders, employees, agents, parent companies, subsidiaries,

1 divisions, franchisees, licensees, customers (excluding private labelers), distributors, wholesalers,
2 retailers, predecessors, successors, and assigns. This Consent Judgment shall have no application
3 to any Covered Product that is distributed or sold exclusively outside the State of California and
4 that is not used by California consumers.

5 **8. BINDING EFFECT, CLAIMS COVERED AND RELEASED**

6 **8.1** This Consent Judgment is a full, final, and binding resolution between ERC, on
7 behalf of itself and in the public interest, and Azuretale and its respective officers, directors,
8 shareholders, employees, agents, parent companies, subsidiaries, divisions, suppliers,
9 franchisees, licensees, customers (not including private label customers of Azuretale),
10 distributors, wholesalers, retailers, and all other upstream and downstream entities in the
11 distribution chain of any Covered Product, and the predecessors, successors, and assigns of any
12 of them (collectively, “Released Parties”).

13 **8.2** ERC, acting in the public interest, releases the Released Parties from any and all
14 claims for violations of Proposition 65 up to and including the Effective Date based on
15 exposure to lead from the Lead Covered Products and PFOA from the PFOA Covered Product,
16 all as set forth in the Notices of Violation. ERC, on behalf of itself only, hereby fully releases
17 and discharges the Released Parties from any and all claims, actions, causes of action, suits,
18 demands, liabilities, damages, penalties, fees, costs, and expenses asserted, or that could have
19 been asserted from the handling, use, or consumption of the Covered Products, as to any
20 alleged violation of Proposition 65 or its implementing regulations arising from the failure to
21 provide Proposition 65 warnings on the Covered Products regarding lead from the Lead
22 Covered Products and/or PFOA from the PFOA Covered Product up to and including the
23 Effective Date. For the sake of clarity, it is the Parties’ intention that this Consent Judgment
24 shall have preclusive effect such that no other actions by private enforcers, whether purporting
25 to act in his, her, or its interests or the public interest shall be permitted to pursue and/or take
26 any action with respect to any violation of Proposition 65 that was alleged in the Notices or
27 Complaint or that could have been brought pursuant to the Notices or Complaint against the
28 Released Parties regarding exposure to lead from the Lead Covered Products and PFOA from

1 the PFOA Covered Product sold or distributed by Azuretale or any other Released Parties,
2 prior to the Effective Date.

3 **8.3** ERC on its own behalf only, and Azuretale on its own behalf only, further waive
4 and release any and all claims they may have against each other for all actions or statements
5 made or undertaken in the course of seeking or opposing enforcement of Proposition 65 in
6 connection with the Notices and Complaint up to and including the Effective Date, provided,
7 however, that nothing in Section 8 shall affect or limit any Party's right to seek to enforce the
8 terms of this Consent Judgment.

9 **8.4** It is possible that other claims not known to the Parties, arising out of the facts
10 alleged in the Notices and Complaint, and relating to the Covered Products, will develop or be
11 discovered. ERC on behalf of itself only, and Azuretale on behalf of itself only, acknowledge
12 that this Consent Judgment is expressly intended to cover and include all such claims up to and
13 including the Effective Date, including all rights of action therefor. ERC and Azuretale
14 acknowledge that the claims released in Sections 8.2 and 8.3 above may include unknown
15 claims, and nevertheless waive California Civil Code section 1542 as to any such unknown
16 claims. California Civil Code section 1542 reads as follows:

17 A GENERAL RELEASE DOES NOT EXTEND TO CLAIMS THAT THE
18 CREDITOR OR RELEASING PARTY DOES NOT KNOW OR SUSPECT TO
19 EXIST IN HIS OR HER FAVOR AT THE TIME OF EXECUTING THE RELEASE
20 AND THAT, IF KNOWN BY HIM OR HER, WOULD HAVE MATERIALLY
AFFECTED HIS OR HER SETTLEMENT WITH THE DEBTOR OR RELEASED
PARTY.

21 ERC on behalf of itself only, and Azuretale on behalf of itself only, acknowledge and
22 understand the significance and consequences of this specific waiver of California Civil Code
23 section 1542.

24 **8.5** Compliance with the terms of this Consent Judgment shall be deemed to
25 constitute compliance with Proposition 65 by any of the Released Parties regarding alleged
26 exposures to lead in the Lead Covered Products and PFOA in the PFOA Covered Product, as
27 set forth in the Notices and Complaint.

28 **8.6** Nothing in this Consent Judgment is intended to apply to any occupational or

environmental exposures arising under Proposition 65, nor shall it apply to any of Azuretale's products other than the Covered Products.

9. SEVERABILITY OF UNENFORCEABLE PROVISIONS

In the event that any of the provisions of this Consent Judgment are held by a court to be unenforceable, the validity of the remaining enforceable provisions shall not be adversely affected.

10. GOVERNING LAW

The terms and conditions of this Consent Judgment shall be governed by and construed in accordance with the laws of the State of California.

11. PROVISION OF NOTICE

9 **12.1** Upon execution of this Consent Judgment by the Parties, ERC shall notice a
10 Motion for Court Approval. The Parties shall use their best efforts to support entry of this

1 **15. GOOD FAITH ATTEMPT TO RESOLVE DISPUTES**

2 If a dispute arises with respect to either Party's compliance with the terms of this Consent

12 describing in reasonable detail the alleged breach and/or non-compliance. Azuretale shall have
13 a period of not less than thirty (30) days from receipt of such notice to cure the alleged breach
14 and/or non-compliance. No Court-filed enforcement action shall be commenced by ERC unless
15 Azuretale fails to cure within the specified period. In any action brought by ERC to enforce
16 this Consent Judgment, ERC may seek whatever fines, costs, penalties, or remedies as are
17 provided by law for failure to comply with the Consent Judgment. To the extent the failure to
18 comply with the Consent Judgment constitutes a violation of Proposition 65 or other laws,
19 ERC shall not be limited to enforcement of this Consent Judgment, but may seek in another
20 action whatever fines, costs, penalties, or remedies as are provided by law for failure to comply
21 with Proposition 65 or other laws.

22 **17. ENTIRE AGREEMENT, AUTHORIZATION**

23 **17.1** This Consent Judgment contains the sole and entire agreement and understanding
24 of the Parties with respect to the entire subject matter herein, including any and all prior
25 discussions, negotiations, commitments, and understandings related thereto. No
26 representations, oral or otherwise, express or implied, other than those contained herein have
27 been made by any Party. No other agreements, oral or otherwise, unless specifically referred to
28 herein, shall be deemed to exist or to bind any Party.

1 **17.2** Each signatory to this Consent Judgment certifies that he or she is fully
2 authorized by the Party he or she represents to stipulate to this Consent Judgment.

3 **18. REQUEST FOR FINDINGS, APPROVAL OF SETTLEMENT AND ENTRY OF**

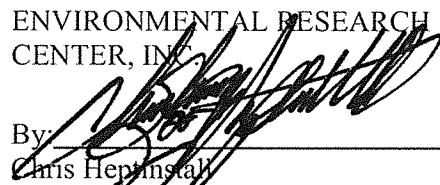

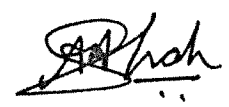

NOTICE OF VIOLATIONS OF CALIFORNIA HEALTH & SAFETY CODE SECTION 25249.5 *ET SEQ.* (PROPOSITION 65)

Dear Alleged Violator and the Appropriate Public Enforcement Agencies:

I am the In-House Counsel for Environmental Research Center, Inc. (“ERC”). ERC is a California non-profit corporation dedicated to, among other causes, helping safeguard the public from health hazards by bringing about a reduction in the use and misuse of hazardous and toxic chemicals, facilitating a safe environment for consumers and employees, and encouraging corporate responsibility.

ERC has identified violations of California’s Safe Drinking Water and Toxic Enforcement Act of 1986 (“Proposition 65”), which is codified at California Health & Safety Code §25249.5 *et seq.*, with respect to the product identified below. These violations have occurred and continue to occur because the alleged Violator identified below failed to provide required clear and reasonable warnings with this product. This letter serves as a notice of these violations to the alleged Violator and the appropriate public enforcement agencies. Pursuant to Section 25249.7(d) of the statute, ERC intends to file a private enforcement action in the public interest 60 days after effective service of this notice unless the public enforcement agencies have commenced and are diligently prosecuting an action to rectify these violations.

General Information about Proposition 65. A copy of a summary of Proposition 65, prepared by the Office of Environmental Health Hazard Assessment, is attached with the copy of this letter served to the alleged Violator identified below.

Alleged Violator. The name of the company covered by this notice that violated Proposition 65 (hereinafter the “Violator”) is:

Azuretale Inc., individually and dba BetterAlt

Consumer Product and Listed Chemical. The product that is the subject of this notice and the chemical in that product identified as exceeding allowable levels is:

- **BetterAlt Muscle Pro Loaded Plant Protein Ashwagandha Safed Musli Iced Coffee Flavor - Perfluorooctanoic Acid (PFOA)**

On November 10, 2017, the State of California officially listed Perfluorooctanoic Acid (PFOA) as a chemical known to cause developmental toxicity. On February 25, 2022, the State of California officially listed Perfluorooctanoic Acid (PFOA) as a chemical known to cause cancer.

It should be noted that ERC may continue to investigate other products that may reveal further violations and result in subsequent notices of violations.

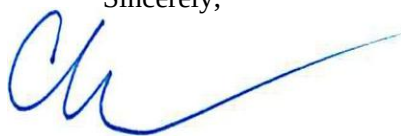
Route of Exposure. The consumer exposures that are the subject of this notice result from the recommended use of this product. Consequently, the route of exposure to this chemical has been and continues to be through ingestion.

Approximate Time Period of Violations. Ongoing violations have occurred every day since at least March 26, 2022, as well as every day since the product was introduced into the California marketplace and will continue every day until clear and reasonable warnings are provided to product purchasers and users or until this known toxic chemical is either removed from or reduced to allowable levels in the product. Proposition 65 requires that a clear and reasonable warning be provided prior to exposure to the identified chemical. The method of warning should be a warning that appears on the product label. The Violator violated Proposition 65 because it failed to provide persons ingesting this product with appropriate warnings that they are being exposed to this chemical.

Consistent with the public interest goals of Proposition 65 and a desire to have these ongoing violations of California law quickly rectified, ERC is interested in seeking a constructive resolution of this matter that includes an enforceable written agreement by the Violator to: (1) recall the identified product so as to eliminate further exposures to the identified chemical, and/or (2) affix clear and reasonable Prop 65 warning labels for products sold in the future while reformulating such product to eliminate the exposures, and (3) conduct bio-monitoring of all California consumers that have ingested the identified chemical in the listed product, and (4) pay an appropriate civil penalty. Such a resolution will prevent further unwarned consumer exposures to the identified chemical, as well as an expensive and time-consuming litigation.

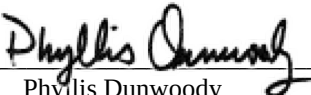

The summary provides basic information about the provisions of the law, and is intended to serve only as a convenient source of general information. It is not intended to provide authoritative guidance on the meaning or application of the law. The reader is directed to the statute and OEHHA implementing regulations (see citations below) for further information.

Regulations that provide more specific guidance on compliance, and that specify procedures to be followed by the State in carrying out certain aspects of the law, are found in Title 27 of the California Code of Regulations, sections 25102 through 27001.¹ These implementing regulations are available online at: <http://oehha.ca.gov/prop65/law/P65Regs.html>.

WHAT DOES PROPOSITION 65 REQUIRE?

The “Proposition 65 List.” Under Proposition 65, the lead agency (OEHHA) publishes a list of chemicals that are known to the State of California to cause cancer and/or reproductive toxicity. Chemicals are placed on the Proposition 65 list if they are known to cause cancer and/or birth defects or other reproductive harm, such as damage to

female or male reproductive systems or to the developing fetus. This list must be updated at least once a year. The current Proposition 65 list of chemicals is available on the OEHHA website at: http://www.oehha.ca.gov/prop65/prop65_list/Newlist.html.

Only those chemicals that are on the list are regulated under Proposition 65. Businesses that produce, use, release or otherwise engage in activities involving listed chemicals must comply with the following:

Clear and reasonable warnings. A business is required to warn a person before “knowingly and intentionally” exposing that person to a listed chemical unless an exemption applies. The warning given must be “clear and reasonable.” This means that the warning must: (1) clearly make known that the chemical involved is known to cause cancer, or birth defects or other reproductive harm; and (2) be given in such a way that it will effectively reach the person before he or she is exposed to that chemical. Some exposures are exempt from the warning requirement under certain circumstances discussed below.

Prohibition from discharges into drinking water. A business must not knowingly discharge or release a listed chemical into water or onto land where it passes or probably will pass into a source of drinking water. Some discharges are exempt from this requirement under certain circumstances discussed below.

DOES PROPOSITION 65 PROVIDE ANY EXEMPTIONS?

Yes. You should consult the current version of the statute and regulations (<http://www.oehha.ca.gov/prop65/law/index.html>) to determine all applicable exemptions, the most common of which are the following:

Grace Period. Proposition 65 warning requirements do not apply until 12 months after the chemical has been listed. The Proposition 65 discharge prohibition does not apply to a discharge or release of a chemical that takes place less than 20 months after the listing of the chemical.

Governmental agencies and public water utilities. All agencies of the federal, state or local government, as well as entities operating public water systems, are exempt.

Businesses with nine or fewer employees. Neither the warning requirement nor the discharge prohibition applies to a business that employs a total of nine or fewer employees. This includes all employees, not just those present in California.

Exposures that pose no significant risk of cancer. For chemicals that are listed under Proposition 65 as known to the State to cause cancer, a warning is not required if the business causing the exposure can demonstrate that the exposure occurs at a level that poses “no significant risk.” This means that the exposure is calculated to result in not more than one excess case of cancer in 100,000 individuals exposed over a 70-year lifetime. The Proposition 65 regulations identify specific “No Significant Risk Levels” (NSRLs) for many listed carcinogens. Exposures below these levels are exempt from the warning requirement. See OEHHA's website at: <http://www.oehha.ca.gov/prop65/getNSRLs.html> for a list of NSRLs, and Section 25701 *et seq.* of the regulations for information concerning how these levels are calculated.

Exposures that will produce no observable reproductive effect at 1,000 times the level in question. For chemicals known to the State to cause reproductive toxicity, a warning is not required if the business causing the exposure can demonstrate that the exposure will produce no observable effect, even at 1,000 times the level in question. In other words, the level of exposure must be below the “no observable effect level” divided by 1,000. This number is known as the Maximum Allowable Dose Level (MADL). See OEHHA's website at: <http://www.oehha.ca.gov/prop65/getNSRLs.html> for a list of MADLs, and Section 25801 *et seq.* of the regulations for information concerning how these levels are calculated.

Exposures to Naturally Occurring Chemicals in Food. Certain exposures to chemicals that naturally occur in foods (i.e., that do not result from any known human activity, including activity by someone other than the person causing the exposure) are exempt from the warning requirements of the law. If the chemical is a contaminant² it must be reduced to the lowest level feasible. Regulations explaining this exemption can be found in Section 25501.

Discharges that do not result in a “significant amount” of the listed chemical entering any source of drinking water. The prohibition from discharges into drinking water does not apply if the discharger is able to demonstrate that a “significant amount” of the listed chemical has not, does not, or will not pass into or probably pass into a source of drinking water, and that the discharge complies with all other applicable laws, regulations, permits, requirements, or orders. A “significant amount” means any detectable amount, except an amount that would meet the “no significant risk” level for chemicals that cause cancer or that is 1,000 times below the “no observable effect” level for chemicals that cause reproductive toxicity, if an individual were exposed to that amount in drinking water.

HOW IS PROPOSITION 65 ENFORCED?

Enforcement is carried out through civil lawsuits. These lawsuits may be brought by the Attorney General, any district attorney, or certain city attorneys. Lawsuits may also be brought by private parties acting in the public interest, but only after providing notice of the alleged violation to the Attorney General, the appropriate district attorney and city attorney, and the business accused of the violation. The notice must provide adequate information to allow the recipient to assess the nature of the alleged violation. The notice must comply with the information and procedural requirements specified in Section 25903 of Title 27 and sections 3100-3103 of Title 11. A private party may not pursue an independent enforcement action under Proposition 65 if one of the governmental officials noted above initiates an enforcement action within sixty days of the notice.

A business found to be in violation of Proposition 65 is subject to civil penalties of up to \$2,500 per day for each violation. In addition, the business may be ordered by a court to stop committing the violation.

A private party may not file an enforcement action based on certain exposures if the alleged violator meets specific conditions. For the following types of exposures, the Act provides an opportunity for the business to correct the alleged violation:

- An exposure to alcoholic beverages that are consumed on the alleged violator's premises to the extent onsite consumption is permitted by law;
- An exposure to a Proposition 65 listed chemical in a food or beverage prepared and sold on the alleged violator's premises that is primarily intended for immediate consumption on- or off-premises. This only applies if the chemical was not intentionally added to the food, and was formed by cooking or similar preparation of food or beverage components necessary to render the food or beverage palatable or to avoid microbiological contamination;
- An exposure to environmental tobacco smoke caused by entry of persons (other than employees) on premises owned or operated by the alleged violator where smoking is permitted at any location on the premises;
- An exposure to listed chemicals in engine exhaust, to the extent the exposure occurs inside a facility owned or operated by the alleged violator and primarily intended for parking non-commercial vehicles.

If a private party alleges that a violation occurred based on one of the exposures described above, the private party must first provide the alleged violator a notice of special compliance procedure and proof of compliance form.

NOTICE OF VIOLATIONS OF CALIFORNIA HEALTH & SAFETY CODE SECTION 25249.5 *ET SEQ.* (PROPOSITION 65)

Dear Alleged Violator and the Appropriate Public Enforcement Agencies:

I am the In-House Counsel for Environmental Research Center, Inc. (“ERC”). ERC is a California non-profit corporation dedicated to, among other causes, helping safeguard the public from health hazards by bringing about a reduction in the use and misuse of hazardous and toxic chemicals, facilitating a safe environment for consumers and employees, and encouraging corporate responsibility.

ERC has identified violations of California’s Safe Drinking Water and Toxic Enforcement Act of 1986 (“Proposition 65”), which is codified at California Health & Safety Code §25249.5 *et seq.*, with respect to the product identified below. These violations have occurred and continue to occur because the alleged Violator identified below failed to provide required clear and reasonable warnings with this product. This letter serves as a notice of these violations to the alleged Violator and the appropriate public enforcement agencies. Pursuant to Section 25249.7(d) of the statute, ERC intends to file a private enforcement action in the public interest 60 days after effective service of this notice unless the public enforcement agencies have commenced and are diligently prosecuting an action to rectify these violations.

General Information about Proposition 65. A copy of a summary of Proposition 65, prepared by the Office of Environmental Health Hazard Assessment, is attached with the copy of this letter served to the alleged Violator identified below.

Alleged Violator. The name of the company covered by this notice that violated Proposition 65 (hereinafter the “Violator”) is:

Azuretale Inc., individually and dba BetterAlt

Consumer Product and Listed Chemical. The product that is the subject of this notice and the chemical in that product identified as exceeding allowable levels is:

BetterAlt Ova Care+ Cordyceps Magnesium Ashoka - Lead

On February 27, 1987, the State of California officially listed lead as a chemical known to cause developmental toxicity, and male and female reproductive toxicity. On October 1, 1992, the State of California officially listed lead and lead compounds as chemicals known to cause cancer.

It should be noted that ERC may continue to investigate other products that may reveal further violations and result in subsequent notices of violations.

Route of Exposure. The consumer exposures that are the subject of this notice result from the recommended use of this product. Consequently, the route of exposure to this chemical has been and continues to be through ingestion.

Approximate Time Period of Violations. Ongoing violations have occurred every day since at least May 6, 2022, as well as every day since the product was introduced into the California marketplace and will continue every day until clear and reasonable warnings are provided to product purchasers and users or until this known toxic chemical is either removed from or reduced to allowable levels in the product. Proposition 65 requires that a clear and reasonable warning be provided prior to exposure to the identified chemical. The method of warning should be a warning that appears on the product label. The Violator violated Proposition 65 because it failed to provide persons ingesting this product with appropriate warnings that they are being exposed to this chemical.

Consistent with the public interest goals of Proposition 65 and a desire to have these ongoing violations of California law quickly rectified, ERC is interested in seeking a constructive resolution of this matter that includes an enforceable written agreement by the Violator to: (1) reformulate the identified product so as to eliminate further exposures to the identified chemical, or provide appropriate warnings on the labels of this product; (2) pay an appropriate civil penalty; and (3) provide clear and reasonable warnings compliant with Proposition 65 to all persons located in California who purchased the above product in the last three years. Such a resolution will prevent further unwarned consumer exposures to the identified chemical, as well as expensive and time-consuming litigation.

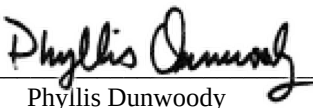

THE SAFE DRINKING WATER AND TOXIC ENFORCEMENT ACT OF 1986 (PROPOSITION 65): A SUMMARY

The following summary has been prepared by the California Office of Environmental Health Hazard Assessment (OEHHA), the lead agency for the implementation of the Safe Drinking Water and Toxic Enforcement Act of 1986 (commonly known as “Proposition 65”). A copy of this summary must be included as an attachment to any notice of violation served upon an alleged violator of the Act. The summary provides basic information about the provisions of the law, and is intended to serve only as a convenient source of general information. It is not intended to provide authoritative guidance on the meaning or application of the law. The reader is directed to the statute and OEHHA implementing regulations (see citations below) for further information.

FOR INFORMATION CONCERNING THE BASIS FOR THE ALLEGATIONS IN THE NOTICE RELATED TO YOUR BUSINESS, CONTACT THE PERSON IDENTIFIED ON THE NOTICE.

The text of Proposition 65 (Health and Safety Code Sections 25249.5 through 25249.13) is available online at: <http://oehha.ca.gov/prop65/law/P65law72003.html>. Regulations that provide more specific guidance on compliance, and that specify procedures to be followed by the State in carrying out certain aspects of the law, are found in Title 27 of the California Code of Regulations, sections 25102 through 27001.¹ These implementing regulations are available online at: <http://oehha.ca.gov/prop65/law/P65Regs.html>.

WHAT DOES PROPOSITION 65 REQUIRE?

The “Proposition 65 List.” Under Proposition 65, the lead agency (OEHHA) publishes a list of chemicals that are known to the State of California to cause cancer and/or reproductive toxicity. Chemicals are placed on the Proposition 65 list if they are known to cause cancer and/or birth defects or other reproductive harm, such as damage to

female or male reproductive systems or to the developing fetus. This list must be updated at least once a year. The current Proposition 65 list of chemicals is available on the OEHHA website at: http://www.oehha.ca.gov/prop65/prop65_list/Newlist.html.

Only those chemicals that are on the list are regulated under Proposition 65. Businesses that produce, use, release or otherwise engage in activities involving listed chemicals must comply with the following:

Clear and reasonable warnings. A business is required to warn a person before “knowingly and intentionally” exposing that person to a listed chemical unless an exemption applies. The warning given must be “clear and reasonable.” This means that the warning must: (1) clearly make known that the chemical involved is known to cause cancer, or birth defects or other reproductive harm; and (2) be given in such a way that it will effectively reach the person before he or she is exposed to that chemical. Some exposures are exempt from the warning requirement under certain circumstances discussed below.

Prohibition from discharges into drinking water. A business must not knowingly discharge or release a listed chemical into water or onto land where it passes or probably will pass into a source of drinking water. Some discharges are exempt from this requirement under certain circumstances discussed below.

DOES PROPOSITION 65 PROVIDE ANY EXEMPTIONS?

Yes. You should consult the current version of the statute and regulations (<http://www.oehha.ca.gov/prop65/law/index.html>) to determine all applicable exemptions, the most common of which are the following:

Grace Period. Proposition 65 warning requirements do not apply until 12 months after the chemical has been listed. The Proposition 65 discharge prohibition does not apply to a discharge or release of a chemical that takes place less than 20 months after the listing of the chemical.

Governmental agencies and public water utilities. All agencies of the federal, state or local government, as well as entities operating public water systems, are exempt.

Businesses with nine or fewer employees. Neither the warning requirement nor the discharge prohibition applies to a business that employs a total of nine or fewer employees. This includes all employees, not just those present in California.

Exposures that pose no significant risk of cancer. For chemicals that are listed under Proposition 65 as known to the State to cause cancer, a warning is not required if the business causing the exposure can demonstrate that the exposure occurs at a level that poses “no significant risk.” This means that the exposure is calculated to result in not more than one excess case of cancer in 100,000 individuals exposed over a 70-year lifetime. The Proposition 65 regulations identify specific “No Significant Risk Levels” (NSRLs) for many listed carcinogens. Exposures below these levels are exempt from the warning requirement. See OEHHA's website at: <http://www.oehha.ca.gov/prop65/getNSRLs.html> for a list of NSRLs, and Section 25701 *et seq.* of the regulations for information concerning how these levels are calculated.

Exposures that will produce no observable reproductive effect at 1,000 times the level in question. For chemicals known to the State to cause reproductive toxicity, a warning is not required if the business causing the exposure can demonstrate that the exposure will produce no observable effect, even at 1,000 times the level in question. In other words, the level of exposure must be below the “no observable effect level” divided by 1,000. This number is known as the Maximum Allowable Dose Level (MADL). See OEHHA's website at: <http://www.oehha.ca.gov/prop65/getNSRLs.html> for a list of MADLs, and Section 25801 *et seq.* of the regulations for information concerning how these levels are calculated.

Exposures to Naturally Occurring Chemicals in Food. Certain exposures to chemicals that naturally occur in foods (i.e., that do not result from any known human activity, including activity by someone other than the person causing the exposure) are exempt from the warning requirements of the law. If the chemical is a contaminant² it must be reduced to the lowest level feasible. Regulations explaining this exemption can be found in Section 25501.

Discharges that do not result in a “significant amount” of the listed chemical entering any source of drinking water. The prohibition from discharges into drinking water does not apply if the discharger is able to demonstrate that a “significant amount” of the listed chemical has not, does not, or will not pass into or probably pass into a source of drinking water, and that the discharge complies with all other applicable laws, regulations, permits, requirements, or orders. A “significant amount” means any detectable amount, except an amount that would meet the “no significant risk” level for chemicals that cause cancer or that is 1,000 times below the “no observable effect” level for chemicals that cause reproductive toxicity, if an individual were exposed to that amount in drinking water.

HOW IS PROPOSITION 65 ENFORCED?

Enforcement is carried out through civil lawsuits. These lawsuits may be brought by the Attorney General, any district attorney, or certain city attorneys. Lawsuits may also be brought by private parties acting in the public interest, but only after providing notice of the alleged violation to the Attorney General, the appropriate district attorney and city attorney, and the business accused of the violation. The notice must provide adequate information to allow the recipient to assess the nature of the alleged violation. The notice must comply with the information and procedural requirements specified in Section 25903 of Title 27 and sections 3100-3103 of Title 11. A private party may not pursue an independent enforcement action under Proposition 65 if one of the governmental officials noted above initiates an enforcement action within sixty days of the notice.

A business found to be in violation of Proposition 65 is subject to civil penalties of up to \$2,500 per day for each violation. In addition, the business may be ordered by a court to stop committing the violation.

A private party may not file an enforcement action based on certain exposures if the alleged violator meets specific conditions. For the following types of exposures, the Act provides an opportunity for the business to correct the alleged violation:

- An exposure to alcoholic beverages that are consumed on the alleged violator's premises to the extent onsite consumption is permitted by law;
- An exposure to a Proposition 65 listed chemical in a food or beverage prepared and sold on the alleged violator's premises that is primarily intended for immediate consumption on- or off-premises. This only applies if the chemical was not intentionally added to the food, and was formed by cooking or similar preparation of food or beverage components necessary to render the food or beverage palatable or to avoid microbiological contamination;
- An exposure to environmental tobacco smoke caused by entry of persons (other than employees) on premises owned or operated by the alleged violator where smoking is permitted at any location on the premises;
- An exposure to listed chemicals in engine exhaust, to the extent the exposure occurs inside a facility owned or operated by the alleged violator and primarily intended for parking non-commercial vehicles.

If a private party alleges that a violation occurred based on one of the exposures described above, the private party must first provide the alleged violator a notice of special compliance procedure and proof of compliance form.

NOTICE OF VIOLATIONS OF CALIFORNIA HEALTH & SAFETY CODE SECTION 25249.5 *ET SEQ.* (PROPOSITION 65)

Dear Alleged Violator and the Appropriate Public Enforcement Agencies:

I am the In-House Counsel for Environmental Research Center, Inc. (“ERC”). ERC is a California non-profit corporation dedicated to, among other causes, helping safeguard the public from health hazards by bringing about a reduction in the use and misuse of hazardous and toxic chemicals, facilitating a safe environment for consumers and employees, and encouraging corporate responsibility.

ERC has identified violations of California’s Safe Drinking Water and Toxic Enforcement Act of 1986 (“Proposition 65”), which is codified at California Health & Safety Code §25249.5 *et seq.*, with respect to the products identified below. These violations have occurred and continue to occur because the alleged Violator identified below failed to provide required clear and reasonable warnings with these products. This letter serves as a notice of these violations to the alleged Violator and the appropriate public enforcement agencies. Pursuant to Section 25249.7(d) of the statute, ERC intends to file a private enforcement action in the public interest 60 days after effective service of this notice unless the public enforcement agencies have commenced and are diligently prosecuting an action to rectify these violations.

General Information about Proposition 65. A copy of a summary of Proposition 65, prepared by the Office of Environmental Health Hazard Assessment, is attached with the copy of this letter served to the alleged Violator identified below.

Alleged Violator. The name of the company covered by this notice that violated Proposition 65 (hereinafter the “Violator”) is:

Azuretale Inc., individually and dba BetterAlt

Consumer Products and Listed Chemical. The products that are the subject of this notice and the chemical in those products identified as exceeding allowable levels are:

1. **BetterAlt Debloat Greens Blend Spirulina Probiotic Blend Mint - Lead**
2. **BetterAlt Psyllium Husk Powder Isabgol Lemon Flavor - Lead**
3. **BetterAlt Muscle Pro Loaded Plant Protein Ashwagandha Safed Musli Iced Coffee Flavor - Lead**

On February 27, 1987, the State of California officially listed lead as a chemical known to cause

developmental toxicity, and male and female reproductive toxicity. On October 1, 1992, the State of California officially listed lead and lead compounds as chemicals known to cause cancer.

It should be noted that ERC may continue to investigate other products that may reveal further violations and result in subsequent notices of violations.

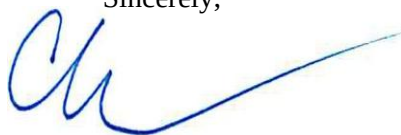
Route of Exposure. The consumer exposures that are the subject of this notice result from the recommended use of these products. Consequently, the route of exposure to this chemical has been and continues to be through ingestion.

Approximate Time Period of Violations. Ongoing violations have occurred every day since at least June 13, 2022, as well as every day since the products were introduced into the California marketplace and will continue every day until clear and reasonable warnings are provided to product purchasers and users or until this known toxic chemical is either removed from or reduced to allowable levels in the products. Proposition 65 requires that a clear and reasonable warning be provided prior to exposure to the identified chemical. The method of warning should be a warning that appears on the product label. The Violator violated Proposition 65 because it failed to provide persons ingesting these products with appropriate warnings that they are being exposed to this chemical.

Consistent with the public interest goals of Proposition 65 and a desire to have these ongoing violations of California law quickly rectified, ERC is interested in seeking a constructive resolution of this matter that includes an enforceable written agreement by the Violator to: (1) reformulate the identified products so as to eliminate further exposures to the identified chemical, or provide appropriate warnings on the labels of these products; (2) pay an appropriate civil penalty; and (3) provide clear and reasonable warnings compliant with Proposition 65 to all persons located in California who purchased the above products in the last three years. Such a resolution will prevent further unwarned consumer exposures to the identified chemical, as well as expensive and time-consuming litigation.

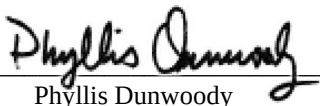

THE SAFE DRINKING WATER AND TOXIC ENFORCEMENT ACT OF 1986 (PROPOSITION 65): A SUMMARY

The following summary has been prepared by the California Office of Environmental Health Hazard Assessment (OEHHA), the lead agency for the implementation of the Safe Drinking Water and Toxic Enforcement Act of 1986 (commonly known as “Proposition 65”). A copy of this summary must be included as an attachment to any notice of violation served upon an alleged violator of the Act. The summary provides basic information about the provisions of the law, and is intended to serve only as a convenient source of general information. It is not intended to provide authoritative guidance on the meaning or application of the law. The reader is directed to the statute and OEHHA implementing regulations (see citations below) for further information.

FOR INFORMATION CONCERNING THE BASIS FOR THE ALLEGATIONS IN THE NOTICE RELATED TO YOUR BUSINESS, CONTACT THE PERSON IDENTIFIED ON THE NOTICE.

Regulations that provide more specific guidance on compliance, and that specify procedures to be followed by the State in carrying out certain aspects of the law, are found in Title 27 of the California Code of Regulations, sections 25102 through 27001.¹ These implementing regulations are available online at: <http://oehha.ca.gov/prop65/law/P65Regs.html>.

WHAT DOES PROPOSITION 65 REQUIRE?

The “Proposition 65 List.” Under Proposition 65, the lead agency (OEHHA) publishes a list of chemicals that are known to the State of California to cause cancer and/or reproductive toxicity. Chemicals are placed on the Proposition 65 list if they are known to cause cancer and/or birth defects or other reproductive harm, such as damage to

female or male reproductive systems or to the developing fetus. This list must be updated at least once a year. The current Proposition 65 list of chemicals is available on the OEHHA website at: http://www.oehha.ca.gov/prop65/prop65_list/Newlist.html.

Only those chemicals that are on the list are regulated under Proposition 65. Businesses that produce, use, release or otherwise engage in activities involving listed chemicals must comply with the following:

Clear and reasonable warnings. A business is required to warn a person before “knowingly and intentionally” exposing that person to a listed chemical unless an exemption applies. The warning given must be “clear and reasonable.” This means that the warning must: (1) clearly make known that the chemical involved is known to cause cancer, or birth defects or other reproductive harm; and (2) be given in such a way that it will effectively reach the person before he or she is exposed to that chemical. Some exposures are exempt from the warning requirement under certain circumstances discussed below.

Prohibition from discharges into drinking water. A business must not knowingly discharge or release a listed chemical into water or onto land where it passes or probably will pass into a source of drinking water. Some discharges are exempt from this requirement under certain circumstances discussed below.

DOES PROPOSITION 65 PROVIDE ANY EXEMPTIONS?

Yes. You should consult the current version of the statute and regulations (<http://www.oehha.ca.gov/prop65/law/index.html>) to determine all applicable exemptions, the most common of which are the following:

Grace Period. Proposition 65 warning requirements do not apply until 12 months after the chemical has been listed. The Proposition 65 discharge prohibition does not apply to a discharge or release of a chemical that takes place less than 20 months after the listing of the chemical.

Governmental agencies and public water utilities. All agencies of the federal, state or local government, as well as entities operating public water systems, are exempt.

Businesses with nine or fewer employees. Neither the warning requirement nor the discharge prohibition applies to a business that employs a total of nine or fewer employees. This includes all employees, not just those present in California.

Exposures that pose no significant risk of cancer. For chemicals that are listed under Proposition 65 as known to the State to cause cancer, a warning is not required if the business causing the exposure can demonstrate that the exposure occurs at a level that poses “no significant risk.” This means that the exposure is calculated to result in not more than one excess case of cancer in 100,000 individuals exposed over a 70-year lifetime. The Proposition 65 regulations identify specific “No Significant Risk Levels” (NSRLs) for many listed carcinogens. Exposures below these levels are exempt from the warning requirement. See OEHHA's website at: <http://www.oehha.ca.gov/prop65/getNSRLs.html> for a list of NSRLs, and Section 25701 *et seq.* of the regulations for information concerning how these levels are calculated.

Exposures that will produce no observable reproductive effect at 1,000 times the level in question. For chemicals known to the State to cause reproductive toxicity, a warning is not required if the business causing the exposure can demonstrate that the exposure will produce no observable effect, even at 1,000 times the level in question. In other words, the level of exposure must be below the “no observable effect level” divided by 1,000. This number is known as the Maximum Allowable Dose Level (MADL). See OEHHA's website at: <http://www.oehha.ca.gov/prop65/getNSRLs.html> for a list of MADLs, and Section 25801 *et seq.* of the regulations for information concerning how these levels are calculated.

Exposures to Naturally Occurring Chemicals in Food. Certain exposures to chemicals that naturally occur in foods (i.e., that do not result from any known human activity, including activity by someone other than the person causing the exposure) are exempt from the warning requirements of the law. If the chemical is a contaminant² it must be reduced to the lowest level feasible. Regulations explaining this exemption can be found in Section 25501.

Discharges that do not result in a “significant amount” of the listed chemical entering any source of drinking water. The prohibition from discharges into drinking water does not apply if the discharger is able to demonstrate that a “significant amount” of the listed chemical has not, does not, or will not pass into or probably pass into a source of drinking water, and that the discharge complies with all other applicable laws, regulations, permits, requirements, or orders. A “significant amount” means any detectable amount, except an amount that would meet the “no significant risk” level for chemicals that cause cancer or that is 1,000 times below the “no observable effect” level for chemicals that cause reproductive toxicity, if an individual were exposed to that amount in drinking water.

HOW IS PROPOSITION 65 ENFORCED?

Enforcement is carried out through civil lawsuits. These lawsuits may be brought by the Attorney General, any district attorney, or certain city attorneys. Lawsuits may also be brought by private parties acting in the public interest, but only after providing notice of the alleged violation to the Attorney General, the appropriate district attorney and city attorney, and the business accused of the violation. The notice must provide adequate information to allow the recipient to assess the nature of the alleged violation. The notice must comply with the information and procedural requirements specified in Section 25903 of Title 27 and sections 3100-3103 of Title 11. A private party may not pursue an independent enforcement action under Proposition 65 if one of the governmental officials noted above initiates an enforcement action within sixty days of the notice.

A business found to be in violation of Proposition 65 is subject to civil penalties of up to \$2,500 per day for each violation. In addition, the business may be ordered by a court to stop committing the violation.

A private party may not file an enforcement action based on certain exposures if the alleged violator meets specific conditions. For the following types of exposures, the Act provides an opportunity for the business to correct the alleged violation:

- An exposure to alcoholic beverages that are consumed on the alleged violator's premises to the extent onsite consumption is permitted by law;
- An exposure to a Proposition 65 listed chemical in a food or beverage prepared and sold on the alleged violator's premises that is primarily intended for immediate consumption on- or off-premises. This only applies if the chemical was not intentionally added to the food, and was formed by cooking or similar preparation of food or beverage components necessary to render the food or beverage palatable or to avoid microbiological contamination;
- An exposure to environmental tobacco smoke caused by entry of persons (other than employees) on premises owned or operated by the alleged violator where smoking is permitted at any location on the premises;
- An exposure to listed chemicals in engine exhaust, to the extent the exposure occurs inside a facility owned or operated by the alleged violator and primarily intended for parking non-commercial vehicles.

If a private party alleges that a violation occurred based on one of the exposures described above, the private party must first provide the alleged violator a notice of special compliance procedure and proof of compliance form.

NOTICE OF VIOLATIONS OF CALIFORNIA HEALTH & SAFETY CODE SECTION 25249.5 *ET SEQ.* (PROPOSITION 65)

Dear Alleged Violator and the Appropriate Public Enforcement Agencies:

I am the In-House Counsel for Environmental Research Center, Inc. (“ERC”). ERC is a California non-profit corporation dedicated to, among other causes, helping safeguard the public from health hazards by bringing about a reduction in the use and misuse of hazardous and toxic chemicals, facilitating a safe environment for consumers and employees, and encouraging corporate responsibility.

ERC has identified violations of California’s Safe Drinking Water and Toxic Enforcement Act of 1986 (“Proposition 65”), which is codified at California Health & Safety Code §25249.5 *et seq.*, with respect to the product identified below. These violations have occurred and continue to occur because the alleged Violator identified below failed to provide required clear and reasonable warnings with this product. This letter serves as a notice of these violations to the alleged Violator and the appropriate public enforcement agencies. Pursuant to Section 25249.7(d) of the statute, ERC intends to file a private enforcement action in the public interest 60 days after effective service of this notice unless the public enforcement agencies have commenced and are diligently prosecuting an action to rectify these violations.

General Information about Proposition 65. A copy of a summary of Proposition 65, prepared by the Office of Environmental Health Hazard Assessment, is attached with the copy of this letter served to the alleged Violator identified below.

Alleged Violator. The name of the company covered by this notice that violated Proposition 65 (hereinafter the “Violator”) is:

Azuretale Inc., individually and dba BetterAlt

Consumer Product and Listed Chemical. The product that is the subject of this notice and the chemical in that product identified as exceeding allowable levels is:

BetterAlt Boost Beet Root Powder - Lead

On February 27, 1987, the State of California officially listed lead as a chemical known to cause developmental toxicity, and male and female reproductive toxicity. On October 1, 1992, the State of California officially listed lead and lead compounds as chemicals known to cause cancer.

It should be noted that ERC may continue to investigate other products that may reveal further violations and result in subsequent notices of violations.

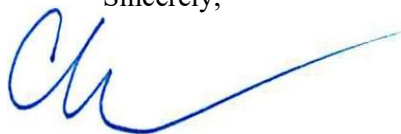
Route of Exposure. The consumer exposures that are the subject of this notice result from the recommended use of this product. Consequently, the route of exposure to this chemical has been and continues to be through ingestion.

Approximate Time Period of Violations. Ongoing violations have occurred every day since at least August 28, 2022, as well as every day since the product was introduced into the California marketplace and will continue every day until clear and reasonable warnings are provided to product purchasers and users or until this known toxic chemical is either removed from or reduced to allowable levels in the product. Proposition 65 requires that a clear and reasonable warning be provided prior to exposure to the identified chemical. The method of warning should be a warning that appears on the product label. The Violator violated Proposition 65 because it failed to provide persons ingesting this product with appropriate warnings that they are being exposed to this chemical.

Consistent with the public interest goals of Proposition 65 and a desire to have these ongoing violations of California law quickly rectified, ERC is interested in seeking a constructive resolution of this matter that includes an enforceable written agreement by the Violator to: (1) reformulate the identified product so as to eliminate further exposures to the identified chemical, or provide appropriate warnings on the labels of this product; (2) pay an appropriate civil penalty; and (3) provide clear and reasonable warnings compliant with Proposition 65 to all persons located in California who purchased the above product in the last three years. Such a resolution will prevent further unwarned consumer exposures to the identified chemical, as well as expensive and time-consuming litigation.

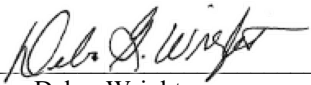
