Re: Proposition 65 Amended Notice of Violation

To Whom It May Concern:

This notice supersedes the original notice AG 2017-01262 dated: April 4, 2017.

We represent Kim Embry, a citizen of the State of California acting in the interest of the general public. This letter serves as notice that the parties listed above are in violation of Proposition 65, the Safe Drinking Water and Toxic Enforcement Act, commencing with section 25249.5 of the Health and Safety Code ("Proposition 65"). In particular, the violations alleged by this notice consist of types of harm that may potentially result from exposures to the toxic chemical Acrylamide. This chemical was listed as known to cause cancer on January 1, 1990, and listed as known to cause developmental/reproductive toxicity in February of 2011.

The specific types of product(s) that, when grilled or toasted to a golden brown, expose consumers to acrylamide in violation of Proposition 65 are detailed below:

Exposure to acrylamide results from consumer ingestion – the reasonably foreseeable use of the product(s). The sales of these products have been occurring since at least March 8, 2017 and are continuing to this day and will continue to occur as long as the products subject to this notice are sold to and used by consumers.

Proposition 65 requires that a clear and reasonable warning is provided with this product regarding the exposures to Acrylamide, caused by ordinary use of the product. The Parties are in violation of Proposition 65 by failing to provide such warning to consumers and as a result of the sale of this product, exposures to Acrylamide have been occurring without proper warning.

Pursuant to Proposition 65, notice and intent to sue shall be provided to violators 60 days before filing a complaint. This letter provides notice of the alleged violation to the parties listed above and the appropriate governmental authorities. A summary of Proposition 65 is attached.
