Re: Public Health and Safety Advocates, LLC’s June 1, 2020 Sixty Day Notice of Proposition 65 Violation to DW Global, Inc.

Dear Mr. Danialpour:

I write on behalf of my client, DW Global, Inc. (“DW Global”), in response to Public Health and Safety Advocates, LLC’s (“PHSA’s”) Sixty Day Notice of Violation (“Notice”) alleging that DW Global violated Proposition 65 by exposing California consumers to products containing lead and cadmium. Please be advised that DW Global has less than 10 employees, which, as I am sure you know, means it is exempt from Proposition 65’s requirements. See Cal. Health & Safety Code § 25249.11(b). Kindly confirm that PHSA will therefore withdraw its Notice.

Should PHSA proceed with any adverse action against DW Global relating to the Notice or Proposition 65, my client will defend itself vigorously and seek all appropriate relief, including sanctions against PHSA and your firm, for filing a baseless lawsuit. We certainly hope that will not be necessary, particularly given the unprecedented global pandemic that we are all facing right now.

This letter is sent without waiving any of DW Global’s rights or defenses, each of which is expressly reserved.
